1 AN ACT Relating to the periodic replacement of license plates;
2 amending RCW 46.16A.200 and 46.17.200; and creating a new section.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 46.16A.200 and 2011 c 171 s 46 are each amended to
5 read as follows:

6 (1) **Design.** All license plates may be obtained by the director
7 from the metal working plant of a state correctional facility or from
8 any source in accordance with existing state of Washington purchasing
9 procedures. License plates:

10 (a) May vary in background, color, and design;

11 (b) Must be legible and clearly identifiable as a Washington state
12 license plate;

13 (c) Must designate the name of the state of Washington without
14 abbreviation;

15 (d) Must be treated with fully reflectorized materials designed to
16 increase visibility and legibility at night;

17 (e) Must be of a size and color and show the registration period as
18 determined by the director; and

1 (f) Before July 1, 2010, may display a symbol or artwork approved
2 by the former special license plate review board and the legislature.
3 Beginning July 1, 2010, special license plate series approved by the
4 department and enacted into law by the legislature may display a symbol
5 or artwork approved by the department.

6 (2) **Exceptions to reflectorized materials.** License plates issued
7 before January 1, 1968, are not required to be treated with
8 reflectorized materials.

9 (3) **Dealer license plates.** License plates issued to a dealer must
10 contain an indication that the license plates have been issued to a
11 vehicle dealer.

12 (4)(a) **Furnished.** The director shall furnish to all persons making
13 satisfactory application for a vehicle registration:

14 (i) Two identical license plates each containing the license plate
15 number; or

16 (ii) One license plate if the vehicle is a trailer, semitrailer,
17 camper, moped, collector vehicle, horseless carriage, or motorcycle.

18 (b) The director may adopt types of license plates to be used as
19 long as the license plates are legible.

20 (5)(a) **Display.** License plates must be:

21 (i) Attached conspicuously at the front and rear of each vehicle if
22 two license plates have been issued;

23 (ii) Attached to the rear of the vehicle if one license plate has
24 been issued;

25 (iii) Kept clean and be able to be plainly seen and read at all
26 times; and

27 (iv) Attached in a horizontal position at a distance of not more
28 than four feet from the ground.

29 (b) The Washington state patrol may grant exceptions to this
30 subsection if the body construction of the vehicle makes compliance
31 with this section impossible.

32 (6) **Change of license classification.** A person who has altered a
33 vehicle that makes the current license plate or plates invalid for the
34 vehicle's use shall:

35 (a) Surrender the current license plate or plates to the
36 department, county auditor or other agent, or subagent appointed by the
37 director;

38 (b) Apply for a new license plate or plates; and

1 (c) Pay a change of classification fee required under RCW
2 46.17.310.

3 (7) **Unlawful acts.** It is unlawful to:

4 (a) Display a license plate or plates on the front or rear of any
5 vehicle that were not issued by the director for the vehicle;

6 (b) Display a license plate or plates on any vehicle that have been
7 changed, altered, or disfigured, or have become illegible;

8 (c) Use holders, frames, or other materials that change, alter, or
9 make a license plate or plates illegible. License plate frames may be
10 used on license plates only if the frames do not obscure license tabs
11 or identifying letters or numbers on the plates and the license plates
12 can be plainly seen and read at all times;

13 (d) Operate a vehicle unless a valid license plate or plates are
14 attached as required under this section;

15 (e) Transfer a license plate or plates issued under this chapter
16 between two or more vehicles without first making application to
17 transfer the license plates. A violation of this subsection (7)(e) is
18 a traffic infraction subject to a fine not to exceed five hundred
19 dollars. Any law enforcement agency that determines that a license
20 plate or plates have been transferred between two or more vehicles
21 shall confiscate the license plate or plates and return them to the
22 department for nullification along with full details of the reasons for
23 confiscation. Each vehicle identified in the transfer will be issued
24 a new license plate or plates upon application by the owner or owners
25 and the payment of full fees and taxes; or

26 (f) Fail, neglect, or refuse to endorse the registration
27 certificate and deliver the license plate or plates to the purchaser or
28 transferee of the vehicle, except as authorized under this section.

29 (8) **Transfer.** (a) Standard issue license plates follow the vehicle
30 when ownership of the vehicle changes unless the registered owner
31 wishes to retain the license plates and transfer them to a replacement
32 vehicle of the same use. A registered owner wishing to keep standard
33 issue license plates shall pay the license plate transfer fee required
34 under RCW 46.17.200(1)(c) when applying for license plate transfer.

35 (b) Special license plates and personalized license plates may be
36 treated in the same manner as described in (a) of this subsection
37 unless otherwise limited by law.

1 (c) License plates issued to the state or any county, city, town,
2 school district, or other political subdivision entitled to exemption
3 as provided by law may be treated in the same manner as described in
4 (a) of this subsection.

5 (9) **Replacement.** (a) An owner or the owner's authorized
6 representative shall apply for a replacement license plate or plates if
7 the current license plate or plates assigned to the vehicle have been
8 lost, defaced, or destroyed, or if one or both plates have become so
9 illegible or are in such a condition as to be difficult to distinguish.
10 An owner or the owner's authorized representative may apply for a
11 replacement license plate or plates at any time the owner chooses.

12 (b) The application for a replacement license plate or plates must:

13 (i) Be on a form furnished or approved by the director; and

14 (ii) Be accompanied by the fee required under RCW 46.17.200(1)(a).

15 (c) The department shall not require the payment of any fee to
16 replace a license plate or plates for vehicles owned, rented, or leased
17 by foreign countries or international bodies to which the United States
18 government is a signatory by treaty.

19 (10) **Periodic replacement.** License plates must be replaced
20 periodically to ensure maximum legibility and reflectivity. The
21 department shall:

22 (a) Use empirical studies documenting the longevity of the
23 reflective materials used to make license plates;

24 (b) Determine how frequently license plates must be replaced;
25 ((and))

26 (c) Require the applicant to pay the periodic license plate
27 replacement fee as required under RCW 46.17.200(1)(e); and

28 (d) Offer to owners the option of retaining the current license
29 plate number when obtaining replacement license plates for the fee
30 required in RCW 46.17.200(1)(b).

31 (11) **Periodic replacement--Exceptions.** The following license
32 plates are not required to be periodically replaced as required in
33 subsection (10) of this section:

34 (a) Horseless carriage license plates issued under RCW 46.18.255
35 before January 1, 1987;

36 (b) Congressional Medal of Honor license plates issued under RCW
37 46.18.230;

1 (c) License plates for commercial motor vehicles with a gross
2 weight greater than twenty-six thousand pounds.

3 (12) **Rules.** The department may adopt rules to implement this
4 section.

5 (13) **Tabs or emblems.** The director may issue tabs or emblems to be
6 attached to license plates or elsewhere on the vehicle to signify
7 initial registration and renewals. Renewals become effective when tabs
8 or emblems have been issued and properly displayed on license plates.

9 **Sec. 2.** RCW 46.17.200 and 2011 c 171 s 56 are each amended to read
10 as follows:

11 (1) In addition to all other fees and taxes required by law, the
12 department, county auditor or other agent, or subagent appointed by the
13 director shall charge:

14 (a) The following license plate fees for each license plate, except
15 for license plates as provided in (e) of this subsection, unless the
16 owner or type of vehicle is exempt from payment:

23 (b) A license plate retention fee, as required under RCW
24 46.16A.200(10)(~~(a)(iii)~~) (d), of twenty dollars if the owner wishes
25 to retain the current license plate number upon license plate
26 replacement, unless the owner or type of vehicle is exempt from
27 payment. The twenty dollar fee must be deposited in the multimodal
28 transportation account created in RCW 47.66.070.

29 (c) A ten dollar license plate transfer fee, as required under RCW
30 46.16A.200(8)(a), when transferring standard issue license plates from
31 one vehicle to another, unless the owner or type of vehicle is exempt
32 from payment. The ten dollar license plate transfer fee must be
33 deposited in the motor vehicle fund created in RCW 46.68.070.

1 (d) Former prisoner of war license plates, as described in RCW
2 46.18.235, may be transferred to a replacement vehicle upon payment of
3 a five dollar license plate fee, in addition to any other fee required
4 by law.

5 (e) The following periodic license plate replacement fees for each
6 license plate, based on license plate type, to a person who applies for
7 a vehicle registration for a vehicle that is subject to periodic
8 license plate replacement as required under RCW 46.16A.200(10):

15 (2) The department may, upon request, provide license plates that
16 have been used and returned to the department to individuals for
17 nonvehicular use. The department may charge a fee of up to five
18 dollars per license plate to cover costs or recovery for postage and
19 handling. The department may waive the fee for license plates used in
20 educational projects and may, by rule, provide standards for the fee
21 waiver and restrictions on the number of license plates provided to any
22 one person. The fee must be deposited in the motor vehicle fund
23 created in RCW 46.68.070.

24 NEW SECTION. Sec. 3. This act applies to vehicle registrations
25 that are due or will become due on or after July 1, 2013.
