1           AN ACT Relating to the operation of motorcycles; and amending RCW  
2 46.61.613, 46.04.437, 46.18.215, 46.18.225, 46.18.230, 46.18.235,  
3 46.18.270, 46.18.280, and 46.18.290.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5           **Sec. 1.** RCW 46.61.613 and 2010 c 8 s 9073 are each amended to read  
6 as follows:

7           The provisions of RCW 46.37.530 and 46.61.610 through 46.61.612  
8 ~~((may be))~~ are temporarily suspended ~~((by the chief of the Washington~~  
9 ~~state patrol, or his or her designee,))~~ with respect to the operation  
10 of motorcycles ~~((within their respective jurisdictions in connection~~  
11 ~~with a parade or public demonstration))~~ on a closed road during a  
12 parade or public demonstration that has been permitted by a local  
13 jurisdiction.

14           **Sec. 2.** RCW 46.04.437 and 2010 c 161 s 133 are each amended to  
15 read as follows:

16           "Purple heart license plates" means special license plates that may  
17 be assigned to a motor vehicle required to display one or two license

1 plates, excluding vehicles registered under chapter 46.87 RCW, upon  
2 terms and conditions established by the department, to recipients of  
3 the Purple Heart medal or to another qualified person.

4 **Sec. 3.** RCW 46.18.215 and 2010 c 161 s 614 are each amended to  
5 read as follows:

6 The department shall create, design, and issue a special baseball  
7 stadium license plate that may be used in lieu of standard issue or  
8 personalized license plates for motor vehicles required to display one  
9 or two license plates, excluding vehicles registered under chapter  
10 46.87 RCW, upon terms and conditions established by the department.  
11 The special license plates commemorate the construction of a baseball  
12 stadium, as defined in RCW 82.14.0485. The department shall also issue  
13 to each recipient of a special baseball stadium license plate a  
14 certificate of participation in the construction of the baseball  
15 stadium.

16 **Sec. 4.** RCW 46.18.225 and 2010 c 161 s 615 are each amended to  
17 read as follows:

18 A state university, regional university, or state college as  
19 defined in RCW 28B.10.016 may apply to the department, in a form  
20 approved by the department and request the department to issue a series  
21 of collegiate license plates, for display on motor vehicles required to  
22 display one or two license plates, excluding vehicles registered under  
23 chapter 46.87 RCW, upon terms and conditions established by the  
24 department, depicting the name and mascot or symbol of the college or  
25 university, as submitted and approved for use by the requesting  
26 institution.

27 **Sec. 5.** RCW 46.18.230 and 2010 c 161 s 618 are each amended to  
28 read as follows:

29 (1) A registered owner who has been awarded the Congressional Medal  
30 of Honor may apply to the department for special license plates for use  
31 on a (~~passenger~~) motor vehicle required to display one or two license  
32 plates, excluding vehicles registered under chapter 46.87 RCW, upon  
33 terms and conditions established by the department. The Congressional  
34 Medal of Honor recipient must:

1 (a) Provide proof from the Washington state department of veterans  
2 affairs showing receipt of the medal; and

3 (b) Be recorded as the registered owner of the motor vehicle on  
4 which the Congressional Medal of Honor license plate or plates will be  
5 displayed.

6 (2) Congressional Medal of Honor license plates must be issued:

7 (a) Only for a personal (~~passenger~~) motor vehicle owned by  
8 persons who have received the Congressional Medal of Honor; and

9 (b) Without payment of vehicle license fees, license plate fees,  
10 and motor vehicle excise taxes.

11 (3) Congressional Medal of Honor license plates must be replaced,  
12 free of charge, if the license plates become lost, stolen, damaged,  
13 defaced, or destroyed.

14 (4) A Congressional Medal of Honor license plate or plates may be  
15 transferred, free of charge, from one motor vehicle to another motor  
16 vehicle owned by the Congressional Medal of Honor recipient upon  
17 application to the department, county auditor or other agent, or  
18 subagent appointed by the director.

19 **Sec. 6.** RCW 46.18.235 and 2010 c 161 s 619 are each amended to  
20 read as follows:

21 (1) A registered owner who is a veteran, as defined in RCW  
22 41.04.007, may apply to the department for disabled American veteran or  
23 former prisoner of war license plates, for use on one personal use  
24 motor vehicle required to display one or two license plates, excluding  
25 vehicles registered under chapter 46.87 RCW, upon terms and conditions  
26 established by the department. The veteran must be recorded as the  
27 registered owner of the motor vehicle on which the disabled American  
28 veteran or former prisoner of war license plate or plates will be  
29 displayed and:

30 (a) Provide certification from the veterans administration or the  
31 military service from which the veteran was discharged that the veteran  
32 has a service-connected disability rating;

33 (b) Have lost the use of both hands or one foot;

34 (c) Have been captured and incarcerated by an enemy of the United  
35 States during a period of war with the United States and have received  
36 a prisoner of war medal;

1 (d) Have become blind in both eyes as the result of military  
2 service; or

3 (e) Be rated by the veterans administration or the military service  
4 from which the veteran was discharged and be receiving service-  
5 connected compensation at the one hundred percent rate that is expected  
6 to exist for more than one year.

7 (2) The special license plates under this section must:

8 (a) Display distinguishing marks, letters, or numerals indicating  
9 that the registered owner is a disabled American veteran or former  
10 prisoner of war; and

11 (b) Be issued for one personal use vehicle without the payment of  
12 any vehicle license fees, license plate fees, or excise taxes.

13 (3) A registered owner who is a veteran, as defined in RCW  
14 41.04.007, may, in lieu of applying for the special license plates  
15 under this section, apply for regular issue or any qualifying special  
16 license plate and receive the full benefit of the vehicle license fee  
17 and excise tax exemption provided in subsection (2)(b) of this section.

18 (4) The department may periodically verify the one hundred percent  
19 rate as described in subsection (1)(e) of this section.

20 (5) A veteran who has been issued disabled American veteran or  
21 former prisoner of war license plates under this section before July 1,  
22 1983, continues to be eligible for the vehicle license fee and excise  
23 tax exemption described in subsection (2)(b) of this section.

24 (6) A disabled American veteran and former prisoner of war license  
25 plate or plates may be transferred from one motor vehicle to another  
26 motor vehicle owned by the veteran upon application to the department,  
27 county auditor or other agent, or subagent appointed by the director.

28 (7) For the purposes of this section:

29 (a) "Blind" means the definition of "blind" used by the state of  
30 Washington in determining eligibility for financial assistance to the  
31 blind under Title 74 RCW; and

32 (b) "Special license plates" does not include any plate from the  
33 armed forces license plate collection established in RCW 46.18.200(3).

34 (8) Any unauthorized use of a special license plate under this  
35 section is a gross misdemeanor.

36 **Sec. 7.** RCW 46.18.270 and 2010 c 161 s 625 are each amended to  
37 read as follows:

1 (1) A registered owner who has survived the attack on Pearl Harbor  
2 on December 7, 1941, may apply to the department for special license  
3 plates for use on only one motor vehicle required to display one or two  
4 license plates, excluding vehicles registered under chapter 46.87 RCW,  
5 upon terms and conditions established by the department, and owned by  
6 the qualified applicant. The applicant must:

7 (a) Be a resident of this state;

8 (b) Have been a member of the United States armed forces on  
9 December 7, 1941;

10 (c) Have been on station on December 7, 1941, between the hours of  
11 7:55 a.m. and 9:45 a.m. Hawaii time at Pearl Harbor, the island of  
12 Oahu, or offshore at a distance not to exceed three miles;

13 (d) Have received an honorable discharge from the United States  
14 armed forces;

15 (e) Provide certification by a Washington state chapter of the  
16 Pearl Harbor survivors association showing that qualifications in (c)  
17 of this subsection have been met;

18 (f) Be recorded as the registered owner of the motor vehicle on  
19 which the Pearl Harbor survivor license plate or plates will be  
20 displayed; and

21 (g) Pay all fees and taxes required by law for registering the  
22 motor vehicle.

23 (2) Pearl Harbor survivor license plates must be issued without the  
24 payment of any license plate fee.

25 (3) Pearl Harbor survivor license plates must be replaced, free of  
26 charge, if the license plates have become lost, stolen, damaged,  
27 defaced, or destroyed.

28 (4) Pearl Harbor survivor license plates may be issued to the  
29 surviving spouse or domestic partner of a Pearl Harbor survivor who met  
30 the requirements in subsection (1) of this section. The surviving  
31 spouse or domestic partner must be a resident of this state. If the  
32 surviving spouse remarries or the surviving domestic partner marries or  
33 enters into a new domestic partnership, he or she must return the  
34 special license plates to the department within fifteen days and apply  
35 for regular license plates or another type of special license plate.

36 (5) A Pearl Harbor survivor license plate or plates may be  
37 transferred from one motor vehicle to another motor vehicle owned by  
38 the Pearl Harbor survivor or the surviving spouse or domestic partner

1 as described in subsection (4) of this section upon application to the  
2 department, county auditor or other agent, or subagent appointed by the  
3 director.

4 **Sec. 8.** RCW 46.18.280 and 2010 c 161 s 628 are each amended to  
5 read as follows:

6 (1) A registered owner who has been awarded a Purple Heart medal by  
7 any branch of the United States armed forces, including the merchant  
8 marines and the women's air forces service pilots may apply to the  
9 department for special license plates for use on only one motor vehicle  
10 required to display one or two license plates, excluding vehicles  
11 registered under chapter 46.87 RCW, upon terms and conditions  
12 established by the department, and owned by the qualified applicant.

13 The applicant must:

14 (a) Be a resident of this state;

15 (b) Have been wounded during one of this nation's wars or conflicts  
16 identified in RCW 41.04.005;

17 (c) Have received an honorable discharge from the United States  
18 armed forces;

19 (d) Provide a copy of the armed forces document showing the  
20 recipient was awarded the Purple Heart medal;

21 (e) Be recorded as the registered owner of the motor vehicle on  
22 which the Purple Heart survivor license plate or plates will be  
23 displayed; and

24 (f) Pay all fees and taxes required by law for registering the  
25 motor vehicle.

26 (2) Purple Heart license plates must be issued without the payment  
27 of any special license plate fee.

28 (3) Purple Heart license plates may be issued to the surviving  
29 spouse or domestic partner of a Purple Heart recipient who met the  
30 requirements in subsection (1) of this section. The surviving spouse  
31 or domestic partner must be a resident of this state. If the surviving  
32 spouse remarries or the surviving domestic partner marries or enters  
33 into a new domestic partnership, he or she must return the special  
34 license plates to the department within fifteen days and apply for  
35 regular license plates or another type of special license plate.

36 (4) A Purple Heart license plate or plates may be transferred from  
37 one motor vehicle to another motor vehicle owned by the Purple Heart

1 recipient or the surviving spouse or domestic partner as described in  
2 subsection (3) of this section upon application to the department,  
3 county auditor or other agent, or subagent appointed by the director.

4 **Sec. 9.** RCW 46.18.290 and 2010 c 161 s 630 are each amended to  
5 read as follows:

6 A registered owner may apply to the department, county auditor or  
7 other agent, or subagent appointed by the director for a square dancer  
8 license plate. The registered owner shall pay the special license  
9 plate fee required under RCW 46.17.220(1)(q), in addition to any other  
10 fee or tax required by law. The square dancer license plate may be  
11 issued in lieu of standard issue or personalized license plates for  
12 motor vehicles required to display one or two license plates, but may  
13 not be issued for vehicles registered under chapter 46.87 RCW.
