

HB 2835 - DIGEST

Reduces certain requirements affecting school districts by providing flexibility in truancy reporting obligations and frequency of audits.

Requires the state auditor to conduct fiscal and performance audits no more often than once every three years for school districts when no findings of impropriety were found for the school districts for the three-year period immediately preceding the audit period.
