House Bills

HB 1130 by Representatives Appleton, Haigh, and Kenney

Requiring licensed midwives to prepare written plans for each patient.

Removes the duty of a midwife to consult with a physician if there are certain deviations from normal in the mother or the infant.

Requires a midwife to develop a written plan for each patient following the initial patient assessment and before the commencement of a regular program of midwifery services.

Requiring massage practitioners to include their license numbers on advertising and display a copy of their license or make it available upon request.

Requires a massage practitioner's name and license number to appear on all of his or her advertisements.

Requires a massage practitioner to display his or her license in his or her principal place of business.

Requiring the renewal of horseless carriage and collector vehicle license plates.

 (6) Identification to be attached to traps;
 (7) Revocation of trapping license; and
 (8) Trapping license fees.

 (4) Option to purchase a solar energy system; and
 (5) Credit against taxes due from a light and power business.

(2) The administration of circumstances and behaviors foreseeable at the time of the legislation's enactment.

Provides a small business taxpayer bill of rights.

Requires the department of commerce to: (1) Develop and offer a small business loan or loan guarantee program of up to one hundred million dollars to provide access to capital for qualified small businesses which are unable to obtain funding from private commercial lenders on commercially reasonable terms or to qualify for federal small business administration loans; and

(2) Establish and continuously update an online portal to provide small businesses with information about a broad array of state, federal, and local services.

Requires master and renewal applications issued through the business license center to include a statement referencing the online business portal.

Requires excise tax returns to include a statement referencing the online business portal.

Requires the department of revenue to waive or cancel certain interest and penalties for a small business taxpayer if the failure to pay taxes due was not intentional.

Allows a business and occupation tax credit for new qualified employment positions created as provided in section 3 of the act.

Repeals the termination of the office of regulatory assistance under the sunset act.

Preventing alcohol poisoning deaths.

Prohibits a person under the age of twenty-one who experiences alcohol poisoning and is in need of medical assistance from being charged or prosecuted.

Requires each court administration or the equivalent to develop and maintain a registry of qualified victim impact panels.

Addresses the requirement to attend a victim impact panel.

Increases the additional fee assessed to certain alcohol violators.

Prohibits a college from charging a student more than a standard transcription fee to accept certain courses for college credit.

Prohibiting the use of eminent domain for economic development.

Prohibits a public entity from taking property for the purpose of economic development.
