Provides a business and occupation tax exemption to restaurants in respect to meals provided without specific charge to employees.

Provides a sales and use tax exemption on meals provided without specific charge to an employee by a restaurant.

Revises the seller's disclosure statement by requesting information on fire protection services.

Directs the chair of the forest practices board to invite relevant stakeholders to participate in a process that investigates potential new long-term funding sources for the program.
