Protects tenants from unreasonable space or lot rent increases while simultaneously recognizing and providing for the need of park owners to receive a just and reasonable return on the investment in their property.

Creates the manufactured/mobile home park rental review board.

Provides that the act is null and void if appropriations are not approved.

Prohibits a city or town from assuming the jurisdiction of certain water-sewer districts unless voters of the entire water-sewer district approve a ballot proposition authorizing the assumption under general election law.

Authorizes group disability insurance for certain lines of coverage that is offered to residents of this state under a group disability insurance policy to be issued to certain other groups.

Creating a strategic plan for career and technical education.

Regarding the provision of telecommunications services by public entities.

Grants public utility districts the authority to provide retail telecommunications services, including broadband, with the expectation that these services will be subject to the same telecommunications taxes, fees, and surcharges that are applicable to other telecommunications providers in the state.

Requires a person who loses or abandons commercial net fishing gear in the waters of the state to report certain information to the department of fish and wildlife.

Encourages a person who loses or abandons shellfish pots in the waters of the state to report certain information to the department of fish and wildlife.

**HB 1718** by Representatives Roberts, Moeller, Dammeier, and Green

Concerning offenders with developmental disabilities or traumatic brain injuries.

Overrules the holding in *Rahman v. State* that a government or private employer may be held liable for injuries to unauthorized occupants of the employer's vehicle.

**HB 1720** by Representatives Hunt and McCoy; by request of Governor Gregoire

Reorganizing and streamlining central service functions, powers, and duties of state government.

Abolishes the department of general administration and the public printer and transfers their powers, duties, and functions to the department of enterprise services.

Transfers certain powers, duties, and functions of the department of information services, the department of personnel, and the office of financial management to the department of enterprise services.

Transfers certain powers, duties, and functions of the department of personnel to the office of financial management.

Requires the code reviser to prepare legislation for the 2012 regular session that changes all statutory references to the director or department of general administration to department of enterprise services.

Prohibits the application of a coal tar pavement product on a driveway or parking area.
