Encourages local governments to enter into interlocal agreements with the energy facility site evaluation council.

# HB 1830 by Representatives Seaquist and Appleton

Creates a Washington state ferry reform executive board charged with executive supervision of ferry system managers as the system implements a series of explicit ferry system reform tasks and prepares to transition to a new, sustainable management structure with enhanced public oversight.

Requires the board to complete its work by June 30, 2013.

Revising the crime of assault in the first degree.

# HB 1839 by Representatives Hinkle, Cody, and Schmick

Requires the insurance commissioner to submit a waiver request to the center for medicaid and medicare services to preserve the state's ability to provide health benefits coverage to high-risk individuals through the state health insurance pool after individuals are able to purchase individual health benefit plans through health benefit exchanges established under federal law.

Requires the capture and relocation of grizzly bears, wolves, or cougars to be conducted consistent with a program that provides for captured animals to be distributed upon release in the state's various natural area preserves and natural resources conservation areas equally on both sides of the crest of the Cascade mountains.

Creates the information technology advisory board, the consolidated technology services agency, and the consolidated technology services board.

Brings the civil commitment laws under chapter 71.09 RCW (sexually violent predators) further in line with other civil commitment laws, including the commitment of the mentally ill under chapter 71.05 RCW and the commitment of the criminally insane under chapter 10.77 RCW.

Creates the parks and recreation advisory commission within the department.

Transfers the powers, duties, and functions of the department of fish and wildlife, the law enforcement and heritage program at the department of natural resources, the parks and recreation commission, and the recreation and conservation office to the department of conservation and recreation.

Transfers the pollution liability insurance agency to the department of ecology.

Transfers the reclaimed water program from the department of health to the department of ecology.

Transfers the site use permit program from the department of ecology to the department of health.

Abolishes the state conservation commission and transfers its powers, duties, and functions to the department of agriculture.

Abolishes the department of archaeology and historic preservation and transfers its powers, duties, and functions to the office of archaeology and historic preservation within the department of natural resources.

Requires the code reviser to: (1) Note, wherever the director or department of fish and wildlife or the director or office of recreation and conservation is used or referred to in statute, that the name of the department or office has changed; and

(2) Prepare legislation for the 2012 regular legislative session that changes all statutory references to the director or office of recreation and conservation and to the director or department of fish and wildlife to the department of conservation and recreation.
