House Bills

HB 2039 by Representatives Hudgins, Hasegawa, and Hunt

Creating the Washington economic prosperity bank.

Creates the Washington economic prosperity bank to: (1) Finance Washington businesses and public infrastructure; and

(2) Increase the effective, efficient, and accountable use of state resources.

Transfers the life sciences discovery fund and the energy freedom program to the Washington economic prosperity bank.

Creates the Washington economic prosperity bank account.

Makes appropriations.

Providing for assistance for financing infrastructure and economic development.

Creates a task force to develop a means to use the state's money to finance public works infrastructure, student loans, and economic development.

Expires December 31, 2012.

HB 2041 by Representatives Fitzgibbon and Sells

Extending collective bargaining rights to employees of the legislative branch of the state government.

Concerning preferences for in-state contractors bidding on public works.

HB 2043 by Representatives Hudgins, Darneille, Cody, Pettigrew, Haigh, Ormsby, Hasegawa, and

Kenney

Increasing state revenues by allowing the sale of liquorrelated products in state and contract liquor stores and by creating a pilot project for the colocation of contract liquor stores in grocery stores.

Allows the sale of liquor-related products in state and contract liquor stores.

Requires the liquor control board to conduct a pilot project to appoint up to five contract liquor stores colocated within grocery stores in high population areas.

Senate Bills

SB 5251-S by Senate Committee on Transportation (originally sponsored by Senators Haugen, Swecker, Sheldon, Hobbs, and White)

Concerning electric vehicle license fees.

(AS OF SENATE 2ND READING 3/29/11)

Imposes an additional fee of one hundred dollars at the time of initial vehicle registration and annual registration renewal for electric vehicles.

Provides a contingent expiration date.

Requires the department of licensing to provide notice of the expiration date to certain parties.

SB 5875-S by Senate Committee on Human Services & Corrections (originally sponsored by Senator Hargrove)

Addressing the terms of supervision for offenders sentenced to a first time offender waiver.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Decreases the term of community custody for certain offenders.

Requires the department of corrections to recalculate the term of community custody for certain offenders.

Hewitt, Keiser, King, Regala, Conway, Carrell, and Hargrove; by request of Governor Gregoire)

Addressing prison safety by implementing the policy recommendations resulting from the national institute of corrections review of prison safety.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Implements changes recommended by the national institute of corrections as a result of its review of safety procedures at the Monroe reformatory.

SB 5911 by Senators Murray and Zarelli; by request of Department of Licensing and Department of Revenue

Concerning the master license service program.

Transfers to the department of revenue all powers, duties, and functions of the department of licensing pertaining to the administration of chapter 19.02 RCW (business license center act), chapter 19.80 RCW (trade names), and chapter 59.30 RCW (manufactured/mobile home communities--dispute resolution and registration).

SB 5912 by Senators Keiser, Pflug, Kohl-Welles, and Kline

Expanding family planning services to two hundred fifty percent of the federal poverty level.

Expands family planning services to two hundred fifty percent of the federal poverty level.

Requires the office of financial management, upon implementation of the expansion, to reduce general fund-state allotments for the medical assistance program by one million five hundred thousand dollars for fiscal year 2012 and by three million dollars for fiscal year 2013.
