House Bills

HB 1371-S2 by House Committee on Ways & Means (originally sponsored by Representatives Darneille and Hunt; by request of Governor Gregoire)

Addressing boards and commissions.

(DIGEST OF PROPOSED 2ND SUBSTITUTE)

Eliminates, renames, and changes and/or transfers duties, functions, and appointing authority of certain boards, commissions, and similar entities.

HB 1981-S by House Committee on Ways & Means (originally sponsored by Representatives Bailey and Carlyle)

Addressing public employee postretirement employment and higher education employees' annuities and retirement income plans.

(DİGEST OF PROPOSED 1ST SUBSTITUTE)

Revises the retirement and annuity programs of the higher education institutions for future participants to reflect changes that have already occurred in state pension plans.

Gives certain newly hired employees more options for retirement plans.

Reduces the expanded postretirement employment provisions for members of certain retirement systems.

Eliminates postretirement employment exceptions that existed for annuity or retirement income plan-covered positions that have been the subject of abuse.

Creates a higher education retirement plan supplemental benefit fund for the purpose of funding future benefit obligations of higher education retirement plan supplemental benefits.

HB 2103 by Representatives Green, Miloscia, Van De Wege, Reykdal, Liias, McCoy, Appleton, Fitzgibbon, Lytton, Moscoso, Jinkins, Moeller, Kenney, Hunt, Hudgins, Kirby, Hasegawa, Ryu, Goodman, and Stanford

Prohibiting certain employer communications about political or religious matters.

Prohibits employers from requiring employees to attend a meeting, or listen to, or respond to, or participate in, any communication relating to political or religious matters.

Requires employers to post a notice of certain employee rights in a conspicuous place accessible to the employees at the employer's place of business.

HB 2104 by Representatives Ormsby, Liias, Reykdal, Moscoso, Jinkins, Moeller, Hudgins, McCoy, Kirby, Hasegawa, Ryu, Appleton, Kenney, Fitzgibbon, Goodman, Miloscia, and Hunt

Prohibiting deductions of workers' compensation premiums and other costs from wages and earnings.

Prohibits deductions of workers' compensation premiums and other costs from wages and earnings.

Senate Bills

SB 5952 by Senators Kohl-Welles, Hobbs, White, Nelson, Kline, and Harper

Concerning low-income and homeless housing assistance surcharges.

Increases the surcharge for local homeless housing and assistance.

Requires certain local governments to establish and implement a process for promoting the availability of rental properties in buildings with fewer than fifty units. This requirement expires June 30, 2017.

Provides contingent effective dates.
