HB 2150-S by House Committee on Ways & Means (originally sponsored by Representatives Pettigrew, Hunter, and Kenney; by request of Department of Social and Health Services)

Generating revenue from community residential service businesses.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Imposes taxes on community residential service businesses.

Requires the joint legislative audit and review committee, in consultation with the department of social and health services and the department of revenue, to conduct a review of the taxes imposed on community residential service businesses.

Creates the developmental disabilities community residential investment account.

Provides a contingent expiration date.

Addressing the use and governance of hearing examiners. (DIGEST OF PROPOSED 1ST SUBSTITUTE)

Directs certain cities to consider assigning certain quasijudicial permit applications and appeals of administrative decisions to professional hearing examiners.

Authorizes electric utilities to: (1) Establish an energy efficiency improvement loan fund;

(2) Receive voluntary contributions from customers that must be deposited into the fund; and

(3) Provide loans to customers for financing the acquisition and installation of energy efficiency improvements.

Supporting the development of aviation biofuels production.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Supports the development of commercial-scale aviation biofuels production facilities in the state by facilitating and streamlining the permitting process for new facilities and the expansion of existing facilities and providing access to low-cost financing through the issuance of revenue bonds.

Requires the housing finance commission to: (1) Issue bonds for financing project costs of facilities;

- (2) Make or purchase loans for financing the facilities; or
- (3) Enter into financing documents relating to the repayment of those loans or the provision of, or security for, debt service on the bonds.

Requires Innovate Washington to convene a sustainable aviation biofuels work group.

Terminates the work group on June 30, 2015.

Creates the school employees' insurance account, the school employees' insurance administrative account, the school employees' benefits board medical benefits

administration account, and the self-insured dental plan benefits administration account.

Declares an intent to provide a choice of United States constitutional currency of gold and silver.

- (2) Develop and maintain a database to measure recidivism rates specific to the sentence for treatment program.

SB 5575-S by Senate Committee on Agriculture, Water & Rural Economic Development (originally sponsored by Senators Hatfield, Delvin, Eide, Schoesler, Haugen, Shin, Kilmer, Hobbs, Becker, Honeyford, Conway, and Sheldon)

Recognizing certain biomass energy facilities as an eligible renewable resource.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Promotes the generation of renewable energy from biomass in economically distressed communities.

Includes qualified biomass energy in the definition of "eligible renewable resource," for purposes of the energy independence act.

Requires qualifying utilities to use qualified renewable energy credits to meet their annual targets.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Exempts from written estimate requirements for auto repair facilities, vehicles that qualify for a horseless carriage or collector vehicle license plate, or vehicles that are parts cars, street rods, or custom vehicles.

Requires the department of health to: (1) Establish a cancer drug repository program for accepting donated cancer drugs and dispensing the drugs to authorized residents; and

(2) Establish and maintain a participating practitioner or pharmacy registry for the program.

Clarifies and updates the administration of sexual assault grant programs by the department of commerce.

Allows the use of alternative traction devices on tires when required for safety because of snow, ice, or other conditions tending to cause a vehicle to skid.

Creating a sentence for treatment program for juvenile offenders.

Requires the department of social and health services to maintain a medium security forestry camp at the Naselle youth camp to fulfill the department's obligation to provide education, treatment, and job training to juvenile offenders who are assessed as posing more than a minimum risk to public safety in the least restrictive continuum of care.

Concerning resident curators of state properties.

Authorizes a state agency, with statutory authority to lease state-owned properties to private parties, to negotiate a lease at a rate that is less than fair market value in consideration of the lessee's occupancy of the property and agreement to restore, maintain, rehabilitate, or otherwise improve the leased property.

Applies premiums to certain medical assistance populations with incomes over one hundred fifty percent of the federal poverty level.

Requires eligibility renewal every six months, instead of every year, for certain populations.

Provides a contingent effective date.

SB 6527 by Senator Benton

Regulating cellular telephone use by state employees.

Requires the office of the chief information officer to: (1) Contract with a private optimization specialist to develop a strategy to match the state's actual cell phone use with the most cost-effective delivery of those services; and

(2) Assist state agencies in developing an implementing agency-wide cell phone use policies.

Prohibits state agencies from issuing cell phones to state employees, other than elected officials, unless certain conditions are met.

Expands insurance coverage of neurodevelopmental therapies.

Concerning health care services for incarcerated offenders.

Authorizes the department of corrections, under certain circumstances, to act on behalf of an inmate for purposes of applying for medicaid eligibility.

Authorizes the secretary of the department of corrections to enter into contracts with certain parties to provide behavioral health and chemical dependency treatment care to inmates.

SB 6532 by Senators Frockt, Litzow, and Harper

Implementing a voluntary quality rating and improvement system for child care centers and early learning programs.

Finds that a two-year field test of a voluntary quality rating and improvement system, for licensed and certified child care centers and homes and other early learning programs, has prepared the state to begin statewide implementation of the system, to the extent funds are available.
