HB 2787-S by House Committee on Transportation (originally sponsored by Representatives Clibborn, Armstrong, Moeller, Eddy, Lias, Sells, Seaquist, Springer, Hunter, and Maxwell; by request of Department of Transportation)

Concerning permitting for the replacement of certain elements of the state route number 520 Evergreen Point bridge.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Addresses permits and construction for the replacement of the floating bridge and landings of the state route number 520 Evergreen Point bridge on or adjacent to Lake Washington.

Prohibits the department of transportation from engaging in or contracting for construction on state route number 520 between Interstate 5 and the western landing of the floating bridge until the legislature has authorized the imposition of tolls on the Interstate 90 floating bridge and/or other funding sufficient to complete construction of the state route number 520 bridge replacement and HOV program.

Limits the rates paid to providers for medical services
for incarcerated offenders and increases the copay on
medical services.

Authorizes the department of corrections, under certain
circumstances, to act on behalf of an inmate for purposes of
applying for medicaid eligibility.

Authorizes the secretary of the department of
corrections to enter into contracts with certain parties to
provide behavioral health and chemical dependency
treatment care to inmates.

Requires certain providers of hospital services to
contract with the department of corrections for inpatient,
outpatient, and ancillary services if deemed appropriate by
the department.

Increases the fee for a concealed pistol license.

SB 6073-S by Senate Committee on Ways & Means (originally sponsored by Senators Kilmer, Regala, Rolfes, and Carrell)

Concerning sales and use taxes related to the state route number 16 corridor improvements project.

Changes the time, from five years to eleven years, to begin repayment of the sales and use taxes imposed on the state route number 16 corridor improvements project.
