1 On page 2, beginning on line 4, strike all of subsection (4) and
2 insert the following:

3 "NEW SECTION. Sec. 2. (1) The legislature finds that there are
4 department of agriculture fees in addition to those included in this
5 act that would be worthwhile for the work group to review and
6 encourages the department of agriculture to continue to convene the
7 work group as often as it is practical to do so. At a minimum, the
8 department shall convene and facilitate a sub-work group with
9 appropriate stakeholders to review fee categories under the food
10 safety program in order to determine which entities may require
11 additional resources for compliance under the federal food safety
12 modernization act. The sub-work group shall review those currently
13 regulated by the state and those that may require department oversight
14 in the future. The sub-work group shall, consistent with RCW
15 43.01.036, report back to the legislature by December 1 each year
16 until 2018.

17 (2) This section expires on June 30, 2019."

19 Renumber the remaining sections consecutively and correct any
20 internal references accordingly. Correct the title.

22 On page 2, beginning on line 20, after "accompanied by" strike all
23 material through "fee" on line 21 and insert "((a fifty five dollar
24 annual license fee)) an annual license fee. The amount of the annual
25 license fee under this section is one hundred fifty dollars until June
26 30, 2016, and two hundred fifty dollars beginning July 1, 2016"

1 On page 4, beginning on line 32, after "director" strike all
2 material through "assessments." on line 33 and insert "~~((by the~~
3 ~~twentieth day of the succeeding month for the previous month's~~
4 ~~assessments.))~~ according to the following schedule:

5 (a) If the monthly amount of the assessment under this section is
6 twenty dollars or more, all moneys collected under this section shall
7 be paid to the director by the twentieth day of the succeeding month
8 for the previous month's assessment.

9 (b) If the monthly amount of the assessment under this section is
10 less than twenty dollars but the quarterly amount is more than twenty
11 dollars, all moneys collected under this section may, at the
12 discretion of the milk processing plant, be paid to the director by
13 the twentieth day of the first month of the succeeding quarter for the
14 previous quarter's assessments. If the assessment required under this
15 section is not paid by quarter consistent with (b) of this subsection,
16 it shall be paid to the director by the twentieth day of the
17 succeeding month for the previous month's assessment.

18 (c) If the quarterly amount of the assessment under this section
19 is less than twenty dollars, all money collected under this section
20 may be paid to the director by the twentieth of January of the
21 succeeding year for the previous year's assessment. If the assessment
22 required under this section is not paid by year consistent with (c) of
23 this subsection, it shall be paid to the director by the twentieth day
24 of the succeeding month for the previous month's assessment.

27 Renumber the remaining sections consecutively and correct any
28 internal references accordingly.

EFFECT: Revises legislative intent language concerning the continuation of a fee work group. Increases the annual milk processing plant license fee to \$150 for the remainder of the 2013-15 biennium and to \$250 thereafter. Provides milk processing plants the option to pay the milk processing assessment quarterly rather than monthly if the assessment is less than \$20 per month but more than \$20 per quarter and annually rather than monthly if the

assessment is less than \$20 per quarter.
