EFFECT: Eliminates the medical marijuana registry and the requirement that health care professionals register qualifying patients and designated providers. Eliminates the Department of Health's responsibilities related to the medical marijuana registry and the issuance of authorization cards. Restores the requirement that

qualifying patients receive valid documentation to obtain protection from arrest and prosecution. Requires that to become a qualifying patient or a designated provider that a health care professional have issued valid documentation to the individual. Requires qualifying patients and designated providers to use valid documentation to purchase marijuana, marijuana-infused products, and marijuana concentrates at marijuana retailers. Specifies that valid documentation expires one year from the date of its issuance and may only be renewed upon reexamination of the qualifying patient.
