1 On page 30, after line 12, insert the following:

2 "NEW SECTION. **Sec. 17.** A new section is added to chapter 46.20
3 RCW to read as follows:

4 (1) Beginning January 1, 2014, any person obtaining or renewing his
5 or her driver's license, driver's instruction permit, agricultural
6 driving permit, identicard, intermediate license, or commercial
7 driver's license shall show proof of his or her United States
8 citizenship or his or her lawful presence within the United States. An
9 original or renewal application must not be granted to any person who
10 does not provide verified proof of his or her United States citizenship
11 or his or her lawful presence within the United States. A person who
12 is a citizen or national of the United States, or who is a legal
13 permanent resident alien, must not be required to provide proof under
14 this subsection, so long as the department has a record of the person's
15 status in compliance with subsection (4) of this section.

16 (2) A person may prove his or her citizenship by providing a valid,
17 unexpired United States passport or passport card, a certified copy of
18 a birth certificate, a consular report of birth abroad issued by the
19 United States department of state, a certificate of naturalization
20 issued by the department of homeland security, or a certificate of
21 citizenship.

22 (3) A person may prove his or her lawful presence within the United
23 States by providing documentation that he or she is an alien:

24 (a) Lawfully admitted for permanent or temporary residence in the
25 United States;

26 (b) With conditional permanent resident status in the United
27 States;

28 (c) Who has an approved application for asylum in the United States
29 or has entered into the United States in refugee status;

30 (d) Who has a valid nonimmigrant status in the United States;

- 1 (e) Who has a pending application for asylum in the United States;
2 (f) Who has a pending or approved application for temporary
3 protected status in the United States;
4 (g) Who has approved deferred action status; or
5 (h) Who has a pending application for lawful permanent residence or
6 conditional permanent resident status.

7 (4) The department shall maintain records of an applicant's status
8 as a United States citizen or as a noncitizen, including the type of
9 document provided and the expiration of the applicant's authorization
10 to lawfully be within the United States. The department shall make
11 such records available to the secretary of state and state and local
12 criminal justice agencies.

13 (5) The department shall verify the status of an applicant through
14 either the systematic alien verification for entitlements program or
15 through verification of the applicant's social security number with the
16 United States social security administration."

17 Renumber the remaining section consecutively and correct any
18 internal references accordingly.

19 On page 30, after line 14, insert the following:

20 "NEW SECTION. **Sec. 18.** Section 17 of this act takes effect
21 January 1, 2014."

22 On page 1, line 1 of the title, after "Relating to" strike the
23 remainder of the title and insert "the requirements for the operation
24 of general motor vehicles and commercial vehicles in compliance with
25 federal regulations; amending RCW 46.01.130, 46.25.010, 46.25.010,
26 46.25.050, 46.25.060, 46.25.070, 46.25.075, 46.25.080, 46.25.100,
27 46.25.130, 46.25.160, 46.61.667, and 46.61.668; adding new sections to

1 chapter 46.25 RCW; adding a new section to chapter 46.20 RCW; and
2 providing effective dates."

EFFECT: Requires applicants for a state-issued driver's license or related identification documents to submit proof of legal presence.
