1 AN ACT Relating to eosinophilia gastrointestinal associated  
2 disorders; and amending RCW 48.20.520, 48.21.300, 48.44.440, and  
3 48.46.510.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 48.20.520 and 1988 c 173 s 1 are each amended to read

4 (2) Such formulas shall be covered when deemed medically necessary  
5 by the medical director or his or her designee of the health  
6 maintenance organization and if provided by the health maintenance  
7 organization or upon the health maintenance organization's referral.  
8 Formulas shall be covered at the usual and customary rates for such  
9 formulas, subject to contract provisions with respect to deductible  
10 amounts or co-payments.
