- 5 Sec. 1. RCW 66.08.190 and 2012 2nd sp.s. c 5 s 8 are each amended to read as follows:
 - (1) Prior to making distribution((\pm)) described in subsection ((\pm)) (3) of this section, ((\pm)) sufficient moneys must be retained to ((\pm)) fund the allotments under RCW 43.88.110 from any legislative appropriation for ((\pm)) city research and services. The legislative appropriation for such services ((\pm)) may not be less than the amount required under RCW 66.24.065.
