**SUBSTITUTE HOUSE BILL 2432**

---

1           AN ACT Relating to enacting planning measures and strategies that  
2 provide for future long-term service and support needs of people with  
3 intellectual and developmental disabilities in Washington state; and  
4 creating new sections.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6           NEW SECTION. **Sec. 1.** The legislature makes the following findings  
7 based on the July 31, 2013, state auditor's report:

8           (1) Over twenty thousand five hundred individuals with  
9 developmental disabilities receive services from the state, while an  
10 additional fifteen thousand who meet financial and physical eligibility  
11 requirements do not currently receive any services from the state (no  
12 paid services caseload);

13           (2) Families are the major care provider of their family member  
14 with a developmental disability;

15           (3) Washington has a complex, severely underfunded service system;

16           (4) Washington serves fewer people who have a developmental  
17 disability than the national average and is ranked thirty-eighth in the  
18 nation for the state fiscal effort for funding of developmental  
19 disabilities services;

1 (5) The majority of people who have the highest activities of daily  
2 living, behavioral, and medical needs live at home with their family;

3 (6) Washington spends less per person on home and community-based  
4 waivers than the national average;

5 (7) Washington needs to expand its community capacity for respite,  
6 crisis stabilization, and peer support networks.

7 NEW SECTION. **Sec. 2.** By January 1, 2015, the developmental  
8 disabilities administration of the department of social and health  
9 services shall identify stakeholders to participate in work groups, at  
10 their own expense, to complete the following and report to the  
11 appropriate committees of the legislature on issues raised in the July  
12 31, 2013, state auditor's report which includes:

13 (1) Providing various community funding scenarios to phase in  
14 serving the fifteen thousand people on the no paid services waitlist  
15 caseload;

16 (2) Developing strategies to expand data gathered during the  
17 initial developmental disabilities application process to improve  
18 waitlist management;

19 (3) Identifying ways to streamline the eligibility and assessment  
20 processes that ensure fairness for services provided by the  
21 developmental disabilities administration;

22 (4) Providing different options that address the need for more  
23 community crisis and respite support for individuals and families;

24 (5) Identifying the resources and models needed to expand community  
25 peer support networks so that they can provide greater support to  
26 people receiving limited services or waiting for services;

27 (6) Reviewing how other states use shared support hours for  
28 community living;

29 (7) Identifying additional community residential options;

30 (8) Identifying strategies to increase employment hours and wages  
31 for individuals employed;

32 (9) Reviewing current community access rules and identifying ways  
33 to increase hours of service;

34 (10) Developing strategies to address retaining an adequate  
35 workforce;

36 (11) Identifying ways to streamline the developmental disabilities  
37 system to make it easier and more accessible to navigate;

1 (12) Identifying mechanisms for improved contract monitoring and  
2 quality assurance;

3 (13) Researching and analyzing moving the developmental  
4 disabilities system to a managed care approach and to more self-  
5 direction;

6 (14) Identifying the various medicaid waiver and state plan options  
7 that could make better use of state funds while making the service  
8 delivery system more accessible to people in need of the services.

9 NEW SECTION. **Sec. 3.** The department of social and health services  
10 shall plan, develop, and implement a medicaid program to replace the  
11 individual and family services program for medicaid-eligible clients no  
12 later than May 1, 2016. The new medicaid program must offer services  
13 that closely resemble the services offered in fiscal year 2014 through  
14 the individual and family services program.
