1 AN ACT Relating to the operation of wheeled all-terrain vehicles in
2 recreation areas for persons with disabilities; amending RCW 46.19.030
3 and 46.63.020; adding a new section to chapter 46.09 RCW; prescribing
4 penalties; and providing an effective date.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** A new section is added to chapter 46.09 RCW
7 to read as follows:

8 (1) The department must issue, and design, an Americans with
9 disabilities act parking sticker for placement on a wheeled all-terrain
10 vehicle, authorizing access to recreation areas that are difficult to
11 access by persons with disabilities, to an applicant that meets the
12 following requirements:

13 (a) The applicant's disability must be determined by a person
14 listed under RCW 46.19.010(2) and recorded on a certification document
15 designed and administered by the department, establishing that the
16 applicant meets one of the following criteria:

17 (i) Loss of one or both legs or feet;

18 (ii) Inability to walk more than two hundred feet without having to
19 stop and rest;

1 (iii) Inability to walk due to severe disability where a person
2 cannot walk without the use of or assistance from a brace, crutches,
3 walker, cane, prosthetic device, wheel chair, other assistive device,
4 or another person;

5 (iv) Lung disease from which the person's expiratory volume for one
6 second is less than one liter when measured by spirometry or from which
7 the person's arterial oxygen is less than 60 mm/hg of room air at rest;

8 (v) Severely limited in ability to walk due to arthritic,
9 neurological, or orthopedic condition;

10 (vi) Uses portable oxygen;

11 (vii) Cardiovascular disease from which the person's functional
12 limitations are classified as class III or IV under standards adopted
13 by the American heart association;

14 (viii) Cardiovascular disease from which a marked limitation of
15 physical activity causes fatigue, palpitation, dyspnea, or anginal
16 pain; or

17 (ix) Other disease or disorder including, but not limited to,
18 severe arthritis or neurological orthopedic impairment that creates a
19 severe mobility limitation; and

20 (b) The wheeled all-terrain vehicle meets all registration
21 requirements under this chapter.

22 (2)(a) The Americans with disabilities act parking sticker must be
23 placed on the rear of the wheeled all-terrain vehicle.

24 (b) The Americans with disabilities act parking sticker must be
25 renewed every three years at the time of annual registration renewal
26 for the wheeled all-terrain vehicle. If the person's disability is
27 temporary, the sticker expires on the date submitted for recovery by
28 the physician as listed on the certification document.

29 (c) The department may by rule establish a fee to cover the cost of
30 designing, producing, and administering the Americans with disabilities
31 act parking sticker.

32 (3) A person must carry either a Washington state driver's license
33 or identicard when operating a wheeled all-terrain vehicle with an
34 Americans with disabilities act parking sticker.

35 (4) The privileges granted under this section may extend to one
36 companion of the operator of a wheeled all-terrain vehicle with an
37 Americans with disabilities act parking sticker serving as operator or
38 passenger of the vehicle if the vehicle is designed for passenger use.

1 (5) The submittal of fraudulent physician certification documents
2 submitted to the department to obtain an Americans with disabilities
3 act parking sticker is a gross misdemeanor.

4 (6) The department may adopt rules to implement and administer this
5 section.

6 **Sec. 2.** RCW 46.19.030 and 2010 c 161 s 704 are each amended to
7 read as follows:

8 (1) The department shall design special license plates for persons
9 with disabilities, parking placards, and year tabs displaying the
10 international symbol of access.

11 (2) Special license plates for persons with disabilities must be
12 displayed on the motor vehicle as standard issue license plates as
13 described in RCW 46.16A.200.

14 (3) Parking placards must be displayed when the motor vehicle is
15 parked by suspending it from the rearview mirror. In the absence of a
16 rearview mirror, the parking placard must be displayed on the
17 dashboard.

18 (4) Special year tabs for persons with disabilities must be
19 displayed on license plates as defined by the department.

20 (5)(a) Persons who have been issued special license plates for
21 persons with disabilities, parking placards, or special license plates
22 with a special year tab for persons with disabilities may park in
23 places reserved for persons with physical disabilities.

24 (b) Persons who possess an Americans with disabilities act parking
25 sticker as issued under section 1 of this act on his or her wheeled
26 all-terrain vehicle may park the wheeled all-terrain vehicle in places
27 reserved for persons with physical disabilities.

28 **Sec. 3.** RCW 46.63.020 and 2013 2nd sp.s. c 23 s 21 are each
29 amended to read as follows:

30 Failure to perform any act required or the performance of any act
