13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

14 **Sec. 1.** RCW 2.48.210 and 1921 c 126 s 12 are each amended to read
15 as follows:

16 Every person before being admitted to practice law in this state
17 shall take and subscribe the following oath:

18 I do solemnly swear:

19 I am a citizen of the United States and owe my allegiance thereto;

20 I will support the Constitution of the United States and the
21 Constitution of the state of Washington;

22 I will maintain the respect due to courts of justice and judicial
23 officers;

24 I will not counsel or maintain any suit or proceeding which shall
25 appear to me to be unjust, nor any defense except such as I believe to
26 be honestly debatable under the law of the land, unless it be in
27 defense of a person charged with a public offense; I will employ for
28 the purpose of maintaining the causes confided to me such means only as
29 are consistent with truth and honor, and will never seek to mislead the
30 judge or jury by any artifice or false statement of fact or law;

31 I will maintain the confidence and preserve inviolate the secrets
32 of my client, and will accept no compensation in connection with his or
33 her business except from him or her or with his or her knowledge and
34 approval;

35 I will abstain from all offensive personality, and advance no fact

1 prejudicial to the honor or reputation of a party or witness, unless
2 required by the justice of the cause with which I am charged;

3 I will never reject, from any consideration personal to myself, the
4 cause of the defenseless or oppressed, or delay any (~~man's~~) person's
5 cause for lucre or malice. So help me God.

6 **Sec. 2.** RCW 6.13.080 and 2008 c 6 s 635 are each amended to read
7 as follows:

8 The homestead exemption is not available against an execution or
9 forced sale in satisfaction of judgments obtained:

10 (1) On debts secured by mechanic's, laborer's, construction,
11 maritime, automobile repair, (~~materialmen's~~) material supplier's, or
12 vendor's liens arising out of and against the particular property
13 claimed as a homestead;

14 (2) On debts secured (a) by security agreements describing as
15 collateral the property that is claimed as a homestead or (b) by
16 mortgages or deeds of trust on the premises that have been executed and
17 acknowledged by both spouses or both domestic partners or by any
18 claimant not married or in a state registered domestic partnership;

19 (3) On one spouse's or one domestic partner's or the community's
20 debts existing at the time of that spouse's or that domestic partner's
21 bankruptcy filing where (a) bankruptcy is filed by both spouses or both
22 domestic partners within a six-month period, other than in a joint case
23 or a case in which their assets are jointly administered, and (b) the
24 other spouse or other domestic partner exempts property from property
25 of the estate under the bankruptcy exemption provisions of 11 U.S.C.
26 Sec. 522(d);

27 (4) On debts arising from a lawful court order or decree or
28 administrative order establishing a child support obligation or
29 obligation to pay maintenance;

30 (5) On debts owing to the state of Washington for recovery of
31 medical assistance correctly paid on behalf of an individual consistent
32 with 42 U.S.C. Sec. 1396p;

33 (6) On debts secured by a condominium's or homeowner association's
34 lien. In order for an association to be exempt under this provision,
35 the association must have provided a homeowner with notice that
36 nonpayment of the association's assessment may result in foreclosure of
37 the association lien and that the homestead protection under this

1 chapter shall not apply. An association has complied with this notice
2 requirement by mailing the notice, by first-class mail, to the address
3 of the owner's lot or unit. The notice required in this subsection
4 shall be given within thirty days from the date the association learns
5 of a new owner, but in all cases the notice must be given prior to the
6 initiation of a foreclosure. The phrase "learns of a new owner" in
7 this subsection means actual knowledge of the identity of a homeowner
8 acquiring title after June 9, 1988, and does not require that an
9 association affirmatively ascertain the identity of a homeowner.
10 Failure to give the notice specified in this subsection affects an
11 association's lien only for debts accrued up to the time an association
12 complies with the notice provisions under this subsection; or

13 (7) On debts owed for taxes collected under chapters 82.08, 82.12,
14 and 82.14 RCW but not remitted to the department of revenue.

15 **Sec. 3.** RCW 8.16.090 and 1909 p 374 s 9 are each amended to read
16 as follows:

17 When ten of the jurors agree upon a verdict, the verdict so agreed
18 upon shall be signed by the ((foreman)) jury foreperson, and the
19 verdict so agreed upon shall be and stand as the verdict of the jury.

20 **Sec. 4.** RCW 9.91.020 and 2000 c 239 s 3 are each amended to read
21 as follows:

22 Every person who, being employed upon any railway, as engineer,
23 ((motorman)) motor operator, ((gripman)) grip operator, conductor,
24 switch tender, ((fireman)) fire tender, bridge tender, flagger, or
25 ((signalman)) signal operator, or having charge of stations, starting,
26 regulating, or running trains upon a railway, or being employed as
27 captain, engineer, or other officer of a vessel propelled by steam, or
28 being the driver of any animal or vehicle upon any public highway,
29 street, or other public place, is intoxicated while engaged in the
30 discharge of any such duties, shall be guilty of a gross misdemeanor.

31 **Sec. 5.** RCW 13.34.105 and 2011 c 309 s 26 are each amended to read
32 as follows:

33 (1) Unless otherwise directed by the court, the duties of the
34 guardian ad litem for a child subject to a proceeding under this

1 chapter, including an attorney specifically appointed by the court to
2 serve as a guardian ad litem, include but are not limited to the
3 following:

4 (a) To investigate, collect relevant information about the child's
5 situation, and report to the court factual information regarding the
6 best interests of the child;

7 (b) To meet with, interview, or observe the child, depending on the
8 child's age and developmental status, and report to the court any views
9 or positions expressed by the child on issues pending before the court;

10 (c) To monitor all court orders for compliance and to bring to the
11 court's attention any change in circumstances that may require a
12 modification of the court's order;

13 (d) To report to the court information on the legal status of a
14 child's membership in any Indian tribe or band;

15 (e) Court-appointed special advocates and guardians ad litem may
16 make recommendations based upon an independent investigation regarding
17 the best interests of the child, which the court may consider and weigh
18 in conjunction with the recommendations of all of the parties;

19 (f) To represent and be an advocate for the best interests of the
20 child;

21 (g) To inform the child, if the child is twelve years old or older,
22 of his or her right to request counsel and to ask the child whether he
23 or she wishes to have counsel, pursuant to RCW 13.34.100(6). The
24 guardian ad litem shall report to the court that the child was notified
25 of this right and indicate the child's position regarding appointment
26 of counsel. The guardian ad litem shall report to the court his or her
27 independent recommendation as to whether appointment of counsel is in
28 the best interest of the child; and

29 (h) In the case of an Indian child as defined in RCW 13.38.040,
30 know, understand, and advocate the best interests of the Indian child.

31 (2) A guardian ad litem shall be deemed an officer of the court for
32 the purpose of immunity from civil liability.

33 (3) Except for information or records specified in RCW
34 13.50.100(7), the guardian ad litem shall have access to all
35 information available to the state or agency on the case. Upon
36 presentation of the order of appointment by the guardian ad litem, any
37 agency, hospital, school organization, division or department of the
38 state, doctor, nurse, or other health care provider, psychologist,

1 psychiatrist, police department, or mental health clinic shall permit
2 the guardian ad litem to inspect and copy any records relating to the
3 child or children involved in the case, without the consent of the
4 parent or guardian of the child, or of the child if the child is under
5 the age of thirteen years, unless such access is otherwise specifically
6 prohibited by law.

7 (4) A guardian ad litem may release confidential information,
8 records, and reports to the office of the family and children's
9 (~~ombudsman~~) ombuds for the purposes of carrying out its duties under
10 chapter 43.06A RCW.

11 (5) The guardian ad litem shall release case information in
12 accordance with the provisions of RCW 13.50.100.

13 **Sec. 6.** RCW 13.50.010 and 2011 1st sp.s. c 40 s 30 are each
14 amended to read as follows:

15 (1) For purposes of this chapter:

16 (a) "Juvenile justice or care agency" means any of the following:
17 Police, diversion units, court, prosecuting attorney, defense attorney,
18 detention center, attorney general, the legislative children's
19 oversight committee, the office of the family and children's
20 (~~ombudsman~~) ombuds, the department of social and health services and
21 its contracting agencies, schools; persons or public or private
22 agencies having children committed to their custody; and any placement
23 oversight committee created under RCW 72.05.415;

24 (b) "Official juvenile court file" means the legal file of the
25 juvenile court containing the petition or information, motions,
26 memorandums, briefs, findings of the court, and court orders;

27 (c) "Records" means the official juvenile court file, the social
28 file, and records of any other juvenile justice or care agency in the
29 case;

30 (d) "Social file" means the juvenile court file containing the
31 records and reports of the probation counselor.

32 (2) Each petition or information filed with the court may include
33 only one juvenile and each petition or information shall be filed under
34 a separate docket number. The social file shall be filed separately
35 from the official juvenile court file.

36 (3) It is the duty of any juvenile justice or care agency to
37 maintain accurate records. To this end:

1 (a) The agency may never knowingly record inaccurate information.
2 Any information in records maintained by the department of social and
3 health services relating to a petition filed pursuant to chapter 13.34
4 RCW that is found by the court to be false or inaccurate shall be
5 corrected or expunged from such records by the agency;

6 (b) An agency shall take reasonable steps to assure the security of
7 its records and prevent tampering with them; and

8 (c) An agency shall make reasonable efforts to insure the
9 completeness of its records, including action taken by other agencies
10 with respect to matters in its files.

11 (4) Each juvenile justice or care agency shall implement procedures
12 consistent with the provisions of this chapter to facilitate inquiries
13 concerning records.

14 (5) Any person who has reasonable cause to believe information
15 concerning that person is included in the records of a juvenile justice
16 or care agency and who has been denied access to those records by the
17 agency may make a motion to the court for an order authorizing that
18 person to inspect the juvenile justice or care agency record concerning
19 that person. The court shall grant the motion to examine records
20 unless it finds that in the interests of justice or in the best
21 interests of the juvenile the records or parts of them should remain
22 confidential.

23 (6) A juvenile, or his or her parents, or any person who has
24 reasonable cause to believe information concerning that person is
25 included in the records of a juvenile justice or care agency may make
26 a motion to the court challenging the accuracy of any information
27 concerning the moving party in the record or challenging the continued
28 possession of the record by the agency. If the court grants the
29 motion, it shall order the record or information to be corrected or
30 destroyed.

31 (7) The person making a motion under subsection (5) or (6) of this
32 section shall give reasonable notice of the motion to all parties to
33 the original action and to any agency whose records will be affected by
34 the motion.

35 (8) The court may permit inspection of records by, or release of
36 information to, any clinic, hospital, or agency which has the subject
37 person under care or treatment. The court may also permit inspection
38 by or release to individuals or agencies, including juvenile justice

1 advisory committees of county law and justice councils, engaged in
2 legitimate research for educational, scientific, or public purposes.
3 The court shall release to the caseload forecast council records needed
4 for its research and data-gathering functions. Access to records or
5 information for research purposes shall be permitted only if the
6 anonymity of all persons mentioned in the records or information will
7 be preserved. Each person granted permission to inspect juvenile
8 justice or care agency records for research purposes shall present a
9 notarized statement to the court stating that the names of juveniles
10 and parents will remain confidential.

11 (9) Juvenile detention facilities shall release records to the
12 caseload forecast council upon request. The commission shall not
13 disclose the names of any juveniles or parents mentioned in the records
14 without the named individual's written permission.

15 (10) Requirements in this chapter relating to the court's authority
16 to compel disclosure shall not apply to the legislative children's
17 oversight committee or the office of the family and children's
18 (~~ombudsman~~) ombuds.

19 (11) For the purpose of research only, the administrative office of
20 the courts shall maintain an electronic research copy of all records in
21 the judicial information system related to juveniles. Access to the
22 research copy is restricted to the Washington state center for court
23 research. The Washington state center for court research shall
24 maintain the confidentiality of all confidential records and shall
25 preserve the anonymity of all persons identified in the research copy.
26 The research copy may not be subject to any records retention schedule
27 and must include records destroyed or removed from the judicial
28 information system pursuant to RCW 13.50.050 (17) and (18) and
29 13.50.100(3).

30 (12) The court shall release to the Washington state office of
31 public defense records needed to implement the agency's oversight,
32 technical assistance, and other functions as required by RCW 2.70.020.
33 Access to the records used as a basis for oversight, technical
34 assistance, or other agency functions is restricted to the Washington
35 state office of public defense. The Washington state office of public
36 defense shall maintain the confidentiality of all confidential
37 information included in the records.

1 **Sec. 7.** RCW 13.50.100 and 2003 c 105 s 2 are each amended to read
2 as follows:

3 (1) This section governs records not covered by RCW 13.50.050.

4 (2) Records covered by this section shall be confidential and shall
5 be released only pursuant to this section and RCW 13.50.010.

6 (3) Records retained or produced by any juvenile justice or care
7 agency may be released to other participants in the juvenile justice or
8 care system only when an investigation or case involving the juvenile

11 juvenile. Records covered under this section and maintained by the
12 juvenile courts which relate to the official actions of the agency may
13 be entered in the statewide judicial information system. However,
14 truancy records associated with a juvenile who has no other case
15 history, and records of a juvenile's parents who have no other case
16 history, shall be removed from the judicial information system when the
17 juvenile is no longer subject to the compulsory attendance laws in
18 chapter 28A.225 RCW. A county clerk is not liable for unauthorized
19 release of this data by persons or agencies not in his or her employ or
20 otherwise subject to his or her control, nor is the county clerk liable
21 for inaccurate or incomplete information collected from litigants or
22 other persons required to provide identifying data pursuant to this
23 section.

24 (4) Subject to (a) of this subsection, the department of social and
25 health services may release information retained in the course of
26 conducting child protective services investigations to a family or
27 juvenile court hearing a petition for custody under chapter 26.10 RCW.

28 (a) Information that may be released shall be limited to
29 information regarding investigations in which: (i) The juvenile was an
30 alleged victim of abandonment or abuse or neglect; or (ii) the
31 petitioner for custody of the juvenile, or any individual aged sixteen
32 or older residing in the petitioner's household, is the subject of a
33 founded or currently pending child protective services investigation
34 made by the department subsequent to October 1, 1998.

35 (b) Additional information may only be released with the written
36 consent of the subject of the investigation and the juvenile alleged to
37 be the victim of abandonment or abuse and neglect, or the parent,

1 custodian, guardian, or personal representative of the juvenile, or by
2 court order obtained with notice to all interested parties.

3 (5) Any disclosure of records or information by the department of
4 social and health services pursuant to this section shall not be deemed
5 a waiver of any confidentiality or privilege attached to the records or
6 information by operation of any state or federal statute or regulation,
7 and any recipient of such records or information shall maintain it in
8 such a manner as to comply with such state and federal statutes and
9 regulations and to protect against unauthorized disclosure.

10 (6) A contracting agency or service provider of the department of
11 social and health services that provides counseling, psychological,
12 psychiatric, or medical services may release to the office of the
13 family and children's (~~ombudsman~~) ombuds information or records
14 relating to services provided to a juvenile who is dependent under
15 chapter 13.34 RCW without the consent of the parent or guardian of the
16 juvenile, or of the juvenile if the juvenile is under the age of
17 thirteen years, unless such release is otherwise specifically
18 prohibited by law.

19 (7) A juvenile, his or her parents, the juvenile's attorney, and
20 the juvenile's parent's attorney, shall, upon request, be given access
21 to all records and information collected or retained by a juvenile
22 justice or care agency which pertain to the juvenile except:

23 (a) If it is determined by the agency that release of this
24 information is likely to cause severe psychological or physical harm to
25 the juvenile or his or her parents the agency may withhold the
26 information subject to other order of the court: PROVIDED, That if the
27 court determines that limited release of the information is
28 appropriate, the court may specify terms and conditions for the release
29 of the information; or

30 (b) If the information or record has been obtained by a juvenile
31 justice or care agency in connection with the provision of counseling,
32 psychological, psychiatric, or medical services to the juvenile, when
33 the services have been sought voluntarily by the juvenile, and the
34 juvenile has a legal right to receive those services without the
35 consent of any person or agency, then the information or record may not
36 be disclosed to the juvenile's parents without the informed consent of
37 the juvenile unless otherwise authorized by law; or

1 (c) That the department of social and health services may delete
2 the name and identifying information regarding persons or organizations
3 who have reported alleged child abuse or neglect.

4 (8) A juvenile or his or her parent denied access to any records
5 following an agency determination under subsection (7) of this section
6 may file a motion in juvenile court requesting access to the records.
7 The court shall grant the motion unless it finds access may not be
8 permitted according to the standards found in subsection (7)(a) and (b)
9 of this section.

10 (9) The person making a motion under subsection (8) of this section
11 shall give reasonable notice of the motion to all parties to the
12 original action and to any agency whose records will be affected by the
13 motion.

14 (10) Subject to the rules of discovery in civil cases, any party to
15 a proceeding seeking a declaration of dependency or a termination of
16 the parent-child relationship and any party's counsel and the guardian
17 ad litem of any party, shall have access to the records of any natural
18 or adoptive child of the parent, subject to the limitations in
19 subsection (7) of this section. A party denied access to records may
20 request judicial review of the denial. If the party prevails, he or
21 she shall be awarded attorneys' fees, costs, and an amount not less
22 than five dollars and not more than one hundred dollars for each day
23 the records were wrongfully denied.

24 (11) No unfounded allegation of child abuse or neglect as defined
25 in RCW 26.44.020(~~(+12+)~~) (1) may be disclosed to a child-placing
26 agency, private adoption agency, or any other licensed provider.

30 disclosed by the office of the attorney general or the department of

1 (1) The department shall establish and maintain a toll-free
2 telephone number for receiving complaints regarding a facility that the
3 department licenses.

4 (2) All facilities that are licensed under this chapter shall post
5 in a place and manner clearly visible to residents and visitors the
6 department's toll-free complaint telephone number and the toll-free
7 number and program description of the long-term care ((ombudsman))

35 representative pursuant to law; or persistently delaying responses to
36 a resident's request for service or assistance. A facility licensed
37 under this chapter shall not willfully interfere with the performance

1 of official duties by a long-term care (~~ombudsman~~) ombuds. The
2 department shall sanction and may impose a civil penalty of not more
3 than three thousand dollars for a violation of this subsection.

35 (3) When the department appoints a temporary manager, the
36 department shall enter into a contract with the temporary manager and
37 shall order the licensee to cease operating the assisted living
38 facility and immediately turn over to the temporary manager possession

1 and control of the assisted living facility, including but not limited
2 to all resident care records, financial records, and other records
3 necessary for operation of the facility while temporary management is
4 in effect. If the department has not appointed a temporary manager and
5 the licensee elects to participate in the temporary management program,
6 the licensee shall select the temporary manager, subject to the
7 department's approval, and enter into a contract with the temporary
8 manager, consistent with this section. The department has the
9 discretion to approve or revoke any temporary management arrangements
10 made by the licensee.

11 (4) When the department appoints a temporary manager, the costs
12 associated with the temporary management may be paid for through the
13 assisted living facility temporary management account established by
14 RCW 18.20.430, or from other departmental funds, or a combination
15 thereof. All funds must be administered according to department
16 procedures. The department may enter into an agreement with the
17 licensee allowing the licensee to pay for some of the costs associated
18 with a temporary manager appointed by the department. If the
19 department has not appointed a temporary manager and the licensee
20 elects to participate in the temporary management program, the licensee
21 is responsible for all costs related to administering the temporary
22 management program at the assisted living facility and contracting with
23 the temporary manager.

24 (5) The temporary manager shall assume full responsibility for the
25 daily operations of the assisted living facility and is responsible for
26 correcting cited deficiencies and ensuring that all minimum licensing
27 requirements are met. The temporary manager must comply with all state
28 and federal laws and regulations applicable to assisted living
29 facilities. The temporary manager shall protect the health, safety,
30 and welfare of the residents for the duration of the temporary
31 management and shall perform all acts reasonably necessary to ensure
32 residents' needs are met. The temporary management contract shall
33 address the responsibility of the temporary manager to pay past due
34 debts. The temporary manager's specific responsibilities may include,
35 but are not limited to:

36 (a) Receiving and expending in a prudent and business-like manner
37 all current revenues of the assisted living facility, provided that

1 priority is given to debts and expenditures directly related to
2 providing care and meeting residents' needs;

3 (b) Hiring and managing all consultants and employees and firing
4 them for good cause;

5 (c) Making necessary purchases, repairs, and replacements, provided
6 that such expenditures in excess of five thousand dollars by a
7 temporary manager appointed by the department must be approved by the
8 department;

9 (d) Entering into contracts necessary for the operation of the
10 assisted living facility;

11 (e) Preserving resident trust funds and resident records; and

12 (f) Preparing all department-required reports, including a detailed
13 monthly accounting of all expenditures and liabilities, which shall be
14 sent to the department and the licensee.

15 (6) The licensee and department shall provide written notification
16 immediately to all residents, resident representatives, interested
17 family members, and the state long-term care (~~ombudsman~~) ombuds
18 program of the temporary management and the reasons for it. This
19 notification shall include notice that residents may move from the
20 assisted living facility without notifying the licensee or temporary
21 manager in advance, and without incurring any charges, fees, or costs
22 otherwise available for insufficient advance notice, during the
23 temporary management period. The notification shall also inform
24 residents and their families or representatives that the temporary
25 management team will provide residents help with relocation and
26 appropriate discharge planning and coordination if desired. The
27 department shall provide assistance with relocation to residents who
28 are department clients and may provide such assistance to other
29 residents. The temporary manager shall meet regularly with staff,
30 residents, residents' representatives, and families to inform them of
31 the plans for and progress achieved in the correction of deficiencies,
32 and of the plans for facility closure or continued operation.

33 (7) The department shall terminate temporary management:

34 (a) After sixty days unless good cause is shown to continue the
35 temporary management. Good cause for continuing the temporary
36 management exists when returning the assisted living facility to its
37 former licensee would subject residents to a threat to health, safety,
38 or welfare;

1 (b) When all residents are transferred and the assisted living
2 facility is closed;

3 (c) When deficiencies threatening residents' health, safety, or

21 work or operations being considered as of a casual, minor, or
22 inconsequential nature. The exemption prescribed in this subsection
23 does not apply in any instance wherein the work or construction is only
24 a part of a larger or major operation, whether undertaken by the same
25 or a different contractor, or in which a division of the operation is
26 made into contracts of amounts less than five hundred dollars for the
27 purpose of evasion of this chapter or otherwise. The exemption
28 prescribed in this subsection does not apply to a person who advertises
29 or puts out any sign or card or other device which might indicate to
30 the public that he or she is a contractor, or that he or she is
31 qualified to engage in the business of contractor;

32 (10) Any construction or operation incidental to the construction
33 and repair of irrigation and drainage ditches of regularly constituted
34 irrigation districts or reclamation districts; or to farming, dairying,
35 agriculture, viticulture, horticulture, or stock or poultry raising; or

37 prevention purposes; except when any of the above work is performed by
38 a registered contractor;

1 (11) An owner who contracts for a project with a registered

28 compensation;

29 (16) Contractors on highway projects who have been prequalified as
30 required by RCW 47.28.070, with the department of transportation to
31 perform highway construction, reconstruction, or maintenance work;

32 (17) A mobile/manufactured home dealer or manufacturer who
33 subcontracts the installation, set-up, or repair work to actively
34 registered contractors. This exemption only applies to the
35 installation, set-up, or repair of the mobile/manufactured homes that
36 were manufactured or sold by the mobile/manufactured home dealer or
37 manufacturer;

1 (18) An entity who holds a valid electrical contractor's license
2 under chapter 19.28 RCW that employs a certified (~~journeyman~~) journey
3 level electrician, a certified residential specialty electrician, or an
4 electrical trainee meeting the requirements of chapter 19.28 RCW to
5 perform plumbing work that is incidentally, directly, and immediately
6 appropriate to the like-in-kind replacement of a household appliance or
7 other small household utilization equipment that requires limited
8 electric power and limited waste and/or water connections. An
9 electrical trainee must be supervised by a certified electrician while
10 performing plumbing work.

13 The definitions in this section apply throughout this chapter

13 (2) The term of one ((~~journeyman~~)) journey level plumber expires
14 July 1, 1995; the term of the second ((~~journeyman~~)) journey level
15 plumber expires July 1, 2000; the term of the specialty plumber expires
16 July 1, 2008; the term of one person conducting a plumbing business
17 expires July 1, 1996; the term of the second person conducting a
18 plumbing business expires July 1, 2000; the term of the third person
19 conducting a plumbing business expires July 1, 2007; and the term of
20 the public member expires July 1, 1997. Thereafter, upon the
21 expiration of said terms, the director shall appoint a new member to
22 serve for a period of three years. However, to ensure that the board
23 can continue to act, a member whose term expires shall continue to
24 serve until his or her replacement is appointed. In the case of any
25 vacancy on the board for any reason, the director shall appoint a new
26 member to serve out the term of the person whose position has become

5 journey level electrician and not more than a total of four thousand
6 hours in all specialties under the supervision of a master
7 ((~~journeyman~~)) journey level electrician, ((~~journeyman~~)) journey level
8 electrician, master specialty electrician working in that electrician's
9 specialty, or specialty electrician working in that electrician's
10 specialty. Specialty electricians with less than a four thousand hour
11 work experience requirement cannot credit the time required to obtain
12 that specialty towards qualifying to become a ((~~journeyman~~)) journey
13 level electrician; or

14 (ii) Successfully completed an apprenticeship program approved
15 under chapter 49.04 RCW for the electrical construction trade.

16 (g) To be eligible to take the examination for a specialty
17 electrician certificate of competency, the applicant must have:

18 (i) Worked in the residential (as specified in WAC 296-46B-
19 920(2)(a)), pump and irrigation (as specified in WAC 296-46B-
20 920(2)(b)), sign (as specified in WAC 296-46B-920(2)(d)), limited
21 energy (as specified in WAC 296-46B-920(2)(e)), nonresidential
22 maintenance (as specified in WAC 296-46B-920(2)(g)), or other new
23 nonresidential specialties as determined by the department in rule
24 under the supervision of a master ((~~journeyman~~)) journey level
25 electrician, ((~~journeyman~~)) journey level electrician, master specialty
26 electrician working in that electrician's specialty, or specialty
27 electrician working in that electrician's specialty for a minimum of
28 four thousand hours;

29 (ii) Worked in the appliance repair specialty as determined by the
30 department in rule, restricted nonresidential maintenance as determined
31 by the department in rule, the equipment repair specialty as determined
32 by the department in rule, the pump and irrigation specialty other than
33 as defined by (g)(i) of this subsection or domestic pump specialty as
34 determined by the department in rule, or a specialty other than the
35 designated specialties in (g)(i) of this subsection for a minimum of
36 the initial ninety days, or longer if set by rule by the department.

27 services before services are initiated that informs the parents of
28 their rights under family assessment response, all of their options,
29 and the options the department has if the parents do not sign the
30 consent form.

31 (14) In conducting an investigation or family assessment of alleged
32 abuse or neglect, the department or law enforcement agency:

33 (a) May interview children. If the department determines that the
34 response to the allegation will be family assessment response, the
35 preferred practice is to request a parent's, guardian's, or custodian's
36 permission to interview the child before conducting the child interview
37 unless doing so would compromise the safety of the child or the
38 integrity of the assessment. The interviews may be conducted on school

1 premises, at day-care facilities, at the child's home, or at other
2 suitable locations outside of the presence of parents. If the
3 allegation is investigated, parental notification of the interview must
4 occur at the earliest possible point in the investigation that will not
5 jeopardize the safety or protection of the child or the course of the
6 investigation. Prior to commencing the interview the department or law
7 enforcement agency shall determine whether the child wishes a third
8 party to be present for the interview and, if so, shall make reasonable
9 efforts to accommodate the child's wishes. Unless the child objects,
10 the department or law enforcement agency shall make reasonable efforts
11 to include a third party in any interview so long as the presence of
12 the third party will not jeopardize the course of the investigation;
13 and

14 (b) Shall have access to all relevant records of the child in the
15 possession of mandated reporters and their employees.

16 (15) If a report of alleged abuse or neglect is founded and
17 constitutes the third founded report received by the department within
18 the last twelve months involving the same child or family, the
19 department shall promptly notify the office of the family and
20 children's ((ombudsman)) ombuds of the contents of the report. The
21 department shall also notify the ((ombudsman)) ombuds of the
22 disposition of the report.

23 (16) In investigating and responding to allegations of child abuse
24 and neglect, the department may conduct background checks as authorized
25 by state and federal law.

26 (17)(a) The department shall maintain investigation records and
27 conduct timely and periodic reviews of all founded cases of abuse and
28 neglect. The department shall maintain a log of screened-out
29 nonabusive cases.

30 (b) In the family assessment response, the department shall not
31 make a finding as to whether child abuse or neglect occurred. No one
32 shall be named as a perpetrator and no investigative finding shall be
33 entered in the department's child abuse or neglect database.

34 (18) The department shall use a risk assessment process when
35 investigating alleged child abuse and neglect referrals. The
36 department shall present the risk factors at all hearings in which the
37 placement of a dependent child is an issue. Substance abuse must be a
38 risk factor.

1 (19) Upon receipt of a report of alleged abuse or neglect the law
2 enforcement agency may arrange to interview the person making the
3 report and any collateral sources to determine if any malice is
4 involved in the reporting.

5 (20) Upon receiving a report of alleged abuse or neglect involving
6 a child under the court's jurisdiction under chapter 13.34 RCW, the
7 department shall promptly notify the child's guardian ad litem of the
8 report's contents. The department shall also notify the guardian ad
9 litem of the disposition of the report. For purposes of this
10 subsection, "guardian ad litem" has the meaning provided in RCW
11 13.34.030.

12 **Sec. 44.** RCW 26.44.220 and 2005 c 345 s 1 are each amended to read
13 as follows:

14 (1) Within existing resources, the department shall develop a
15 curriculum designed to train staff of the department's children's
16 administration who assess or provide services to adolescents on how to
17 screen and respond to referrals to child protective services when those
18 referrals may involve victims of abuse or neglect between the ages of
19 eleven and eighteen. At a minimum, the curriculum developed pursuant
20 to this section shall include:

21 (a) Review of relevant laws and regulations, including the
22 requirement that the department investigate complaints if a parent's or
23 caretaker's actions result in serious physical or emotional harm or
24 present an imminent risk of serious harm to any person under eighteen;

25 (b) Review of policies of the department's children's
26 administration that require assessment and screening of abuse and
27 neglect referrals on the basis of risk and not age;

28 (c) Explanation of safety assessment and risk assessment models;

29 (d) Case studies of situations in which the department has received
30 reports of alleged abuse or neglect of older children and adolescents;

31 (e) Discussion of best practices in screening and responding to
32 referrals involving older children and adolescents; and

33 (f) Discussion of how abuse and neglect referrals related to
34 adolescents are investigated and when law enforcement must be notified.

35 (2) As it develops its curriculum pursuant to this section, the
36 department shall request that the office of the family and children's
37 (~~ombudsman~~) ombuds review and comment on its proposed training

1 materials. The department shall consider the comments and
2 recommendations of the office of the family and children's
3 ((ombudsman)) ombuds as it develops the curriculum required by this
4 section.

5 (3) The department shall complete the curriculum materials required
6 by this section no later than December 31, 2005.

7 (4) Within existing resources, the department shall incorporate
8 training on the curriculum developed pursuant to this section into
9 existing training for child protective services workers who screen
10 intake calls, children's administration staff responsible for assessing
11 or providing services to older children and adolescents, and all new
12 employees of the children's administration responsible for assessing or
13 providing services to older children and adolescents.

14 **Sec. 45.** RCW 27.53.030 and 2011 c 219 s 1 are each reenacted and
15 amended to read as follows:

16 The definitions in this section apply throughout this chapter
17 unless the context clearly requires otherwise.

18 (1) "Amateur society" means any organization composed primarily of
19 persons who are not professional archaeologists, whose primary interest
20 is in the archaeological resources of the state, and which has been
21 certified in writing by two professional archaeologists.

22 (2) "Archaeological object" means an object that comprises the
23 physical evidence of an indigenous and subsequent culture, including
24 material remains of past human life, including monuments, symbols,

36 (7) "Field investigation" means an on-site inspection by a
37 professional archaeologist or by an individual under the direct

1 supervision of a professional archaeologist employing archaeological
2 inspection techniques for both the surface and subsurface
3 identification of archaeological resources and artifacts resulting in
4 a professional archaeological report detailing the results of such
5 inspection.

6 (8) "Historic" means peoples and cultures who are known through
7 written documents in their own or other languages. As applied to
8 underwater archaeological resources, the term "historic" shall include
9 only those properties which are listed in or eligible for listing in
10 the Washington state register of historic places (RCW 27.34.220) or the
11 national register of historic places as defined in the national
12 historic preservation act of 1966 (Title 1, Sec. 101, Public Law 89-
13 665; 80 Stat. 915; 16 U.S.C. Sec. 470) as now or hereafter amended.

14 (9) "Historic archaeological resources" means those properties

20 (10) "Prehistoric" means peoples and cultures who are unknown
21 through contemporaneous written documents in any language.

22 (11) "Professional archaeologist" means a person with
23 qualifications meeting the federal secretary of the interior's
24 standards for a professional archaeologist. Archaeologists not meeting
25 this standard may be conditionally employed by working under the
26 supervision of a professional archaeologist for a period of four years
27 provided the employee is pursuing qualifications necessary to meet the
28 federal secretary of the interior's standards for a professional
29 archaeologist. During this four-year period, the professional
30 archaeologist is responsible for all findings. The four-year period is
31 not subject to renewal.

32 **Sec. 46.** RCW 28A.175.075 and 2010 c 243 s 4 are each amended to
33 read as follows:

34 (1) The office of the superintendent of public instruction shall
35 establish a state-level building bridges work group that includes K-12

2 limited to, recommendations for implementing emerging best practices,

5 (i) A recommended state goal and annual state targets for the
6 percentage of students graduating from high school;

7 (ii) A recommended state goal and annual state targets for the

10 (iii) Recommended funding for supporting career guidance and the
11 planning and implementation of K-12 dropout prevention, intervention,
12 and reengagement systems in school districts and a plan for phasing the
13 funding into the program of basic education, beginning in the 2011-2013

15 (iv) A plan for phasing in the expansion of the current school
16 improvement planning program to include state-funded, dropout-focused

19 (4) State agencies in the building bridges work group shall work
20 together, wherever feasible, on the following activities to support
21 school/family/community partnerships engaged in building K-12 dropout

25 (b) Providing joint funding;

1 (a) Whether to adopt an official conceptual approach or framework
2 for all entities working with vulnerable youth that can support
3 coordinated planning and evaluation;

27 (1) The office of the superintendent of public instruction, in
28 consultation with the state board of education, must:

29 (a) Calculate the annual extended graduation rate for each high
30 school, which is the rate at which a class of students enters high
31 school as (~~freshmen~~) first-year students and graduates with a high
32 school diploma, including students who receive a high school diploma
33 after the year they were expected to graduate. The office may
34 statistically adjust the rate for student demographics in the high
35 school, including the number of students eligible for free and reduced-

13 shall be measured by a reduction in the number of students suspended or

18 (2) The office of the superintendent of public instruction may add
19 dropout prevention indicators to the list of indicators under

21 assessment mastery, or student retention.

22 (3) To the maximum extent possible, the office of the
23 superintendent of public instruction shall rely on data collected
24 through the comprehensive education data and research system to
25 calculate the dropout prevention indicators under this section and
26 shall minimize additional data collection from schools and school
27 districts unless necessary to meet the requirements of this section.

29 develop a metric for measuring the performance of each high school on

14 the environment, and such other studies as may be prescribed by rule of

31 (2) The committee shall recommend specific policies and strategies

12 input and advice from other state and local agencies and organizations

15 disproportionately affect student achievement and student success.

16 (4) The educational opportunity gap oversight and accountability
17 committee shall be composed of the following members:

18 (a) The chairs and ranking minority members of the house and senate
19 education committees, or their designees;

20 (b) One additional member of the house of representatives appointed
21 by the speaker of the house and one additional member of the senate
22 appointed by the president of the senate;

23 (c) A representative of the office of the education (~~ombudsman~~)
24 ombuds;

25 (d) A representative of the center for the improvement of student

2 reimbursed for travel or other expenses.

3 (7) The chair or cochairs of the committee shall be selected by the
4 members of the committee. Staff support for the committee shall be
5 provided by the center for the improvement of student learning.
6 Members of the committee shall serve without compensation but must be
7 reimbursed as provided in RCW 43.03.050 and 43.03.060. Legislative
8 members of the committee shall be reimbursed for travel expenses in
9 accordance with RCW 44.04.120.

10 (8) The superintendent of public instruction, the state board of
11 education, the professional educator standards board, and the quality
12 education council shall work collaboratively with the educational
13 opportunity gap oversight and accountability committee to close the
14 achievement gap.

15 **Sec. 50.** RCW 28A.300.285 and 2010 c 239 s 2 are each amended to
16 read as follows:

17 (1) By August 1, 2011, each school district shall adopt or amend if
18 necessary a policy and procedure that at a minimum incorporates the
19 revised model policy and procedure provided under subsection (4) of
20 this section that prohibits the harassment, intimidation, or bullying
21 of any student. It is the responsibility of each school district to
22 share this policy with parents or guardians, students, volunteers, and
23 school employees in accordance with rules adopted by the superintendent
24 of public instruction. Each school district shall designate one person
25 in the district as the primary contact regarding the antiharassment,
26 intimidation, or bullying policy. The primary contact shall receive
27 copies of all formal and informal complaints, have responsibility for
28 assuring the implementation of the policy and procedure, and serve as
29 the primary contact on the policy and procedures between the school
30 district, the office of the education (~~ombudsman~~) ombuds, and the
31 office of the superintendent of public instruction.

32 (2) "Harassment, intimidation, or bullying" means any intentional
33 electronic, written, verbal, or physical act, including but not limited
34 to one shown to be motivated by any characteristic in RCW 9A.36.080(3),
35 or other distinguishing characteristics, when the intentional
36 electronic, written, verbal, or physical act:

- 1 (a) Physically harms a student or damages the student's property;
2 or
3 (b) Has the effect of substantially interfering with a student's
4 education; or
5 (c) Is so severe, persistent, or pervasive that it creates an
6 intimidating or threatening educational environment; or
7 (d) Has the effect of substantially disrupting the orderly
8 operation of the school.

9 Nothing in this section requires the affected student to actually
10 possess a characteristic that is a basis for the harassment,
11 intimidation, or bullying.

12 (3) The policy and procedure should be adopted or amended through
13 a process that includes representation of parents or guardians, school
14 employees, volunteers, students, administrators, and community
15 representatives. It is recommended that each such policy emphasize
16 positive character traits and values, including the importance of civil
17 and respectful speech and conduct, and the responsibility of students
18 to comply with the district's policy prohibiting harassment,
19 intimidation, or bullying.

20 (4)(a) By August 1, 2010, the superintendent of public instruction,
21 in consultation with representatives of parents, school personnel, the
22 office of the education (~~ombudsman~~) ombuds, the Washington state
23 school directors' association, and other interested parties, shall
24 provide to the education committees of the legislature a revised and
25 updated model harassment, intimidation, and bullying prevention policy
26 and procedure. The superintendent of public instruction shall publish
27 on its web site, with a link to the safety center web page, the revised
28 and updated model harassment, intimidation, and bullying prevention
29 policy and procedure, along with training and instructional materials
30 on the components that shall be included in any district policy and
31 procedure. The superintendent shall adopt rules regarding school
32 districts' communication of the policy and procedure to parents,
33 students, employees, and volunteers.

34 (b) The office of the superintendent of public instruction has the
35 authority to update with new technologies access to this information in
36 the safety center, to the extent resources are made available.

37 (c) Each school district shall by August 15, 2011, provide to the
38 superintendent of public instruction a brief summary of its policies,

1 procedures, programs, partnerships, vendors, and instructional and
2 training materials to be posted on the school safety center web site,
3 and shall also provide the superintendent with a link to the school
4 district's web site for further information. The district's primary
5 contact for bullying and harassment issues shall annually by August
6 15th verify posted information and links and notify the school safety
7 center of any updates or changes.

8 (5) The Washington state school directors' association, with the
9 assistance of the office of the superintendent of public instruction,
10 shall convene an advisory committee to develop a model policy
11 prohibiting acts of harassment, intimidation, or bullying that are
12 conducted via electronic means by a student while on school grounds and
13 during the school day. The policy shall include a requirement that
14 materials meant to educate parents and students about the seriousness
15 of cyberbullying be disseminated to parents or made available on the

19 safe internet use as well as what options are available if a student is
20 being bullied via electronic means((7)) including, but not limited to,
21 reporting threats to local police and when to involve school officials,
22 the internet service provider, or phone service provider. The school
23 directors' association shall submit the model policy and sample
24 materials, along with a recommendation for local adoption, to the
25 governor and the legislature and shall post the model policy and sample
26 materials on its web site by January 1, 2008. Each school district
27 board of directors shall establish its own policy by August 1, 2008.

28 (6) As used in this section, "electronic" or "electronic means"
29 means any communication where there is the transmission of information
30 by wire, radio, optical cable, electromagnetic, or other similar means.

33 (1) The office of the superintendent of public instruction and the

17 entering first-time undergraduate students who place into and enroll in

19 (g) Success beyond remedial education: The number and percentage
20 of entering first-time undergraduate students who complete entry
21 college-level math and English courses within the first two consecutive
22 academic years;

23 (h) Credit accumulation: The number and percentage of first-time

18 particular purpose shall not be effective to limit the liability of
19 merchant sellers except insofar as the disclaimer sets forth with
20 particularity the qualities and characteristics which are not being
21 warranted. Remedies for breach of warranty can be limited in
22 accordance with the provisions of this Article on liquidation or
23 limitation of damages and on contractual modification of remedy (RCW
24 62A.2-718 and RCW 62A.2-719).

25 **Sec. 135.** RCW 62A.2-318 and 1965 ex.s. c 157 s 2-318 are each
26 amended to read as follows:

27 A seller's warranty whether express or implied extends to any
28 natural person who is in the family or household of his or her buyer or
29 who is a guest in his or her home if it is reasonable to expect that
30 such person may use, consume, or be affected by the goods and who is
31 injured in person by breach of the warranty. A seller may not exclude
32 or limit the operation of this section.

33 **Sec. 136.** RCW 62A.2-319 and 1965 ex.s. c 157 s 2-319 are each
34 amended to read as follows:

35 (1) Unless otherwise agreed, the term F.O.B. (which means "free on

1 board") at a named place, even though used only in connection with the
2 stated price, is a delivery term under which:

3 (a) When the term is F.O.B. the place of shipment, the seller must
4 at that place ship the goods in the manner provided in this Article
5 (RCW 62A.2-504) and bear the expense and risk of putting them into the
6 possession of the carrier; or

7 (b) When the term is F.O.B. the place of destination, the seller
8 must at his or her own expense and risk transport the goods to that
9 place and there tender delivery of them in the manner provided in this
10 Article (RCW 62A.2-503);

11 (c) When under either (a) or (b) of this subsection the term is
12 also F.O.B. vessel, car, or other vehicle, the seller must in addition
13 at his or her own expense and risk load the goods on board. If the

17 (2) Unless otherwise agreed the term F.A.S. vessel (which means
18 "free alongside") at a named port, even though used only in connection
19 with the stated price, is a delivery term under which the seller must:

20 (a) At his or her own expense and risk deliver the goods alongside
21 the vessel in the manner usual in that port or on a dock designated and
22 provided by the buyer; and

23 (b) Obtain and tender a receipt for the goods in exchange for which
24 the carrier is under a duty to issue a bill of lading.

25 (3) Unless otherwise agreed, in any case falling within subsection
26 (1)(a) or (c) or (~~subsection~~) (2) of this section, the buyer must
27 seasonably give any needed instructions for making delivery, including
28 when the term is F.A.S. or F.O.B. the loading berth of the vessel and
29 in an appropriate case its name and sailing date. The seller may treat
30 the failure of needed instructions as a failure of cooperation under
31 this Article (RCW 62A.2-311). He or she may also at his or her option
32 move the goods in any reasonable manner preparatory to delivery or
33 shipment.

34 (4) Under the term F.O.B. vessel or F.A.S., unless otherwise
35 agreed, the buyer must make payment against tender of the required
36 documents and the seller may not tender nor the buyer demand delivery
37 of the goods in substitution for the documents.

1 **Sec. 137.** RCW 62A.2-320 and 1965 ex.s. c 157 s 2-320 are each
2 amended to read as follows:

3 (1) The term C.I.F. means that the price includes in a lump sum the
4 cost of the goods and the insurance and freight to the named
5 destination. The term C.&F. or C.F. means that the price so includes
6 cost and freight to the named destination.

7 (2) Unless otherwise agreed and even though used only in connection
8 with the stated price and destination, the term C.I.F. destination or
9 its equivalent requires the seller at his or her own expense and risk
10 to:

11 (a) Put the goods into the possession of a carrier at the port for
12 shipment and obtain a negotiable bill or bills of lading covering the
13 entire transportation to the named destination; and

14 (b) Load the goods and obtain a receipt from the carrier (which may
15 be contained in the bill of lading) showing that the freight has been
16 paid or provided for; and

17 (c) Obtain a policy or certificate of insurance, including any war
18 risk insurance, of a kind and on terms then current at the port of
19 shipment in the usual amount, in the currency of the contract, shown to
20 cover the same goods covered by the bill of lading and providing for
21 payment of loss to the order of the buyer or for the account of whom it
22 may concern; but the seller may add to the price the amount of the
23 premium for any such war risk insurance; and

24 (d) Prepare an invoice of the goods and procure any other documents
25 required to effect shipment or to comply with the contract; and

26 (e) Forward and tender with commercial promptness all the documents
27 in due form and with any indorsement necessary to perfect the buyer's
28 rights.

29 (3) Unless otherwise agreed, the term C.&F. or its equivalent has
30 the same effect and imposes upon the seller the same obligations and
31 risks as a C.I.F. term except the obligation as to insurance.

32 (4) Under the term C.I.F. or C.&F., unless otherwise agreed, the
33 buyer must make payment against tender of the required documents and
34 the seller may not tender nor the buyer demand delivery of the goods in
35 substitution for the documents.

36 **Sec. 138.** RCW 62A.2-324 and 1965 ex.s. c 157 s 2-324 are each
37 amended to read as follows:

1 Under a term "no arrival, no sale" or terms of like meaning, unless
2 otherwise agreed((7)):

3 (a) The seller must properly ship conforming goods and if they
4 arrive by any means he or she must tender them on arrival but he or she
5 assumes no obligation that the goods will arrive unless he or she has
6 caused the nonarrival; and

7 (b) Where without fault of the seller the goods are in part lost or
8 have so deteriorated as no longer to conform to the contract or arrive
9 after the contract time, the buyer may proceed as if there had been
10 casualty to identified goods (RCW 62A.2-613).

22 overseas, of good international repute. The term "confirmed credit"
23 means that the credit must also carry the direct obligation of such an
24 agency which does business in the seller's financial market.

27 (1) In a sale by auction if goods are put up in lots each lot is
28 the subject of a separate sale.

32 auctioneer may in his or her discretion reopen the bidding or declare

36 a fraudulent transfer or voidable preference.

1 **Sec. 142.** RCW 62A.2-501 and 1965 ex.s. c 157 s 2-501 are each
2 amended to read as follows:

3 (1) The buyer obtains a special property and an insurable interest
4 in goods by identification of existing goods as goods to which the
5 contract refers even though the goods so identified are nonconforming
6 and he or she has an option to return or reject them. Such
7 identification can be made at any time and in any manner explicitly
8 agreed to by the parties. In the absence of explicit agreement,
9 identification occurs:

10 (a) When the contract is made if it is for the sale of goods
11 already existing and identified;

12 (b) If the contract is for the sale of future goods other than
13 those described in (~~paragraph~~) (c) of this subsection, when goods are
14 shipped, marked, or otherwise designated by the seller as goods to
15 which the contract refers;

16 (c) When the crops are planted or otherwise become growing crops or
17 the young are conceived if the contract is for the sale of unborn young
18 to be born within twelve months after contracting or for the sale of
19 crops to be harvested within twelve months or the next normal harvest
20 season after contracting whichever is longer.

21 (2) The seller retains an insurable interest in goods so long as
22 title to or any security interest in the goods remains in him or her
23 and where the identification is by the seller alone he or she may until
24 default or insolvency or notification to the buyer that the
25 identification is final substitute other goods for those identified.

26 (3) Nothing in this section impairs any insurable interest
27 recognized under any other statute or rule of law.

28 **Sec. 143.** RCW 62A.2-502 and 2000 c 250 s 9A-806 are each amended
29 to read as follows:

30 (1) Subject to subsections (2) and (3) of this section and even
31 though the goods have not been shipped, a buyer who has paid a part or
32 all of the price of goods in which he or she has a special property
33 under the provisions of the immediately preceding section may on making
34 and keeping good a tender of any unpaid portion of their price recover
35 them from the seller if:

36 (a) In the case of goods bought for personal, family, or household

1 purposes, the seller repudiates or fails to deliver as required by the
2 contract; or

3 (b) In all cases, the seller becomes insolvent within ten days
4 after receipt of the first installment on their price.

5 (2) The buyer's right to recover the goods under subsection (1)(a)
6 of this section vests upon acquisition of a special property, even if
7 the seller had not then repudiated or failed to deliver.

8 (3) If the identification creating his or her special property has
9 been made by the buyer, he or she acquires the right to recover the
10 goods only if they conform to the contract for sale.

11 **Sec. 144.** RCW 62A.2-504 and 1965 ex.s. c 157 s 2-504 are each
12 amended to read as follows:

13 Where the seller is required or authorized to send the goods to the
14 buyer and the contract does not require him or her to deliver them at
15 a particular destination, then unless otherwise agreed he or she must:

16 (a) Put the goods in the possession of such a carrier and make such
17 a contract for their transportation as may be reasonable having regard
18 to the nature of the goods and other circumstances of the case; and

19 (b) Obtain and promptly deliver or tender in due form any document
20 necessary to enable the buyer to obtain possession of the goods or
21 otherwise required by the agreement or by usage of trade; and

22 (c) Promptly notify the buyer of the shipment. Failure to notify
23 the buyer under (~~paragraph (c)~~) this subsection or to make a proper
24 contract under (~~paragraph (a)~~) subsection (a) of this section is a
25 ground for rejection only if material delay or loss ensues.

26 **Sec. 145.** RCW 62A.2-507 and 1965 ex.s. c 157 s 2-507 are each

28 (1) Tender of delivery is a condition to the buyer's duty to accept
29 the goods and, unless otherwise agreed, to his or her duty to pay for
30 them. Tender entitles the seller to acceptance of the goods and to
31 payment according to the contract.

32 (2) Where payment is due and demanded on the delivery to the buyer
33 of goods or documents of title, his or her right as against the seller
34 to retain or dispose of them is conditional upon his or her making the
35 payment due.

1 **Sec. 146.** RCW 62A.2-508 and 1965 ex.s. c 157 s 2-508 are each
2 amended to read as follows:

3 (1) Where any tender or delivery by the seller is rejected because
4 nonconforming and the time for performance has not yet expired, the
5 seller may seasonably notify the buyer of his or her intention to cure
6 and may then within the contract time make a conforming delivery.

7 (2) Where the buyer rejects a nonconforming tender which the seller
8 had reasonable grounds to believe would be acceptable with or without
9 money allowance, the seller may if he or she seasonably notifies the
10 buyer have a further reasonable time to substitute a conforming tender.

11 **Sec. 147.** RCW 62A.2-510 and 1965 ex.s. c 157 s 2-510 are each
12 amended to read as follows:

13 (1) Where a tender or delivery of goods so fails to conform to the
14 contract as to give a right of rejection, the risk of their loss
15 remains on the seller until cure or acceptance.

16 (2) Where the buyer rightfully revokes acceptance, he or she may to
17 the extent of any deficiency in his or her effective insurance coverage
18 treat the risk of loss as having rested on the seller from the
19 beginning.

20 (3) Where the buyer as to conforming goods already identified to
21 the contract for sale repudiates or is otherwise in breach before risk
22 of their loss has passed to him or her, the seller may to the extent of
23 any deficiency in his or her effective insurance coverage treat the
24 risk of loss as resting on the buyer for a commercially reasonable

14 business at the market of rejection a merchant buyer is under a duty
15 after rejection of goods in his or her possession or control to follow
16 any reasonable instructions received from the seller with respect to
17 the goods and in the absence of such instructions to make reasonable
18 efforts to sell them for the seller's account if they are perishable or
19 threaten to decline in value speedily. Instructions are not reasonable
20 if on demand indemnity for expenses is not forthcoming.

33 perishables, if the seller gives no instructions within a reasonable
34 time after notification of rejection, the buyer may store the rejected
35 goods for the seller's account or reship them to him or her or resell

1 them for the seller's account with reimbursement as provided in the
2 preceding section. Such action is not acceptance or conversion.

3 **Sec. 151.** RCW 62A.2-606 and 1965 ex.s. c 157 s 2-606 are each
4 amended to read as follows:

5 (1) Acceptance of goods occurs when the buyer:

6 (a) After a reasonable opportunity to inspect the goods signifies
7 to the seller that the goods are conforming or that he or she will take
8 or retain them in spite of their nonconformity; or

9 (b) Fails to make an effective rejection (~~((subsection (1) of))~~) RCW
10 62A.2-602(1)), but such acceptance does not occur until the buyer has
11 had a reasonable opportunity to inspect them; or

12 (c) Does any act inconsistent with the seller's ownership; but if
13 such act is wrongful as against the seller it is an acceptance only if
14 ratified by him or her.

15 (2) Acceptance of a part of any commercial unit is acceptance of
16 that entire unit.

17 **Sec. 152.** RCW 62A.2-607 and 1965 ex.s. c 157 s 2-607 are each

19 (1) The buyer must pay at the contract rate for any goods accepted.

20 (2) Acceptance of goods by the buyer precludes rejection of the
21 goods accepted and if made with knowledge of a nonconformity cannot be
22 revoked because of it unless the acceptance was on the reasonable
23 assumption that the nonconformity would be seasonably cured but
24 acceptance does not of itself impair any other remedy provided by this
25 Article for nonconformity.

26 (3) Where a tender has been accepted:

27 (a) The buyer must within a reasonable time after he or she
28 discovers or should have discovered any breach notify the seller of
29 breach or be barred from any remedy; and

32 breach, he or she must so notify the seller within a reasonable time

36 to the goods accepted.

1 (5) Where the buyer is sued for breach of a warranty or other
2 obligation for which his or her seller is answerable over:

3 (a) He or she may give his or her seller written notice of the
4 litigation. If the notice states that the seller may come in and
5 defend and that if the seller does not do so he or she will be bound in
6 any action against him or her by his or her buyer by any determination
7 of fact common to the two litigations, then unless the seller after
8 reasonable receipt of the notice does come in and defend he or she is
9 so bound.

10 (b) If the claim is one for infringement or the like (~~((subsection~~
11 ~~(3) of))~~ RCW 62A.2-312(3)), the original seller may demand in writing
12 that his or her buyer turn over to him or her control of the litigation
13 including settlement or else be barred from any remedy over and if he
14 or she also agrees to bear all expense and to satisfy any adverse
15 judgment, then unless the buyer after reasonable receipt of the demand
16 does turn over control the buyer is so barred.

17 (6) The provisions of subsections (3), (4), and (5) of this section
18 apply to any obligation of a buyer to hold the seller harmless against
19 infringement or the like (~~((subsection (3) of))~~ RCW 62A.2-312(3)).

20 **Sec. 153.** RCW 62A.2-608 and 1965 ex.s. c 157 s 2-608 are each
21 amended to read as follows:

22 (1) The buyer may revoke his or her acceptance of a lot or
23 commercial unit whose nonconformity substantially impairs its value to
24 him or her if he or she has accepted it:

25 (a) On the reasonable assumption that its nonconformity would be
26 cured and it has not been seasonably cured; or

27 (b) Without discovery of such nonconformity if his or her
28 acceptance was reasonably induced either by the difficulty of discovery
29 before acceptance or by the seller's assurances.

30 (2) Revocation of acceptance must occur within a reasonable time
31 after the buyer discovers or should have discovered the ground for it
32 and before any substantial change in condition of the goods which is
33 not caused by their own defects. It is not effective until the buyer
34 notifies the seller of it.

35 (3) A buyer who so revokes has the same rights and duties with
36 regard to the goods involved as if he or she had rejected them.

1 **Sec. 154.** RCW 62A.2-609 and 1965 ex.s. c 157 s 2-609 are each
2 amended to read as follows:

3 (1) A contract for sale imposes an obligation on each party that
4 the other's expectation of receiving due performance will not be
5 impaired. When reasonable grounds for insecurity arise with respect to
6 the performance of either party the other may in writing demand
7 adequate assurance of due performance and until he or she receives such
8 assurance may if commercially reasonable suspend any performance for
9 which he or she has not already received the agreed return.

10 (2) Between merchants, the reasonableness of grounds for insecurity
11 and the adequacy of any assurance offered shall be determined according
12 to commercial standards.

13 (3) Acceptance of any improper delivery or payment does not
14 prejudice the aggrieved party's right to demand adequate assurance of

17 a reasonable time not exceeding thirty days such assurance of due

27 (b) Resort to any remedy for breach (RCW 62A.2-703 or ((RCW))
28 62A.2-711), even though he or she has notified the repudiating party
29 that he or she would await the latter's performance and has urged
30 retraction; and

31 (c) In either case suspend his or her own performance or proceed in
32 accordance with the provisions of this Article on the seller's right to
33 identify goods to the contract notwithstanding breach or to salvage
34 unfinished goods (RCW 62A.2-704).

1 (1) Until the repudiating party's next performance is due, he or
2 she can retract his or her repudiation unless the aggrieved party has
3 since the repudiation canceled or materially changed his or her
4 position or otherwise indicated that he or she considers the

6 (2) Retraction may be by any method which clearly indicates to the
7 aggrieved party that the repudiating party intends to perform, but must
8 include any assurance justifiably demanded under the provisions of this

10 (3) Retraction reinstates the repudiating party's rights under the
11 contract with due excuse and allowance to the aggrieved party for any
12 delay occasioned by the repudiation.

34 Where the contract requires for its performance goods identified
35 when the contract is made, and the goods suffer casualty without fault

1 of either party before the risk of loss passes to the buyer, or in a
2 proper case under a "no arrival, no sale" term (RCW 62A.2-324) then:

3 (a) If the loss is total, the contract is avoided; and

4 (b) If the loss is partial or the goods have so deteriorated as no
5 longer to conform to the contract, the buyer may nevertheless demand

19 given the association a written request for a notice of delinquent
20 assessments shall be reduced by up to three months if and to the extent
21 that the lien priority under subsection (3) of this section includes
22 delinquencies which relate to a period after such holder becomes an
23 eligible mortgagee or has given such notice and before the association
24 gives the holder a written notice of the delinquency. This subsection

33 associations have liens for assessments created at any time on the same
34 real estate, those liens have equal priority.

35 (7) Recording of the declaration constitutes record notice and
36 perfection of the lien for assessments. While no further recording of
37 any claim of lien for assessment under this section shall be required
38 to perfect the association's lien, the association may record a notice

1 of claim of lien for assessments under this section in the real
2 property records of any county in which the condominium is located.
3 Such recording shall not constitute the written notice of delinquency
4 to a mortgagee referred to in subsection (2) of this section.

5 (8) A lien for unpaid assessments and the personal liability for
6 payment of assessments is extinguished unless proceedings to enforce
7 the lien or collect the debt are instituted within three years after
8 the amount of the assessments sought to be recovered becomes due.

9 (9) The lien arising under this section may be enforced judicially
10 by the association or its authorized representative in the manner set
11 forth in chapter 61.12 RCW. The lien arising under this section may be
12 enforced nonjudicially in the manner set forth in chapter 61.24 RCW for
13 nonjudicial foreclosure of deeds of trust if the declaration (a)
14 contains a grant of the condominium in trust to a trustee qualified
15 under RCW 61.24.010 to secure the obligations of the unit owners to the
16 association for the payment of assessments, (b) contains a power of
17 sale, (c) provides in its terms that the units are not used principally
18 for agricultural or farming purposes, and (d) provides that the power
19 of sale is operative in the case of a default in the obligation to pay
20 assessments. The association or its authorized representative shall
21 have the power, unless prohibited by the declaration, to purchase the
22 unit at the foreclosure sale and to acquire, hold, lease, mortgage, or
23 convey the same. Upon an express waiver in the complaint of any right
24 to a deficiency judgment in a judicial foreclosure action, the period
25 of redemption shall be eight months. Nothing in this section shall
26 prohibit an association from taking a deed in lieu of foreclosure.

27 (10) From the time of commencement of an action by the association
28 to foreclose a lien for nonpayment of delinquent assessments against a
29 unit that is not occupied by the owner thereof, the association shall
30 be entitled to the appointment of a receiver to collect from the lessee
31 thereof the rent for the unit as and when due. If the rental is not
32 paid, the receiver may obtain possession of the unit, refurbish it for
33 rental up to a reasonable standard for rental units in this type of
34 condominium, rent the unit or permit its rental to others, and apply
35 the rents first to the cost of the receivership and attorneys' fees
36 thereof, then to the cost of refurbishing the unit, then to applicable
37 charges, then to costs, fees, and charges of the foreclosure action,
38 and then to the payment of the delinquent assessments. Only a receiver

1 may take possession and collect rents under this subsection, and a
2 receiver shall not be appointed less than ninety days after the
3 delinquency. The exercise by the association of the foregoing rights
4 shall not affect the priority of preexisting liens on the unit.

5 (11) Except as provided in subsection (3) of this section, the
6 holder of a mortgage or other purchaser of a unit who obtains the right
7 of possession of the unit through foreclosure shall not be liable for
8 assessments or installments thereof that became due prior to such right
9 of possession. Such unpaid assessments shall be deemed to be common
10 expenses collectible from all the unit owners, including such mortgagee
11 or other purchaser of the unit. Foreclosure of a mortgage does not
12 relieve the prior owner of personal liability for assessments accruing
13 against the unit prior to the date of such sale as provided in this
14 subsection.

15 (12) In addition to constituting a lien on the unit, each
16 assessment shall be the joint and several obligation of the owner or
17 owners of the unit to which the same are assessed as of the time the
18 assessment is due. In a voluntary conveyance, the grantee of a unit
19 shall be jointly and severally liable with the grantor for all unpaid
20 assessments against the grantor up to the time of the grantor's
21 conveyance, without prejudice to the grantee's right to recover from
22 the grantor the amounts paid by the grantee therefor. Suit to recover
23 a personal judgment for any delinquent assessment shall be maintainable
24 in any court of competent jurisdiction without foreclosing or waiving
25 the lien securing such sums.

27 late charges and a rate of interest to be charged on all subsequent
28 delinquent assessments or installments thereof. In the absence of
29 another established nonusurious rate, delinquent assessments shall bear
30 interest from the date of delinquency at the maximum rate permitted

32 delinquent.

33 (14) The association shall be entitled to recover any costs and
34 reasonable attorneys' fees incurred in connection with the collection
35 of delinquent assessments, whether or not such collection activities
36 result in suit being commenced or prosecuted to judgment. In addition,
37 the association shall be entitled to recover costs and reasonable

1 attorneys' fees if it prevails on appeal and in the enforcement of a
2 judgment.

3 (15) The association upon written request shall furnish to a unit
4 owner or a mortgagee a statement signed by an officer or authorized
5 agent of the association setting forth the amount of unpaid assessments
6 against that unit. The statement shall be furnished within fifteen
7 days after receipt of the request and is binding on the association,
8 the board of directors, and every unit owner, unless and to the extent
9 known by the recipient to be false.

10 (16) To the extent not inconsistent with this section, the
11 declaration may provide for such additional remedies for collection of
12 assessments as may be permitted by law.

13 **Sec. 176.** RCW 66.20.120 and 1933 ex.s. c 62 s 22 are each amended
14 to read as follows:

15 Any person in charge of an institution regularly conducted as a
16 hospital or sanatorium for the care of persons in ill health, or as a
17 home devoted exclusively to the care of aged people, may, if he or she
18 holds a special permit under this title for that purpose, administer
19 liquor purchased by him or her under his or her special permit to any
20 patient or inmate of the institution who is in need of the same, either
21 by way of external application or otherwise for medicinal purposes, and
22 may charge for the liquor so administered; but no liquor shall be
23 administered by any person under this section except to bona fide
24 patients or inmates of the institution of which he or she is in charge
25 and in cases of actual need and every person in charge of an
26 institution who administers liquor in evasion or violation of this
27 title shall be guilty of a violation of this title.

28 **Sec. 177.** RCW 67.08.080 and 1999 c 282 s 5 are each amended to
29 read as follows:

30 A boxing event held in this state may not be for more than ten
31 rounds and no one round of any bout shall be scheduled for longer than
32 three minutes and there shall be not less than one minute intermission
33 between each round. In the event of bouts involving state, regional,
34 national, or world championships, the department may grant an extension
35 of no more than two additional rounds to allow total bouts of twelve
36 rounds. A contestant in any boxing event under this chapter may not be

1 permitted to wear gloves weighing less than eight ounces. The director
2 shall adopt rules to assure clean and (~~sportsmanlike~~) sporting
3 conduct on the part of all contestants and officials, and the orderly
4 and proper conduct of the event in all respects, and to otherwise make
5 rules consistent with this chapter, but such rules shall apply only to
6 events held under the provisions of this chapter. The director may
7 adopt rules with respect to round and bout limitations and clean and
8 (~~sportsmanlike~~) sporting conduct for kickboxing, martial arts, or
9 wrestling events.

10 **Sec. 178.** RCW 67.16.200 and 2007 c 100 s 1 are each amended to
11 read as follows:

12 (1) A class 1 racing association licensed by the commission to
13 conduct a race meet may seek approval from the commission to conduct
14 parimutuel wagering at a satellite location or locations within the
15 state of Washington. In order to participate in parimutuel wagering at
16 a satellite location or locations within the state of Washington, the
17 holder of a class 1 racing association license must have conducted at
18 least one full live racing season. All class 1 racing associations
19 must hold a live race meet within each succeeding twelve-month period
20 to maintain eligibility to continue to participate in parimutuel
21 wagering at a satellite location or locations. The sale of parimutuel
22 pools at satellite locations shall be conducted simultaneous to all

31 of any class 1 racing facility. For the purposes of this section,
32 "driving miles" means miles measured by the most direct route as
33 determined by the commission; and

34 (b) A licensee shall not conduct satellite wagering at any
35 satellite location within sixty driving miles of any other racing
36 facility conducting a live race meet.

1 (2) Subject to local zoning and other land use ordinances, the
2 commission shall be the sole judge of whether approval to conduct
3 wagering at a satellite location shall be granted.

4 (3) The licensee shall combine the parimutuel pools of the
5 satellite location with those of the racing facility for the purpose of
6 determining odds and computing payoffs. The amount wagered at the
7 satellite location shall be combined with the amount wagered at the
8 racing facility for the application of take out formulas and
9 distribution as provided in RCW 67.16.102, 67.16.105, 67.16.170, and
10 67.16.175. A satellite extension of the licensee's racing facility
11 shall be subject to the same application of the rules of racing as the
12 licensee's racing facility.

13 (4) Upon written application to the commission, a class 1 racing
14 association may be authorized to transmit simulcasts of live horse
15 races conducted at its racetrack to locations outside of the state of
16 Washington approved by the commission and in accordance with the
17 interstate horse racing act of 1978 (15 U.S.C. Sec. 3001 to 3007) or
18 any other applicable laws. The commission may permit parimutuel pools
19 on the simulcast races to be combined in a common pool. A racing
20 association that transmits simulcasts of its races to locations outside
21 this state shall pay at least fifty percent of the fee that it receives
22 for sale of the simulcast signal to the horsemen's or horsewomen's
23 purse account for its live races after first deducting the actual cost
24 of sending the signal out of state.

25 (5) Upon written application to the commission, a class 1 racing
26 association may be authorized to transmit simulcasts of live horse
27 races conducted at its racetrack to licensed racing associations
28 located within the state of Washington and approved by the commission
29 for the receipt of the simulcasts. The commission shall permit
30 parimutuel pools on the simulcast races to be combined in a common
31 pool. The fee for in-state, track-to-track simulcasts shall be five
32 and one-half percent of the gross parimutuel receipts generated at the
33 receiving location and payable to the sending racing association. A
34 racing association that transmits simulcasts of its races to other
35 licensed racing associations shall pay at least fifty percent of the
36 fee that it receives for the simulcast signal to the horsemen's or
37 horsewomen's purse account for its live race meet after first deducting
38 the actual cost of sending the simulcast signal. A racing association

1 that receives races simulcast from class 1 racing associations within
2 the state shall pay at least fifty percent of its share of the
3 parimutuel receipts to the horsemen's or horsewomen's purse account for
4 its live race meet after first deducting the purchase price and the
5 actual direct costs of importing the race.

6 (6) A class 1 racing association may be allowed to import
7 simulcasts of horse races from out-of-state racing facilities. With
8 the prior approval of the commission, the class 1 racing association
9 may participate in a multijurisdictional common pool and may change its
10 commission and breakage rates to achieve a common rate with other
11 participants in the common pool.

12 (a) The class 1 racing association shall make written application
13 with the commission for permission to import simulcast horse races for
14 the purpose of parimutuel wagering. Subject to the terms of this
15 section, the commission is the sole authority in determining whether to
16 grant approval for an imported simulcast race.

17 (b) When open for parimutuel wagering, a class 1 racing association
18 which imports simulcast races shall also conduct simulcast parimutuel
19 wagering within its licensed racing enclosure on all races simulcast
20 from other class 1 racing associations within the state of Washington.

21 (c) On any imported simulcast race, the class 1 racing association
22 shall pay fifty percent of its share of the parimutuel receipts to the
23 horsemen's or horsewomen's purse account for its live race meet after
24 first deducting the purchase price of the imported race and the actual
25 costs of importing and offering the race.

26 (7) A licensed nonprofit racing association may be approved to
27 import one simulcast race of regional or national interest on each live
28 race day.

29 (8) For purposes of this section, a class 1 racing association is
30 defined as a licensee approved by the commission to conduct during each
31 twelve-month period at least forty days of live racing. If a live race
32 day is canceled due to reasons directly attributable to acts of God,
33 labor disruptions affecting live race days but not directly involving
34 the licensee or its employees, or other circumstances that the
35 commission decides are beyond the control of the class 1 racing
36 association, then the canceled day counts toward the forty-day
37 requirement. The commission may by rule increase the number of live

1 racing days required to maintain class 1 racing association status or
2 make other rules necessary to implement this section.

3 (9) This section does not establish a new form of gaming in
4 Washington or allow expanded gaming within the state beyond what has
5 been previously authorized. Simulcast wagering has been allowed in
6 Washington before April 19, 1997. Therefore, this section does not
7 allow gaming of any nature or scope that was prohibited before April
8 19, 1997. This section is necessary to protect the Washington equine
9 breeding and racing industries, and in particular those sectors of
10 these industries that are dependent upon live horse racing. The
11 purpose of this section is to protect these industries from adverse
12 economic impacts and to promote fan attendance at class 1 racing
13 facilities. Therefore, a licensed class 1 racing association may be
14 approved to disseminate imported simulcast race card programs to

27 9.46.071. The informational signs concerning problem and compulsive
28 gambling must include a toll-free telephone number for problem and
29 pathological gamblers and be developed under RCW 9.46.071.

30 (11) Chapter 10, Laws of 2001 1st sp. sess. does not establish a
31 new form of gaming in Washington or allow expanded gaming within the
32 state beyond what has been previously authorized. Simulcast wagering
33 has been allowed in Washington before August 23, 2001. Therefore, this
34 section does not allow gaming of any nature or scope that was
35 prohibited before August 23, 2001. Chapter 10, Laws of 2001 1st sp.
36 sess. is necessary to protect the Washington equine breeding and racing
37 industries, and in particular those sectors of these industries that
38 are dependent upon live horse racing. The purpose of chapter 10, Laws

1 of 2001 1st sp. sess. is to protect these industries from adverse
2 economic impacts and to promote fan attendance at class 1 racing
3 facilities.

4 **Sec. 179.** RCW 70.97.040 and 2005 c 504 s 406 are each amended to
5 read as follows:

6 (1)(a) Every person who is a resident of an enhanced services
7 facility shall be entitled to all the rights set forth in this chapter,
8 and chapters 71.05 and 70.96A RCW, and shall retain all rights not
9 denied him or her under these chapters.

10 (b) No person shall be presumed incompetent as a consequence of
11 receiving an evaluation or voluntary or involuntary treatment for a
12 mental disorder, chemical dependency disorder, or both, under this
13 chapter, or chapter 71.05 or 70.96A RCW, or any prior laws of this
14 state dealing with mental illness. Competency shall not be determined
15 or withdrawn except under the provisions of chapter 10.77 or 11.88 RCW.

16 (c) At the time of his or her treatment planning meeting, every
17 resident of an enhanced services facility shall be given a written
18 statement setting forth the substance of this section. The department
19 shall by rule develop a statement and process for informing residents
20 of their rights in a manner that is likely to be understood by the

22 (2) Every resident of an enhanced services facility shall have the
23 right to adequate care and individualized treatment.

24 (3) The provisions of this chapter shall not be construed to deny
25 to any person treatment by spiritual means through prayer in accordance
26 with the tenets and practices of a church or religious denomination.

27 (4) Persons receiving evaluation or treatment under this chapter
28 shall be given a reasonable choice of an available physician or other
29 professional person qualified to provide such services.

30 (5) The physician-patient privilege or the psychologist-client
31 privilege shall be deemed waived in proceedings under this chapter
32 relating to the administration of antipsychotic medications. As to
33 other proceedings under chapter 10.77, 70.96A, or 71.05 RCW, the
34 privileges shall be waived when a court of competent jurisdiction in
35 its discretion determines that such waiver is necessary to protect

1 (6) Insofar as danger to the person or others is not created, each
2 resident of an enhanced services facility shall have, in addition to
3 other rights not specifically withheld by law, the following rights, a
4 list of which shall be prominently posted in all facilities,
5 institutions, and hospitals providing such services:

6 (a) To wear his or her own clothes and to keep and use his or her
7 own personal possessions, except when deprivation of same is essential
8 to protect the safety of the resident or other persons;

9 (b) To keep and be allowed to spend a reasonable sum of his or her
10 own money for canteen expenses and small purchases;

11 (c) To have access to individual storage space for his or her
12 private use;

13 (d) To have visitors at reasonable times;

14 (e) To have reasonable access to a telephone, both to make and
15 receive confidential calls, consistent with an effective treatment
16 program;

17 (f) To have ready access to letter writing materials, including
18 stamps, and to send and receive uncensored correspondence through the
19 mails;

20 (g) Not to consent to the administration of antipsychotic
21 medications beyond the hearing conducted pursuant to RCW 71.05.215 or
22 71.05.217, or the performance of electroconvulsant therapy, or surgery,
23 except emergency life-saving surgery, unless ordered by a court under
24 RCW 71.05.217;

25 (h) To discuss and actively participate in treatment plans and
26 decisions with professional persons;

27 (i) Not to have psychosurgery performed on him or her under any
28 circumstances;

29 (j) To dispose of property and sign contracts unless such person
30 has been adjudicated an incompetent in a court proceeding directed to
31 that particular issue; and

32 (k) To complain about rights violations or conditions and request
33 the assistance of a mental health (~~ombudsman~~) ombuds or
34 representative of Washington protection and advocacy. The facility may
35 not prohibit or interfere with a resident's decision to consult with an
36 advocate of his or her choice.

37 (7) Nothing contained in this chapter shall prohibit a resident
38 from petitioning by writ of habeas corpus for release.

1 (8) Nothing in this section permits any person to knowingly violate
2 a no-contact order or a condition of an active judgment and sentence or
3 active supervision by the department of corrections.

4 (9) A person has a right to refuse placement, except where subject
5 to commitment, in an enhanced services facility. No person shall be
6 denied other department services solely on the grounds that he or she
7 has made such a refusal.

8 (10) A person has a right to appeal the decision of the department
9 that he or she is eligible for placement at an enhanced services
10 facility, and shall be given notice of the right to appeal in a format
11 that is accessible to the person with instructions regarding what to do
12 if the person wants to appeal.

13 **Sec. 180.** RCW 70.97.100 and 2005 c 504 s 412 are each amended to
14 read as follows:

15 (1) The department shall establish licensing rules for enhanced
16 services facilities to serve the populations defined in this chapter.

17 (2) No person or public or private agency may operate or maintain
18 an enhanced services facility without a license, which must be renewed
19 annually.

20 (3) A licensee shall have the following readily accessible and
21 available for review by the department, residents, families of
22 residents, and the public:

23 (a) Its license to operate and a copy of the department's most
24 recent inspection report and any recent complaint investigation reports
25 issued by the department;

26 (b) Its written policies and procedures for all treatment, care,
27 and services provided directly or indirectly by the facility; and

28 (c) The department's toll-free complaint number, which shall also

1 protection and advocacy system, or a mental health ((ombudsperson))
2 ombuds.

3 (6) Each enhanced services facility will post in a prominent place
4 in a common area a notice by the Washington protection and advocacy
5 system providing contact information.

6 **Sec. 181.** RCW 70.128.150 and 1995 1st sp.s. c 18 s 27 are each
7 amended to read as follows:

8 Whenever possible, adult family homes are encouraged to contact and
9 work with local quality assurance projects such as the volunteer
10 ((ombudsman)) ombuds with the goal of assuring high quality care is
11 provided in the home.

12 An adult family home may not willfully interfere with a
13 representative of the long-term care ((ombudsman)) ombuds program in
14 the performance of official duties. The department shall impose a
15 penalty of not more than one thousand dollars for any such willful
16 interference.

17 **Sec. 182.** RCW 70.128.163 and 2009 c 560 s 6 are each amended to
18 read as follows:

19 (1) When the department has summarily suspended a license, the
20 licensee may, subject to the department's approval, elect to
21 participate in a temporary management program. All provisions of this
22 section shall apply.

23 The purposes of a temporary management program are as follows:

24 (a) To mitigate dislocation and transfer trauma of residents while
25 the department and licensee may pursue dispute resolution or appeal of
26 a summary suspension of license;

27 (b) To facilitate the continuity of safe and appropriate resident
28 care and services;

29 (c) To preserve a residential option that meets a specialized
30 service need and/or is in a geographical area that has a lack of
31 available providers; and

32 (d) To provide residents with the opportunity for orderly

34 (2) Licensee participation in the temporary management program is

9 necessary to ensure that residents' needs are met. The licensee is
10 responsible for all costs related to administering the temporary
11 management program and contracting with the temporary management. The
12 temporary management agreement shall at a minimum address the
13 following:

14 (a) Provision of liability insurance to protect residents and their
15 property;

16 (b) Preservation of resident trust funds;

17 (c) The timely payment of past due or current accounts, operating
18 expenses, including but not limited to staff compensation, and all debt
19 that comes due during the period of the temporary management;

20 (d) The responsibilities for addressing all other financial
21 obligations that would interfere with the ability of the temporary
22 manager to provide adequate care and services to residents; and

23 (e) The authority of the temporary manager to manage the home,
24 including the hiring, managing, and firing of employees for good cause,
25 and to provide adequate care and services to residents.

26 (4) The licensee and department shall provide written notification
27 immediately to all residents, legal representatives, interested family
28 members, and the state long-term care (~~ombudsman~~) ombuds program, of
29 the temporary management and the reasons for it. This notification
30 shall include notice that residents may move from the home without
31 notifying the licensee in advance, and without incurring any charges,
32 fees, or costs otherwise available for insufficient advance notice,

12 (1) The department shall maintain a toll-free telephone number for
13 receiving complaints regarding adult family homes.

14 (2) An adult family home shall post in a place and manner clearly
15 visible to residents and visitors the department's toll-free complaint
16 telephone number.

17 (3) No adult family home shall discriminate or retaliate in any
18 manner against a resident on the basis or for the reason that such
19 resident or any other person made a complaint to the department or the
20 long-term care ((ombudsman)) ombuds or cooperated with the
21 investigation of such a complaint.

22 **Sec. 184.** RCW 70.129.030 and 1998 c 272 s 5 are each amended to
23 read as follows:

24 (1) The facility must inform the resident both orally and in
25 writing in a language that the resident understands of his or her
26 rights and all rules and regulations governing resident conduct and
27 responsibilities during the stay in the facility. The notification
28 must be made prior to or upon admission. Receipt of the information
29 must be acknowledged in writing.

30 (2) The resident or his or her legal representative has the right:

31 (a) Upon an oral or written request, to access all records
32 pertaining to himself or herself including clinical records within

34 (b) After receipt of his or her records for inspection, to purchase

5 state (~~ombudsmen~~) ombuds program, and the protection and advocacy
6 systems; and

7 (c) A statement that the resident may file a complaint with the
8 appropriate state licensing agency concerning alleged resident abuse,
9 neglect, and misappropriation of resident property in the facility.

10 (6) Notification of changes.

11 (a) A facility must immediately consult with the resident's
12 physician, and if known, make reasonable efforts to notify the
13 resident's legal representative or an interested family member when
14 there is:

15 (i) An accident involving the resident which requires or has the
16 potential for requiring physician intervention;

17 (ii) A significant change in the resident's physical, mental, or
18 psychosocial status (i.e., a deterioration in health, mental, or
19 psychosocial status in either life-threatening conditions or clinical
20 complications).

21 (b) The facility must promptly notify the resident or the
22 resident's representative shall make reasonable efforts to notify an
23 interested family member, if known, when there is:

24 (i) A change in room or roommate assignment; or

25 (ii) A decision to transfer or discharge the resident from the
26 facility.

27 (c) The facility must record and update the address and phone
28 number of the resident's representative or interested family member,
29 upon receipt of notice from them.

30 **Sec. 185.** RCW 70.129.090 and 1994 c 214 s 10 are each amended to
31 read as follows:

32 (1) The resident has the right and the facility must not interfere
33 with access to any resident by the following:

34 (a) Any representative of the state;

35 (b) The resident's individual physician;

36 (c) The state long-term care (~~ombudsman~~) ombuds as established
37 under chapter 43.190 RCW;

1 (d) The agency responsible for the protection and advocacy system
2 for (~~developmentally disabled~~) individuals with developmental
3 disabilities as established under part C of the developmental
4 disabilities assistance and bill of rights act;

5 (e) The agency responsible for the protection and advocacy system
6 for (~~mentally ill~~) individuals with mental illness as established

22 (~~ombudsman~~) ombuds to examine a resident's clinical records with the
23 permission of the resident or the resident's legal representative, and
24 consistent with state and federal law.

26 read as follows:

27 (1) The facility must permit each resident to remain in the
28 facility, and not transfer or discharge the resident from the facility
29 unless:

30 (a) The transfer or discharge is necessary for the resident's

19 transfer or discharge required under subsection (3) of this section

38 address and telephone number of the agency responsible for the

1 protection and advocacy of (~~developmentally disabled~~) individuals
2 with developmental disabilities established under part C of the
3 developmental disabilities assistance and bill of rights act; and

4 (f) For residents (~~who are mentally ill~~) with mental illness, the
5 mailing address and telephone number of the agency responsible for the
6 protection and advocacy of (~~mentally ill~~) individuals with mental
7 illness established under the protection and advocacy for mentally ill
8 individuals act.

9 (6) A facility must provide sufficient preparation and orientation
10 to residents to ensure safe and orderly transfer or discharge from the
11 facility.

12 (7) A resident discharged in violation of this section has the
13 right to be readmitted immediately upon the first availability of a
14 gender-appropriate bed in the facility.

4 representatives shall jointly appoint the members under (a)(ii), (xiv),
5 and (xvi) of this subsection.

6 (c) The representative from partners for our children shall convene
7 the initial meeting of the committee no later than June 15, 2009.

8 (d) The cochairs of the committee shall be the assistant secretary
9 for the children's administration and another member selected by a
10 majority vote of those members present at the initial meeting.

11 (2) The committee shall establish a transition plan containing
12 recommendations to the legislature and the governor consistent with
13 this section for the provision of child welfare services by supervising
14 agencies pursuant to RCW 74.13.360.

15 (3) The plan shall include the following:

16 (a) A model or framework for performance-based contracts to be used
17 by the department that clearly defines:

18 (i) The target population;

19 (ii) The referral and exit criteria for the services;

20 (iii) The child welfare services including the use of evidence-
21 based services and practices to be provided by contractors;

22 (iv) The roles and responsibilities of public and private agency
23 workers in key case decisions;

24 (v) Contract performance and outcomes, including those related to
25 eliminating racial disparities in child outcomes;

26 (vi) That supervising agencies will provide culturally competent
27 service;

28 (vii) How to measure whether each contractor has met the goals
29 listed in RCW 74.13.360(4); and

30 (viii) Incentives to meet performance outcomes;

31 (b) A method or methods by which clients will access community-
32 based services, how private supervising agencies will engage other
33 services or form local service networks, develop subcontracts, and
34 share information and supervision of children;

35 (c) Methods to address the effects of racial disproportionality, as
36 identified in the 2008 Racial Disproportionality Advisory Committee
37 Report published by the Washington state institute for public policy in
38 June 2008;

1 (d) Methods for inclusion of the principles and requirements of the
2 centennial accord executed in November 2001, executed between the state
3 of Washington and federally recognized tribes in Washington state;

4 (e) Methods for assuring performance-based contracts adhere to the
5 letter and intent of the federal Indian child welfare act;

6 (f) Contract monitoring and evaluation procedures that will ensure
7 that children and families are receiving timely and quality services
8 and that contract terms are being implemented;

9 (g) A method or methods by which to ensure that the children's
10 administration has sufficiently trained and experienced staff to
11 monitor and manage performance-based contracts;

12 (h) A process by which to expand the capacity of supervising and
13 other private agencies to meet the service needs of children and
14 families in a performance-based contractual arrangement;

15 (i) A method or methods by which supervising and other private
16 agencies can expand services in underserved areas of the state;

17 (j) The appropriate amounts and procedures for the reimbursement of
18 supervising agencies given the proposed services restructuring;

19 (k) A method by which to access and enhance existing data systems
20 to include contract performance information;

21 (l) A financing arrangement for the contracts that examines:

22 (i) The use of case rates or performance-based fee-for-service
23 contracts that include incentive payments or payment schedules that
24 link reimbursement to outcomes; and

25 (ii) Ways to reduce a contractor's financial risk that could
26 jeopardize the solvency of the contractor, including consideration of
27 the use of a risk-reward corridor that limits risk of loss and
28 potential profits or the establishment of a statewide risk pool;

29 (m) A description of how the transition will impact the state's
30 ability to obtain federal funding and examine options to further
31 maximize federal funding opportunities and increased flexibility;

32 (n) A review of whether current administrative staffing levels in
33 the regions should be continued when the majority of child welfare
34 services are being provided by supervising agencies;

35 (o) A description of the costs of the transition, the initial
36 start-up costs and the mechanisms to periodically assess the overall
37 adequacy of funds and the fiscal impact of the changes, and the

1 feasibility of the plan and the impact of the plan on department
2 employees during the transition; and

4 necessary to accomplish the transition.

6 select two demonstration sites within which to implement chapter 520,

23 and family populations to be provided services under performance-based
24 contracts with supervising agencies. The committee shall also identify
25 the time frame within which cases will be transferred to supervising
26 agencies. The performance-based contracts entered into with
27 supervising agencies shall encompass the provision of child welfare
28 services to enough children and families in each demonstration site to
29 allow for the assessment of whether there are meaningful differences,
30 to be defined by the committee, between the outcomes achieved in the
31 demonstration sites and the comparison sites or populations. To ensure
32 adequate statistical power to assess these differences, the populations
33 served shall be large enough to provide a probability greater than
34 seventy percent that meaningful difference will be detected and a
35 ninety-five percent probability that observed differences are not due
36 to chance alone.

37 (6) The committee shall also prepare as part of the plan a

1 recommendation as to how to implement chapter 520, Laws of 2009 so that
2 full implementation of chapter 520, Laws of 2009 is achieved no later
3 than December 30, 2015.

4 (7) The committee shall prepare the plan to manage the delivery of
5 child welfare services in a manner that achieves coordination of the
6 services and programs that deliver primary prevention services.

7 (8) Beginning June 30, 2009, the committee shall report quarterly

9 established in RCW 44.04.220. From June 30, 2012, until December 30,
10 2015, the committee need only report twice a year. The committee shall

7 preliminary review of the complaint, assess the severity of the

9 involving imminent danger to the health, safety, or well-being of a
10 resident must be responded to within two days. When appropriate, the
11 department shall make an on-site investigation within a reasonable time
12 after receipt of the complaint or otherwise ensure that complaints are
13 responded to.

14 (b) The complainant must be: Promptly contacted by the department,
15 unless anonymous or unavailable despite several attempts by the
16 department, and informed of the right to discuss the alleged violations
17 with the inspector and to provide other information the complainant
18 believes will assist the inspector; informed of the department's course
19 of action; and informed of the right to receive a written copy of the
20 investigation report.

21 (c) In conducting the investigation, the department shall interview
22 the complainant, unless anonymous, and shall use its best efforts to
23 interview the vulnerable adult or adults allegedly harmed, and,
24 consistent with the protection of the vulnerable adult shall interview
25 facility staff, any available independent sources of relevant
26 information, including if appropriate the family members of the
27 vulnerable adult.

28 (d) Substantiated complaints involving harm to a resident, if an
29 applicable law or rule has been violated, shall be subject to one or
30 more of the actions provided in RCW 74.39A.080 or 70.128.160. Whenever
31 appropriate, the department shall also give consultation and technical
32 assistance to the provider.

33 (e) After a department finding of a violation for which a stop
34 placement has been imposed, the department shall make an on-site
35 revisit of the provider within fifteen working days from the request
36 for revisit, to ensure correction of the violation. For violations
37 that are serious or recurring or uncorrected following a previous
38 citation, and create actual or threatened harm to one or more

1 residents' well-being, including violations of residents' rights, the
2 department shall make an on-site revisit as soon as appropriate to
3 ensure correction of the violation. Verification of correction of all
4 other violations may be made by either a department on-site revisit or
5 by written or photographic documentation found by the department to be
6 credible. This subsection does not prevent the department from
7 enforcing license or contract suspensions or revocations. Nothing in
8 this subsection shall interfere with or diminish the department's
9 authority and duty to ensure that the provider adequately cares for
10 residents, including to make departmental on-site revisits as needed to
11 ensure that the provider protects residents and to enforce compliance
12 with this chapter.

13 (f) Substantiated complaints of neglect, abuse, exploitation, or
14 abandonment of residents, or suspected criminal violations, shall also
15 be referred by the department to the appropriate law enforcement
16 agencies, the attorney general, and appropriate professional
17 disciplining authority.

18 (6) The department may provide the substance of the complaint to
19 the licensee or contractor before the completion of the investigation
20 by the department unless such disclosure would reveal the identity of
21 a complainant, witness, or resident who chooses to remain anonymous.
22 Neither the substance of the complaint provided to the licensee or
23 contractor nor any copy of the complaint or related report published,
24 released, or made otherwise available shall disclose, or reasonably
25 lead to the disclosure of, the name, title, or identity of any
26 complainant, or other person mentioned in the complaint, except that
27 the name of the provider and the name or names of any officer,
28 employee, or agent of the department conducting the investigation shall
29 be disclosed after the investigation has been closed and the complaint
30 has been substantiated. The department may disclose the identity of
31 the complainant if such disclosure is requested in writing by the
32 complainant. Nothing in this subsection shall be construed to
33 interfere with the obligation of the long-term care ((ombudsman))
34 ombuds program or department staff to monitor the department's
35 licensing, contract, and complaint investigation files for long-term
36 care facilities.

37 (7) The resident has the right to be free of interference,
38 coercion, discrimination, and reprisal from a facility in exercising

1 his or her rights, including the right to voice grievances about
2 treatment furnished or not furnished. A facility that provides long-
3 term care services shall not discriminate or retaliate in any manner
4 against a resident, employee, or any other person on the basis or for
5 the reason that such resident or any other person made a complaint to
6 the department, the attorney general, law enforcement agencies, or the
7 long-term care ((ombudsman)) ombuds, provided information, or otherwise
8 cooperated with the investigation of such a complaint. Any attempt to
9 discharge a resident against the resident's wishes, or any type of
10 retaliatory treatment of a resident by whom or upon whose behalf a
11 complaint substantiated by the department has been made to the
12 department, the attorney general, law enforcement agencies, or the
13 long-term care ((ombudsman)) ombuds, within one year of the filing of
14 the complaint, raises a rebuttable presumption that such action was in
15 retaliation for the filing of the complaint. "Retaliatory treatment"
16 means, but is not limited to, monitoring a resident's phone, mail, or
17 visits; involuntary seclusion or isolation; transferring a resident to
18 a different room unless requested or based upon legitimate management
19 reasons; withholding or threatening to withhold food or treatment
20 unless authorized by a terminally ill resident or his or her
21 representative pursuant to law; or persistently delaying responses to
22 a resident's request for service or assistance. A facility that
23 provides long-term care services shall not willfully interfere with the
24 performance of official duties by a long-term care ((ombudsman))

26 of not more than three thousand dollars for a violation of this
27 subsection.

30 (1) Subject to funding provided for this specific purpose, the
31 department of social and health services shall develop for phased-in
32 implementation a statewide internal quality review and accountability
33 program for residential care services. The program must be designed to
34 enable the department to improve the accountability of staff and the
35 consistent application of investigative activities across all long-term
36 care settings, and must allow the systematic monitoring and evaluation
37 of long-term care licensing and certification. The program must be

20 (1) The facility shall admit as residents only those individuals
21 whose needs can be met by:

22 (a) The facility;

23 (b) The facility cooperating with community resources; or

24 (c) The facility cooperating with other providers of care
25 affiliated or under contract with the facility.

26 (2) The facility shall transfer a resident to a hospital or other
27 appropriate facility when a change occurs in the resident's physical or
28 mental condition that requires care or service that the facility cannot
29 provide. The resident, the resident's guardian, if any, the resident's
30 next of kin, the attending physician, and the department shall be
31 consulted at least fifteen days before a transfer or discharge unless
32 the resident is transferred under emergency circumstances. The
33 department shall use casework services or other means to insure that
34 adequate arrangements are made to meet the resident's needs.

35 (3) A resident shall be transferred or discharged only for medical
36 reasons, the resident's welfare or request, the welfare of other

1 residents, or nonpayment. A resident may not be discharged for
2 nonpayment if the discharge would be prohibited by the medicaid

4 (4) If a resident chooses to remain in the nursing facility, the
5 department shall respect that choice, provided that if the resident is
6 a medicaid recipient, the resident continues to require a nursing
7 facility level of care.

8 (5) If the department determines that a resident no longer requires
9 a nursing facility level of care, the resident shall not be discharged
10 from the nursing facility until at least thirty days after written
11 notice is given to the resident, the resident's surrogate decision
12 maker and, if appropriate, a family member or the resident's
13 representative. A form for requesting a hearing to appeal the
14 discharge decision shall be attached to the written notice. The
15 written notice shall include at least the following:

16 (a) The reason for the discharge;

17 (b) A statement that the resident has the right to appeal the
18 discharge; and

19 (c) The name, address, and telephone number of the state long-term
20 care ((ombudsman)) ombuds.

21 (6) If the resident appeals a department discharge decision, the
22 resident shall not be discharged without the resident's consent until
23 at least thirty days after a final order is entered upholding the
24 decision to discharge the resident.

25 (7) Before the facility transfers or discharges a resident, the
26 facility must first attempt through reasonable accommodations to avoid
27 the transfer or discharge unless the transfer or discharge is agreed to
28 by the resident. The facility shall admit or retain only individuals
29 whose needs it can safely and appropriately serve in the facility with
30 available staff or through the provision of reasonable accommodations
31 required by state or federal law. "Reasonable accommodations" has the
32 meaning given to this term under the federal Americans with
33 disabilities act of 1990, 42 U.S.C. Sec. 12101 et seq. and other
34 applicable federal or state antidiscrimination laws and regulations.

35 **Sec. 230.** RCW 74.42.640 and 2006 c 209 s 13 are each amended to
36 read as follows:

37 (1) To ensure the proper delivery of services and the maintenance

1 and improvement in quality of care through self-review, each facility
2 may maintain a quality assurance committee that, at a minimum,
3 includes:

- 4 (a) The director of nursing services;
- 5 (b) A physician designated by the facility; and
- 6 (c) Three other members from the staff of the facility.

7 (2) When established, the quality assurance committee shall meet at
8 least quarterly to identify issues that may adversely affect quality of
9 care and services to residents and to develop and implement plans of
10 action to correct identified quality concerns or deficiencies in the
11 quality of care provided to residents.

12 (3) To promote quality of care through self-review without the fear
13 of reprisal, and to enhance the objectivity of the review process, the
14 department shall not require, and the long-term care ((ombudsman))
15 ombuds program shall not request, disclosure of any quality assurance
16 committee records or reports, unless the disclosure is related to the
17 committee's compliance with this section, if:

18 (a) The records or reports are not maintained pursuant to statutory
19 or regulatory mandate; and

20 (b) The records or reports are created for and collected and
21 maintained by the committee.

22 (4) The department may request only information related to the
23 quality assurance committee that may be necessary to determine whether
24 a facility has a quality assurance committee and that it is operating
25 in compliance with this section.

26 (5) Good faith attempts by the committee to identify and correct
27 quality deficiencies shall not be used as a basis for imposing
28 sanctions.

29 (6) If the facility offers the department documents generated by,
30 or for, the quality assurance committee as evidence of compliance with
31 nursing facility requirements, the documents are protected as quality
32 assurance committee documents under subsections (7) and (9) of this
33 section when in the possession of the department. The department is
34 not liable for an inadvertent disclosure, a disclosure related to a
35 required federal or state audit, or disclosure of documents incorrectly
36 marked as quality assurance committee documents by the facility.

37 (7) Information and documents, including the analysis of complaints
38 and incident reports, created specifically for, and collected and

1 maintained by, a quality assurance committee are not subject to
2 discovery or introduction into evidence in any civil action, and no
3 person who was in attendance at a meeting of such committee or who
4 participated in the creation, collection, or maintenance of information
5 or documents specifically for the committee shall be permitted or
6 required to testify in any civil action as to the content of such
7 proceedings or the documents and information prepared specifically for
8 the committee. This subsection does not preclude: (a) In any civil
9 action, the discovery of the identity of persons involved in the care
10 that is the basis of the civil action whose involvement was independent
11 of any quality improvement committee activity; and (b) in any civil
12 action, the testimony of any person concerning the facts which form the
13 basis for the institution of such proceedings of which the person had
14 personal knowledge acquired independently of their participation in the
15 quality assurance committee activities.

16 (8) A quality assurance committee under subsection (1) of this
17 section, RCW 18.20.390, 70.41.200, 4.24.250, or 43.70.510 may share
18 information and documents, including the analysis of complaints and
19 incident reports, created specifically for, and collected and
20 maintained by, the committee, with one or more other quality assurance
21 committees created under subsection (1) of this section, RCW 18.20.390,
22 70.41.200, 4.24.250, or 43.70.510 for the improvement of the quality of
23 care and services rendered to nursing facility residents. Information
24 and documents disclosed by one quality assurance committee to another
25 quality assurance committee and any information and documents created
26 or maintained as a result of the sharing of information and documents
27 shall not be subject to the discovery process and confidentiality shall
28 be respected as required by subsections (7) and (9) of this section,
29 RCW 18.20.390 (6) and (8), 43.70.510(4), 70.41.200(3), and 4.24.250(1).
30 The privacy protections of chapter 70.02 RCW and the federal health
31 insurance portability and accountability act of 1996 and its
32 implementing regulations apply to the sharing of individually
33 identifiable patient information held by a coordinated quality
34 improvement program. Any rules necessary to implement this section
35 shall meet the requirements of applicable federal and state privacy
36 laws.

37 (9) Information and documents, including the analysis of complaints

1 and incident reports, created specifically for, and collected and
2 maintained by, a quality assurance committee are exempt from disclosure
3 under chapter 42.56 RCW.

4 (10) Notwithstanding any records created for the quality assurance
5 committee, the facility shall fully set forth in the resident's
6 records, available to the resident, the department, and others as
7 permitted by law, the facts concerning any incident of injury or loss
8 to the resident, the steps taken by the facility to address the
9 resident's needs, and the resident outcome.

10 (11) A facility operated as part of a hospital licensed under
11 chapter 70.41 RCW may maintain a quality assurance committee in
12 accordance with this section which shall be subject to the provisions
13 of subsections (1) through (10) of this section or may conduct quality
14 improvement activities for the facility through a quality improvement
15 committee under RCW 70.41.200 which shall be subject to the provisions
16 of RCW 70.41.200(9).

17 **Sec. 231.** RCW 76.09.320 and 1987 c 95 s 6 are each amended to read
18 as follows:

19 (1) Subject to the availability of appropriated funds, the
20 department shall pay fifty percent of the cost of implementing the
21 hazard-reduction program, except as provided in subsection (2) of this
22 section.

23 (2) In the event department funds described in subsection (1) of
24 this section are not available for all or a portion of a forest
25 landowner's property, the landowner may request application of the
26 hazard-reduction program to the owner's lands, provided the landowner
27 funds one hundred percent of the cost of implementation of the
28 department's recommended actions on his or her property.

29 (3) No cost-sharing funds may be made available for sites where the
30 department determines that the hazardous condition results from a
31 violation of then-prevailing standards as established by statute or
32 rule.

35 The department shall develop fire protection projects within the
36 high hazard forest area and shall determine the boundaries thereof in

3 project on an acreage basis. Such assessment shall not, however,
4 exceed twenty-five cents per acre annually nor more than one dollar and
5 fifty cents per acre in the aggregate and shall constitute a lien upon
6 any forest products harvested therefrom. The landowner may by written
7 notice to the department elect to pay his or her assessment on a
8 deferred basis at a rate of ten cents per thousand board feet and/or

16 total ownership is less than forty acres, then payment shall be applied
17 on an undivided basis to the entire areas as to which the assessment
18 remains unpaid. The landowner who elects to pay on deferred basis may
19 pay any unpaid assessment and interest at any time.

20 **Sec. 233.** RCW 76.14.090 and 1988 c 128 s 44 are each amended to
21 read as follows:

22 Notice of each project, the estimated assessment per acre, and a
23 description of the boundaries thereof shall be given by publication in
24 a local newspaper of general circulation thirty days in advance of
25 commencing work. Any person owning land within the project may within
26 ten days after publication of notice demand a hearing before the
27 department in Olympia and present any reasons why he or she feels the
28 assessment should not be made upon his or her land. Thereafter, the
29 department may change the boundaries of said project to eliminate land
30 from the project which it determines in its discretion will not be
31 benefited by the project.

32 **Sec. 234.** RCW 76.14.100 and 1988 c 128 s 45 are each amended to

34 Except when the owner has notified the department in writing that
35 he or she will make payment on the deferred plan, the assessment shall

17 portion thereof, he or she may make direct payment to the department.

35 to participate in the taking of fish or shellfish in a treaty Indian

2 in a treaty Indian fishery. A violation of this subsection is a gross

36 (5) A violation of this section constitutes illegal fishing and is
37 subject to the suspensions provided for commercial fishing violations.

3 (1)(a) When purchasing any hunting license, persons under the age
4 of eighteen shall present certification of completion of a course of

7 All persons purchasing any hunting license for the first time, if born
8 after January 1, 1972, shall present such certification.

7 (2) The annual fee for a fish buyer's license is ninety-five
8 dollars. The application fee is one hundred five dollars.

5 to ascertain the facts upon all such applications in such manner and
6 under such regulations as it may deem proper. Any person incurring any
7 penalty under this section may appeal the same to the council. Such
8 appeals shall be filed within thirty days of receipt of notice imposing
9 any penalty unless an application for remission or mitigation is made
10 to the council. When an application for remission or mitigation is

12 notice from the council setting forth the disposition of the

29 shall be the same as an ordinary civil action except as otherwise
30 provided in this chapter. All penalties recovered under this section
31 shall be paid into the state treasury and credited to the general fund.

32 (6) Civil proceedings to enforce this chapter may be brought by the
33 attorney general or the prosecuting attorney of any county affected by
34 the violation on his or her own motion or at the request of the
35 council. Criminal proceedings to enforce this chapter may be brought
36 by the prosecuting attorney of any county affected by the violation on
37 his or her own motion or at the request of the council.

1 (7) The remedies and penalties in this section, both civil and
2 criminal, shall be cumulative and shall be in addition to any other
3 penalties and remedies available at law, or in equity, to any person.

4 **Sec. 284.** RCW 81.04.020 and 1961 c 14 s 81.04.020 are each amended
5 to read as follows:

6 Each commissioner shall have power to administer oaths, certify to
7 all official acts, and to issue subpoenas for the attendance of
8 witnesses and the production of papers, waybills, books, accounts,
9 documents, and testimony in any inquiry, investigation, hearing, or
10 proceeding in any part of the state.

11 The superior court of the county in which any such inquiry,
12 investigation, hearing, or proceeding may be had, shall have power to
13 compel the attendance of witnesses and the production of papers,
14 waybills, books, accounts, documents, and testimony as required by such
15 subpoena. The commission or the commissioner before which the
16 testimony is to be given or produced, in case of the refusal of any
17 witness to attend or testify or produce any papers required by the

21 witnesses, or the production of said papers, and that the witness has
22 been summoned in the manner prescribed in this chapter, and that the

25 has failed and refused to attend or produce the papers required by the
26 subpoena, before the commission, in the cause or proceedings named in
27 the notice and subpoena, or has refused to answer questions propounded
28 to him or her in the course of such proceeding, and ask an order of
29 said court, compelling the witness to attend and testify before the
30 commission. The court, upon the petition of the commission, shall
31 enter an order directing the witness to appear before said court at a
32 time and place to be fixed by the court in such order, and then and
33 there show cause why he or she has not responded to said subpoena. A
34 copy of said order shall be served upon said witness. If it shall
35 appear to the court that said subpoena was regularly issued by the
36 commission, the court shall thereupon enter an order that said witness
37 appear before the commission at said time and place as fixed in said

1 order, and testify or produce the required papers, and upon failing to
2 obey said order, said witness shall be dealt with as for contempt of
3 court.

6 Each witness who appears under subpoena shall receive for his or
7 her attendance four dollars per day and ten cents per mile traveled by

19 the attendance of witnesses at any place within the state.

22 The commission and each commissioner, or any person employed by the
23 commission, shall have the right, at any and all times, to inspect the
24 accounts, books, papers, and documents of any public service company,

26 officer, agent, or employee of such public service company in relation
27 thereto, and with reference to the affairs of such company: PROVIDED,
28 That any person other than a commissioner who shall make any such
29 demand shall produce his or her authority from the commission to make
30 such inspection.

31 **Sec. 288.** RCW 81.04.120 and 1961 c 14 s 81.04.120 are each amended
32 to read as follows:

33 At the time fixed for the hearing mentioned in RCW 81.04.110, the
34 complainant and the person or corporation complained of shall be

1 entitled to be heard and introduce such evidence as he or she or it may
2 desire. The commission shall issue process to enforce the attendance
3 of all necessary witnesses. At the conclusion of such hearing, the
4 commission shall make and render findings concerning the subject matter
5 and facts inquired into and enter its order based thereon. A copy of
6 such order, certified under the seal of the commission, shall be served

8 provision of this title, or any rule or regulation adopted by the

22 forfeiture; but no person or corporation shall be prosecuted, punished,
23 or subjected to any penalty or forfeiture for or on account of any

26 proceedings under this section: PROVIDED, That no person so testifying
27 shall be exempt from prosecution or punishment for any perjury

12 All moneys collected under the provisions of this chapter shall
13 within thirty days be paid to the state treasurer and by him or her
14 deposited to the public service revolving fund.

16 to read as follows:

17 The commission shall investigate all accidents that may occur upon
18 the lines of any common carrier resulting in loss of life, to any
19 passenger or employee, and may investigate any and all accidents or
20 wrecks occurring on the line of any common carrier. Notice of the
21 investigation shall be given in all cases for a sufficient length of
22 time to enable the company affected to participate in the hearing and
23 may be given orally or in writing, in such manner as the commission may

27 and fix the responsibility therefor. The examination and investigation

22 hundred dollars nor more than five hundred dollars, or by imprisonment
23 in the county jail of the county where the misdemeanor is committed,
24 not exceeding six months.

27 Any railroad operating within this state, shall not employ or use
28 as (~~flagman~~) flagger any person or persons who cannot read, write,

32 It shall be the duty of the inspector of tracks, bridges,
33 structures, and equipment, and such deputies as may be appointed, to
34 inspect all equipment, and appliances connected therewith, and all
35 apparatus, tracks, bridges and structures, depots and facilities and
36 accommodations connected therewith, and facilities and accommodations

1 furnished for the use of employees, and make such reports of his or her
2 inspection to the commission as may be required. He or she shall, on

22 or she shall also report to the commission the violation of any law

26 The inspector, or such deputies as may be appointed, shall have the
27 right and privilege of riding on any locomotive, either on freight or

31 locomotive or caboose may require such inspector to produce his or her

1 Every person, company, or corporation having the control or
2 management of any railroad shall, outside of any corporate city or

6 or corporation operating the same, a substantial fence, and at every
7 point where any roadway or other public highway shall cross said

16 The term "commission," when used in this chapter, means the
17 utilities and transportation commission of Washington.

19 and county roads, streets, alleys, avenues, boulevards, parkways, and
20 other public places actually open and in use, or to be opened and used,
21 for travel by the public.

22 The term "railroad," when used in this chapter, means every
23 railroad, including interurban and suburban electric railroads, by
24 whatsoever power operated, for the public use in the conveyance of
25 persons or property for hire, with all bridges, ferries, tunnels,
26 equipment, switches, spurs, sidings, tracks, stations, and terminal
27 facilities of every kind, used, operated, controlled, managed, or owned
28 by or in connection therewith. The said term shall also include every
29 logging and other industrial railway owned or operated primarily for
30 the purpose of carrying the property of its owners or operators or of
31 a limited class of persons, with all tracks, spurs, and sidings used in
32 connection therewith. The said term shall not include street railways
33 operating within the limits of any incorporated city or town.

34 The term "railroad company," when used in this chapter, includes
35 every corporation, company, association, joint stock association,
36 partnership, or person, its, their, or his or her lessees, trustees, or

1 receivers appointed by any court whatsoever, owning, operating,
2 controlling, or managing any railroad, as that term is defined in this
3 section.

4 The term "over-crossing," when used in this chapter, means any
5 point or place where a highway crosses a railroad by passing above the
6 same.

7 The term "under-crossing," when used in this chapter, means any
8 point or place where a highway crosses a railroad by passing under the
9 same.

10 The term "over-crossing" or "under-crossing," shall also mean any
11 point or place where one railroad crosses another railroad not at
12 grade.

13 The term "grade crossing," when used in this chapter, means any
14 point or place where a railroad crosses a highway or a highway crosses
15 a railroad or one railroad crosses another, at a common grade.

16 **Sec. 303.** RCW 81.53.030 and 1984 c 7 s 373 are each amended to
17 read as follows:

18 Whenever a railroad company desires to cross a highway or railroad
19 at grade, it shall file a written petition with the commission setting
20 forth the reasons why the crossing cannot be made either above or below
21 grade. Whenever the legislative authority of a county, or the
22 municipal authorities of a city, or the state officers authorized to
23 lay out and construct state roads, or the state parks and recreation
24 commission, desire to extend a highway across a railroad at grade, they
25 shall file a written petition with the commission, setting forth the
26 reasons why the crossing cannot be made either above or below grade.
27 Upon receiving the petition, the commission shall immediately
28 investigate it, giving at least ten days' notice to the railroad

1 right to construct a grade crossing at the point in question. The
2 commission may provide in the order authorizing a grade crossing, or at

4 maintain proper signals, warnings, (~~flagmen~~) flaggers, interlocking
5 devices, or other devices or means to secure the safety of the public
6 and its employees. In respect to existing railroad grade crossings
7 over highways the construction of which grade crossings was
8 accomplished other than under a commission order authorizing it, the
9 commission may in any event require the railroad company to install and
10 maintain, at or near each crossing, on both sides of it, a sign known
11 as the sawbuck crossing sign with the lettering "Railroad Crossing"
12 inscribed thereon with a suitable inscription indicating the number of
13 tracks. The sign shall be of standard design conforming to
14 specifications furnished by the Washington state department of
15 transportation.

16 **Sec. 304.** RCW 81.53.120 and 1961 c 14 s 81.53.120 are each amended
17 to read as follows:

18 Whenever two or more lines of railroad owned or operated by
19 different companies cross a highway, or each other, by an over-
20 crossing, under-crossing, or grade crossing required or permitted by

22 expense of making such crossing not chargeable to any municipality,
23 county, or to the state, and the expense of constructing and

33 companies, a hearing for that purpose shall be held, at least ten days'
34 notice of which shall be given.

35 **Sec. 305.** RCW 81.53.261 and 2007 c 234 s 99 are each amended to
36 read as follows:

1 Whenever the secretary of transportation or the governing body of
2 any city, town, or county, or any railroad company whose road is
3 crossed by any highway, shall deem that the public safety requires
4 signals or other warning devices, other than sawbuck signs, at any
5 crossing of a railroad at common grade by any state, city, town, or
6 county highway, road, street, alley, avenue, boulevard, parkway, or
7 other public place actually open and in use or to be opened and used
8 for travel by the public, he or she or it shall file with the utilities
9 and transportation commission a petition in writing, alleging that the
10 public safety requires the installation of specified signals or other
11 warning devices at such crossing or specified changes in the method and
12 manner of existing crossing warning devices. Upon receiving such
13 petition, the commission shall promptly set the matter for hearing,
14 giving at least twenty days notice to the railroad company or companies
15 and the county or municipality affected thereby, or the secretary of
16 transportation in the case of a state highway, of the time and place of
17 such hearing. At the time and place fixed in the notice, all persons
18 and parties interested shall be entitled to be heard and introduce
19 evidence, which shall be reduced to writing and filed by the
20 commission. If the commission shall determine from the evidence that
21 public safety does not require the installation of the signal, other
22 warning device or change in the existing warning device specified in
23 the petition, it shall make determinations to that effect and enter an
24 order denying said petition in toto. If the commission shall determine
25 from the evidence that public safety requires the installation of such
26 signals or other warning devices at such crossing or such change in the
27 existing warning devices at said crossing, it shall make determinations
28 to that effect and enter an order directing the installation of such
29 signals or other warning devices or directing that such changes shall
30 be made in existing warning devices. The commission shall also at said
31 hearing apportion the entire cost of installation and maintenance of
32 such signals or other warning devices, other than sawbuck signs, as
33 provided in RCW 81.53.271: PROVIDED, That upon agreement by all
34 parties to waive hearing, the commission shall forthwith enter its
35 order.

36 No railroad shall be required to install any such signal or other
37 warning device until the public body involved has either paid or

1 executed its promise to pay to the railroad its portion of the
2 estimated cost thereof.

3 Nothing in this section shall be deemed to foreclose the right of
4 the interested parties to enter into an agreement, franchise, or permit
5 arrangement providing for the installation of signals or other warning
6 devices at any such crossing or for the apportionment of the cost of

21 under this section shall be subject to review, supersedeas, and appeal
22 as provided in chapter 34.05 RCW.

23 Nothing in this section shall be deemed to relieve any railroad
24 from liability on account of failure to provide adequate protective
25 devices at any such crossing.

23 real and/or personal property of any company shall be subject to
24 visitation, investigation, examination, and/or listing at any and all
25 times by the department, or any person officially designated by the
26 director.

23 assessed stock of merchandise, as that word is defined in this section,

27 percentage determined by dividing the amount of such merchandise

7 labeling, or relabeling shall not be considered as a change in form
8 within the meaning of this section. A taxpayer who has made no
9 shipments of merchandise, either out-of-state or in-state, during the
10 preceding year, may compute the percentage to be applied to the stock
11 of merchandise on the basis of his or her experience from March 1st of
12 the preceding year to the last day of February of the current year, in
13 lieu of computing the percentage on the basis of his or her experience
14 during the preceding year. The rule of strict construction shall not
15 apply to this section.

16 All rights, title, or interest in or to any aircraft parts,
17 equipment, furnishings, or accessories (but not engines or major
18 structural components) which are manufactured outside of the state of
19 Washington and are owned by purchasers of the aircraft constructed,
20 under construction or to be constructed in the state of Washington, and
21 are shipped into the state of Washington for installation in or use in
22 connection with the operation of such aircraft shall be exempt from
23 taxation prior to and during construction of such aircraft and while
24 held in this state for periods preliminary to and during the
25 transportation of such aircraft from the state of Washington.

21 An exempt property owner shall notify the department of revenue of
22 any change of use prior to each assessment year. Any other person

26 or she shall report the information to the department with a
27 recommendation that the exempt status be canceled. The final
28 determination shall be made by the department.

30 read as follows:

31 Any applicant aggrieved by the department of revenue's denial of an
32 exemption application may petition the state board of tax appeals to
33 review an application for either real or personal property tax

1 the property is entitled to an exemption, and (2) the amount or portion
2 thereof.

3 A county assessor of the county in which the exempted property is
4 located shall be empowered to appeal to the state board of tax appeals

6 department of revenue which he or she feels is not warranted.

7 Appeals from a department of revenue decision must be made within
8 thirty days after the mailing of the approval or denial.

13 Any person deeming himself or herself aggrieved by the assessment

23 ordered paid by the court, as provided in this chapter, may apply to

26 order directing the payment to such claimant of the portion of such
27 money as he or she or it may be found entitled to; but if, upon
28 application, the court or judge thereof shall decide that the title to

36 Upon the entry of the judgment upon the verdict of the jury, the

1 clerk of said court shall immediately prepare a transcript, which shall
2 contain a list of the names of all the persons and corporations
3 benefited by said improvement and the amount of benefit derived by
4 each, respectively, and shall duly certify the same, together with a
5 list of the lands benefited by said improvement belonging to each
6 person and corporation, and shall file the same with the auditor of the
7 county, who shall immediately enter the same upon the tax rolls of his
8 or her office, as provided by law for the entry of other taxes, against
9 the land of each of the said persons named in said list, together with
10 the amounts thereof, and the same shall be subject to the same interest
11 and penalties in case of delinquency as in case of general taxes, and
12 shall be collected in the same manner as other taxes and subject to the
13 same right of redemption, and the lands sold for the collection of said
14 taxes shall be subject to the same right of redemption as the sale of
15 lands for general taxes: PROVIDED, That said assessments shall not
16 become due and payable except at such time or times and in such amounts
17 as may be designated by the board of commissioners of said drainage
18 district, which designation shall be made to the county auditor by said
19 board of commissioners of said drainage district, by serving written
20 notice upon the county auditor designating the time and the amount of
21 the assessment, said assessment to be in proportion to benefits to
22 become due and payable, which amount shall fall due at the time of the
23 falling due of general taxes, and the amount so designated shall be
24 added by the auditor to the general taxes of said person, persons, or
25 corporation, according to said notice, upon the assessment rolls in his
26 or her said office, and collected therewith; PROVIDED FURTHER, That no
27 one call for assessments by said commissioners shall be in an amount to
28 exceed twenty-five percent of the amount estimated by the board of
29 commissioners to be necessary to pay the costs of the proceedings, and
30 the establishment of said district and drainage system and the cost of
31 construction of said work; PROVIDED FURTHER, That where the amount
32 realized from the original assessment and tax shall not prove
33 sufficient to complete the original plans and specifications of any
34 drainage system, alterations, extensions, or changes therein, for which
35 the said original assessment was made, the board of commissioners of
36 said district shall make such further assessment as may be necessary to
37 complete said system according to the original plans and

1 specifications, which assessment shall be made and collected in the
2 manner provided in this section for the original assessment.

3 **Sec. 394.** RCW 85.06.180 and 1895 c 115 s 18 are each amended to
4 read as follows:

5 After the filing of said certificate said commissioners of such
6 drainage district shall proceed at once in the construction of said
7 improvement, and in carrying on said construction or any extensions
8 thereof they shall have full charge and management thereof, and shall
9 have the power to employ such assistance as they may deem necessary and
10 purchase all material that may be necessary in the construction and
11 carrying on of the work of said improvement, and shall have power to
12 let the whole or any portion of said work to any responsible
13 contractor, and shall in such case enter into all necessary agreements
14 with such contractor that may be necessary in the premises: PROVIDED,
15 That in case the whole or any portion of said improvement is let to any
16 contractor said commissioners shall require said contractor to give a
17 bond in double the amount of the contract price of the whole or of such
18 portion of said work covered by said contract, with two or more
19 sureties to be approved by the board of commissioners of said drainage
20 district and running to said district as obligee therein, conditioned
21 for the faithful and accurate performance of said contract by said
22 contractor, his or her executors, administrators, or assigns, according

24 contractor to enter into a further or additional bond in the same
25 amount, with two or more good and sufficient sureties to be approved by
26 said board of commissioners of said drainage district in the name of
27 said district as obligee therein, conditioned that said contractor, his
28 or her executors, administrators, or assigns, or subcontractor, his or
29 her executors, administrators, or assigns, performing the whole or any
30 portion of said work under contract of said original contractor, shall
31 pay or cause to be paid all just claims for all persons performing
32 labor or rendering services in the construction of said work, or
33 furnishing materials, merchandise, or provisions of any kind or
34 character used by said contractor or subcontractor, or any employee
35 thereof in the construction of said improvement: PROVIDED FURTHER,
36 That no sureties on said last mentioned bond shall be liable thereon
37 unless the persons or corporation performing said labor and furnishing

1 said materials, goods, wares, merchandise, and provisions, shall,
2 within ninety days after the completion of said improvement, file their
3 claim, duly verified; that the amount is just and due and remains
4 unpaid, with the board of commissioners of said drainage district.

5 **Sec. 395.** RCW 85.06.210 and 1895 c 115 s 21 are each amended to
6 read as follows:

7 Any person or corporation owning land within said district shall
8 have a right to connect any private drains or ditches for the proper
9 drainage of such land with said system, and in case any persons or
10 corporations shall desire to drain such lands into said system and
11 shall find it necessary, in order to do so, to procure the right-of-way
12 over the land of another, or others, and if consent thereto cannot be
13 procured from such person or persons, then such landowner may present
14 in writing a request to the board of commissioners of said district,
15 setting forth therein the necessity of being able to connect his or her
16 private drainage with said system, and pray therein that said system be
17 extended to such point as he or she may designate in said writing, and
18 immediately thereon said board of commissioners shall cause a petition

28 proceedings shall be paid from the assessment of benefits to be made on
29 the lands of the person or persons benefited by such extension, and the
30 assessment and compensation for the right-of-way, damages and benefits,
31 and payment of damages and compensation, and the collection of the
32 assessments for benefits, shall be the same as in the proceedings under
33 the original petition, and the construction of the said extension shall
34 be made under the same provisions as the construction of the original
35 improvement; and all things that may be done or performed in connection
36 therewith shall be, as near as may be applicable, in accordance with
37 the provisions already set forth herein for the establishment and

1 construction of said original improvement: PROVIDED, That such
2 petitioner or petitioners shall, at the time of filing such petition by
3 said drainage commissioners, enter into a good and sufficient bond to
4 said drainage district in the full penal sum of five hundred dollars,
5 with two or more sureties, to be approved by the court, conditioned for
6 the payment of all costs in case the prayer of said petition should not
7 be granted, which bond shall be filed in said cause.

8 **Sec. 396.** RCW 85.06.250 and 1985 c 396 s 42 are each amended to
9 read as follows:

10 The board of commissioners of such district shall elect one of
11 their number ((~~chairman~~)) chair and shall either elect one of their
12 number, or appoint a voter of the district, as secretary, who shall
13 keep minutes of all the district's proceedings. The board of
14 commissioners may issue warrants of such district in payment of all
15 claims of indebtedness against such district, which shall be in form
16 and substance the same as county warrants, or as near the same as may
17 be practicable, and shall draw the legal rate of interest from the date
18 of their presentation to the treasurer for payment, as hereinafter
19 provided, and shall be signed by the ((~~chairman~~)) chair and attested by

29 not paid for want of funds; and no warrant shall draw interest under
30 the provisions of this chapter until it is so presented and indorsed by

8 created under the provisions of an act of the legislature of the state
9 of Washington, entitled "An act to provide for the establishment and
10 creation of drainage districts, and the construction and maintenance of
11 a system of drainage, and to provide for the means of payment thereof,
12 and declaring an emergency", approved March 20, 1895, and when the
13 drainage commissioners of such district have employed surveyors or
14 (~~draughtsmen~~) drafters, or legal assistance as provided in RCW
15 85.06.100, and have incurred expenses for the compensation of such
16 surveyors, (~~draughtsmen~~) drafters, and legal assistance, and have
17 issued to such surveyors, (~~draughtsmen~~) drafters, or persons

27 district for the purpose of paying such outstanding warrants, orders,
28 vouchers, or other evidences of indebtedness, together with interest
29 thereon.

30 **Sec. 399.** RCW 85.06.560 and 1903 c 67 s 2 are each amended to read
31 as follows:

32 The county auditor of any county in which such drainage district is
33 located upon the written request of any holder or owner of any such
34 warrant, order, voucher, or other evidence of indebtedness, mentioned
35 in the preceding section, shall forthwith cause to be published in the
36 newspaper doing the county printing, if any such there be, and if not,

1 then in some newspaper of general circulation in the county, a notice
2 directing any and all holders or owners of any such warrants, orders,
3 vouchers, or other evidences of indebtedness, to present the same to
4 him or her, at his or her office, for registration within ninety days
5 from the date of the first publication of such notice; and such notice
6 shall be published once a week for six consecutive weeks. Said notice

23 **Sec. 400.** RCW 85.06.570 and 1903 c 67 s 3 are each amended to read
24 as follows:

25 At any time after the expiration of the time within which warrants,
26 orders, vouchers, or other evidences of indebtedness, may be registered
27 as provided in the preceding section, the holder or owner of any such
28 registered warrant, order, voucher, or other evidence of indebtedness,
29 may for himself or herself and in behalf of all other holders or owners
30 of such registered warrants, orders, vouchers, or other evidences of
31 indebtedness, file a petition in the superior court of the county in
32 which such drainage district is located praying for an order directing
33 the publication and posting of the notice hereinafter provided for, and
34 for a hearing upon said petition, and for an order directing the board
35 of county commissioners to assess the lands embraced within said
36 drainage district for the purpose of paying such registered warrants,

1 orders, vouchers, or other evidences of indebtedness and the costs of
2 the proceedings provided for in RCW 85.06.550 through 85.06.630. Said
3 petition shall set forth:

4 (1) That said drainage district was duly established and created,
5 giving the time.

6 (2) The facts in connection with the expenses incurred by the
7 drainage commissioners in the employment of surveyors, (~~draughtsmen~~)
8 drafters, or legal assistance and the issuance of such registered
9 warrants, orders, vouchers, or other evidences of indebtedness.

10 (3) The facts in connection with the compliance with the provisions
11 of RCW 85.06.550 through 85.06.630.

12 (4) A list of such registered warrants, orders, vouchers, or other
13 evidences of indebtedness showing the names of owners or holders, the
14 amounts, the date of issuance, the purpose for which issued, when shown
15 upon the face thereof, and the date of presentation for payment,
16 respectively.

17 **Sec. 401.** RCW 85.06.600 and 1903 c 67 s 6 are each amended to read
18 as follows:

19 At the time and place fixed in said order for the hearing of said
20 petition, or at such time to which the court may continue said hearing,
21 the court shall proceed to a hearing upon said petition and upon any
22 objections or exceptions which have been filed thereto. And upon it
23 appearing to the satisfaction of the court from the proofs offered in
24 support thereof that the allegations of said petition are true, the
25 said court shall ascertain the total amount of said registered
26 warrants, orders, vouchers, or other evidences of indebtedness with the
27 accrued interest and the costs of said proceedings, and thereupon the
28 said court shall enter an order directing the board of county

6 From any final order entered by the said superior court as above
7 provided for, any party to said proceeding feeling himself or herself
8 aggrieved thereby may seek appellate review, as provided by the general
9 appeal law of this state.

10 **Sec. 403.** RCW 85.06.750 and 1988 c 202 s 76 are each amended to
11 read as follows:

12 Upon the return of the verdict of the jury as provided in the
13 preceding section, if it shall appear to the court that the total
14 benefits found by the jury to have accrued to the lands of the district
15 is equal to or exceeds the actual cost of the improvement including the
16 increased cost of completing the same, the court shall enter its
17 judgment in accordance therewith, as supplemental to and in lieu of the
18 original decree fixing the benefits to the respective tracts of land,
19 and thereafter the assessment and levy for the original cost of the
20 construction of the improvement, including the indebtedness incurred
21 for completing the improvement together with interest at the legal rate
22 on the warrants issued therefor, and all assessments and levies if any,
23 for the future maintenance of the drainage system described in the
24 judgment shall be based upon the respective benefits determined and

31 **Sec. 404.** RCW 85.07.070 and 1983 c 167 s 190 are each amended to
32 read as follows:

33 (1) Said bonds shall be numbered consecutively from one upwards and
34 shall be in denominations of not less than one hundred dollars nor more
35 than one thousand dollars each. They shall bear the date of issue,

1 shall be made payable in not more than ten years from the date of their
2 issue, and shall bear interest at a rate or rates as authorized by the
3 board of commissioners, payable annually. The bonds may be in any
4 form, including bearer bonds or registered bonds as provided in RCW
5 39.46.030. The bonds and any coupon shall be signed by the

14 All outstanding warrants of such district so sought to be redeemed
15 shall become due and payable immediately upon receipt by the county
16 treasurer of the money from the sale of said bonds; and upon a call of
17 such outstanding warrants or obligations issued by him or her, the same
18 shall cease to draw interest at the end of thirty days after the date
19 of the first publication of such call. The call shall be made by the
20 treasurer by publishing notice thereof for two consecutive weeks in the
21 county paper authorized to do the county printing. The notice shall
22 designate the number of each warrant sought to be redeemed.

23 **Sec. 406.** RCW 85.07.120 and 1935 c 103 s 7 are each amended to
24 read as follows:

25 It shall be the duty of the county treasurer of each county in
26 which there may be a district issuing bonds under the provisions of RCW
27 85.07.060 through 85.07.120, whenever he or she has on hand one
28 thousand dollars over and above interest requirements in the special
29 fund for the payment of said bonds and interest, to advertise in the
30 newspaper doing the county printing, for the presentation to him or her
31 for payment of as many of the bonds issued under the provisions of RCW
32 85.07.060 through 85.07.120 as he or she may be able to pay with the
33 funds in his or her hands. The bonds shall be redeemed and paid in
34 their numerical order, beginning with bond No. 1 and continuing until
35 all of said bonds are paid. The treasurer's call for presentation and
36 redemption of such bonds shall state the number of the bond or bonds so

1 called. Thirty days after the first publication of said notice of the
2 treasurer calling any of said bonds by their numbers, such bonds shall
3 cease to bear interest, and the notice of call shall so state. If any
4 bond so called is not presented, the treasurer shall hold in said fund
5 until presentation of such bond is made, the amount of money sufficient
6 to redeem the same with interest thereon to the date interest was
7 terminated by such call.

8 **Sec. 407.** RCW 85.07.140 and 1935 c 102 s 2 are each amended to
9 read as follows:

10 If the court is satisfied that the status of said property has
11 changed so that it is no longer susceptible to benefit from the
12 improvement of such district and should be removed from the assessment
13 roll thereof, and it be established that all benefits assessed against
14 said lands up to the date of trial have been paid, such court may enter
15 a decree striking such land from the assessment roll of said district,
16 and it shall not be subject to future assessment for benefits or
17 maintenance by such district, unless, thereafter, it is again brought
18 into such districts by the proceedings provided by law to extend the
19 district or include benefited property which is not assessed. Nothing
20 herein shall prevent such property from being again brought into said

29 **Sec. 408.** RCW 85.08.340 and 1917 c 130 s 29 are each amended to
30 read as follows:

31 Whenever in the progress of the construction of the system of
32 improvement it shall become necessary to construct a portion of such
33 system across any public or other road or public utility, the board of
34 supervisors, or in case the work is being done by contract the board of
35 county commissioners, shall serve notice in writing upon the public
36 officers, corporation, or person having charge of, or controlling or

1 owning such road or public utility, as the case may be, of the present
2 necessity of such crossing, giving the location, kind, dimensions, and
3 requirement thereof, for the purpose of the system of improvement, and
4 stating a reasonable time, to be fixed by the county engineer, within
5 which plans for such crossing must be filed for approval in case the
6 public officers, corporation, or person controlling or owning such road
7 or public utility desire to construct such crossing. As soon as
8 convenient, within the time fixed in the notice, the public officers,
9 corporation, or person shall, if they desire to construct such
10 crossing, prepare and submit to the county engineer for approval
11 duplicate detailed plans and specifications for such crossing. Upon
12 submission of such plans, the county engineer shall examine and may
13 modify the same to meet the requirements of the system of improvement,
14 and when such plans or modified plans are satisfactory to the county
15 engineer, he or she shall approve the same and return one thereof to
16 the public officers, corporation, or person submitting the same, and
17 file the duplicate in his or her office, and shall notify such public
18 officers, corporation, or person of the time within which said crossing
19 must be constructed. Upon the return of such approved plans, the
20 public officers, corporation, or person controlling such road or public
21 utility shall, within the time fixed by the county engineer, construct
22 such crossing in accordance with the approved plans, and shall
23 thereafter maintain the same. In case such public officers,
24 corporation, or person controlling or owning such road or public
25 utility shall fail to file plans for such crossing within the time
26 prescribed in the notice, the board of supervisors or of county
27 commissioners, as the case may be, shall proceed with the construction
28 of such crossing in such manner as will cause no unnecessary injury to
29 or interference with such road or public utility. The cost of
30 construction and maintenance of only such crossings or such portion of
31 such cost as would not have been necessary but for the construction of
32 the system of improvement shall be a proper charge against the
33 improvement district, and only so much of such cost as the board of
34 county commissioners shall deem reasonable shall be allowed as a charge
35 against the district in the case of crossings constructed by others
36 than the district. The amount of costs of construction allowed as a
37 charge against the district by the board of county commissioners shall

1 be credited on the assessments against the property on which the
2 crossing is constructed, and any excess over such assessment shall be
3 paid out of the funds of the district.

4 **Sec. 409.** RCW 85.08.360 and 1917 c 130 s 30 are each amended to
5 read as follows:

6 When the improvement is fully completed and accepted by the county
7 engineer, the clerk of the board shall compile and file with the board
8 of county commissioners an itemized statement of the total cost of
9 construction, including engineering and election expenses, the cost of
10 publishing and posting notices, damages, and costs allowed or awarded
11 for property taken or damaged, including compensation of attorneys,
12 including the costs of crossings constructed by the district and the
13 cost of crossings constructed by others and allowed by the board of
14 county commissioners, and including the sum paid or to be paid to the
15 United States, and the discount, if any, on the bonds and warrants sold
16 and including all other costs and expenses, including fees, per diem,
17 and necessary expenses of nonsalaried officers incurred in connection
18 with the improvement, together with interest on such costs and expenses
19 from the time when incurred at the rate of interest borne by the
20 warrants issued for the cost of construction. There shall also be
21 included in said statement, in case the county engineer is a salaried
22 officer, a statement of the services performed by him or her in
23 connection with said improvement at a per diem of five dollars per day
24 and his or her necessary expenses, and a reasonable sum to be fixed by
25 the board of county commissioners on account of the services rendered
26 by the prosecuting attorney. Upon the filing of such statement of
27 costs and expenses the board of county commissioners shall revise and
28 correct the same if necessary and add thereto a reasonable sum which
29 shall be not less than five percent nor more than ten percent of the
30 total thereof in drainage improvement districts, and not less than ten
31 percent nor more than fifteen percent of the total thereof in diking
32 improvement districts, to cover possible errors in the statement or the
33 apportionment hereinafter provided for, and the cost of such
34 apportionment and other subsequent expenses, and interest on the costs
35 of construction from the date of the statement until fifty days after
36 the filing of the assessment roll with the treasurer; and unless the
37 same have been previously appointed, shall appoint a board of

1 appraisers consisting of the county engineer and two other competent
2 persons, to apportion the grand total as contained in said statement as
3 hereinafter provided. Each member of said board of appraisers shall
4 take, subscribe, and file with the board of county commissioners an
5 oath to faithfully and impartially perform his or her duties to the
6 best of his or her ability in making said apportionment, and said board
7 of appraisers shall proceed to carefully examine the system and the
8 public and private property within the district and fairly, justly, and
9 equitably apportion the grand total cost of the improvement against the
10 property and the county or counties, cities, and towns within the
11 district, in proportion to the benefits accruing thereto.

12 **Sec. 410.** RCW 85.08.400 and 1984 c 7 s 377 are each amended to
13 read as follows:

14 Upon the filing of the schedule of apportionment, the county
15 legislative authority shall fix the time and place for a hearing
16 thereon, which time shall be not more than sixty days from the date of
17 the filing of the schedule. Notice of the hearing shall be given in
18 the manner provided for giving notice of a hearing in RCW 85.08.150.
19 The notice shall fix the time and place of the hearing on the roll, and
20 shall state that the schedule of apportionment showing the amount of
21 the cost of the improvement apportioned to each county, city, town, and
22 piece of property benefited by the improvement is on file in the office
23 of the county legislative authority and is open to public inspection,
24 and shall notify all persons who may desire to object thereto that they
25 may make their objections in writing and file them with the clerk of
26 the county legislative authority at or before the date fixed for the
27 hearing. The notice shall also state that at the time and place fixed
28 and at such other times and places as the hearing may be continued to,
29 the county legislative authority will sit as a board of equalization
30 for the purpose of considering the schedule and at the hearing or
31 hearings will also consider any objections made thereto, or any part
32 thereof, and will correct, revise, raise, lower, change, or modify the
33 schedule or any part thereof, or set aside the schedule and order that
34 the apportionment be made de novo as to such body shall appear just and
35 equitable, and that at the hearing the board will confirm the schedule
36 as finally approved by them and will levy an assessment against the
37 property described thereon for the amounts as fixed by them. The

1 county legislative authority shall serve by mail, at least ten days
2 before the hearing, upon the commissioner of public lands of the state
3 of Washington a like notice, in duplicate, showing the amount of the
4 cost of the improvements apportioned against all state, school,
5 granted, or other lands owned by the state of Washington in the
6 district. The county legislative authority shall serve a like notice
7 upon the state secretary of transportation showing the amount
8 apportioned against any state primary or secondary highways. Upon
9 receipt of the notice the commissioner of public lands or the secretary
10 of transportation, as the case may be, shall endorse thereon a
11 statement either that he or she elects to accept or that he or she
12 elects to contest the apportionment, and shall return the notice, so
13 endorsed, to the county legislative authority. At or before the
14 hearing any person interested may file with the clerk of the county
15 legislative authority written objections to any item or items of the
16 apportionment.

17 **Sec. 411.** RCW 85.08.410 and 1983 c 3 s 230 are each amended to
18 read as follows:

19 At such hearing, which may be adjourned from time to time and from
20 place to place, until finally completed, the board of county
21 commissioners shall carefully examine and consider said schedule and
22 any objections filed or made thereto and shall correct, revise, raise,
23 lower, change, or modify such schedule or any part thereof, or strike
24 therefrom any property not benefited, or set aside such schedule and
25 order that such apportionment be made de novo, as to such body shall
26 appear equitable and just. The board shall cause the clerk of the
27 board to enter on such schedule all such additions, cancellations,
28 changes, modifications, and reapportionments, all credits for damages
29 allowed or awarded to the owner of any piece of property benefited, but
30 not paid, as provided in RCW 85.08.200; also a credit in favor of the
31 county on any apportionment against the county, of all sums paid on
32 account of said improvement, as provided in RCW 85.08.210; and all sums
33 allowed the county on account of services rendered by the county
34 engineer or prosecuting attorney, as provided in RCW 85.08.360; and all
35 credits allowed to property owners constructing crossings as provided
36 in RCW 85.08.340. When the board of county commissioners shall have
37 finally determined that the apportionment as filed or as changed and

1 modified by the board is a fair, just and equitable apportionment, and
2 that the proper credits have been entered thereon, the members of the
3 board approving the same shall sign the schedule and cause the clerk of
4 the board to attest their signature under his or her seal, and shall
5 enter an order on the journal approving the final apportionment and all
6 proceedings leading thereto and in connection therewith, and shall levy
7 the amounts so apportioned against the property benefited, and the
8 determination by the board of county commissioners in fixing and
9 approving such apportionment and making such levy shall be final and
10 conclusive.

11 The board of county commissioners shall also at said hearing, levy,
12 in the manner hereinafter provided for the levy of maintenance
13 assessments, such assessment as they shall deem necessary to provide
14 funds for the maintenance of the system of improvement until the first
15 annual assessment for maintenance shall fall due.

16 **Sec. 412.** RCW 85.08.420 and 1923 c 46 s 9 are each amended to read
17 as follows:

18 Upon the approval of said roll the county auditor shall immediately
19 prepare a completed assessment roll which shall contain, first, a map
20 of the district showing each separate description of property assessed;
21 second, an index of the schedule of apportionments; third, an index of
22 the record of the proceedings had in connection with the improvement;
23 fourth, a copy of the resolution of the board of county commissioners
24 fixing the method of payment of assessments; fifth, the warrant of the
25 auditor authorizing the county treasurer to collect assessments; and
26 sixth, the approved schedule of apportionments of assessments; and
27 shall charge the county treasurer with the total amount of assessment
28 and turn the roll over to the treasurer, for collection in accordance
29 with the resolution of the board of county commissioners fixing the
30 method of payment of assessments. As soon as the assessment roll has
31 been turned over to the treasurer for collection, he or she shall
32 publish a notice in the official newspaper of the county for once a
33 week for at least two consecutive weeks, that the said roll is in his
34 or her hands for collection and that any assessment thereon or any
35 portion of any such assessment may be paid at any time on or before a
36 date stated in such notice, which date shall be thirty days after the
37 date of the first publication, without interest, and the treasurer

1 shall accept such payment as in said notice provided. Upon the
2 expiration of such thirty-day period the county treasurer shall certify
3 to the county auditor the total amount of assessments so collected by
4 him or her and the total amount of assessments remaining unpaid upon
5 said roll.

6 **Sec. 413.** RCW 85.08.440 and 1988 c 202 s 77 are each amended to
7 read as follows:

8 The decision of the board of county commissioners upon any
9 objections made within the time and in the manner prescribed in RCW
10 85.08.400 through 85.08.430, may be reviewed by the superior court upon
11 an appeal thereto taken in the following manner. Such appeal shall be
12 made by filing written notice of appeal with the clerk of such board
13 and with the clerk of the superior court of the county in which such
14 drainage or diking improvement district is situated, or in case of
15 joint drainage or diking improvement districts with the clerk of the
16 court of the county in which the greater length of such drainage or
17 diking improvement system lies, within ten days after the order
18 confirming such assessment roll shall have become effective, and such
19 notice shall describe the property and set forth the objections of such
20 appellant to such assessment; and, within ten days from the filing of
21 such notice of appeal with the clerk of the superior court, the
22 appellant shall file with the clerk of said court a transcript
23 consisting of the assessment roll and his or her objections thereto,
24 together with the order confirming such assessment roll, and the record
25 of the board of county commissioners with reference to said assessment,
26 which transcript, upon payment of the necessary fees therefor, shall be
27 furnished by such clerk of the board of county commissioners, and by
28 him or her certified to contain full, true, and correct copies of all
29 matters and proceedings required to be included in such transcript.
30 Such fees shall be the same as the fees payable to the county clerk for
31 the preparation and certification of transcripts on appeal to the
32 supreme court or the court of appeals in civil actions. At the time of
33 the filing of the notice of appeal with the clerk of the superior
34 court, the appellant shall execute and file with the clerk of the
35 superior court a sufficient bond in the penal sum of two hundred
36 dollars, with good and sufficient surety, to be approved by the judge
37 of said court, conditioned to prosecute such appeal without delay, and

1 if unsuccessful, to pay all costs to which the county or the drainage
2 or diking improvement district is put by reason of such appeal. The
3 court may order the appellant upon application therefor, to execute and
4 file such additional bond or bonds as the necessity of the case may
5 require; within three days after such transcript is filed in the
6 superior court as aforesaid, the appellant shall give written notice to
7 the prosecuting attorney of the county, and to the clerk of the board
8 of county commissioners that such transcript is filed. Said notice
9 shall state a time (not less than three days from the service thereof)
10 when the appellant will call up the said cause for hearing; and the
11 superior court of said county shall, at said time or at such further
12 time as may be fixed by order of the court, hear and determine such
13 appeal without a jury. The judgment of the court shall confirm,
14 correct, modify, or annul the assessment insofar as the same affects
15 the property of the appellant. A certified copy of the decision of the
16 court shall be filed with the officer who shall have custody of the
17 assessment roll, and he or she shall modify and correct such assessment
18 roll in accordance with such decision. Appellate review of the
19 judgment of the superior court may be sought as in other civil cases.
20 However, the review must be sought within fifteen days after the date
21 of the entry of the judgment of such superior court. A certified copy
22 of the order of the supreme court or the court of appeals upon such
23 appeal shall be filed with the officer having custody of such
24 assessment roll, who shall thereupon modify and correct such assessment
25 roll in accordance with such decision.

26 **Sec. 414.** RCW 85.08.490 and 1923 c 46 s 11 are each amended to
27 read as follows:

28 The purchaser, upon the foreclosure of any certificate of
29 delinquency for any assessment or installment thereof, shall acquire
30 title to such property subject to the installments of the assessment
31 not yet due at the date of the decree of foreclosure, and the
32 complaint, decree of foreclosure, order of sale, sale, certificate of
33 sale and deed shall so state.

34 The holder of any certificate of delinquency for general taxes may,
35 before commencing any action to foreclose the lien of such certificate,
36 pay in full all drainage or diking or sewerage improvement district
37 assessments or any installment thereof due and outstanding against the

1 whole or any portion of the property included in such certificate of
2 delinquency and the amount of all assessments so paid together with
3 interest at ten percent per annum thereon shall be included in the
4 amount for which foreclosure may be had; or, if he or she elects to
5 foreclose such certificate without paying such assessments in full, the
6 purchaser at such foreclosure sale shall acquire title to such property
7 subject to all such drainage or diking or sewerage improvement district
8 assessments. Any property in any drainage or diking or sewerage
9 improvement district sold under foreclosure for general taxes shall
10 remain subject to the lien of all drainage and diking or sewerage
11 improvement district assessments or installments thereof not yet due at
12 the time of the decree of foreclosure and the complaint, decree of
13 foreclosure, order of sale, sale, certificate of sale and deed shall so
14 state.

15 **Sec. 415.** RCW 85.08.500 and 1923 c 46 s 11 are each amended to
16 read as follows:

17 Property subject to a drainage or diking or sewerage improvement
18 district assessment, acquired by a county pursuant to a foreclosure and
19 sale for general taxes, when offered for sale by the county, shall be
20 offered for the amount of the general taxes for which the same was
21 struck off to the county, together with all drainage or diking or
22 sewerage improvement district assessments or installments thereof, due
23 at the time of such resale, including maintenance assessments, and
24 supplemental assessments levied pursuant to the provisions of RCW
25 85.08.520, coming due while the property was held in the name of the
26 county; and the property shall be sold subject to the lien of all
27 drainage or diking or sewerage improvement district assessments or
28 installments thereof not yet due at the time of such sale, and the
29 notice of sale and deed shall so state. PROVIDED, That the county
30 board may in its discretion, sell said property at a lesser sum than
31 the amount for which the property is offered in the notice of sale.
32 The proceeds of such sale shall be applied first to discharge in full
33 the lien or liens for general taxes for which said property was sold,
34 and the remainder, or such portion thereof as may be necessary, shall
35 be applied toward the discharge of all drainage or diking or sewerage
36 improvement district assessment liens upon such property, and the
37 surplus, if any, shall be applied toward the payment of any delinquent

1 or due local assessments or local assessment installments outstanding
2 against the property levied by any authority other than that of the
3 county, taking them in the order of their maturities, beginning with
4 the earliest; after which if any money remains the treasurer shall hold
5 the same for the person whose interest in the property entitles him or
6 her thereto. If there be no purchaser, the property shall again be
7 offered for sale within one year thereafter, and shall be successively
8 offered for sale each year until a sale thereof be effected.

9 Property struck off to or bid in by a county may be leased pursuant
10 to resolution of the county commissioners on such terms as the
11 commissioners shall determine for a period ending not later than the
12 time at which such property shall again be offered for sale as required
13 by law. Rentals received under such lease shall be applied in the
14 manner hereinabove provided for the proceeds of sale of such property.

15 All statements of general state taxes where drainage, diking, or
16 sewer improvement district assessments against the land described
17 therein are due shall include a notation thereon or be accompanied by
18 a statement showing such fact.

19 **Sec. 416.** RCW 85.08.570 and 1923 c 46 s 13 are each amended to
20 read as follows:

21 When a drainage, diking, or sewerage system is proposed which will
22 require a location, or the assessment of lands, in more than one
23 county, application therefor shall be made to the board of county
24 commissioners in each of said counties, and the county engineers shall
25 make preliminary reports for their respective counties. The lines of
26 such proposed improvement shall be examined by the county engineers of
27 the counties wherein said improvements will lie, jointly. The hearings
28 in regard to such improvements, provided for by RCW 85.08.150, and
29 85.08.400 through 85.08.430 shall be had by the boards of county
30 commissioners of the two counties in joint sessions, and all other
31 matters required to be done by the county commissioners in regard to
32 such improvement and the improvement district shall be had and done by
33 the boards of county commissioners of the counties wherein such system
34 of improvements shall lie, either in joint session at such place as the
35 said board shall order, or by concurrent order entered into by the said

18 shall furnish to the auditor of the other county duplicate copies of

20 of all proceedings had and papers filed in connection with such
21 improvements shall be kept, one with the auditor of each county.
22 Protests or other papers filed with the auditor who is not clerk of the
23 joint sessions shall be forwarded forthwith by him or her to the
24 auditor who acts as clerk of such joint sessions. The treasurer of
25 said county shall register and certify and pay the warrants and the
26 bonds, and shall have charge of the funds of the district; and to him
27 or her, the treasurer of the county in which the lesser portion of such
28 system of improvements lie, shall remit semiannually, in time for the
29 semiannual warrant and bond calls, all such collections made in such
30 other county. A drainage, diking, or sewerage improvement district
31 lying in more than one county shall be designated "joint drainage (or
32 diking) or sewerage improvement district No. . . . of and
33 counties." All proceedings in regard to joint drainage,
34 diking improvement districts, which have heretofore been had and done
35 substantially in accordance with the amendatory provisions of this
36 chapter are hereby approved and declared to be valid.

1 **Sec. 417.** RCW 85.08.820 and 1988 c 127 s 38 are each amended to
2 read as follows:

3 Whenever the department of ecology shall have purchased and the
4 state of Washington owns the entire issue of any series of bonds of any
5 county in the state, the payment of which is to be made from and is
6 secured by assessments upon the property included within any drainage
7 improvement district organized and existing in such county, and it
8 shall appear to the satisfaction of the director of ecology that owing
9 to and by reason of the nature of the soil within and the topography of
10 such drainage improvement district the lands contained therein were not
11 or will not be drained sufficiently to permit the cultivation thereof
12 within the time when assessments for the payment of the interest on
13 said bonds and to constitute a sinking fund to retire said bonds as
14 provided by law became or will become due, and that by reason thereof
15 the owners of said lands were or will be unable to meet said
16 assessment, the director of ecology shall have the power and he or she
17 is hereby authorized under such terms and conditions as he or she shall
18 deem advisable to enter into a contract in writing with the board of
19 county commissioners of the county issuing such bonds, waiving the
20 payment of interest upon such bonds from the date of their issue for
21 not to exceed five years, and extending the time of payment of said
22 bonds for not to exceed five years; and upon the execution of said
23 contract the board of county commissioners of said county shall have
24 the power and is hereby authorized to cancel all assessments made upon
25 the lands included within such drainage improvement district for the
26 payment of principal and/or interest on said bonds prior to the date of
27 said contract, and to omit the levy of any assessments for said
28 purposes until the expiration of the time of the waiver of interest
29 payments upon said bonds specified in said contract.

30 **Sec. 418.** RCW 85.08.840 and 1957 c 94 s 3 are each amended to read
31 as follows:

32 The boards of county commissioners of the counties in which a joint
33 drainage improvement district is situated shall have jurisdiction in
34 joint session to hear, supervise, and conduct the merger proceedings
35 relating to such a district. The auditor of the county in which the
36 greater length of the system of improvements lies shall act as clerk of
37 the joint sessions of the boards of county commissioners, and shall

1 give the notice provided for in RCW 85.08.870. He or she shall furnish
2 to the auditor of the other county duplicate copies of the records of
3 proceedings of the joint sessions. Duplicate records of all
4 proceedings had and papers filed in connection with the merger of a
5 joint drainage improvement district shall be kept with the auditor of
6 each county. The board of county commissioners of the county in which
7 a drainage improvement district or consolidated drainage improvement
8 district is situated shall have exclusive jurisdiction to hear,
9 supervise, and conduct merger proceedings relating to such districts.

10 **Sec. 419.** RCW 85.15.030 and 1973 1st ex.s. c 195 s 111 are each
11 amended to read as follows:

12 To operate under this chapter, the board of commissioners of the
13 improvement district shall cause to be prepared and filed with the
14 board of county commissioners a property roll. The roll shall contain:
15 (1) A description of all properties benefited and improvements thereon
16 which receive protection and service from the systems of the district
17 with the name of the owner or the reputed owner thereof and his or her
18 address as shown on the tax rolls of the assessor or treasurer of the
19 county wherein the property is located and (2) the determined value of
20 such land and improvements thereon as last assessed and equalized by
21 the assessor of such county or counties. Such assessed and equalized
22 values shall be deemed prima facie to be just, fair, and correct
23 valuations against which annual taxes shall be levied for the operation
24 of the district and the maintenance and expansion of its facilities.

25 If property outside of the limits of the original district are upon
26 the roll as adopted ultimately, and the original district has
27 outstanding bonds or long-term warrants, the board of county
28 commissioners shall set up separate dollar rate levies for the full
29 retirement thereof.

30 **Sec. 420.** RCW 85.15.090 and 1967 c 184 s 10 are each amended to
31 read as follows:

32 The decision of the board of county commissioners upon any
33 objection made within the time and in the manner prescribed may be
34 reviewed by the superior court of the county wherein the property in
35 question is located, upon appeal thereto taken in the following manner:
36 Any person aggrieved must file his or her petition for writ of review

1 with the clerk of the superior court wherein the property is located
2 within ten days after the roll affecting such aggrieved party was
3 adopted by resolution, and serve a copy thereof upon the county
4 treasurer. The petition shall describe the property in question, shall
5 set forth the written objections which were made to the decision, and
6 the date of filing of such objections, and shall be signed by such
7 party or someone in his or her behalf. The court shall forthwith grant
8 such petition if correct as to form and filed in accordance with this
9 chapter.

10 **Sec. 421.** RCW 85.15.110 and 1967 c 184 s 12 are each amended to
11 read as follows:

12 The county clerk shall charge the same filing fees for petitions
13 for review as in civil actions. At the time of the filing of such a
14 petition with the clerk, the appellant shall execute and file a bond in
15 the penal sum of two hundred dollars, with at least two sureties, to be
16 approved by the judge of the court, conditioned upon his or her
17 prosecuting his or her appeal without delay and to guarantee all costs
18 which may be assessed against him or her by reason of such review. The
19 court shall, on motion of either party to the cause, with notice to the
20 other party, set the cause for trial at the earliest time available to
21 the court, fixing a date for hearing and trial without a jury. The
22 cause shall have preference over all civil actions pending in the court
23 except eminent domain and forcible entry and detainer proceedings.

24 **Sec. 422.** RCW 85.15.150 and 1967 c 184 s 16 are each amended to
25 read as follows:

26 The board of any improvement district proceeding under this chapter
27 shall, on or before the first day of September of each year, make an
28 estimate of the costs reasonably anticipated to be required for the
29 effective functioning of the district during the ensuing year and until
30 further revenue therefor can be made available, and shall cause its
31 (~~chairman~~) chair or secretary to file the same with the board of
32 county commissioners of the county containing the district and other
33 benefited area. The board of county commissioners shall, on or before
34 the first Monday in October next ensuing, certify the amount of the
35 district's estimate, or such amount as it shall deem advisable, to the
36 county treasurer. The amount so certified shall be applied by the

1 regular taxing agencies against the benefit valuation of lands,

9 as general taxes and they shall be included in and be made a part of
10 any general tax foreclosure proceedings, according to the provisions of
11 law with relation to such foreclosures. As assessment collections are
12 made, the county treasurer shall credit the same to the funds of the
13 district.

14 **Sec. 423.** RCW 85.16.130 and 1949 c 26 s 9 are each amended to read
15 as follows:

16 At the hearing upon the report of the appraisers, which may be
17 adjourned from time to time until finally completed, the board shall
18 carefully examine and consider the special benefits and the
19 apportionment of estimated costs determined by the appraisers and
20 reported in the schedule or schedules, and any objections thereto which
21 shall have been made in writing and filed with the board on or prior to
22 ten o'clock a.m. of the date fixed for such hearing. Each objector
23 shall be given reasonable time and opportunity to submit evidence and
24 be heard on the merits of his or her objections. At the conclusion of
25 such hearing, the board shall so correct, revise, raise, lower, change,
26 or modify such schedule or schedules, or any part thereof, or strike
27 therefrom any property not specially benefited, as to said board shall
28 appear equitable and just. The board shall cause the clerk of the
29 board to enter on each such schedule or schedules all such additions,
30 cancellations, changes, and modifications made by it.

31 **Sec. 424.** RCW 85.16.150 and 1949 c 26 s 10 are each amended to
32 read as follows:

33 When the board shall have determined that the schedule or schedules
34 of benefits and/or apportionment of costs as filed or as changed and
35 modified by it are fair, just and equitable and, if estimated costs
36 have been apportioned, that said benefits equal or exceed said costs

1 apportioned, the members of the board approving the same shall sign
2 said schedule or schedules and cause the clerk of the board to attest
3 their signatures under his or her seal, and shall enter an order in the
4 journal approving and confirming the final determination of such
5 benefits and apportionment of costs and all proceedings leading thereto
6 and in connection therewith. If separate schedules be established for
7 maintenance of the diking system and of the drainage system, the board
8 shall by order establish two separate maintenance funds, one for the
9 maintenance of the diking system and one for the maintenance of the
10 drainage system.

11 **Sec. 425.** RCW 85.18.160 and 1951 c 45 s 17 are each amended to
12 read as follows:

13 The board of commissioners of any diking district proceeding under
14 this chapter shall, on or before the first day of November of each
15 year, make an estimate of the costs reasonably anticipated to be
16 required for the effective functioning of such district during the
17 ensuing year and until further revenue therefor can be made available,
18 and cause its (~~chairman~~) chair or secretary to certify the same on or
19 before said date to the county auditor, and the amount so certified
20 shall be levied by the regular taxing agencies against the base
21 benefits to the lands and buildings within such district as shown by
22 the then current complete roll of such properties and the determined
23 benefits thereto as therefore certified to and filed with such county
24 auditor by the commissioners of such district. When thus levied, the
25 amount of assessment produced thereby shall be added by the general
26 taxing authorities to the general taxes against said lands and
27 collected therewith as a part thereof. If unpaid, any delinquencies in
28 such assessments shall bear interest at the same rate and in the same
29 manner as general taxes and they shall be included in and be made a
30 part of any general tax foreclosure proceedings, according to the
31 provisions of law with relation to such foreclosures. As assessment
32 collections are made, the county treasurer shall credit the same to the
33 funds of such district.

34 **Sec. 426.** RCW 85.16.210 and 1988 c 202 s 80 are each amended to
35 read as follows:

36 At such hearing, which may be adjourned from time to time as may be

1 necessary to give all persons interested or affected a reasonable
2 opportunity to be heard, and after consideration of all evidence
3 offered and all factors, situations, and conditions bearing upon or
4 determinative of the benefits accruing and to accrue to such pieces or
5 parcels of property, the board shall correct, revise, raise, lower, or
6 otherwise change or confirm the benefits as theretofore determined, in
7 respect of such pieces or parcels of property, as to it shall seem
8 fair, just, and equitable under the circumstances, and thereafter such

11 consideration to the facts and the roll, will hear all objections
12 filed, will review the roll and alter, modify, or change the same
13 consistent with facts established and with equity and fair dealing
14 concerning the properties involved to the end that just levies will be
15 made for service and benefits received and to be received against each
16 property for the purposes mentioned; and at the hearing or continuance
17 thereof, it will adopt the roll in final form and certify and file a
18 copy thereof with the assessor and treasurer of the county wherein the
19 property is located; and will cause annual millage to be levied against
20 such established valuations for the purposes stated;

21 (4) That all persons desiring to object to the proceedings, to the
22 proposed base valuations, or to any other thing or matter in connection
23 with the proceedings, must file written objections with the board
24 stating clearly the basis of the objection before the time of the
25 hearing, or all objections will be deemed waived.

26 **Sec. 447.** RCW 85.32.170 and 1961 c 131 s 18 are each amended to
27 read as follows:

28 The decision of the board upon any objection made within the time
29 and in the manner prescribed in this chapter may be reviewed by the
30 superior court of the county wherein the property in question is
31 located. Any person aggrieved must file his or her petition for writ
32 of review with the clerk of the superior court wherein the property is
33 located within ten days after the roll affecting such aggrieved party
34 was adopted by resolution, and he or she shall serve a copy thereof
35 upon the board. The petition shall describe the property in question,
36 set forth the written objections which were made to the decision, give
37 the date of filing of such objections, and shall be signed by such

1 party or someone in his or her behalf. The court shall forthwith grant

6 A flood control district shall be managed by a board of directors
7 consisting of three members. The initial directors shall be appointed,

9 The directors shall elect a (~~chairman~~) chair from their number and
10 shall either elect one of their number, or appoint a voter of the
11 district, as secretary to hold office at its pleasure and who shall
12 keep a record of its proceedings.

13 **Sec. 449.** RCW 86.09.292 and 1937 c 72 s 98 are each amended to
14 read as follows:

15 In case any member of the district board is absent at the time of
16 any regular monthly meeting of said board, and a quorum of said board
17 cannot be obtained by reason of the absence of said member, it shall be
18 the duty of the (~~chairman~~) chair of the board of county commissioners
19 of the county in which the office of the district board is located to
20 act in place of said absent member, and the acts of the district board
21 at said meeting shall be valid so far as a quorum is concerned and
22 shall have the same effect as though said absent member were present
23 and acting thereat.

24 **Sec. 450.** RCW 86.09.301 and 1985 c 396 s 62 are each amended to
25 read as follows:

26 Every district officer, upon taking office, shall take and
27 subscribe an official oath for the faithful discharge of the duties of
28 his or her office during the term of his or her incumbency.

29 **Sec. 451.** RCW 86.09.304 and 1985 c 396 s 63 are each amended to
30 read as follows:

31 Every district officer or employee handling any district funds
32 shall execute a surety bond payable to the district in the sum of
33 double the estimated amount of funds handled monthly, conditioned that
34 the principal will strictly account for all moneys or credit received

1 by him or her for the use of the district. Each bond and the amount
2 thereof shall be approved by the county legislative authority of the
3 county within which the major portion of the district is situated, and
4 thereafter filed with the secretary of the district.

5 **Sec. 452.** RCW 86.09.310 and 1937 c 72 s 104 are each amended to
6 read as follows:

7 Every person, upon the expiration or sooner termination of his or
8 her term of office as an officer of the district, shall immediately
9 turn over and deliver, under oath, to his or her successor in office,
10 all records, books, papers, and other property under his or her control
11 and belonging to such office. In case of the death of any officer, his
12 or her legal representative shall turn over and deliver such records,
13 books, papers, and other property to the successor in office of such
14 deceased person.

15 **Sec. 453.** RCW 86.09.319 and 1937 c 72 s 107 are each amended to
16 read as follows:

17 Any county treasurer collecting or handling funds of the district
18 shall be liable upon his or her official bond and to criminal
19 prosecution for malfeasance, misfeasance, or nonfeasance in office
20 relative to any of his or her duties prescribed herein.

21 **Sec. 454.** RCW 86.09.325 and 1983 c 167 s 201 are each amended to
22 read as follows:

23 The ex officio district treasurer shall pay out moneys collected or
24 deposited with him or her in behalf of the district, or portions
25 thereof, upon warrants issued by the county auditor against the proper
26 funds of the districts, except the sums to be paid out of the bond fund
27 for interest and principal payments on bonds.

28 **Sec. 455.** RCW 86.09.328 and 1937 c 72 s 110 are each amended to
29 read as follows:

30 The said ex officio district treasurer shall report in writing on
31 or before the fifteenth day of each month to the district board, the
32 amount of money held by him or her, the amount in each fund, the amount
33 of receipts for the month preceding in each fund, and the amount or

1 amounts paid out of each fund, and said report shall be filed with the
2 secretary of the board.

3 **Sec. 456.** RCW 86.09.391 and 1985 c 396 s 66 are each amended to
4 read as follows:

5 The board of appraisers shall elect a member as (~~chairman~~) chair
6 and the secretary of the district or his or her deputy shall be ex
7 officio secretary of the board of appraisers. The appraisers shall
8 receive such compensation and expenses as the board of directors of the
9 district, with the approval of the county legislative authority of the
10 county within which the major portion of the district is situated,
11 shall determine, and which may forthwith be paid by the issuance of
12 district warrants.

13 **Sec. 457.** RCW 86.09.430 and 1986 c 278 s 43 are each amended to
14 read as follows:

15 Said notice of hearing on said determination of assessment ratios
16 shall state that the base assessment map designating the classes in
17 which the lands in the district have been placed for assessment
18 purposes on the ratios authorized by law, has been prepared by the
19 board of appraisers and is on file at the office of the district board
20 and may be inspected at any time during office hours; that a hearing on
21 said map will be held before the county legislative authority at the
22 office of the district board on, the day of
23,, at the hour of o'clock (naming
24 the time), where any person may appear and present such objections, if
25 any, he or she may have to said map, and shall be signed by the
26 secretary of the district.

14 in the nature of an appeal, initiated in the superior court of the
15 county in which the land affected is situated. The matter shall be
16 heard and tried by the court and shall be informal and summary but full

20 read as follows:

21 The secretary of the district on or before the first day of
22 November in each year shall estimate the amount of money necessary to

25 submit the same to the county legislative authority of the county
26 within which the major portion of the district is situated for its
27 suggestions, approval, and revision and upon the approval of the budget
28 by said county legislative authority, either as originally submitted or

26 Upon receiving the assessment roll, the county treasurer shall
27 prepare therefrom an assessment book in which shall be written the
28 description of the land as it appears in the assessment roll, the name
29 of the owner or owners where known, and if assessed to the unknown
30 owners, then the word "unknown", and the total assessment levied
31 against each tract of land. Proper space shall be left in said book
32 for the entry therein of all subsequent proceedings relating to the

37 such person specifying the amount of the assessment and the amount paid

2 any land in the district is located to furnish upon request of the
3 owner, or any person interested, a statement showing any and all
4 assessments levied as shown by the assessment roll in his or her office
5 upon land described in such request, and all statements of general
6 taxes covering any land in the district shall be accompanied by a
7 statement showing the condition of district assessments against such
8 lands: PROVIDED, That the failure of the county treasurer to render
9 any statement herein required of him or her shall not render invalid
10 any assessments made by any district or proceedings had for the
11 enforcement and collection of district assessments pursuant to this
12 chapter.

13 **Sec. 462.** RCW 86.09.496 and 1937 c 72 s 166 are each amended to
14 read as follows:

15 On or before the thirty-first day of December of each year, the
16 county treasurer of the county in which the land is located shall cause
17 to be posted the delinquency list which must contain the names of
18 persons to whom the property is assessed and a description of the
19 property delinquent and the amount of the assessment and costs due,
20 opposite each name and description.

21 He or she must append to and post with the delinquency list a
22 notice that unless the assessments delinquent, together with costs and
23 accrued interest, are paid, the real property upon which such
24 assessments are a lien will be sold at public auction. The said notice
25 and delinquent list shall be posted at least twenty days prior to the
26 time of sale. Concurrent as nearly as possible with the date of the
27 posting aforesaid, the said county treasurer shall publish the location
28 of the place where said notice is posted and in connection therewith a
29 notice that unless delinquent assessments together with costs and
30 accrued interest are paid, the real property upon which such
31 assessments are a lien will be sold at public auction. Such notice
32 must be published once a week for three successive weeks in a newspaper
33 of general circulation published in the county within which the land is
34 located; but said notice of publication need not comprise the
35 delinquent list where the same is posted as herein provided. Both
36 notices must designate the time and place of sale. The time of sale
37 must not be less than twenty-one nor more than twenty-eight days from

1 the date of posting and from the date of the first publication of the
2 notice thereof, and the place must be at some point designated by the
3 treasurer.

4 **Sec. 463.** RCW 86.09.499 and 1937 c 72 s 167 are each amended to
5 read as follows:

6 The treasurer of the county in which the land is situated shall
7 conduct the sale of all lands situated therein and must collect in
8 addition to the assessment due as shown on the delinquent list the
9 costs and expenses of sale and interest at the rate of ten percent per
10 annum from the date or dates of delinquency as hereinbefore provided.
11 On the day fixed for the sale, or some subsequent day to which he or
12 she may have postponed it, and between the hours of ten o'clock a.m.
13 and three o'clock p.m., the county treasurer making the sale must
14 commence the same, beginning at the head of the list, and continuing
15 alphabetically, or in the numerical order of the parcels, lots, or
16 blocks, until completed. He or she may postpone the day of commencing

22 The owner or person in possession of any real estate offered for
23 sale for assessments due thereon may designate in writing to the county
24 treasurer, by whom the sale is to be made, and prior to the sale, what
25 portion of the property he or she wishes sold, if less than the whole;
26 but if the owner or possessor does not, then the treasurer may
27 designate it, and the person who will take the least quantity of the
28 land, or in case an undivided interest is assessed, then the smallest
29 portion of the interest, and pay the assessment and costs due,
30 including one dollar to the treasurer for duplicate of the certificate
31 of sale, is the purchaser. The treasurer shall account to the district
32 for said one dollar. If the purchaser does not pay the assessment and

36 the property is offered for sale, and if there is no purchaser in good

4 secretary of the district, and filed by him or her in the office of the
5 district. No charge shall be made for the duplicate certificate where
6 the district is the purchaser, and in such case the treasurer shall
7 make an entry, "Sold to the district", and he or she will be credited
8 with the amount thereof in settlement. The district, as a purchaser at
9 said sale, shall be entitled to the same rights as a private purchaser,
10 and may assign or transfer the certificate of sale upon the payment of
11 the amount which would be due if redemption were being made by the
12 owner. If no redemption is made of land for which the district holds
13 a certificate of purchase, the district will be entitled to receive the
14 treasurer's deed therefor in the same manner as a private person would
15 be entitled thereto.

16 After receiving the amount of assessments and costs, the county
17 treasurer must make out in duplicate a certificate, dated on the day of
18 sale, stating (when known) the names of the persons assessed, a
19 description of the land sold, the amount paid therefor, that it was
20 sold for assessments, giving the amount and the year of assessment, and
21 specifying the time when the purchaser will be entitled to a deed. The
22 certificate must be signed by the treasurer making the sale and one
23 copy delivered to the purchaser, and the other filed in the office of
24 the county treasurer of the county in which the land is situated:
25 PROVIDED, That upon the sale of any lot, parcel, or tract of land not
26 larger than an acre, the fee for a duplicate certificate shall be
27 twenty-five cents and in case of a sale to a person or a district, of
28 more than one parcel or tract of land, the several parcels or tracts
29 may be included in one certificate.

30 **Sec. 465.** RCW 86.09.508 and 1937 c 72 s 170 are each amended to
31 read as follows:

32 A redemption of the property sold may be made by the owner or any
33 person on behalf and in the name of the owner or by any party in
34 interest at any time before deed issues, by paying the amount of the
35 purchase price and interest as in this chapter provided, and the amount
36 of any assessments which such purchaser may have paid thereon after
37 purchase by him or her and during the period of redemption in this

1 section provided, together with like interest on such amount, and if
2 the district is the purchaser, the redemptioner shall not be required
3 to pay the amount of any district assessment levied subsequent to the
4 assessment for which said land was sold, but all subsequent and unpaid
5 assessments levied upon said land to the date of such redemption shall
6 remain a lien and be payable and the land be subject to sale and
7 redemption at the times applicable to such subsequent annual district
8 assessment. Redemption must be made in legal tender, as provided for
9 the collection of state and county taxes, and the county treasurer must
10 credit the amount paid to the person named in the certificate and pay
11 it on demand to such person or his or her assignees. No redemption
12 shall be made except to the county treasurer of the county in which the
13 land is situated.

14 **Sec. 466.** RCW 86.09.511 and 1937 c 72 s 171 are each amended to
15 read as follows:

16 Upon completion of redemption, the county treasurer to whom
17 redemption has been made shall enter the word "redeemed", the date of
18 redemption and by whom redeemed on the certificate and on the margin of
19 the assessment book where the entry of the certificate is made. If the
20 property is not redeemed within two years, after the fifteenth day of
21 January of the year in which such property was sold, the county
22 treasurer of the county in which the land sold is situated must
23 thereafter, upon demand of the owner of the certificate of sale, make
24 to the purchaser, or his or her assignees a deed of the property,
25 reciting in the deed substantially the matters contained in the
26 certificate, and that no person redeemed the property during the time
27 allowed by law for its redemption. The treasurer shall receive from

29 deed: PROVIDED, If redemption is not made of any lot, parcel, or tract
30 of land not larger than one acre, the fee for a deed shall be twenty-
31 five cents and when any person or district holds a duplicate
32 certificate covering more than one tract of land, the several parcels,
33 or tracts of lands, mentioned in the certificate may be included in one
34 deed.

35 **Sec. 467.** RCW 86.09.556 and 1937 c 72 s 186 are each amended to
36 read as follows:

1 Any claim against the district shall be presented to the district
2 board for allowance or rejection. Upon allowance, the claim shall be
3 attached to a voucher verified by the claimant or his or her agent and
4 approved by the ((~~chairman~~)) chair of the board and countersigned by
5 the secretary and directed to the county auditor of the county in which
6 the office of the district treasurer is located, for the issuance of a
7 warrant against the proper fund of the district in payment of said
8 claim.

9 **Sec. 468.** RCW 86.09.562 and 1986 c 278 s 45 are each amended to
10 read as follows:

11 Said county treasurer shall pay out the moneys received or
12 deposited with him or her or any portion thereof upon warrants issued
13 by the county auditor of the same county of which the district
14 treasurer is an officer against the proper funds of the district except
15 the sums to be paid out of the special funds for interest and principal
16 payments on bonds or notes.

17 **Sec. 469.** RCW 86.09.619 and 1965 c 26 s 12 are each amended to
18 read as follows:

19 It shall be the duty of the board of directors of the district to
20 make adequate provision for the payment of all district bonds in
21 accordance with their terms by levy and collection of assessments or
22 otherwise and upon its failure so to do said levy and collection of
23 assessments shall be made as follows:

24 (1) If the annual assessment roll has not been delivered to the
25 county treasurer on or before the fifteenth day of January, he or she
26 shall notify the secretary by registered mail that the roll must be
27 delivered to him or her forthwith.

28 (2) If the roll is not delivered within ten days from the date of
29 mailing the notice, or if the roll has not been equalized and the levy
30 made, the treasurer shall immediately notify the county commissioners
31 of the county in which the office of the directors is situated, and
32 such commissioners shall cause an assessment roll for the district to
33 be prepared and shall equalize it if necessary, and make the levy in
34 the same manner and with like effect as if it had been made and
35 equalized by the directors, and all expenses incident thereto shall be
36 borne by the district.

1 (3) In case of neglect or refusal of the secretary to perform his
2 or her duties, the district treasurer shall perform them, and shall be
3 accountable therefor, on his or her official bond, as in other cases.

4 **Sec. 470.** RCW 86.09.703 and 1985 c 396 s 86 are each amended to
5 read as follows:

6 If funds are available the county legislative authority shall, at
7 the expense of the county, refer the petition to the county engineer
8 for a preliminary investigation as to the feasibility of the objects
9 sought by the petition. If the investigation discloses that the matter
10 petitioned for is feasible, conducive to the public welfare, consistent
11 with a comprehensive plan of development and in the best interest of
12 the district and will promote the purposes for which the district was
13 organized, the county legislative authority shall so find, approve the
14 petition, enter an order in his or her records declaring the
15 establishment of the new boundaries as petitioned for, or as modified
16 by him or her, and file a certified copy of the order with each county
17 auditor, without filing fee, and with the board.

18 The board shall forthwith cause a review of the classifications and
19 ratio of benefits, in the same manner and with the same effect as for
20 the determination of such matters in the first instance.

21 The lands in the original district shall remain bound for the whole
22 of the original unpaid assessment thereon for the payment of any
23 outstanding warrants or bonds to be paid by such assessments. Until
24 the assessments are collected and all indebtedness of the original
25 district paid, separate funds shall be maintained for the original
26 district and the revised district.

27 **Sec. 471.** RCW 86.13.030 and 1913 c 54 s 3 are each amended to read
28 as follows:

29 When such a contract shall have been entered into it shall be the
30 duty of each of the boards of county commissioners to make for their
31 respective counties, each year, a tax levy at a rate sufficient to meet
32 the requirements of the contract to be performed by the county, or
33 sufficient to provide such lesser amount as the boards of county
34 commissioners shall agree upon for such year, to be evidenced by
35 separate resolution of each board, and when such levy shall be made the
36 same shall be extended upon the tax rolls of the county levying the

1 same as other taxes shall be extended, and shall be collected in the
2 same manner and shall be a lien upon the property as in the case of
3 other taxes. The fund realized in each county by such tax levy shall
4 go into a separate fund in the treasury of the county collecting the
5 same, to be designated intercounty river improvement fund, and the
6 entire fund so collected in the two counties shall be devoted to and be
7 disbursed for the purposes specified in such contract and as in this
8 chapter provided, and for no other purpose, but without regard to the
9 particular county in which the work is performed, material required or
10 expenditure made, it being the intent that the entire fund realized in
11 the two counties shall be devoted to the one common purpose as if the
12 two counties were one county and the two funds one fund. The fund in
13 each county shall be disbursed by the county treasurer of such county
14 upon warrants signed by the county auditor of that county. Such
15 warrants shall be issued by order of the board of county commissioners
16 of such county, or a majority thereof. Each county auditor shall,
17 whenever requested by the county auditor of the other county, furnish
18 the county auditor of the other county a statement of payments into and
19 warrants drawn upon the fund of his or her county from time to time,
20 and in addition thereto, each county auditor shall on the first Monday
21 of January, April, July and October each year during the life of the
22 contract furnish the other a complete statement thereof. Obligations
23 incurred in the prosecution of such improvement and warrants issued
24 shall be payable only out of said special funds, and no general
25 obligation against or debt of either county shall be created thereby or
26 by any contract entered into by virtue of this chapter, but it is not
27 the intent of this chapter to deny to either county the right to have
28 in the courts any proper proceeding to compel compliance with such
29 contract on the part of the other county.

30 **Sec. 472.** RCW 86.13.050 and 1913 c 54 s 5 are each amended to read
31 as follows:

32 When such a contract shall have been entered into and occasion
33 shall arise for the joint action of the two boards of county
34 commissioners whether such joint action is provided for in this chapter
35 or otherwise desired upon any matter having relation to such contract
36 or the prosecution of such improvement, such joint action may be
37 secured by a notice calling a joint meeting signed by two county

1 commissioners, designating the time and place in either county of such
2 meeting, served by one of the two county auditors upon the remaining
3 county commissioners at least seven days (exclusive of the date of
4 service or mailing) prior to the time so designated. If the notice is
5 signed by two county commissioners of the same county the place of
6 meeting shall be at some place in the other county designated in the
7 notice. Such service may be personal or by mail addressed to the
8 member in care of the county auditor of his or her county. The six
9 county commissioners may constitute a legal meeting without notice by
10 being present together for that purpose. The auditor's certificate of
11 such personal service or mailing, attached to a copy of the notice,
12 shall be made a part of the records of the meeting and be competent
13 proof of the fact. Except in the case hereinafter provided for, the
14 presence of four of the county commissioners shall be necessary to
15 constitute a legal meeting. Each meeting shall be presided over by one
16 of those present selected by vote. The county auditor of the county
17 wherein the meeting is held shall be secretary of the meeting, and
18 shall make duplicate record of its proceedings, one of which, with his
19 or her certificate thereon, shall be forwarded to the county auditor of
20 the other county, and such record shall be a part of the record of the
21 board of county commissioners of each county. A majority vote of those
22 present at any legal meeting shall be determinative upon any question
23 properly considered at the meeting, and shall be binding upon each
24 county as if enacted or adopted by its own board of county
25 commissioners separately, but no joint meeting whatsoever shall in any
26 manner continue, extend, change, alter, modify, or abrogate the
27 contract when made or any of the terms and conditions contained
28 therein. Each county commissioner shall be paid out of said fund in
29 his or her own county all disbursements made by him or her for
30 traveling and other expenses incurred in attending any joint meeting or
31 in any way connected with the prosecution of the improvement. Any
32 legal meeting shall have power to adjourn to another time and place.
33 An adjourned meeting shall have all the powers of the meeting of which
34 it is an adjournment, but shall have no power after the end of the
35 thirtieth day following the date of the original meeting of which it is
36 an adjournment. If the three county commissioners of either county
37 shall fail to attend any two meetings consecutively called, the notice
38 for the next succeeding meeting may be also served upon the special

1 commissioner hereinafter provided for, and if he or she and three
2 county commissioners attend pursuant to such notice the four shall
3 constitute a legal meeting, but if he or she does not so attend and
4 three county commissioners do attend, the same shall constitute a legal
5 meeting: PROVIDED, All notices calling a joint meeting shall specify
6 distinctly and separately each question to be considered at said
7 meeting; and it shall be unlawful to consider any question at such
8 meeting or at any adjourned meeting thereof except those which have
9 been distinctly and separately specified, except in cases where all six
10 county commissioners are present or five county commissioners present
11 are unanimous on the question, and in any action which may be taken on
12 any question other than those specified in the notice shall be void and
13 shall not be binding on either county, except in cases where all six
14 county commissioners are present or the action was by unanimous vote of
15 five county commissioners present at such meeting.

16 **Sec. 473.** RCW 86.13.060 and 1913 c 54 s 6 are each amended to read
17 as follows:

18 When such a contract shall have been entered into there shall be
19 designated at the first legal joint meeting, or adjournment thereof,
20 held in each calendar year a special commissioner to serve as such
21 until the first joint meeting held in the ensuing year. If such
22 designation shall not be made at any such first annual meeting, the
23 United States engineer in charge of the district in which such
24 improvement is located shall be such special commissioner until the
25 next succeeding first annual meeting. If a special commissioner shall
26 for any reason fail to serve as such officer, or be removed by
27 unanimous vote of any legal meeting, a successor to him or her may be
28 chosen at any subsequent legal joint meeting during his or her term.
29 Such special commissioner shall have power to attend and vote at any
30 joint meeting in the following cases and none other, to wit: (1) In
31 cases specially so provided in RCW 86.13.050 hereof; (2) in any case
32 where the vote of any such joint meeting shall stand equally divided
33 upon any question arising under this chapter or such contract or in the
34 prosecution of the work of improvement. The special commissioner shall
35 have no voice or vote except upon questions on which the vote of the
36 county commissioners is equally divided. The procedure in cases
37 covered by the foregoing subdivision (2) of this section shall be

1 substantially as follows: It shall be the duty of the secretary of the
2 meeting at which the division shall occur, if the attendance of the
3 special commissioner at that meeting is not secured, to forthwith
4 transmit to the special commissioner written notice of the fact of
5 disagreement and the question involved, and of the time and place to
6 which the meeting shall have been adjourned or at which the question
7 will recur. If there shall be no such adjournment of the meeting, or
8 if the secretary shall not give such notice, any two commissioners may
9 in the manner provided in RCW 86.13.050 call a joint meeting for the
10 consideration of the question in dispute, and in such event either
11 county auditor may give such notice to the special commissioner. No
12 informality in the mode of securing the attendance of the special
13 commissioner shall invalidate the proceedings of or any vote taken at
14 any meeting which he or she shall attend and which he or she is
15 empowered to attend by the provisions of this chapter. The special
16 commissioner shall receive, to be paid equally out of the two funds,
17 his or her traveling and other expenses incurred in attending meetings
18 or otherwise in connection with the work of improvement, and such
19 compensation for his or her services as shall be fixed by the joint
20 meeting which shall have selected him or her, or failing to be so
21 fixed, his or her compensation shall be ten dollars per day of actual
22 service.

23 **Sec. 474.** RCW 86.13.090 and 1913 c 54 s 9 are each amended to read
24 as follows:

25 When such a contract shall have been entered into, it shall be
26 lawful to issue warrants upon said fund though there be at the time of
27 such issuance no money in the fund, but in such cases the aggregate of
28 such warrants so issued in any year shall not exceed one-half the
29 amount of the next annual tax levy required by such contract. Such
30 warrants shall be stamped by the county treasurer when presented to him
31 or her for payment, to bear interest at a certain rate thereafter until
32 paid, such rate to be the then current rate as determined by the county
33 auditor.

34 **Sec. 475.** RCW 86.13.100 and 1915 c 103 s 1 are each amended to
35 read as follows:

36 Whenever two counties of this state, acting under a contract made

1 pursuant to RCW 86.13.010 through 86.13.090, shall make an improvement
2 in connection with the course, channel, or flow of a river, shall
3 acquire property by statute, purchase, gift, or otherwise, said
4 counties, acting through their boards of county commissioners jointly
5 shall have the power, and are hereby authorized to sell, transfer,
6 trade, lease, or otherwise dispose of said property by public or
7 private, negotiation or sale. The deeds to the property so granted,
8 transferred, leased, or sold shall be executed by the ((~~chairman~~))
9 chair of the meeting of the joint boards of county commissioners, and
10 attested by the secretary of said joint meeting where the sale is
11 authorized. The proceeds of the sale of said property shall be used by
12 said counties for the carrying on, completion or maintenance of said
13 improvement, as directed by the boards of county commissioners of said
14 counties acting jointly.

15 **Sec. 476.** RCW 86.15.060 and 2005 c 127 s 1 are each amended to
16 read as follows:

17 (1) Except as provided in subsection (2) of this section,
18 administration of the affairs of zones shall be in the county engineer.
19 The engineer may appoint such deputies and engage such employees,
20 specialists, and technicians as may be required by the zone and as are
21 authorized by the zone's budget. Subject to the approval of the
22 supervisors, the engineer may organize, or reorganize as required, the
23 zone into such departments, divisions, or other administrative
24 relationships as he or she deems necessary to its efficient operation.

1 The treasurer shall also establish the following accounts within
2 the zone fund:

6 (2) An account for each outstanding bond issue to which will be
7 deposited any revenues collected for the retirement of such outstanding
8 bonds or for the payment of interest or charges thereon; and

9 (3) A general account to which all other receipts of the zone shall
10 be deposited.

11 **Sec. 478.** RCW 86.16.035 and 1995 c 8 s 5 are each amended to read
12 as follows:

13 Subject to RCW 43.21A.068, the department of ecology shall have
14 supervision and control over all dams and obstructions in streams, and
15 may make reasonable regulations with respect thereto concerning the
16 flow of water which he or she deems necessary for the protection to
17 life and property below such works from flood waters.

18 **Sec. 479.** RCW 86.24.030 and 1988 c 127 s 39 are each amended to
19 read as follows:

20 The state director of ecology, when state funds shall be available
21 therefor, shall have authority on behalf of the state to enter into
22 contracts with the United States or any agency thereof and/or with any
23 such flood control district, county, or counties so acting jointly, for
24 flood control purposes for any such flood control district, county, or
25 counties so acting jointly, the amount of the state's participation in
26 any such contract to be such sum as may be appropriated therefor, or,
27 in event of unallocated state appropriations for flood control
28 purposes, in such necessary sum as to any such contract as he or she
29 shall determine.

30 **Sec. 480.** RCW 87.03.025 and 1963 c 20 s 13 are each amended to
31 read as follows:

32 Whenever public lands of the state are situated in or taken into an
33 irrigation district they shall be treated the same as other lands,
34 except as hereinafter provided. The commissioner of public lands shall
35 be served with a copy of the petition proposing to include such lands,

1 together with a map of the district and notice of the time and place of
2 hearing thereon, at least thirty days before the hearing, and if he or
3 she determines that such lands will be benefited by being included in
4 the district he or she shall give his or her consent thereto in
5 writing. If he or she determines that they will not be benefited he or
6 she shall file with the board a statement of his or her objections
7 thereto.

8 Any public lands of the state which are situated within the
9 boundaries of an irrigation district, but which were not included in

28 shall be subject to the provisions of the laws of this state relating
29 to the collection of irrigation district assessments to the same extent
30 and in the same manner in which lands of like character held under
31 private ownership are subject thereto, but collection and payment of
32 the assessments shall be governed solely by the provisions of chapter
33 79.44 RCW.

34 **Sec. 481.** RCW 87.03.031 and 1961 c 105 s 2 are each amended to
35 read as follows:

36 Any qualified district elector who certifies as provided in RCW
37 87.03.032 through 87.03.034 that he or she cannot conveniently be

1 present to cast his or her ballot at his or her proper election
2 precinct on the day of any irrigation district election shall be
3 entitled to vote by absentee ballot in such election in the manner
4 herein provided.

5 **Sec. 482.** RCW 87.03.032 and 1961 c 105 s 3 are each amended to
6 read as follows:

7 The notice of election shall conform to the requirements for
8 election notices provided by Title 87 RCW for the election being held,
9 and shall specify in addition that any qualified district elector who
10 certifies that he or she cannot conveniently be present at his or her
11 proper election precinct on the day of election may vote by absentee
12 ballot, and that a ballot and form of certificate of qualifications
13 will be furnished to him or her on written request being made of the
14 district's secretary. The requisite ballot and a form of certificate
15 of qualifications shall be furnished by the district's secretary to any
16 person who prior to the date of election makes written request
17 therefor, stating that he or she is a qualified district elector. Such
18 ballot and form may be furnished also to qualified district electors in
19 any way deemed to be convenient without regard to requests having been

22 read as follows:

23 (1) To be counted in a given election, an absentee ballot must
24 conform to these requirements:

25 (a) It must be sealed in an unmarked envelope and delivered to the
26 district's principal office prior to the close of the polls on the day
27 of that election; or be sealed in an unmarked envelope and mailed to
28 the district's secretary, postmarked not later than midnight of that
29 election day and received by the secretary within five days of that
30 date.

31 (b) The sealed envelope containing the ballot shall be accompanied
32 by a certificate of qualifications stating, with respect to the voter,
33 his or her name, age, citizenship, residence, that he or she holds
34 title or evidence of title to lands within the district which, under

3 (c) The statements in the certificate of qualifications shall be

8 disclosing his or her vote. The witness, by affixing his or her
9 signature to the certificate of qualifications, shall certify that he
10 or she is acquainted with the voter, that in his or her presence the
11 voter's signature was affixed and the ballot enclosed as required in
12 this paragraph.

13 (2) The form of statement of qualifications and its certification
14 shall be substantially as prescribed by the district's board of
15 directors. This form may also provide that the voter shall describe
16 all or some part of his or her lands within the district which, under
17 RCW 87.03.045 entitles him or her to vote in the election, but a voter
18 otherwise qualified shall not be disqualified because of the absence or
19 inaccuracy of the description so given. The regular form of irrigation
20 district ballot shall be used by absentee voters.

21 **Sec. 484.** RCW 87.03.045 and 1985 c 66 s 1 are each amended to read
22 as follows:

23 In districts with two hundred thousand acres or more, a person
24 eighteen years old, being a citizen of the United States and a resident
25 of the state and who holds title or evidence of title to land in the
26 district or proposed district shall be entitled to vote therein. He or
27 she shall be entitled to one vote for the first ten acres of said land
28 or fraction thereof and one additional vote for all of said land over
29 ten acres. A majority of the directors shall be residents of the
30 county or counties in which the district is situated and all shall be
31 electors of the district. If more than one elector residing outside
32 the county or counties is voted for as director, only that one who
33 receives the highest number of votes shall be considered in
34 ascertaining the result of the election. Where land is community
35 property both the husband and wife may vote if otherwise qualified. An
36 agent of a corporation owning land in the district, duly authorized in
37 writing, may vote on behalf of the corporation by filing with the

1 election officers his or her instrument of authority. An elector
2 resident in the district shall vote in the precinct in which he or she
3 resides, all others shall vote in the precinct nearest their residence.

4 **Sec. 485.** RCW 87.03.075 and 1985 c 66 s 4 are each amended to read
5 as follows:

6 Voting in an irrigation district shall be by ballot. Ballots shall
7 be of uniform size and quality, provided by the district, and for the
8 election of directors shall contain only the names of the candidates
9 who have filed with the secretary of the district a declaration in
10 writing of their candidacy, or a petition of nomination as hereinafter
11 provided, not later than five o'clock p.m. on the first Monday in
12 November. Ballots shall contain space for sticker voting or for the
13 writing in of the name of an undeclared candidate. Ballots shall be
14 issued by the election board according to the number of votes an
15 elector is entitled to cast. A person filing a declaration of
16 candidacy, or petition of nomination as hereinafter provided, shall
17 designate therein the position for which he or she is a candidate. No
18 ballots on any form other than the official form shall be received or
19 counted.

20 In any election for directors where the number of votes which may
21 be received will have no bearing on the length of the term to be
22 served, the candidates for the position of director, in lieu of filing
23 a declaration of candidacy hereunder, shall file with the secretary of
24 the district a petition of nomination signed by at least ten qualified
25 electors of the district, or of the division if the district has been
26 divided into director divisions, not later than five o'clock p.m. on
27 the first Monday in November. If, after the expiration of the date for
28 filing petitions of nomination, it appears that only one qualified
29 candidate has been nominated thereby for each position to be filled it
30 shall not be necessary to hold an election, and the board of directors
31 shall at their next meeting declare such candidate elected as director.
32 The secretary shall immediately make and deliver to such person a
33 certificate of election signed by him or her and bearing the seal of
34 the district. The procedure set forth in this paragraph shall not
35 apply to any other irrigation district elections.

1 **Sec. 486.** RCW 87.03.080 and 1961 c 192 s 14 are each amended to
2 read as follows:

3 An election of directors in an irrigation district shall be held on
4 the second Tuesday of December of each year, and the term of each
5 director shall be three years from the first Tuesday of January
6 following his or her election. The directors elected at the
7 organization election shall serve until their successors are elected
8 and qualified. At the first annual election occurring thirty days or
9 more after the date of the order establishing the district, there shall
10 be elected directors to succeed those chosen at the organization
11 election. If the board consists of three directors the candidate
12 receiving the highest number of votes shall serve a term of three
13 years; the next highest, two years; and the next highest, one year. In
14 case of five directors, the two candidates receiving the highest number
15 of votes shall each serve a term of three years; the next two highest,

24 directors, the board of directors, acting on its own initiative or on
25 the written petition of at least twenty electors of the district, shall
26 submit the question to the electors of the district at a regular or
27 special district election. In the event the electors by a majority of
28 the votes cast favor an increase in the number of directors, there
29 shall be elected at the next annual district election two additional
30 directors. The person receiving the highest number of votes shall
31 serve for a three year term and the next highest, a two year term.

32 The number of directors may be decreased to five or three, as the
33 case may be, substantially in the same manner as that provided for the
34 increase of directors. In case of three directors the term of one
35 director only shall expire annually.

36 **Sec. 487.** RCW 87.03.081 and 1961 c 192 s 15 are each amended to
37 read as follows:

1 A vacancy in the office of director shall be filled by appointment
2 by the board of county commissioners of the county in which the
3 proceedings for the organization of the district were had. At the next
4 annual election occurring thirty days or more after the date of the
5 appointment, a successor shall be elected who shall take office on the
6 first Tuesday in January following and shall serve for the remainder of
7 the unexpired term.

8 A director appointed to fill a vacancy occurring after the
9 expiration of the term of a director shall serve until his or her
10 successor is elected and qualified. At the next election of directors
11 occurring thirty days or more after the appointment, a successor shall
12 be elected who shall take office on the first Tuesday in January next
13 and shall serve for the term for which he or she was elected.

14 Failure on the part of any irrigation district to hold one or more
15 annual elections for selection of officers, or otherwise to provide
16 district officers shall not dissolve the district or impair its powers,
17 where later officers for the district are appointed or elected and
18 qualify as such and exercise the powers and duties of their offices in
19 the manner provided by law.

20 **Sec. 488.** RCW 87.03.082 and 1961 c 192 s 16 are each amended to
21 read as follows:

22 Each director shall take and subscribe an official oath for the
23 faithful discharge of the duties of his or her office, and shall
24 execute a bond to the district in the sum of one thousand dollars,
25 conditioned for the faithful discharge of his or her duties, which
26 shall be approved by the judge of the superior court of the county
27 where the district was organized, and the oath and bond shall be
28 recorded in the office of the county clerk of that county and filed
29 with the secretary of the board of directors. The secretary shall take
30 and subscribe a written oath of office and execute a bond in the sum of
31 not less than one thousand dollars to be fixed by the directors, which
32 shall be approved and filed as in the case of the bond of a director.
33 If a district is appointed fiscal agent of the United States to collect
34 money for it, the secretary and directors and the district treasurer
35 shall each execute such additional bonds as the secretary of the
36 interior may require, conditioned for the faithful discharge of their

1 duties which shall be approved, recorded, and filed as other official
2 bonds. All such bonds shall be secured at the cost of the district.

3 **Sec. 489.** RCW 87.03.090 and 1931 c 60 s 1 are each amended to read
4 as follows:

5 The inspector is (~~(chairman)~~) chair of the election board, and may
6 First: Administer all oaths required in the progress of an
7 election.

8 Second: Appoint judges and clerks, if, during the progress of the
9 election, any judge or clerk cease to act. Any member of the board of
10 election, or any clerk thereof, may administer and certify oaths
11 required to be administered during the progress of an election. The
12 board of election for each precinct may, if they deem it necessary,
13 before opening the polls, appoint two persons to act as clerks of the
14 election. Before opening the polls, each member of the board and each
15 clerk must take and subscribe an oath to faithfully perform the duties
16 imposed upon them by law. Any elector of the precinct may administer
17 and certify such oath. The polls must be opened at one o'clock p.m. on
18 the afternoon of the election, and be kept open until eight o'clock
19 p.m., when the same must be closed. The provisions of the general
20 election law of this state, concerning the form of ballots to be used
21 shall not apply to elections held under this act: PROVIDED, That any
22 district elections called before this act shall take effect shall be
23 noticed and conducted in the manner prescribed by law in effect at the
24 time the election is called.

25 **Sec. 490.** RCW 87.03.100 and 1981 c 345 s 2 are each amended to
26 read as follows:

27 As soon as all the votes are read off and counted, a certificate
28 shall be drawn upon each of the papers containing the poll list and
29 tallies, or attached thereto, stating the number of votes each one
30 voted for has received, and designating the office to fill which he or
31 she was voted for, which number shall be written in figures and in
32 words at full length. Each certificate shall be signed by the
33 (~~(clerk[s])~~) clerks, (~~(judge[s])~~) judges, and the inspector. One of
34 said certificates, with the poll list and the tally paper to which it
35 is attached, shall be retained by the inspector, and preserved by him
36 or her at least six months. The ballots, together with the other of

1 said certificates, with the poll list and tally paper to which it is
2 attached, shall be sealed by the inspector, in the presence of the
3 judges and clerks, and endorsed "Election returns of [naming the
4 precinct] precinct," and be directed to the secretary of the board of
5 directors, and shall be immediately delivered by the inspector, or by
6 some other safe and responsible carrier designated by said inspector,
7 to said secretary, and the ballots shall be kept unopened for at least
8 six months, and if any person be of the opinion that the vote of any
9 precinct has not been correctly counted, he or she may appear on the
10 day appointed for the board of directors to open and canvass the
11 returns, and demand a recount of the vote of the precinct that is so
12 claimed to have been incorrectly counted.

13 **Sec. 491.** RCW 87.03.110 and 1913 c 165 s 4 are each amended to
14 read as follows:

15 The secretary of the board of directors must, as soon as the result
16 is declared, enter in the records of such board a statement of such
17 result, which statement must show:

- 18 (1) The whole number of votes cast in the district;
- 19 (2) The name of the persons voted for;
- 20 (3) The office to fill which each person was voted for;
- 21 (4) The number of votes given in each precinct to each of such
22 persons;
- 23 (5) The number of votes given in each precinct for and against any
24 proposition voted upon.

25 The board of directors must declare elected the person having the
26 highest number of votes given for each office. The secretary must
27 immediately make out, and deliver to such person a certificate of
28 election signed by him or her and authenticated by the seal of the
29 district.

30 **Sec. 492.** RCW 87.03.115 and 1983 c 262 s 1 are each amended to
31 read as follows:

32 The directors of the district shall organize as a board and shall
33 elect a president from their number, and appoint a secretary, who shall
34 keep a record of their proceedings. The office of the directors and
35 principal place of business of the district shall be at some place in
36 the county in which the organization was effected, to be designated by

1 the directors. The directors serving districts of five thousand acres
2 or more shall hold a regular monthly meeting at their office on the
3 first Tuesday in every month, or on such other day in each month as the
4 board shall direct in its bylaws, and may adjourn any meeting from time
5 to time as may be required for the proper transaction of business.
6 Directors serving districts of less than five thousand acres shall hold
7 at least quarterly meetings on a day designated by the board's bylaws,
8 and may adjourn any meeting from time to time as may be required for
9 the proper transaction of business. Special meetings shall be called
10 and conducted in the manner required by chapter 42.30 RCW. All
11 meetings of the directors must be public. A majority of the directors
12 shall constitute a quorum for the transaction of business, and in all
13 matters requiring action by the board there shall be a concurrence of
14 at least a majority of the directors. All records of the board shall
15 be open to the inspection of any electors during business hours. The
16 board shall have the power, and it shall be its duty, to adopt a seal
17 of the district, to manage and conduct the business and affairs of the
18 district, to make and execute all necessary contracts, to employ and
19 appoint such agents, officers, and employees as may be necessary and
20 prescribe their duties, and to establish equitable bylaws, rules, and
21 regulations for the government and management of the district, and for
22 the equitable distribution of water to the lands within the district,
23 upon the basis of the beneficial use thereof, and generally to perform
24 all such acts as shall be necessary to fully carry out the provisions
25 of this chapter: PROVIDED, That all water, the right to the use of
26 which is acquired by the district under any contract with the United
27 States shall be distributed and apportioned by the district in
28 accordance with the acts of congress, and rules and regulations of the
29 secretary of the interior until full reimbursement has been made to the
30 United States, and in accordance with the provisions of said contract
31 in relation thereto. The bylaws, rules, and regulations must be on
32 file and open to inspection of any elector during regular business
33 hours. All leases, contracts, or other form of holding any interest in
34 any state or other public lands shall be, and the same are hereby
35 declared to be title to and evidence of title to lands and for all
36 purposes within this act, shall be treated as the private property of
37 the lessee or owner of the contractual or possessory interest:
38 PROVIDED, That nothing in this section shall be construed to affect the

1 title of the state or other public ownership, nor shall any lien for
2 such assessment attach to the fee simple title of the state or other
3 public ownership. The board of directors shall have authority to
4 develop and to sell, lease, or rent the use of: (1) Water derived from
5 the operation of the district water facilities to such municipal and
6 quasi municipal entities, the state of Washington, and state entities
7 and agencies, public and private corporations and individuals located
8 within and outside the boundaries of the district and on such terms and
9 conditions as the board of directors shall determine; and (2) power
10 derived from hydroelectric facilities authorized by RCW 87.03.015(1) as
11 now or hereafter amended, to such municipal or quasi municipal
12 corporations and cooperatives authorized to engage in the business of
13 distributing electricity, electrical companies subject to the
14 jurisdiction of the utilities and transportation commission, and other
15 irrigation districts and on such terms and conditions as the board of
16 directors shall determine: PROVIDED, No water shall be furnished for
17 use outside of said district until all demands and requirements for
18 water for use in said district are furnished and supplied by said
19 district: AND PROVIDED FURTHER, That as soon as any public lands
20 situated within the limits of the district shall be acquired by any
21 private person, or held under any title of private ownership, the owner
22 thereof shall be entitled to receive his or her proportion of water as
23 in case of other land owners, upon payment by him or her of such sums
24 as shall be determined by the board, and at the time to be fixed by the
25 board, which sums shall be such equitable amount as such lands should
26 pay having regard to placing said lands on the basis of equality with
27 other lands in the district as to benefits received, and giving credit
28 if equitable for any sums paid as water rent by the occupant of said
29 lands prior to the vesting of private ownership, and such lands shall
30 also become subject to all taxes and assessments of the district
31 thereafter imposed.

32 **Sec. 493.** RCW 87.03.175 and 1923 c 138 s 7 are each amended to
33 read as follows:

34 Said director shall forthwith consider said certified report and if
35 he or she deem it advisable make, through the appropriate divisions of
36 his or her department, additional studies of the project at the expense

1 of the district, and as soon as practicable thereafter, but in any
2 event within ninety days from the receipt of said certified report,
3 make his or her findings and submit the same to the district board.

4 **Sec. 494.** RCW 87.03.180 and 1923 c 138 s 7 are each amended to
5 read as follows:

6 In his or her findings said state director shall give generally his
7 or her conclusions regarding the supply of water available for the
8 project, the nature of the soil proposed to be irrigated and its
9 susceptibility to irrigation, the duty of water for irrigation and the
10 probable need of drainage, the probable cost of works, water rights,
11 and other property necessary for the project, the conditions of land
12 settlement therein, and the proper amount and dates of maturity of the
13 bonds proposed to be issued, and such other matters as he or she deems
14 pertinent to the success of the project, provided that said findings
15 and conclusions shall be advisory only and shall not be binding upon
16 the directors of the irrigation district.

17 **Sec. 495.** RCW 87.03.245 and 1919 c 180 s 8 are each amended to
18 read as follows:

19 The board of directors must allow the secretary as many deputies,
20 to be appointed by them, as will, in the judgment of the board, enable
21 him or her to complete the assessment within the time herein
22 prescribed. The board must fix the compensation of such deputies for
23 the time actually engaged.

24 **Sec. 496.** RCW 87.03.250 and 1921 c 129 s 12 are each amended to
25 read as follows:

26 On or before the first Tuesday in September in each year to and
27 including the year 1923, and on or before the first Tuesday in November
28 beginning with the year 1924 and each year thereafter, the secretary
29 must complete his or her assessment roll and deliver it to the board,
30 who must immediately give a notice thereof, and of the time the board
31 of directors, acting as a board of equalization will meet to equalize
32 assessments, by publication in a newspaper published in each of the
33 counties comprising the district. The time fixed for the meeting shall
34 not be less than twenty nor more than thirty days from the first

1 publication of the notice, and in the meantime the assessment roll must
2 remain in the office of the secretary for the inspection of all persons
3 interested.

4 **Sec. 497.** RCW 87.03.255 and 1921 c 129 s 13 are each amended to
5 read as follows:

6 Upon the day specified in the notice required by RCW 87.03.250 for
7 the meeting, the board of directors, which is hereby constituted a
8 board of equalization for that purpose, shall meet and continue in
9 session from day to day as long as may be necessary, not to exceed ten
10 days, exclusive of Sundays, to hear and determine such objections to
11 the said assessment roll as may come before them; and the board may
12 change the same as may be just. The secretary of the board shall be
13 present during its session, and note all changes made at said hearing;
14 and on or before the 30th day of October in each year to and including
15 the year 1923, and on or before the 15th day of January beginning with
16 the (~~{year}~~) year 1925 and each year thereafter he or she shall have
17 the assessment roll completed as finally equalized by the board.

18 **Sec. 498.** RCW 87.03.260 and 1983 c 167 s 216 are each amended to
19 read as follows:

20 The board of directors shall in each year before said roll is
21 delivered by the secretary to the respective county treasurers, levy an
22 assessment sufficient to raise the ensuing annual interest on the
23 outstanding bonds, and all payments due or to become due in the ensuing
24 year to the United States or the state of Washington under any contract
25 between the district and the United States or the state of Washington
26 accompanying which bonds of the district have not been deposited with
27 the United States or the state of Washington as in this act provided.
28 Beginning in the year preceding the maturity of the first series of the
29 bonds of any issue, the board must from year to year increase said
30 assessment for the ensuing years in an amount sufficient to pay and
31 discharge the outstanding bonds as they mature. Similar levy and
32 assessment shall be made for the expense fund which shall include
33 operation and maintenance costs for the ensuing year. The board shall
34 also at the time of making the annual levy, estimate the amount of all
35 probable delinquencies on said levy and shall thereupon levy a
36 sufficient amount to cover the same and a further amount sufficient to

1 cover any deficit that may have resulted from delinquent assessments
2 for any preceding year. The board shall also, at the time of making
3 the annual levy, estimate the amount of the assessments to be made
4 against lands owned by the district, including local improvement
5 assessments, and shall levy a sufficient amount to pay said
6 assessments. All lands owned by the district shall be exempt from
7 general state and county taxes: PROVIDED, HOWEVER, That in the event
8 any lands, and any improvements located thereon, acquired by the
9 district by reason of the foreclosure of irrigation district
10 assessments, shall be by said district resold on contract, then and in
11 that event, said land, and any such improvements, shall be by the
12 county assessor immediately placed upon the tax rolls for taxation as
13 real property and shall become subject to general property taxes from
14 and after the date of said contract, and the secretary of the said
15 irrigation district shall be required to immediately report such sale
16 within ten days from the date of said contract to the county assessor
17 who shall cause the property to be entered on the tax rolls as of the
18 first day of January following.

19 The board may also at the time of making the said annual levy, levy
20 an amount not to exceed twenty-five percent of the whole levy for the
21 said year for the purpose of creating a surplus fund. This fund may be
22 used for any of the district purposes authorized by law. The
23 assessments, when collected by the county treasurer, shall constitute
24 a special fund, or funds, as the case may be, to be called
25 respectively, the "Bond Fund of Irrigation District," the
26 "Contract Fund of Irrigation District," the "Expense Fund
27 of Irrigation District," the " Warrant Fund of
28 Irrigation District," the "Surplus Fund of Irrigation
29 District".

30 If the annual assessment roll of any district has not been
31 delivered to the county treasurer on or before the 15th day of January
32 in the year 1927, and in each year thereafter, he or she shall notify
33 the secretary of the district by registered mail that said assessment
34 roll must be delivered to the office of the county treasurer forthwith.
35 If said assessment roll is not delivered within ten days from the date
36 of mailing of said notice to the secretary of the district, or if said
37 roll when delivered is not equalized and the required assessments
38 levied as required by law, or if for any reason the required assessment

1 or levy has not been made, the county treasurer shall immediately
2 notify the legislative authority of the county in which the office of
3 the board of directors is situated, and said county legislative
4 authority shall cause an assessment roll for the said district to be
5 prepared and shall equalize the same if necessary and make the levy
6 required by this chapter in the same manner and with like effect as if
7 the same had been equalized and made by the said board of directors,
8 and all expenses incident thereto shall be borne by the district. In
9 case of neglect or refusal of the secretary of the district to perform
10 the duties imposed by law, then the treasurer of the county in which
11 the office of the board of directors is situated must perform such
12 duties, and shall be accountable therefor, on his or her official bond,
13 as in other cases.

14 At the time of making the annual levy in the year preceding the
15 final maturity of any issue of district bonds, the board of directors
16 shall levy a sufficient amount to pay and redeem all bonds of said
17 issue then remaining unpaid. All surplus remaining in any bond fund
18 after all bonds are paid in full must be transferred to the surplus
19 fund of the district.

20 Any surplus moneys in the surplus fund or any surplus moneys in the
21 bond fund when so requested by the board of directors shall be invested
22 by the treasurer of said county under the direction of said board of
23 directors in United States bonds or bonds of the state of Washington,
24 or any bonds pronounced by the treasurer of the state of Washington as
25 valid security for the deposit of public funds, and in addition thereto
26 any bonds or warrants of said district, all of which shall be kept in
27 the surplus fund until needed by the district for the purposes
28 authorized by law.

29 **Sec. 499.** RCW 87.03.270 and 2009 c 350 s 6 are each amended to
30 read as follows:

31 The assessment roll, before its equalization and adoption, shall be
32 checked and compared as to descriptions and ownerships, with the county
33 treasurer's land rolls. On or before the fifteenth day of January in
34 each year the secretary must deliver the assessment roll or the
35 respective segregation thereof to the county treasurer of each
36 respective county in which the lands therein described are located, and

1 said assessments shall become due and payable after the county
2 treasurer has completed the property tax roll for the current year's
3 collection and provided the notification required by RCW 84.56.020.

4 All assessments on said roll shall become delinquent on the first
5 day of May following the filing of the roll unless the assessments are
6 paid on or before the thirtieth day of April of said year: PROVIDED,
7 That if an assessment is ten dollars or more for said year and if one-
8 half of the assessment is paid on or before the thirtieth day of April,
9 the remainder shall be due and payable on or before the thirty-first
10 day of October following and shall be delinquent after that date. All
11 delinquent assessments shall bear interest at the rate of twelve
12 percent per annum, computed on a monthly basis and without compounding,
13 from the date of delinquency until paid.

14 Upon receiving the assessment roll the county treasurer shall
15 prepare therefrom an assessment book in which shall be written the
16 description of the land as it appears in the assessment roll, the name
17 of the owner or owners where known, and if assessed to the unknown
18 owners, then the word "unknown", and the total assessment levied
19 against each tract of land. Proper space shall be left in said book
20 for the entry therein of all subsequent proceedings relating to the
21 payment and collection of said assessments.

22 On or before April 1st of each year, the treasurer of the district
23 shall send a statement of assessments due. County treasurers who
24 collect irrigation district assessments may send the statement of
25 irrigation district assessments together with the statement of general
26 taxes.

27 Upon payment of any assessment the county treasurer must enter the
28 date of said payment in said assessment book opposite the description
29 of the land and the name of the person paying and give a receipt to
30 such person specifying the amount of the assessment and the amount paid
31 with the description of the property assessed.

32 It shall be the duty of the treasurer of the district to furnish
33 upon request of the owner, or any person interested, a statement
34 showing any and all assessments levied as shown by the assessment roll
35 in his or her office upon land described in such request. All
36 statements of irrigation district assessments covering any land in the
37 district shall show the amount of the irrigation district assessment,
38 the dates on which the assessment is due, the place of payment, and, if

1 the property was sold for delinquent assessments in a prior year, the
2 amount of the delinquent assessment and the notation "certificate
3 issued": PROVIDED, That the failure of the treasurer to render any
4 statement herein required of him or her shall not render invalid any
5 assessments made by any irrigation district.

6 It shall be the duty of the county treasurer of any county, other
7 than the county in which the office of the board of directors is
8 located, to make monthly remittances to the county treasurer of the
9 county in which the office of the board of directors is located
10 covering all amounts collected by him or her for the irrigation
11 district during the preceding month.

12 When the treasurer collects a delinquent assessment, the treasurer
13 shall collect any other amounts due by reason of the delinquency,
14 including accrued costs, which shall be deposited to the treasurer's
15 operation and maintenance fund.

16 **Sec. 500.** RCW 87.03.272 and 1982 c 102 s 2 are each amended to
17 read as follows:

18 Notwithstanding the provisions of RCW 87.03.260, 87.03.270,
19 87.03.440, and 87.03.445, the board of directors of any district acting
20 as fiscal agent for the United States or the state of Washington for
21 the collection of any irrigation charges may authorize the secretary of
22 the district to act as the exclusive collection agent for the
23 collection of all nondelinquent irrigation assessments of the district
24 pursuant to such rules and regulations as the board of directors may
25 adopt.

26 When the secretary acts as collection agent, his or her official
27 bond shall be of a sufficient amount as determined by the board of
28 directors of the district to cover any amounts he or she may be
29 handling while acting as collection agent, in addition to any other
30 amount required by reason of his or her other duties.

31 The assessment roll of such district shall be delivered to the
32 county treasurer in accordance with the provisions of RCW 87.03.260 and
33 87.03.270 and the assessment roll shall be checked and verified by the
34 county treasurer as provided in RCW 87.03.270.

35 After the assessment roll has been checked and verified by the
36 county treasurer, the secretary of the district shall proceed to
37 publish the notice as required under RCW 87.03.270; except that the

1 notice shall provide that until the assessments and tolls become
2 delinquent on November 1st they shall be due and payable in the office
3 of the secretary of the district.

4 When the secretary of such district receives payments, he or she
5 shall issue a receipt for such payments and shall be accountable on his
6 or her official bond for the safekeeping of such funds and shall remit
7 the same, along with an itemized statement of receipts, at least once

10 When the county treasurer receives the monthly statement of
11 receipts from the secretary, he or she shall enter the payments shown

14 of the secretary to transmit to the county treasurer the delinquency
15 list which shall include the names, amounts, and such other information
16 as the county treasurer shall require, and thereafter the secretary
17 shall not accept any payment on the delinquent portion of any account.
18 Upon receipt of the list of delinquencies, the county treasurer shall
19 proceed under the provisions of this chapter as though he or she were
20 the collection agent for such district to the extent of such delinquent
21 accounts.

22 **Sec. 501.** RCW 87.03.280 and 1925 c 3 s 1 are each amended to read
23 as follows:

24 Where any district under contract with the United States has levied
25 any assessment for the collection of money payable to the United States
26 under such contract, and the secretary of the interior has by agreement
27 with the board of directors of said district, authorized the extension
28 or cancellation of any payments due to the United States by the
29 cancellation of assessments already levied therefor but remaining
30 unpaid, the board of directors of such district shall certify to the
31 county treasurer of the county in which the land is located, a
32 statement of the year and amounts assessed against each tract for which
33 such cancellation has been authorized, and the county treasurer, upon
34 receipt of such certificate, shall, in all cases where the assessment
35 remains unpaid and the lands have not been sold, endorse upon the
36 district's assessment roll, "Corrected under Certificate of Board of

1 such tract the amount of such assessment so authorized to be canceled;
2 and in all cases where such cancellations have been certified to the
3 county treasurer after such lands assessed have been sold and before
4 the period of redemption shall have expired, the county treasurer
5 shall, in those cases where the tract assessed has been sold to the
6 district, and the district is the owner of the certificate of sale,
7 require the district to surrender its certificate of sale and shall
8 thereupon deduct the amount of such cancellation plus the penalties
9 thereon upon the original assessment roll with an endorsement,
10 "Corrected under Certificate of Board of Directors" and he or she shall
11 thereupon issue to the district in lieu of the certificate surrendered,
12 a substitute certificate of sale for the corrected amount of such
13 assessment, if any, remaining uncanceled, and shall file a copy thereof
14 in the office of the county auditor as in the case of the original
15 certificate surrendered, and such substitute certificate shall entitle
16 the holder thereof to all rights possessed under the original
17 certificate so corrected as to amount: PROVIDED, HOWEVER, That such
18 cancellation shall have the same effect as though the lands had
19 originally not been assessed for the amounts so deducted and shall not
20 operate to bar the district of the right in making subsequent annual
21 assessments to levy and collect against such tracts the amount of any
22 money due the United States, including the amount of any assessments so
23 canceled.

24 **Sec. 502.** RCW 87.03.440 and 1996 c 320 s 18 and 1996 c 214 s 1 are
25 each reenacted and amended to read as follows:

26 The treasurer of the county in which is located the office of the
27 district shall be ex officio treasurer of the district, and any county
28 treasurer handling district funds shall be liable upon his or her
29 official bond and to criminal prosecution for malfeasance and
30 misfeasance, or failure to perform any duty as county or district
31 treasurer. The treasurer of each county in which lands of the district
32 are located shall collect and receipt for all assessments levied on
33 lands within his or her county. There shall be deposited with the
34 district treasurer all funds of the district. The district treasurer
35 shall pay out such funds upon warrants issued by the county auditor
36 against the proper funds of the district, except the sums to be paid
37 out of the bond fund for interest and principal payments on bonds:

1 PROVIDED, That in those districts which designate their own treasurer,
2 the treasurer may issue the warrants or any checks when the district is
3 authorized to issue checks. All warrants shall be paid in the order of
4 their issuance. The district treasurer shall report, in writing, on
5 the first Monday in each month to the directors, the amount in each
6 fund, the receipts for the month preceding in each fund, and file the
7 report with the secretary of the board. The secretary shall report to
8 the board, in writing, at the regular meeting in each month, the amount
9 of receipts and expenditures during the preceding month, and file the
10 report in the office of the board.

11 The preceding paragraph of this section notwithstanding, the board
12 of directors or board of control of an irrigation district which lies
13 in more than one county and which had assessments in each of two of the
14 preceding three years equal to at least five hundred thousand dollars,
15 or a board of joint control created under chapter 87.80 RCW, may
16 designate some other person having experience in financial or fiscal
17 matters as treasurer of the district. In addition, the board of
18 directors of an irrigation district which lies entirely within one
19 county may designate some other person having experience in financial
20 or fiscal matters as treasurer of the district if the district had
21 assessments, tolls, and miscellaneous collections in each of two of the
22 preceding three years equal to at least two million dollars or if the
23 board has the approval of the county treasurer to designate some other
24 person. If a board designates a treasurer, it shall require a bond
25 with a surety company authorized to do business in the state of
26 Washington in an amount of two hundred fifty thousand dollars
27 conditioned that he or she will faithfully perform the duties of his or
28 her office as treasurer of the district. The premium on the bond shall
29 be paid by the district. The designated treasurer shall collect and
30 receipt for all irrigation district assessments on lands within the
31 district and shall act with the same powers and duties and be under the
32 same restrictions as provided by law for county treasurers acting in
33 matters pertaining to irrigation districts, except the powers, duties,
34 and restrictions in RCW 87.56.110 and 87.56.210 which shall continue to
35 be those of county treasurers.

36 In those districts which have designated their own treasurers, the
37 provisions of law pertaining to irrigation districts which require
38 certain acts to be done and which refer to and involve a county

1 treasurer or the office of a county treasurer or the county officers
2 charged with the collection of irrigation district assessments, except
3 RCW 87.56.110 and 87.56.210 shall be construed to refer to and involve
4 the designated district treasurer or the office of the designated
5 district treasurer.

6 Any claim against the district for which it is liable under
7 existing laws shall be presented to the board as provided in RCW
8 4.96.020 and upon allowance it shall be attached to a voucher and
9 approved by the ((~~chairman~~)) chair and signed by the secretary and
10 directed to the proper official for payment: PROVIDED, That in the
11 event claimant's claim is for crop damage, the claimant in addition to
12 filing his or her claim within the applicable period of limitations
13 within which an action must be commenced and in the manner specified in
14 RCW 4.96.020 must file with the secretary of the district, or in the
15 secretary's absence one of the directors, not less than three days
16 prior to the severance of the crop alleged to be damaged, a written
17 preliminary notice pertaining to the crop alleged to be damaged. Such
18 preliminary notice, so far as claimant is able, shall advise the
19 district; that the claimant has filed a claim or intends to file a
20 claim against the district for alleged crop damage; shall give the name
21 and present residence of the claimant; shall state the cause of the
22 damage to the crop alleged to be damaged and the estimated amount of
23 damage; and shall accurately locate and describe where the crop alleged
24 to be damaged is located. Such preliminary notice may be given by
25 claimant or by anyone acting in his or her behalf and need not be
26 verified. No action may be commenced against an irrigation district
27 for crop damages unless claimant has complied with the provisions of
28 RCW 4.96.020 and also with the preliminary notice requirements of this
29 section.

30 **Sec. 503.** RCW 87.03.442 and 1961 c 276 s 4 are each amended to
31 read as follows:

32 The secretary or other authorized person shall issue receipts for
33 all moneys received for deposit in such funds and he or she and any
34 other person handling the funds shall furnish a surety bond to be
35 approved by the board and the attorney for the district, in such amount
36 as the board may designate and conditioned for the safekeeping of such
37 funds and the premium thereon shall be paid by the district.

1 Upon depositing any district funds the secretary shall demand and
2 the depositary bank shall furnish a surety bond, to be approved by the
3 board and the attorney, in an amount equal to the maximum deposit,
4 conditioned for the prompt payment of the deposits upon demand, and the
5 bond shall not be canceled during the time for which it was written.
6 Or the depositary may deposit with the secretary or in some bank to the
7 credit of the district in lieu of the bond, securities approved by the
8 board of a market value in an amount not less than the amount of the
9 maximum deposit. All depositaries which have qualified for insured
10 deposits under any federal deposit insurance act need not furnish bonds
11 or securities, except for so much of the deposit as is not so insured.

12 **Sec. 504.** RCW 87.03.570 and 1889-90 p 695 s 50 are each amended to
13 read as follows:

14 The board of directors, at the time and place mentioned in said
15 notice, or at such other time or times to which the hearing of said
16 petition may be adjourned, shall proceed to hear the petition and all
17 the objections thereto presented in writing by any person showing
18 cause, as aforesaid, why said proposed change of the boundaries of the
19 district should not be made. The failure by any person interested in
20 said district, or in the matter of the proposed change of its
21 boundaries, to show cause in writing, as aforesaid, shall be deemed and
22 taken as an assent on his or her part to a change of the boundaries of
23 the district as prayed for in said petition, or to such a change
24 thereof as will include a part of said lands. And the filing of such
25 petition with said board, as aforesaid, shall be deemed and taken as an
26 assent on the part of each and all of such petitioners to such a change
27 of said boundaries that they may include the whole or any portion of
28 the lands described in said petition.

29 **Sec. 505.** RCW 87.03.610 and 1889-90 p 698 s 58 are each amended to
30 read as follows:

31 A guardian, an executor or administrator of an estate, who is
32 appointed as such under the laws of this state, and who, as such
33 guardian, executor or administrator, is entitled to the possession of
34 the lands belonging to the estate which he or she represents, may, on
35 behalf of his or her ward or the estate which he or she represents,
36 upon being thereunto authorized by the proper court, sign and

1 acknowledge the petition in this act mentioned, and may show cause, as
2 in this act mentioned, why the boundaries of the district should not be
3 changed.

4 **Sec. 506.** RCW 87.03.660 and 1921 c 129 s 38 are each amended to
5 read as follows:

6 The board of directors, at the time and place mentioned in the
7 notice, or at the time or times to which the hearing of said petition
8 may be adjourned, shall proceed to hear the petition, and all
9 objections thereto presented in writing, by any person showing cause,
10 as aforesaid, why the prayer of said petition should not be granted.
11 The failure of any person interested in said district or consolidated
12 district to show cause, in writing, why the tract or tracts of land
13 mentioned in said petition should not be excluded from said district,
14 or the former district mentioned should not be excluded from the
15 consolidated district, as the case may be, shall be deemed and taken as
16 an assent by him or her to such exclusion, and the filing of such
17 petition with such board, as aforesaid, shall be deemed and taken as an
18 assent by each and all of such petitioners to such exclusion.

19 **Sec. 507.** RCW 87.03.690 and 1889-90 p 703 s 71 are each amended to
20 read as follows:

21 A guardian, and executor or an administrator of an estate who is
22 appointed as such under the laws of this state, and who, as such
23 guardian, executor or administrator, is entitled to the possession of
24 the lands belonging to the estate which he or she represents, may, on
25 behalf of his or her ward or the estate which he or she represents,
26 upon being thereto properly authorized by the proper court, sign and
27 acknowledge the petition in this act mentioned, and may show cause, as
28 in this act provided, why the boundaries of the district should not be
29 changed.

30 **Sec. 508.** RCW 87.03.760 and 1988 c 202 s 86 are each amended to
31 read as follows:

32 At the conclusion, or final adjournment, of the hearing provided
33 for in RCW 87.03.755, the board of directors of the district shall have
34 the power, by unanimous resolution to adopt the proposed plan, or such
35 modification thereof as may be determined by the board, and reduce the

1 boundaries of the district to such area as, in the judgment of the
2 board, can be furnished with sufficient water for successful irrigation
3 by the irrigation system of the district, and to exclude from the
4 district all lands lying outside of such reduced boundaries, and
5 provide for the repayment to the owners of any such excluded lands,
6 respectively, of any sums paid for assessments levied by the district,
7 and to cancel all unpaid assessments levied by the district against the
8 lands excluded and release such lands from further liability therefor.
9 Any person interested and feeling himself or herself aggrieved by the
10 adoption of such final resolution reducing the boundaries of the
11 district and excluding lands therefrom, shall have a right of appeal
12 from the action of the board to the superior court of the county in
13 which the district is situated, which appeal may be taken in the manner
14 provided by law for appeals from justices' courts, and if upon the
15 hearing of such appeal it shall be determined by the court that the
16 irrigation system of the district will not furnish sufficient water for
17 the successful irrigation of the lands included within the reduced
18 boundaries of the district, or that any lands have been excluded from
19 the district unnecessarily, arbitrarily, capriciously, or fraudulently
20 or without substantial reason for such exclusion, the court shall enter
21 a decree canceling and setting aside the proceedings of the board of
22 directors, otherwise the court shall enter a decree confirming the
23 action of the board. Any party to the proceedings on appeal in the
24 superior court, feeling himself or herself aggrieved by the decree of
25 the superior court confirming the action of the board of directors of
26 the district reducing the boundaries of the district and excluding
27 lands therefrom, may seek appellate review within thirty days after the
28 entry of the decree of the superior court in the manner provided by
29 law. If, at the expiration of thirty days from the entry of the final
30 resolution of the board of directors of the district reducing the
31 boundaries of the district and excluding lands therefrom, no appeal has
32 been taken to the superior court of the county in which the district is
33 situated, or if, after hearing upon appeal the superior court shall
34 confirm the action of the district, and at the expiration of thirty
35 days from the entry of such decree, no appellate review is sought, the
36 boundaries of the district shall thereafter be in accordance with the
37 resolution of the board reducing the boundaries, and all lands excluded
38 from the district by such resolution shall be relieved from all further

1 liability for any indebtedness of the district or any unpaid
2 assessments theretofore levied against such lands, and the owners of
3 excluded lands, upon which assessments have been paid, shall be
4 entitled to warrants of the district for all sums paid by reason of
5 such assessments, payable from a special fund created for that purpose,
6 for which levies shall be made upon the lands remaining in the
7 district, as the board of directors may provide.

8 **Sec. 509.** RCW 87.03.765 and 1988 c 202 s 87 are each amended to
9 read as follows:

10 Whenever it shall appear, to the satisfaction of the director of
11 ecology, that the irrigation system of any irrigation district, to
12 which the department of ecology of the state of Washington under a
13 contract with the district for the purchase of its bonds, has advanced
14 funds for the purpose of constructing an irrigation system for the
15 district, has been found incapable of furnishing sufficient water for
16 the successful irrigation of all of the lands of such district, and
17 that the board of directors of such district has reduced the boundaries
18 thereof and excluded from the district, as provided in RCW 87.03.750
19 through 87.03.760, sufficient lands to render such irrigation system
20 adequate for the successful irrigation of the lands of the district,
21 and that more than thirty days have elapsed since the adoption of the
22 resolution by the board of directors reducing the boundaries of the
23 district and excluding lands therefrom, and no appeal has been taken
24 from the action of the board, or that the action of the board has been
25 confirmed by the superior court of the county in which the district is

29 confirmed, the director of ecology shall be and he or she is hereby
30 authorized to cancel and reduce the obligation of the district to the
31 department of ecology, for the repayment of moneys advanced for the
32 construction of an irrigation system for the district, to such amount
33 as, in his or her judgment, the district will be able to pay from
34 revenues derived from assessments upon the remaining lands of the
35 district, and to accept, in payment of the balance of the obligation of
36 the district, the authorized bonds of the district, in numerical order
37 beginning with the lowest number, on the basis of the percentage of the

1 face value thereof fixed in contracts between the district and the
2 department of ecology, in an amount equal to said balance of the
3 obligation of the district, in full and complete satisfaction of all
4 claims of the department of ecology against the district.

5 **Sec. 510.** RCW 87.03.820 and 1973 c 150 s 1 are each amended to
6 read as follows:

7 Whenever as the result of abandonment of an irrigation district
8 right-of-way real property held by an irrigation district is to be sold
9 or otherwise disposed of, notice shall be given to the owners of lands
10 adjoining that real property and such owners shall have a right of
11 first refusal to purchase at the appraised price all or any part of the
12 real property to be sold or otherwise disposed of which adjoins or is
13 adjacent to their land.

14 Real property to be sold or otherwise disposed of under this
15 section shall have been first appraised by the county assessor or by a
16 person designated by him or her.

17 Notice under this section shall be sufficient if sent by registered
18 mail to the owner, and at the address, as shown in the tax records of
19 the county in which the land is situated. Notice under this section
20 shall be in addition to any other notice required by law.

21 After sixty days from the date of sending of notice, if no
22 applications for purchase have been received by the irrigation district
23 or other person or entity sending notice, the rights of first refusal
24 of owners of adjoining lands shall be deemed to have been waived, and
25 the real property may be sold or otherwise disposed of.

26 If two or more owners of adjoining lands apply to purchase the same
27 real property, or apply to purchase overlapping parts of the real
28 property, the respective rights of the applicants may be determined in
29 the superior court of the county in which the real property is
30 situated; and the court may divide the real property in question
31 between some or all of the applicants or award the whole to one
32 applicant, as justice may require.

33 Any sale or other disposal of real property pursuant to chapters
34 87.52, 87.53, and 87.56 RCW shall be made in accordance with the
35 requirements of this section.

1 **Sec. 511.** RCW 87.04.010 and 1961 c 192 s 1 are each amended to
2 read as follows:

3 An irrigation district comprising two hundred thousand or more
4 acres, or irrigation districts comprising less than two hundred
5 thousand acres which have followed the optional procedure specified in
6 this amendatory act, shall be divided into divisions of as nearly equal
7 area as practical, consistent with being fair and equitable to the
8 electors of the district. The number of divisions shall be the same as
9 the number of directors, which shall be numbered first, second, third,
10 etc. One director, who shall be an elector of the division, shall be
11 elected for each division of the district by the electors of his or her
12 division. A district elector shall be considered an elector of the
13 division in which he or she holds title to or evidence of title to
14 land. An elector holding title to or evidence of title to land in more
15 than one division shall be considered an elector of the division
16 nearest his or her place of residence.

17 **Sec. 512.** RCW 87.22.065 and 1929 c 120 s 7 are each amended to
18 read as follows:

19 Said notice shall state that the district (naming it) proposes to
20 issue and dispose of a refunding bond issue specifying the amount; that
21 proceedings have been instituted in the superior court of the state of
22 Washington in and for the specified county to determine the maximum
23 benefits to be received by the lands within the operation of said
24 district from the issuance and disposal of said proposed bond issue,
25 and further to determine the irrigable acreage which will be assessed
26 for the payment of said bonds, shall state that a schedule of the lands
27 involved together with a statement of the amount of maximum benefits
28 received by the amount of irrigable acreage in each respectively, is on
29 file in said proceedings and may be inspected by any interested person,
30 shall state the time and place fixed for the hearing of the petition
31 and shall state that any person interested in such proceedings may on
32 or before the day fixed for said hearing file his or her written
33 objections thereto with the clerk of said court, or he or she will be
34 forever bound by such orders as the court shall make in such
35 proceedings.

1 **Sec. 513.** RCW 87.22.215 and 1929 c 120 s 30 are each amended to
2 read as follows:

3 Any bondholder or group of bondholders shall have the right to
4 request said county treasurer in writing to pay the interest and
5 installments of principal of his or her or their bond or bonds to such
6 agent as may be designated in said request and payment to said agent
7 shall constitute a valid payment to the record owner or owners of said
8 bond or bonds within the provisions of this chapter.

9 **Sec. 514.** RCW 87.25.030 and 1988 c 127 s 51 are each amended to
10 read as follows:

11 If, after the investigation herein provided for, the director finds
12 that the project of the district is feasible, that the bond issue
13 proposed to be certified is necessary and in sufficient amount to
14 complete the improvement contemplated and that the district shows a
15 clear probability of successful operation, he or she shall submit a
16 complete transcript, to be furnished and certified by the district, of
17 the proceedings relating to the organization and establishment of the
18 district and relating to or affecting the validity of the bond issue
19 involved, to the attorney general, for his or her written opinion as to
20 the legality of the same. If the attorney general finds that any of
21 the matters submitted in the transcript are not legally sufficient he
22 or she shall so state in his or her opinion to the director of ecology.
23 The district shall then be given an opportunity, if possible, to
24 correct the proceeding or thing complained of to the satisfaction of
25 the attorney general. If the attorney general finds that all the
26 matters submitted in the transcript as originally submitted or as

31 **Sec. 515.** RCW 87.25.060 and 1923 c 51 s 6 are each amended to read
32 as follows:

33 When the proposed bond issue has been finally approved by the
34 director, he or she shall file a supplemental report with the secretary
35 of state giving the numbers, date or dates of issue, and denominations

1 of said bonds which shall then be entitled to certification as herein
2 provided.

3 **Sec. 516.** RCW 87.25.100 and 1988 c 127 s 55 are each amended to
4 read as follows:

5 Whenever the bonds of any irrigation district have been certified,
6 as provided in this chapter, no expenditures shall be made from the
7 proceeds of such bonds, nor shall any liability chargeable against such
8 proceeds be incurred, until there shall have been filed with and
9 approved by the director of ecology a schedule of proposed expenditures
10 in such form as said director shall prescribe, and no expenditures from
11 the proceeds of said bonds shall be made for any purpose in excess of
12 the amount allowed therefor in such schedule without the written
13 consent of said director: PROVIDED, FURTHER, That, if it shall be
14 necessary, the attorney general may employ competent attorneys to
15 assist him or her in the performance of his or her duties under this
16 chapter, said attorneys to be paid by the irrigation district for which
17 services are rendered from any of the funds of said district at such
18 time and in such manner as the attorney general shall require.

19 **Sec. 517.** RCW 87.52.030 and 1897 c 79 s 3 are each amended to read
20 as follows:

21 Upon the delivery of said petition the board of directors of said
22 irrigation district shall, at their next succeeding regular monthly
23 meeting, order an election, the date of which election shall be within
24 twenty days from the date of said meeting of the board of directors and
25 which election shall be conducted as other elections of irrigation
26 districts are conducted. At said election the qualified electors of
27 said irrigation district shall cast ballots which shall contain the
28 words "Disorganize, Yes," or "Disorganize, No." No person shall be
29 entitled to vote at any election held under the provisions of RCW
30 87.52.010 through 87.52.060 unless he or she is a qualified voter under
31 the election laws of the state, and holds title or evidence of title to
32 land in said district.

33 **Sec. 518.** RCW 87.52.040 and 1897 c 79 s 4 are each amended to read
34 as follows:

35 If three-fifths of the votes cast at any election under the

1 provisions of RCW 87.52.010 through 87.52.060 shall contain the words
2 "Disorganize, Yes," then the board of directors shall present to the
3 superior judge of the county in which said irrigation district is
4 located an application for an order of said superior court that such
5 irrigation district be declared disorganized and dissolved, and that
6 its affairs be liquidated and wound up, as provided for in RCW
7 87.52.010 through 87.52.060, and reciting that at an election of such
8 irrigation district, held as provided in RCW 87.52.010 through
9 87.52.060, three-fifths of the votes cast contained the words
10 "Disorganize, Yes," and such petition shall be certified to by the

26 order declaring said irrigation district dissolved and disorganized.

27 **Sec. 519.** RCW 87.52.060 and 1897 c 79 s 5 are each amended to read
28 as follows:

29 Upon the disorganization of any irrigation district under the
30 provisions of RCW 87.52.010 through 87.52.060, the board of directors
31 at the time of the disorganization shall be trustees of the creditors
32 and of the property holders of said district for the purpose of
33 collecting and paying all indebtedness of said district, in which
34 actual construction work has been done, and shall have the power to sue
35 and be sued. It shall be the duty of said board of directors, and they
36 shall have the power and authority, to levy and collect a tax
37 sufficient to pay all such indebtedness, which tax shall be levied and

1 collected in the manner prescribed by law for the levying and

17 the legal limitation of indebtedness specified by law for irrigation
18 districts; or any indebtedness contracted by such irrigation district
19 or its officers without lawful authority.

20 **Sec. 520.** RCW 87.53.100 and 1951 c 237 s 10 are each amended to
21 read as follows:

22 Upon the entry of final judgment, the court shall issue an order
23 appointing a trustee for the district and shall deliver to him or her
24 a certified copy of the order. The court shall fix the compensation of
25 the trustee and the amount of his or her bond to be obtained at the
26 cost of the district.

27 **Sec. 521.** RCW 87.53.120 and 1951 c 237 s 12 are each amended to
28 read as follows:

29 The trustee shall file with the clerk a report of the disposition
30 made of the cash funds and of the sale and if the court finds the sale
31 was fairly conducted, it shall enter an order confirming the sale, and
32 the trustee shall execute and deliver to the purchaser an instrument
33 conveying to him or her all property and rights of the district, free
34 from all claims of the district or its creditors, which shall entitle
35 the purchaser to immediate possession.

1 **Sec. 522.** RCW 87.53.150 and 1988 c 127 s 62 are each amended to
2 read as follows:

3 Whenever any bonds of the district are held in the state
4 reclamation revolving account, and, in the opinion of the director of
5 ecology, the district is or will be unable to meet its obligations, and
6 that the state's investment can be best preserved by the dissolution of
7 the district the director may give his or her consent to dissolution
8 under such stipulations and adjustments of the indebtedness as he or
9 she deems best for the state.

10 **Sec. 523.** RCW 87.56.040 and 1925 ex.s. c 124 s 4 are each amended
11 to read as follows:

12 Such action shall be one in rem and personal service of process
13 shall not be required to be made on any interested person: PROVIDED,
14 That the court shall be authorized in proper instances to order
15 issuance and personal service of process specifying such time for
16 appearance as the court shall require, AND PROVIDED FURTHER, That any
17 owner of land within the district or any creditor of the district or
18 their respective attorneys may file with the receiver provided for in
19 this chapter, a written request that his or her name and address be
20 placed on the receiver's mailing list and thereafter the receiver shall
21 mail to such person at his or her given address at least ten days'
22 written notice of all subsequent hearings before the court. Personal
23 service of said notice may be made in any instance in lieu of mailing
24 at the option of the receiver.

25 **Sec. 524.** RCW 87.56.180 and 1925 ex.s. c 124 s 23 are each amended
26 to read as follows:

27 The judgment shall also name a trustee to be nominated by the
28 creditors representing a majority of the indebtedness who shall give
29 bond conditioned for the faithful performance of his or her duties and
30 the strict accounting of all funds received by him or her in such
31 amount as the court shall determine, and who shall have authority to
32 receive payment on account of said judgment and to satisfy said
33 judgment against the several lands at the time payment thereon is made
34 by the landowners in proportion to the amount of said payment. When
35 any landowner shall make full payment of the amount of the judgment

1 apportioned against his or her land, he or she shall be entitled to
2 full satisfaction thereof of record.

3 **Sec. 525.** RCW 87.56.190 and 1925 ex.s. c 124 s 24 are each amended
4 to read as follows:

5 In case any landowner fails to pay the judgment against his or her
6 land or any installment thereof, when the same shall become due and
7 payable, said judgment may be enforced by the trustee named in the
8 decree in the manner provided by law for the enforcement of judgments
9 in the superior court, and the costs of execution and sale shall be
10 charged to the defaulting land.

11 **Sec. 526.** RCW 87.56.203 and 1925 ex.s. c 124 s 26 are each amended
12 to read as follows:

13 The trustee named in the decree shall receive such compensation for
14 his or her services as the court shall determine to be paid at such
15 times as the court shall fix from funds collected on account of said
16 judgment.

17 **Sec. 527.** RCW 87.56.210 and 1925 ex.s. c 124 s 28 are each amended
18 to read as follows:

19 If the judgment rendered by the court, upon stipulation, be not
20 appealed from as in this chapter provided and the time for appeal has
21 expired, or having been appealed from has been finally determined upon
22 appeal, the court shall upon application of the receiver, order all
23 evidences of indebtedness filed in the registry of the court under the
24 provisions relating to judgment upon stipulation to be delivered to the
25 office of the county treasurer, who shall have authority and it shall
26 be his or her duty to cancel the same, and said evidences of
27 indebtedness shall thereafter cease to be obligations of the district,
28 and the district thereafter shall be discharged of said indebtedness.

29 **Sec. 528.** RCW 87.64.010 and 1983 c 167 s 243 are each amended to
30 read as follows:

31 Whenever the state shall now or hereafter own, the entire issue of
32 the bonds of any irrigation, diking or drainage district, and in the
33 judgment of the director of ecology such district is, or will be,
34 unable to meet its obligations to the state as they mature, and in the

1 judgment of the director of ecology the investment of the state can be
2 made more secure by extending, without refunding, the time of payment
3 of any or all said bonds and interest payments, or by the exchange of
4 the bonds held by the state for refunding bonds of such district issued
5 as in the manner provided by law at the same or a lower rate of
6 interest and/or for a longer term, or by the cancellation of a portion
7 of the bonds held by the state and/or interest accrued thereon, and the

19 **Sec. 529.** RCW 87.64.020 and 1983 c 167 s 244 are each amended to
20 read as follows:

21 Whenever the state shall, now or hereafter, own a portion of the
22 bonds of any irrigation, diking, or drainage district, and in the
23 judgment of the director of ecology such district is, or will be,
24 unable to meet its obligations as they mature, and in the judgment of
25 the director of ecology the investment of the state can be made more
26 secure by extending, without refunding, the time of payment of any or
27 all said bonds and interest payments or by exchanging the bonds held by
28 the state for the refunding bonds of the district issued in the manner
29 provided by law at the same or a lower rate of interest and/or for a
30 longer term, or by the cancellation of a portion of the bonds held by
31 the state and/or interest accrued thereon, and the exchange of the
32 remaining bonds held by the state for the refunding bonds of the
33 district issued in the manner provided by law at the same or a lower
34 rate of interest and/or for a longer term, the director of ecology

5 PROVIDED, That the owners of at least ninety percent of all the other
6 bonds of said district shall make and execute the same arrangement with
7 the district: AND PROVIDED FURTHER, That when, in addition to owning
8 a portion of the first issue of bonds of any such irrigation, diking,
9 or drainage district, the state also owns all the outstanding second
10 issue of bonds of such district, the director of ecology shall be and
11 he or she is hereby authorized and empowered to surrender and cancel
12 said second issue of bonds held by the state upon whatsoever terms and
13 conditions he or she shall deem to the best interest of the state: AND
14 PROVIDED FURTHER, That whenever the owners of at least ninety percent
15 of all other bonds of such district and/or other evidences of
16 indebtedness are willing to release their existing obligations against
17 said district and to substitute therefor a contract to pay such
18 existing indebtedness in whole or in part from the proceeds of the sale
19 of lands owned by the district at the time of such settlement, or
20 acquired by the district through levies then existing, the director of
21 ecology shall be and he or she is hereby authorized and empowered to
22 cancel the bonds held by the state upon whatsoever terms that he or she
23 shall deem most beneficial for the state, or if deemed beneficial to
24 the state, he or she may release the state's bonds and join with the
25 other holders in the above mentioned contract for the sale of the
26 district land as hereinbefore stated: AND PROVIDED FURTHER, That the
27 director of ecology be and he or she is hereby authorized to accept in
28 any settlement made under this chapter, refunding bonds of any
29 irrigation district that may be issued in accordance with chapter 87.22
30 RCW, or any amendment thereto, and he or she is hereby authorized, when
31 in his or her judgment it is to the interest of the state, to
32 participate in the refunding of bonds of an irrigation district held
33 under said chapter 87.22 RCW, or any amendment thereto.

34 **Sec. 530.** RCW 87.64.040 and 1988 c 127 s 64 are each amended to
35 read as follows:

36 Whenever the department of ecology shall have heretofore entered,
37 or shall hereafter enter, into a contract with an irrigation, diking,

1 or drainage district and shall have expended moneys under said
2 contract, and said district shall be indebted to the state for the
3 moneys so expended, and in the judgment of the director of ecology said
4 district shall have not received benefits equal to the amount of said
5 indebtedness, the director of ecology shall be and is hereby authorized
6 and empowered to settle and compromise the claim of the state against
7 said district upon such terms and for such an amount as he or she shall
8 deem fair and just to the state and the district.

9 **Sec. 531.** RCW 87.84.070 and 1973 1st ex.s. c 195 s 132 are each
10 amended to read as follows:

11 The directors shall be empowered to specially assess land located
12 in the district for benefits thereto taking as a basis the last
13 equalized assessment for county purposes: PROVIDED, That such
14 assessment shall not exceed twenty-five cents per thousand dollars of
15 assessed value upon such assessed valuation without securing
16 authorization by vote of the electors of the district at an election
17 called for that purpose.

19 in the manner and form provided for irrigation district elections. The
20 manner of conducting and voting at such an election, opening and
21 closing polls, canvassing the votes, certifying the returns, and
22 declaring the result shall be nearly as practicable the same as in
23 irrigation district elections.

24 The special assessment provided for herein shall be due and payable
25 at such times and in such amounts as designated by the district
26 directors, which designation shall be made to the county auditor in
27 writing, and the amount so designated shall be added to the general
28 taxes, and entered upon the assessment rolls in his or her office, and
29 collected therewith.

30 **Sec. 532.** RCW 88.08.060 and 1909 c 249 s 293 are each amended to
31 read as follows:

32 Every person not duly licensed thereto, who shall pilot or offer to
33 pilot any vessel into, within or out of the waters of Juan de Fuca
34 Strait or Puget Sound, shall be guilty of a misdemeanor: PROVIDED,
35 That nothing herein shall prohibit a master of a vessel acting as his

1 or her own pilot, nor compel a master or owner of any vessel to take
2 out a pilot license for that purpose.

3 **Sec. 533.** RCW 88.16.130 and 1977 ex.s. c 337 s 14 are each amended
4 to read as follows:

5 Any person not holding a license as pilot under the provisions of
6 this chapter who pilots any vessel subject to the provisions of this
7 chapter on waters covered by this chapter shall pay to the board the
8 pilotage rates payable under the provisions of this chapter. Any
9 master or owner of a vessel required to employ a pilot licensed under
10 the provisions of this chapter who refuses to do so when such a pilot
11 is available shall be punished pursuant to RCW 88.16.150 as now or
12 hereafter amended and shall be imprisoned in the county jail of the
13 county wherein he or she is so convicted until said fine and the costs
14 of his or her prosecution are paid.

15 **Sec. 534.** RCW 88.24.010 and Code 1881 s 3271 are each amended to

17 Any person owning land adjoining any navigable waters or
18 watercourse, within or bordering upon this state, may erect upon his or
19 her own land any wharf or wharves, and may extend them so far into said
20 waters or watercourses as the convenience of shipping may require; and
21 he or she may charge for wharfage such rates as shall be reasonable:
22 PROVIDED, That he or she shall at all times leave sufficient room in
23 the channel for the ordinary purposes of navigation.

24 **Sec. 535.** RCW 88.24.020 and 1893 c 49 s 1 are each amended to read
25 as follows:

26 (1) Whenever any person shall be desirous of erecting any wharf at
27 the terminus of any public highway, or at any accustomed landing place,
28 he or she may apply to the county commissioners of the proper county,
29 who, if they shall be satisfied that the public convenience requires
30 said wharf, may authorize the same to be erected and kept up for any
31 length of time not exceeding twenty years. And they shall annually
32 prescribe the rates of wharfage and charges thereon, but there shall be
33 no charge for the landing of passengers or their baggage.

34 (2) No such authority shall be granted to any person other than the
35 owner of the land where the wharf is proposed to be erected, unless

1 such owner shall neglect to apply for such authority; and whenever
2 application shall be made for such authority by any person other than

9 county commissioners at which application shall be made and by serving
10 a copy of said notice in writing upon such owner of the land, if
11 residing in the county, at least ten days before the session of the
12 board of county commissioners at which the application is made.

13 (3) When such application is heard, if the owner of such land
14 applies for such authority and files his or her undertaking with one or
15 more sureties to be approved by the county commissioners in a sum not
16 less than one hundred dollars nor more than five hundred dollars, to be
17 fixed by the county commissioners, conditioned that such person will
18 erect said wharf within the time therein limited, to be fixed by the
19 county commissioners, and maintain the same and keep said wharf
20 according to law; and if default shall at any time be made in the
21 condition of such undertaking damages not exceeding the penalty may be
22 recovered by any person aggrieved before any court having competent
23 jurisdiction, then said county commissioners shall authorize such owner
24 of the land to erect and keep such wharf.

25 (4) If such owner of the land does not apply as aforesaid the
26 commissioners may authorize the same to be erected and kept by such
27 applicant upon his or her entering into an undertaking as required of
28 such owner of the land.

29 **Sec. 536.** RCW 88.24.030 and Code 1881 s 3273 are each amended to
30 read as follows:

31 Whenever any person or persons shall be desirous of erecting a
32 wharf at the terminus of any street of any incorporated town or city in
33 the state, he or she or they may apply to the municipal authorities of
34 such town or city who, if they shall be satisfied that the public
35 convenience requires said wharf, may authorize the same to be erected
36 and kept in repair for any length of time not exceeding ten years; and
37 every person building, owning or occupying a wharf in this state, upon

1 which wharfage is charged and received, shall be held accountable to
2 the owner or owners, consignees or agents, for any and all damage done
3 to property stored upon, or passing over said wharf, in consequence of
4 the unfinished, incomplete, or insufficient condition of said wharf;
5 and every such person shall post or cause to be posted in a conspicuous
6 place on said wharf the established rates of wharfage, noting
7 passengers and their baggage free.

8 **Sec. 537.** RCW 88.32.020 and 1907 c 236 s 2 are each amended to
9 read as follows:

10 Whenever the board of county commissioners of any such county shall
11 have adjudged as provided in RCW 88.32.010, said board shall thereupon
12 apply to the person, who, for the time being, shall be judge of the
13 United States district court, for the district within which the county
14 shall be situated, to name eleven reputable citizens and freeholders of
15 such county and file a list thereof with said board of county
16 commissioners. The persons so named, or a majority of them, shall act
17 as a commission, and be known as the "river and harbor improvement
18 commission of county", and shall receive no compensation,
19 except their actual necessary expenses, including necessary clerical

33 discharge my duties as a member of said commission." In case the
34 person who is United States judge shall be unable or decline to act,

1 the board of county commissioners shall name the eleven persons to act
2 as such commission.

3 **Sec. 538.** RCW 88.32.040 and 1907 c 236 s 3 are each amended to
4 read as follows:

5 It shall be the duty of such commission to define and establish an
6 assessment district, within such county, comprising all the taxable
7 real property, and also (with the limitations hereinafter expressed)
8 the state shorelands, which shall be specially benefited by said river,
9 lake, canal, or harbor improvement, and to apportion and assess the
10 amount of separate, special, and particular benefits against each lot,
11 block, parcel, or tract of land or shoreland within such district, by
12 reason of such improvement. The commission in making the assessment
13 shall include in the properties upon (~~(which)~~) which the assessment
14 is laid, all shorelands of the state, whether unsold or under contract
15 of sale and subject to sale by it and as against all purchasers from

22 assessment, and at the time of such payment the county treasurer shall
23 give him or her, in addition to a regular receipt for such payment, a
24 certificate that such payment has been made, which certificate the
25 purchaser shall immediately file with the commissioner of public lands,
26 and no patent from the state nor deed shall issue to such purchaser,
27 nor shall any assignment of his or her contract to purchase be approved
28 by the commissioner of public lands until every matured installment of
29 such assessment shall have first been fully paid and satisfied:
30 PROVIDED, HOWEVER, That no such assessment shall create any charge
31 against such shoreland or affect the title thereof as against the
32 state, and the state shall be as free to forfeit or annul such contract
33 and again sell such land as if the assessment had never been made, and
34 in case of such forfeiture or annulment the state shall be free to sell
35 again such land entirely disencumbered and unencumbered of all right
36 and claim of such former purchaser, and such purchaser shall have no
37 right, interest, or claim upon or against such land or the state or

1 such new purchaser or at all, but every such sum paid by such former
2 purchaser upon such assessment shall be utterly forfeited as against
3 him or her, his or her personal representatives and assigns, and shall
4 inure to the benefit of such new purchaser.

5 **Sec. 539.** RCW 88.32.090 and 1988 c 202 s 90 are each amended to
6 read as follows:

7 Any person who feels aggrieved by the final assessment made against
8 any lot, block, or parcel of land owned by him or her may appeal
9 therefrom to the superior court of such county. Such appeal shall be
10 taken within the time, and substantially in the manner prescribed by
11 the laws of this state for appeals from justice's courts. All notices
12 of appeal shall be filed with the board of county commissioners, and
13 served upon the prosecuting attorney of the county. The clerk of the

25 The final assessment shall be a lien, paramount to all other liens,
26 except liens for taxes and other special assessments, upon the property
27 assessed, from the time the assessment roll shall be approved by said
28 board of county commissioners and placed in the hands of the county
29 treasurer, as collector. After said roll shall have been delivered to
30 the county treasurer for collection, he or she shall proceed to collect
31 the same, in the manner as other taxes are collected: PROVIDED, That

32 be begun until the bonds shall have been sold and the proceeds shall
33 have been paid into a fund to be called "Local Improvement Fund No.
34, County of", and the owner or owners of such bonds
35 shall look only to such fund for the payment of either the principal or
36 interest of such bonds.

1 Such bonds shall be issued in denominations of one hundred dollars
2 each, and shall be substantially in the following form:

7 This bond is not a general debt of the county of and
8 has not been authorized by the voters of said county as a part of its

12 specified and its issuance and sale is authorized by the resolution of
13 the county legislative authority, passed on the day of

23 before maturity in such manner and amounts as he or she may have cash
24 on hand to pay the same in the said fund from which the same is
25 payable, and shall bear interest at the rate of percent per
26 annum, payable semiannually; both principal and interest payable at the
27 office of the county treasurer. The county legislative authority of
28 said county, as the agent of said local improvement district No.
29, established by resolution No., has caused this bond to
30 be issued in the name of said county, as the bond of said local
31 improvement district, the proceeds thereof to be applied in part
32 payment of so much of the cost of the improvement of the rivers, lakes,
33 canals, or harbors of county, under resolution No.,
34 as is to be borne by the owners of property in said local improvement
35 district, and the said local improvement fund, district No. of
36 county, has been established by resolution for said

1 purpose; and the owner or owners of this bond shall look only to said

6 consecutive issues, beginning not more than twenty days before the

8 interest on this bond shall cease at the date named in such call.

9 "This bond is one of a series of bonds, aggregating in
10 all the principal sum of dollars, issued for said local
11 improvement district, all of which bonds are subject to the same terms
12 and conditions as herein expressed.

29 **Sec. 542.** RCW 88.32.160 and 1983 c 167 s 246 are each amended to
30 read as follows:

31 Each and every bond issued for any such improvement shall be signed
32 by the ((~~chairman~~)) chair of the county legislative authority and the
33 county auditor, sealed with the corporate seal of the county, and
34 attested by the county clerk. The bonds issued for each local
35 improvement district shall be in the aggregate for such an amount as
36 authorized by the resolution of the county legislative authority with

1 reference to such river, lake, canal or harbor improvement, and each
2 issue of such bonds shall be numbered consecutively, beginning with
3 number 1.

4 **Sec. 543.** RCW 88.32.170 and 1983 c 167 s 247 are each amended to
5 read as follows:

6 The owner of any lot or parcel of land charged with any assessment
7 as provided for hereinabove, may redeem the same from all liability by
8 paying the entire assessment charged against such lot or parcel of

11 redeem the same at any time after the bonds above specified shall have

33 (~~chairman~~) chair and clerk as aforesaid, and for all purposes under
34 RCW 88.32.070 and 88.32.080, in case of counties joining, the word
35 board wherever occurring in said sections shall be interpreted to mean
36 such joint board, and the word clerk shall be deemed to mean the clerk

1 of such joint board, and the posting of notices shall be in at least
2 ten public places in each county, and the publication of the same shall
3 be in a newspaper of each county, and the objections mentioned in RCW
4 88.32.080 shall be filed with the clerk of the joint board, who shall
5 cause a copy thereof, certified by him or her to be filed with the
6 clerk of the board of county commissioners of the county where the real
7 estate of the party objecting is situated.

10 The minutes of the proceedings of the joint board and the
11 assessment roll as finally settled by such board shall be made up in as
12 many counterparts as there are counties joining as aforesaid, and shall
13 be signed by the ((~~chairman~~)) chair and clerk of said board, and one of
14 said counterparts so signed shall be filed by said clerk with the clerk
15 of the board of county commissioners of each of said counties, and any
16 appeals and subsequent proceedings under RCW 88.32.090 to 88.32.170,
17 inclusive, as far as relates to real estate in any individual county,
18 shall be as nearly as may be the same as if the local improvement
19 district and bond issue concerned that county only.

20 **Sec. 547.** RCW 89.08.010 and 1973 1st ex.s. c 184 s 2 are each
21 amended to read as follows:

22 It is hereby declared, as a matter of legislative determination:

23 (1) That the lands of the state of Washington are among the basic
24 assets of the state and that the preservation of these lands is
25 necessary to protect and promote the health, safety, and general
26 welfare of its people; that improper land-use practices have caused and
27 have contributed to, and are now causing and contributing to, a
28 progressively more serious erosion of the lands of this state by wind
29 and water; that the breaking of natural grass, plant, and forest cover
30 have interfered with the natural factors of soil stabilization, causing
31 loosening of soil and exhaustion of humus, and developing a soil
32 condition that favors erosion; that the topsoil is being blown and
33 washed off of lands; that there has been an accelerated washing of
34 sloping lands; that these processes of erosion by wind and water speed
35 up with removal of absorptive topsoil, causing exposure of less
36 absorptive and less protective but more erosive subsoil; that failure

1 by any land occupier to conserve the soil and control erosion upon his
2 or her lands may cause a washing and blowing of soil from his or her
3 lands onto other lands and makes the conservation of soil and control
4 of erosion on such other lands difficult or impossible, and that
5 extensive denuding of land for development creates critical erosion
6 areas that are difficult to effectively regenerate and the resulting
7 sediment causes extensive pollution of streams, ponds, lakes, and other
8 waters.

9 (2) That the consequences of such soil erosion in the form of soil
10 blowing and soil washing are the silting and sedimentation of stream
11 channels, reservoirs, dams, ditches, and harbors, and loading the air
12 with soil particles; the loss of fertile soil material in dust storms;
13 the piling up of soil on lower slopes and its deposit over alluvial
14 plains; the reduction in productivity or outright ruin of rich bottom
15 lands by overwash of poor subsoil material, sand, and gravel swept out
16 of the hills; deterioration of soil and its fertility, deterioration of
17 crops grown thereon, and declining acre yields despite development of
18 scientific processes for increasing such yields; loss of soil and water
19 which causes destruction of food and cover for wildlife; a blowing and
20 washing of soil into streams which silts over spawning beds, and
21 destroys water plants, diminishing the food supply of fish; a
22 diminishing of the underground water reserve, which causes water
23 shortages, intensifies periods of drought, and causes crop failures; an
24 increase in the speed and volume of rainfall run-off, causing severe
25 and increasing floods, which bring suffering, disease, and death;
26 impoverishment of families attempting to farm eroding and eroded lands;
27 damage to roads, highways, railways, buildings, and other property from
28 floods and from dust storms; and losses in navigation, hydroelectric
29 power, municipal water supply, irrigation developments, farming, and
30 grazing.

31 (3) That to conserve soil resources and control and prevent soil
32 erosion and prevent flood water and sediment damages, and further
33 agricultural and nonagricultural phases of the conservation,
34 development, utilization, and disposal of water, it is necessary that
35 land-use practices contributing to soil wastage and soil erosion be
36 discouraged and discontinued, and appropriate soil-conserving land-use
37 practices, and works of improvement for flood prevention of
38 agricultural and nonagricultural phases of the conservation,

1 development, utilization, and disposal of water be adopted and carried
2 out; that among the procedures necessary for widespread adoption, are
3 the carrying on of engineering operations such as the construction of
4 terraces, terrace outlets, check-dams, desilting basins, flood water
5 retarding structures, channel floodways, dikes, ponds, ditches, and the
6 like; the utilization of strip cropping, contour cultivating, and
7 contour furrowing; land irrigation; seeding and planting of waste,
8 sloping, abandoned, or eroded lands to water-conserving and erosion-
9 preventing plants, trees, and grasses; forestation and reforestation;
10 rotation of crops; soil stabilizations with trees, grasses, legumes,
11 and other thick-growing, soil-holding crops, retardation of run-off by
12 increasing absorption of rainfall; and retirement from cultivation of
13 steep, highly erosive areas and areas now badly gullied or otherwise
14 eroded.

15 (4) Whereas, there is a pressing need for the conservation of
16 renewable resources in all areas of the state, whether urban, suburban,
17 or rural, and that the benefits of resource practices, programs, and
18 projects, as carried out by the state conservation commission and by
19 the conservation districts, should be available to all such areas;
20 therefore, it is hereby declared to be the policy of the legislature to
21 provide for the conservation of the renewable resources of this state,
22 and for the control and prevention of soil erosion, and for the
23 prevention of flood water and sediment damages, and for furthering
24 agricultural and nonagricultural phases of conservation, development,
25 utilization, and disposal of water, and thereby to preserve natural
26 resources, control floods, prevent impairment of dams and reservoirs,
27 assist in maintaining the navigability of rivers and harbors, preserve
28 wildlife, protect the tax base, protect public lands, and protect and
29 promote the health, safety, and general welfare of the people of this
30 state. To this end all incorporated cities and towns heretofore
31 excluded from the boundaries of a conservation district established
32 pursuant to the provisions of the state conservation district law, as
33 amended, may be approved by the conservation commission as being
34 included in and deemed a part of the district upon receiving a petition
35 for annexation signed by the governing authority of the city or town
36 and the conservation district within the exterior boundaries of which
37 it lies in whole or in part or to which it lies closest.

1 **Sec. 548.** RCW 89.08.170 and 1973 1st ex.s. c 184 s 18 are each
2 amended to read as follows:

3 If the secretary of state finds that the name of the proposed
4 district is such as will not be confused with that of any other
5 district, he or she shall enter the application and statement in his or
6 her records. If he or she finds the name may be confusing, he or she
7 shall certify that fact to the commission, which shall submit a new
8 name free from such objections, and he or she shall enter the
9 application and statement as modified, in his or her records.
10 Thereupon the district shall be considered organized into a body
11 corporate.

12 The secretary of state shall then issue to the supervisors a
13 certificate of organization of the district under the seal of the
14 state, and shall record the certificate in his or her office. Proof of
15 the issuance of the certificate shall be evidence of the establishment
16 of the district, and a certified copy of the certificate shall be
17 admissible as evidence and shall be proof of the filing and contents
18 thereof. The name of a conservation district may be changed upon
19 recommendation by the supervisors of a district and approval by the
20 state conservation commission and the secretary of state. The new name

24 read as follows:

25 Territory may be added to an existing district upon filing a
26 petition as in the case of formation with the commission by twenty
27 percent of the voters of the affected area to be included. The same
28 procedure shall be followed as for the creation of the district.

29 As an alternate procedure, the commission may upon the petition of
30 a majority of the voters in any one or more districts or in unorganized
31 territory adjoining a conservation district change the boundaries of a
32 district, or districts, if such action will promote the practical and
33 feasible administration of such district or districts.

34 Upon petition of the boards of supervisors of two or more
35 districts, the commission may approve the combining of all or parts of
36 such districts and name the district, or districts, with the approval

15 to another, the property, records, and accounts of the districts
16 involved shall be distributed to the remaining district or districts as
17 approved by the commission. A new certificate of organization, naming
18 and describing the new district or districts, shall be issued by the
19 secretary of state.

20 **Sec. 550.** RCW 89.08.200 and 1973 1st ex.s. c 184 s 21 are each
21 amended to read as follows:

22 The term of office of each supervisor shall be three years and
23 until his or her successor is appointed or elected and qualified,
24 except that the supervisors first appointed shall serve for one and two
25 years respectively from the date of their appointments, as designated
26 in their appointments.

27 In the case of elected supervisors, the term of office of each
28 supervisor shall be three years and until his or her successor is
29 elected and qualified, except that for the first election, the one
30 receiving the largest number of votes shall be elected for three years;

33 Vacancies in the office of appointed supervisors shall be filled by

2 concurrence of a majority is required for any official action or
3 determination.

4 Supervisors shall serve without compensation, but they shall be

7 the state conservation commission upon notice and hearing, for neglect
8 of duty or malfeasance in office, but for no other reason.

9 The governing board shall designate a ((~~chairman~~)) chair from time
10 to time.

11 **Sec. 551.** RCW 89.08.210 and 2000 c 45 s 1 are each amended to read
12 as follows:

13 The supervisors may employ a secretary, treasurer, technical
14 experts, and such other officers, agents, and employees, permanent and
15 temporary, as they may require, and determine their qualifications,
16 duties, and compensation. It may call upon the attorney general for
17 legal services, or may employ its own counsel and legal staff. The
18 supervisors may delegate to their ((~~chairman~~)) chair, to one or more
19 supervisors, or to one or more agents or employees such powers and
20 duties as it deems proper. The supervisors shall furnish to the
21 commission, upon request, copies of such internal rules, regulations,

33 any person, corporation, joint stock association or family owning lands
34 that are within the scope of this chapter.

35 The term "family" shall mean a group consisting of either or both
36 husband and wife, together with their children under eighteen years of
37 age, or all of such children if both parents are dead, the term "their

1 children" including the issue and lawfully adopted children of either
2 or both husband and wife. Within the meaning of this chapter, lands
3 shall be deemed to be held by a family if held as separate property of
4 husband or wife, or if held as a part or all of their community
5 property, or if they are the property of any or all of their children
6 under eighteen years of age.

2 read as follows:

3 From and after the date that the consent of the United States shall
4 be given thereto by act of congress, the department of natural
5 resources is authorized, upon request from the secretary of the
6 interior, to cause an appraisal to be made by the board of natural
7 resources of state lands in any division of any federal reclamation
8 project which the secretary of the interior shall advise the department
9 that he or she desires to have subdivided into farm units of class
10 referred to in RCW 89.12.140, and also to cause to be appraised by the
11 board of natural resources such public lands of the United States on
12 the same project, or elsewhere in the state of Washington, as the
13 secretary of the interior may propose to exchange for such state land,
14 and when the secretary of the interior shall have secured from congress

30 director, and such amounts as may be authorized by him or her for the

22 That no district, the bonds, notes, or warrants of which have been

26 district or incur obligations chargeable against such funds or issue

1 owners of lands therein agreements to limit the amount of their

12 Upon the giving of notice of hearing on the petition by the clerk
13 of the county board aforesaid, there is hereby authorized and created

16 included in the proposed reclamation district are situated, and of the
17 state director of ecology, which commission shall consider and
18 determine said petition.

21 The state director of ecology shall be ex officio ((~~chairman~~))
22 chair of said commission, and the clerk of the county board of the

26 powers, functions, duties and business.

15 rights shall be acquired in the manner provided by law for the taking
16 of private property for public use by private corporations.

35 department's decision other than the tentative determinations of the
36 validity and extent of the right, the court must certify to the
37 pollution control hearings board for review and decision those portions

1 of the department's decision. Review by the pollution control hearings
2 board shall be conducted consistent with chapter 43.21B RCW and the
3 board's implementing regulations, except that the requirements for
4 filing, service, and content of the notice of appeal shall be governed

17 any treaty or other federal rights of an Indian tribe, or the rights of
18 any federal agency or other person or entity arising under federal law.
19 Nothing in this section is intended or shall be construed as affecting
20 or modifying any existing right of a federally recognized Indian tribe
21 to protect from impairment its federally reserved water rights in
22 federal court.

25 Whenever proceedings shall be instituted for the determination of
26 the rights to the use of water, any defendant who shall fail to appear

30 by such decree.

12 90.40.010 through 90.40.080 except that the notice and certificate

15 the duties prescribed by RCW 90.40.030.

16 **Sec. 597.** RCW 90.03.270 and 1987 c 109 s 85 are each amended to
17 read as follows:

18 Upon receipt of an application it shall be the duty of the
19 department to make an endorsement thereon of the date of its receipt,
20 and to keep a record of same. If upon examination, the application is
21 found to be defective, it shall be returned to the applicant for
22 correction or completion, and the date and the reasons for the return
23 thereof shall be endorsed thereon and made a record in his or her
24 office. No application shall lose its priority of filing on account of

3 occupied, or controlled by any person, association, or corporation, or
4 by the United States and used in connection with said beneficial use of
5 water, shall be guilty of a misdemeanor or, if there is actual physical
6 injury to or destruction of any real or personal property, of property
7 destruction and shall incur the penalties set forth in RCW 9.61.070.

8 (2) Any person or persons who shall willfully or unlawfully take or
9 use water, or conduct the same into his or her ditch or to his or her
10 land, or land occupied by him or her, and for such purpose shall cut,
11 dig, break down, or open any headgate, bank, embankment, canal or
12 reservoir, flume, or conduit, or interfere with, injure, or destroy any
13 weir, measuring box, or other appliance for the apportionment and
14 measurement of water, or unlawfully take or cause to run or pour out of
15 such structure or appliance any water, shall be guilty of a misdemeanor
16 or, if there is actual physical injury to or destruction of any real or
17 personal property, of property destruction and shall incur the
18 penalties set forth in RCW 9.61.070.

19 (3) The use of water through such structure or structures,
20 appliance or appliances hereinbefore named after its or their having
21 been interfered with, injured or destroyed, shall be prima facie
22 evidence of the guilt of the person using it.

23 **Sec. 599.** RCW 90.03.440 and 1987 c 109 s 97 are each amended to
24 read as follows:

25 When two or more persons, joint owners in an irrigation ditch or
26 reservoir, not incorporated, or their lessees, are unable to agree
27 relative to the division or distribution of water received through
28 their ditch or from their reservoir, and where there is no disagreement
29 as to the ownership of said water, it shall be lawful for any such
30 owner or owners, his or her or their lessee or lessees, or either of
31 them, to apply to the department, in writing, setting forth such fact
32 and giving such information as shall enable the department to estimate
33 the probable expense of such service, asking the department to appoint
34 some suitable person to take charge of such ditch or reservoir for the
35 purpose of making a just division or distribution of the water from the
36 same to the parties entitled to the use thereof. The department shall

1 probable expense of such division and upon receipt of certified check
2 for said amount, the department shall appoint a suitable person to make
3 such division. The person so appointed shall take exclusive charge of
4 such ditch or reservoir for the purpose of dividing the water therefrom
5 in accordance with the established rights of the diverters therefrom,
6 and continue the said work until the necessity therefor shall cease to
7 exist. The expense of such investigation and division shall be a
8 charge upon all of the co-owners and the person advancing the payment
9 to the department shall be entitled to recover in any court of
10 competent jurisdiction from his or her co-owners their proportionate
11 share of the expense.

12 **Sec. 600.** RCW 90.03.450 and 1919 c 71 s 5 are each amended to read
13 as follows:

14 Upon the failure of any co-owner to pay his or her proportionate
15 share of such expense as mentioned in RCW 90.03.430 within thirty days
16 after receiving a statement of the same as performed by his or her co-
17 owner or owners, such person or persons so performing such labor may
18 secure payment of said claim by filing an itemized and sworn statement
19 thereof, setting forth the date of the performance and the nature of
20 the labor so performed, with the county auditor of the county wherein
21 said ditch is situated, and when so filed it shall constitute a valid
22 lien against the interest of such person or persons who shall fail to
23 perform their proportionate share of the work requisite to the proper
24 maintenance of said ditch, which said lien when so taken may be
25 enforced in the same manner as provided by law for the enforcement of
26 mechanics' and builders' liens.

27 **Sec. 601.** RCW 90.08.040 and 1977 c 22 s 1 are each amended to read
28 as follows:

29 Where water rights of a stream have been adjudicated a stream
30 (~~(patrolman)~~) patroller shall be appointed by the director of the
31 department of ecology upon application of water users having
32 adjudicated water rights in each particular water resource making a
33 reasonable showing of the necessity therefor, which application shall
34 have been approved by the district water master if one has been
35 appointed, at such time, for such stream, and for such periods of

1 service as local conditions may indicate to be necessary to provide the

9 shall also enforce such special rules and regulations as the director

13 Each stream ((~~patrolman~~)) patroller shall receive a wage per day
14 for each day actually employed in the duties of his or her office, or
15 if employed by the month, he or she shall receive a salary per month,
16 which wage or salary shall be fixed in the manner provided by law for
17 the fixing of the salaries or compensation of other state officers or
18 employees, plus travel expenses in accordance with RCW 43.03.050 and

22 such wage to be apportioned by the director. He or she shall be

27 audited and certified by the director and the county auditor shall
28 issue a warrant therefor upon the current expense fund.

30 as follows:

31 The salary of the stream ((~~patrolman~~)) patroller shall be borne by
32 the water users receiving the benefits and shall be paid to the county
33 or counties in the following manner:

34 The county or counties may assess each water user for his or her
35 proportionate share of the total stream ((~~patrolman~~)) patroller expense
36 in the same ratio that the amount of water diverted by him or her bears

1 to the total amount diverted from the stream during each season, on an
2 annual basis, to recover all such county expenses. The stream
3 ((~~patrolman~~)) patroller shall keep an accurate record of the amount of
4 water diverted by each water user coming under his or her supervision.
5 On the first of each month the stream ((~~patrolman~~)) patroller shall

7 for the preceding month. Where the water users are organized into an
8 irrigation district or water users' association, such organization may
9 enter into an agreement with the county or counties for direct payment
10 to the stream ((~~patrolman~~)) patroller in order to minimize
11 administrative costs.

12 **Sec. 604.** RCW 90.08.070 and 1977 c 22 s 4 are each amended to read
13 as follows:

14 Upon failure of any water user to pay his or her proportionate
15 share of the expense referred to in RCW 90.08.050 and 90.08.060, the
16 county or counties shall be entitled to sue for and recover any such
17 unpaid portion in any court of competent jurisdiction.

18 **Sec. 605.** RCW 90.14.061 and 1988 c 127 s 74 are each amended to
19 read as follows:

20 Filing of a statement of a claim shall take place and be completed
21 upon receipt by the department of ecology, at its office in Olympia, of
22 an original statement signed by the claimant or his or her authorized
23 agent, and two copies thereof. Any person required to file hereunder
24 may file through a designated representative. A company, district,
25 public or municipal corporation, or the United States when furnishing
26 to persons water pertaining to water rights required to be filed under
27 RCW 90.14.041, shall have the right to file one claim on behalf of said
28 persons on a form prepared by the department for the total benefits of
29 each person served; provided that a separate claim shall be filed by
30 such company, district, public or private corporation, or the United
31 States for each operating unit of the filing entity providing such
32 water and for each water source. Within thirty days after receipt of
33 a statement of claim the department shall acknowledge the same by a
34 notation on one copy indicating receipt thereof and the date of
35 receipt, together with the wording of the first sentence of RCW
36 90.14.081, and shall return said copy by certified or registered mail

2 statement of claim shall be accepted for filing by the department of
3 ecology unless accompanied by a two dollar filing fee.

4 **Sec. 606.** RCW 90.14.101 and 1988 c 127 s 76 are each amended to
5 read as follows:

6 To insure that all persons referred to in RCW 90.14.031 and
7 90.14.041 are notified of the registration provisions of this chapter,
8 the department of ecology is directed to give notice of the
9 registration provisions of this chapter as follows:

10 (1) It shall cause a notice in writing to be placed in a prominent
11 and conspicuous place in all newspapers of the state having a
12 circulation of more than fifty thousand copies for each week day, and
13 in at least one newspaper published in each county of the state, at
14 least once each year for five consecutive years.

15 (2) It shall cause a notice substantially the same as a notice in
16 writing to be broadcast by each commercial television station operating
17 in the United States and viewed in the state, and by at least one
18 commercial radio station operating from each county of the state having
19 such a station regularly at six month intervals for five consecutive
20 years.

21 (3) It shall cause a notice in writing to be placed in a prominent
22 and conspicuous location in each county court house in the state.

23 (4) The county treasurer of each county shall enclose with each
24 mailing of one or more statements of taxes due issued in 1972 a copy of
25 a notice in writing and a declaration that it shall be the duty of the
26 recipient of the statement of taxes due to forward the notice to the

28 notice and declaration shall be supplied to each county treasurer by

31 provide reimbursement to the county treasurer for the reasonable

33 arising from the inclusion of a notice in writing as required herein.

34 (5) It shall provide copies of the notice in writing to the press
35 services with offices located in Thurston county during January of the
36 years 1970, 1971, 1972, 1973, and 1974.

1 The director of the department may also in his or her discretion
2 give notice in any other manner which will carry out the purposes of
3 this section. Where notice in writing is given pursuant to subsections
4 (1) and (3) of this section, RCW 90.14.041, 90.14.051, and 90.14.071
5 shall be set forth and quoted in full.

6 **Sec. 607.** RCW 90.14.130 and 1987 c 109 s 13 are each amended to
7 read as follows:

8 When it appears to the department of ecology that a person entitled
9 to the use of water has not beneficially used his or her water right or
10 some portion thereof, and it appears that said right has or may have
11 reverted to the state because of such nonuse, as provided by RCW
12 90.14.160, 90.14.170, or 90.14.180, the department of ecology shall
13 notify such person by order: PROVIDED, That where a company,
14 association, district, or the United States has filed a blanket claim
15 under the provisions of RCW 90.14.060 for the total benefits of those
16 served by it, the notice shall be served on such company, association,
17 district or the United States and not upon any of its individual water
18 users who may not have used the water or some portion thereof which
19 they were entitled to use. The order shall contain: (1) A description
20 of the water right, including the approximate location of the point of
21 diversion, the general description of the lands or places where such
22 waters were used, the water source, the amount involved, the purpose of
23 use, and the apparent authority upon which the right is based; (2) a
24 statement that unless sufficient cause be shown on appeal the water
25 right will be declared relinquished; and (3) a statement that such
26 order may be appealed to the pollution control hearings board. Any
27 person aggrieved by such an order may appeal it to the pollution
28 control hearings board pursuant to RCW 43.21B.310. The order shall be
29 served by registered or certified mail to the last known address of the
30 person and be posted at the point of diversion or withdrawal. The order
31 by itself shall not alter the recipient's right to use water, if any.

33 read as follows:

34 Any person entitled to divert or withdraw waters of the state by
35 virtue of his or her ownership of land abutting a stream, lake, or
36 watercourse, who abandons the same, or who voluntarily fails, without

1 sufficient cause, to beneficially use all or any part of said right to
2 withdraw or divert said water for any period of five successive years
3 after July 1, 1967, shall relinquish such right or portion thereof, and
4 such right or portion thereof shall revert to the state, and the waters
5 affected by said right shall become available for appropriation in
6 accordance with the provisions of RCW 90.03.250.

7 **Sec. 609.** RCW 90.24.020 and 1939 c 107 s 3 are each amended to
8 read as follows:

9 Such petition shall contain a complete description of the property
10 surrounding said lake with the number of front feet contained in each
11 tract with the name of the owner thereof and his or her address
12 together with a brief statement of the reasons and necessity for such
13 application; that the level sought to be established will in no wise
14 interfere with the navigability of said lake or in any manner affect or
15 interfere with fish or game fish which may be then contained or may
16 thereafter be deposited in said lake, but that in order to protect fish
17 or game fish in said lake the construction of fish ladders or other
18 devices may be required to conserve and protect such fish or game fish,
19 then in that event the property owners to be benefited by the
20 establishment of said water level in such lake shall be required to pay
21 the cost thereof, in proportion to lineal feet of water front owned by

25 In the event the court shall find that to protect fish and game
26 fish in said lake that fish ladders or other devices should be

29 proper device to be constructed, the probable cost thereof and by its
30 order and judgment shall apportion the cost thereof among the persons
31 whose property abuts on said lake in proportion to the lineal feet of
32 waterfront owned by each, which sum so found shall constitute a lien
33 against said real property and shall be paid to the county treasurer
34 and by him or her placed in a special fund to be known as "Lake
35 Improvement Fund." The director of ecology shall appoint

1 a suitable person to be compensated by the property owners to regulate
2 the determined level as decreed by the court.

3 **Sec. 611.** RCW 90.44.110 and 1987 c 109 s 114 are each amended to
4 read as follows:

5 No public groundwaters that have been withdrawn shall be wasted
6 without economical beneficial use. The department shall require all
7 wells producing waters which contaminate other waters to be plugged or
8 capped. The department shall also require all flowing wells to be so
9 capped or equipped with valves that the flow of water can be completely
10 stopped when the wells are not in use under the terms of their
11 respective permits or approved declarations of vested rights.
12 Likewise, the department shall also require both flowing and nonflowing
13 wells to be so constructed and maintained as to prevent the waste of
14 public groundwaters through leaky casings, pipes, fittings, valves, or
15 pumps--either above or below the land surface: PROVIDED, HOWEVER, That

22 In the issuance of an original permit, or of an amendment to an
23 original permit or certificate of vested right to withdraw and
24 appropriate public groundwaters under the provisions of this chapter,
25 the department may, as in his or her judgment is necessary, specify for
26 the proposed well or wells or other works a manner of construction
27 adequate to accomplish the provisions of this section.

28 **Sec. 612.** RCW 90.44.130 and 1987 c 109 s 116 are each amended to
29 read as follows:

30 As between appropriators of public groundwater, the prior
31 appropriator shall as against subsequent appropriators from the same
32 groundwater body be entitled to the preferred use of such groundwater
33 to the extent of his or her appropriation and beneficial use, and shall
34 enjoy the right to have any withdrawals by a subsequent appropriator of
35 groundwater limited to an amount that will maintain and provide a safe
36 sustaining yield in the amount of the prior appropriation. The

1 department shall have jurisdiction over the withdrawals of groundwater
2 and shall administer the groundwater rights under the principle just
3 set forth, and it shall have the jurisdiction to limit withdrawals by
4 appropriators of groundwater so as to enforce the maintenance of a safe

12 order that overdraft of public groundwaters may be prevented so far as
13 is feasible. Each such area or zone shall, as nearly as known facts
14 permit, be so designated as to enclose a single and distinct body of
15 public groundwater. Each such subarea may be so designated as to
16 enclose all or any part of a distinct body of public groundwater, as
17 the department deems will most effectively accomplish the purposes of
18 this chapter.

19 Designation of, or modification of the boundaries of such a
20 groundwater area, subarea, or zone may be proposed by the department on
21 its own motion or by petition to the department signed by at least
22 fifty or one-fourth, whichever is the lesser number, of the users of
23 groundwater in a proposed groundwater area, subarea, or zone. Before
24 any proposed groundwater area, subarea, or zone shall be designated, or
25 before the boundaries or any existing groundwater area, subarea, or
26 zone shall be modified the department shall publish a notice setting
27 forth: (1) In terms of the appropriate legal subdivisions a
28 description of all lands enclosed within the proposed area, subarea, or
29 zone, or within the area, subarea, or zone whose boundaries are
30 proposed to be modified; (2) the object of the proposed designation or
31 modification of boundaries; and (3) the day and hour, and the place
32 where written objections may be submitted and heard. Such notice shall
33 be published in three consecutive weekly issues of a newspaper of
34 general circulation in the county or counties containing all or the
35 greater portion of the lands involved, and the newspaper of publication
36 shall be selected by the department. Publication as just prescribed
37 shall be construed as sufficient notice to the landowners and water
38 users concerned.

1 Objections having been heard as herein provided, the department
2 shall make and file in its office written findings of fact with respect
3 to the proposed designation or modification and, if the findings are in
4 the affirmative, shall also enter a written order designating the
5 groundwater area, or subarea, or zone or modifying the boundaries of
6 the existing area, subarea, or zone. Such findings and order shall
7 also be published substantially in the manner herein prescribed for
8 notice of hearing, and when so published shall be final and conclusive
9 unless an appeal therefrom is taken within the period and in the manner
10 prescribed by RCW 43.21B.310. Publication of such findings and order
11 shall give force and effect to the remaining provisions of this section
12 and to the provisions of RCW 90.44.180, with respect to the particular
13 area, subarea, or zone.

14 Priorities of right to withdraw public groundwater shall be
15 established separately for each groundwater area, subarea, or zone and,
16 as between such rights, the first in time shall be the superior in
17 right. The priority of the right acquired under a certificate of
18 groundwater right shall be the date of filing of the original
19 application for a withdrawal with the department, or the date or
20 approximate date of the earliest beneficial use of water as set forth
21 in a certificate of a vested groundwater right, under the provisions of
22 RCW 90.44.090.

23 Within ninety days after the designation of a groundwater area,
24 subarea, or zone as herein provided, any person, firm, or corporation
25 then claiming to be the owner of artificially stored groundwater within
26 such area, subarea, or zone shall file a certified declaration to that
27 effect with the department on a form prescribed by the department.
28 Such declaration shall cover: (1) The location and description of the
29 works by whose operation such artificial groundwater storage is
30 purported to have been created, and the name or names of the owner or
31 owners thereof; (2) a description of the lands purported to be
32 underlain by such artificially stored groundwater, and the name or
33 names of the owner or owners thereof; (3) the amount of such water
34 claimed; (4) the date or approximate date of the earliest artificial
35 storage; (5) evidence competent to show that the water claimed is in
36 fact water that would have been dissipated naturally except for
37 artificial improvements by the claimant; and (6) such additional
38 factual information as reasonably may be required by the department.

1 If any of the purported artificially stored groundwater has been or
2 then is being withdrawn, the claimant also shall file (1) the
3 declarations which this chapter requires of claimants to a vested right
4 to withdraw public groundwaters, and (2) evidence competent to show
5 that none of the water withdrawn under those declarations is in fact
6 public groundwater from the area, subarea, or zone concerned:
7 PROVIDED, HOWEVER, That in case of failure to file a declaration within
8 the ninety-day period herein provided, the claimant may apply to the
9 department for a reasonable extension of time, which shall not exceed
10 two additional years and which shall be granted only upon a showing of
11 good cause for such failure.

12 Following publication of the declaration and findings--as in the
13 case of an original application, permit, or certificate of right to
14 appropriate public groundwaters--the department shall accept or reject
15 such declaration or declarations with respect to ownership or
16 withdrawal of artificially stored groundwater. Acceptance of such
17 declaration or declarations by the department shall convey to the
18 declarant no right to withdraw public groundwaters from the particular
19 area, subarea, or zone, nor to impair existing or subsequent rights to
20 such public waters.

21 Any person, firm, or corporation hereafter claiming to be the owner
22 of groundwater within a designated groundwater area, subarea, or zone
23 by virtue of its artificial storage subsequent to such designation
24 shall, within three years following the earliest artificial storage
25 file a declaration of claim with the department, as herein prescribed
26 for claims based on artificial storage prior to such designation:
27 PROVIDED, HOWEVER, That in case of such failure the claimant may apply
28 to the department for a reasonable extension of time, which shall not
29 exceed two additional years and which shall be granted upon a showing
30 of good cause for such failure.

31 Any person, firm, or corporation hereafter withdrawing groundwater
32 claimed to be owned by virtue of artificial storage subsequent to
33 designation of the relevant groundwater area, subarea, or zone shall,
34 within ninety days following the earliest such withdrawal, file with
35 the department the declarations required by this chapter with respect
36 to withdrawals of public groundwater.

1 **Sec. 613.** RCW 90.48.095 and 1991 c 200 s 1103 are each amended to
2 read as follows:

3 In carrying out the purposes of this chapter or chapter 90.56 RCW
4 the department shall, in conjunction with either the adoption of rules,
5 consideration of an application for a waste discharge permit or the
6 termination or modification of such permit, or proceedings in
7 adjudicative hearings, have the authority to issue process and subpoena
8 witnesses effective throughout the state on its own behalf or that of
9 an interested party, compel their attendance, administer oaths, take
10 the testimony of any person under oath and, in connection therewith
11 require the production for examination of any books or papers relating
12 to the matter under consideration by the department. In case of
13 disobedience on the part of any person to comply with any subpoena
14 issued by the department, or on the refusal of any witness to testify
15 to any matters regarding which he or she may be lawfully interrogated,
16 it shall be the duty of the superior court of any county, or of the
17 judge thereof, on application of the department, to compel obedience by
18 proceedings for contempt, as in the case of disobedience of the
19 requirements of a subpoena issued from such court or a refusal to
20 testify therein. In connection with the authority granted under this
21 section no witness or other person shall be required to divulge trade
22 secrets or secret processes. Persons responding to a subpoena as
23 provided herein shall be entitled to fees as are witnesses in superior
24 court.

25 **Sec. 614.** RCW 90.58.170 and 1994 c 253 s 1 are each amended to
26 read as follows:

27 A shorelines hearings board sitting as a quasi-judicial body is
28 hereby established within the environmental and land use hearings
29 office under RCW 43.21B.005. The shorelines hearings board shall be
30 made up of six members: Three members shall be members of the
31 pollution control hearings board; two members, one appointed by the
32 association of Washington cities and one appointed by the association
33 of county commissioners, both to serve at the pleasure of the
34 associations; and the commissioner of public lands or his or her
35 designee. The ((~~chairman~~)) chair of the pollution control hearings
36 board shall be the ((~~chairman~~)) chair of the shorelines hearings board.
37 Except as provided in RCW 90.58.185, a decision must be agreed to by at

1 least four members of the board to be final. The members of the
2 shorelines (~~(hearings)~~) hearings board shall receive the
3 compensation, travel, and subsistence expenses as provided in RCW
4 43.03.050 and 43.03.060.

5 **Sec. 615.** RCW 91.08.030 and 1911 c 23 s 3 are each amended to read
6 as follows:

7 The plan of such proposed waterway shall be presented to the board
8 by a written petition of owners of lands which it is represented will
9 be improved by the construction, deepening or widening of such
10 waterway; and such petition shall be signed by the owners of thirty-
11 five percent or more of the area of lands in the district, and shall be
12 verified by one or more of the petitioners to the effect that the
13 signatures attached are the genuine signature of the persons or
14 corporations signing the same. Each petitioner shall add a description
15 of the lands he or she owns. If petitioners are unmarried persons they
16 shall so state. If lands are owned by married persons, husband and
17 wife shall join in the petition. If a petitioner is a corporation, the
18 signature shall be accompanied by a certified copy of a resolution of
19 the board of directors or trustees of the corporation authorizing the
20 person signing the petition for the corporation to execute it. If
21 lands included in the petition are owned by minors, insane persons, or
22 other persons under guardianship in this state, the petition may be
23 signed by the guardians of such persons: PROVIDED, That the signature
24 be accompanied by a certified copy of an order of the superior court
25 having the guardianship of such person in charge, authorizing the
26 guardian to sign the petition. A petition may consist of one or more
27 separate papers or sheets which are identified with the subject matter.

28 The petitioners shall file with the board, with their petition, a
29 map of the lands in the district and a statement showing each separate
30 ownership of lands as shown by the public records of the county, and
31 their location in the county, with the names of the owners as shown by
32 such records, and the location of the proposed waterway if a new
33 waterway is to be constructed. If an existing waterway is to be
34 deepened the map shall show its location, and if it is to be widened
35 the map shall show its location and the extent to which it is to be
36 widened. With the petition there shall also be presented satisfactory
37 evidence from the real property records of the county that the

1 petitioners are severally the owners in fee simple of their respective
2 tracts of land, and that all taxes and assessments due thereon are
3 paid. If it is proposed that any lands in the district shall be filled
4 with the material dug or dredged from such waterway, the petition shall
5 so state, and the map of the district and plan of the improvement shall
6 show the location, depth, and yardage of such fill. The petition may
7 also fix the price per cubic yard at which such fill shall be charged
8 to the land filled, which charge shall be added to the assessment for
9 the improvement to be made upon such lands and be paid as a part
10 thereof. If the price of filling is not fixed by the petition it may
11 be fixed by the board.

12 At any time after the filing of such petition one or more of the
13 petitioners may file and record in the office of the auditor of the
14 county, notice of the pendency of the proceeding, describing the
15 boundaries of the proposed district, and from the time of such filing
16 all persons shall be deemed to have notice of the pendency of the
17 proceeding and be bound thereby. Upon the hearing upon such petition,
18 hereinafter provided, if the same be denied any person interested may
19 file in the office of said county auditor a certified copy of the order
20 denying the same, whereupon the auditor shall enter the discharge of
21 the notice of the pendency of the proceeding on the margin of the
22 record thereof. And the like discharge may be filed whenever the
23 proceeding is terminated for any other reason.

24 **Sec. 616.** RCW 91.08.080 and 1911 c 23 s 6 are each amended to read
25 as follows:

26 At the time and place prescribed in the said notice any owner of
27 land within said proposed improvement district may file with the board
28 his or her written consent to the proposed improvement, and he or she
29 shall then be considered as a petitioner; and if the owners of more
30 than one half of the lands within the district, including the lands
31 represented by the petition, shall assent to the prayer of said
32 petition, the board shall then proceed to hear and consider any
33 objections which may have been filed at that or any previous time, and
34 may adjourn such hearing from day to day. If the board after full
35 hearing on the merits of the proposed waterway shall be satisfied that
36 the same will be of benefit to the public interests, and that private
37 benefit will result to the lands within the district sufficient to

10 The board shall file a petition, verified by its (~~chairman~~) chair
11 and signed by the prosecuting attorney, in the superior court of the
12 county, praying that the property described may be taken or damaged for
13 the purpose specified and that compensation therefor be ascertained by
14 a jury or by the court in case a jury be waived. Such petition shall
15 allege the creation of the waterway district and contain a copy of the
16 order directing the proceeding, a reasonably accurate description of
17 the lots or parcels of land or other property which will be taken or
18 damaged, and the names of the owners and occupants of said lands and of
19 said persons having any interest therein so far as known to the said
20 board, or as appears from the records in the office of the county
21 auditor.

22 **Sec. 618.** RCW 91.08.150 and 1911 c 23 s 13 are each amended to
23 read as follows:

24 In case the land or other property sought to be taken or damaged is
25 state land, the summons and copy of petition shall be served upon the
26 commissioner of public lands; if it is county land it shall be served
27 upon the county auditor, and if school land, upon the county auditor
28 and the (~~chairman~~) chair of the board of directors of the school
29 district. Service upon other parties defendant, public or private,
30 shall be made in the same manner as is or shall be provided by law for
31 service of summons in other civil actions. If the state is made a
32 defendant the attorney general shall represent it. If the county is a
33 defendant the court shall appoint an attorney to represent it at all
34 stages of the proceedings, and may allow him or her compensation for
35 his or her services as costs of the proceeding.

2 read as follows:

3 The jury or court shall also ascertain the just compensation to be
4 paid to any person found to have an interest in any lot or parcel of
5 land or property which may be taken or damaged for such improvement,
6 whether or not such person's name or such lot or parcel of land or
7 other property is mentioned or described in said petition: PROVIDED,
8 That such person shall first be admitted as a party defendant to such
9 suit by such court and shall file a statement of his or her interest
10 in, and a description of, the lot or parcel of land or other property
11 in respect to which he or she claims compensation.

12 **Sec. 620.** RCW 91.08.220 and 1911 c 23 s 20 are each amended to
13 read as follows:

14 The court shall have power at any time, upon proof that any
15 defendant who has not been served with process has ceased to be an
16 owner since the filing of such petition, to substitute the new owner as
17 a defendant, and after due service of the summons and petition upon him
18 or her proceed as though he or she had been a party in the first
19 instance; and the court may upon any finding of the jury, or at any
20 time during the course of the proceedings, enter every such order,
21 rule, judgment, or decree as the nature of the case may require.

22 **Sec. 621.** RCW 91.08.250 and 1988 c 202 s 94 are each amended to
23 read as follows:

24 Any final judgment rendered by said court upon the findings of the
25 court or a jury, shall be the lawful and sufficient condemnation of the
26 land or property to be taken, or of the right to damage the same in the
27 manner proposed, upon the payment of the amount of such findings and
28 all costs which shall be taxed as in other civil cases: PROVIDED, That
29 in case any defendant recovers no award, no costs shall be taxed. Such
30 judgment shall be final and conclusive as to the damages caused by such
31 improvement, unless appellate review is sought, and no review shall
32 delay proceedings under the order of said board if it shall pay into

4 **Sec. 628.** RCW 91.08.410 and 1981 c 156 s 34 are each amended to
5 read as follows:

6 Immediately after the expiration of the time fixed by his or her
7 notice for payment of assessments without interest, the treasurer shall
8 divide the several assessments which remain unpaid in whole or in part
9 into ten equal amounts or installments, as near as may be, without
10 fractional cents, and enter said installments upon the roll opposite
11 the several assessments, numbering the same from one to ten
12 successively. And thereafter said treasurer shall annually for ten
13 years, before the time fixed by law for the collection of state and
14 county taxes, add one of the said assessment installments with interest

8 The indebtedness of any such district on contracts, or upon
9 employment or for supplies, shall be paid by warrants on the district
10 fund only, to be issued by the board upon allowed written claims. Such
11 warrants shall be in form the same as county warrants, or as nearly the
12 same as may be practicable; shall draw the legal rate of interest from
13 the date of their presentation to the county treasurer for payment, and
14 shall be signed by the (~~chairman~~) chair and attested by the clerk:
15 PROVIDED, That no warrants shall be issued in payment of any
16 indebtedness of such district for less than the face or par value.

17 **Sec. 634.** RCW 91.08.560 and 1911 c 23 s 55 are each amended to

19 All warrants issued under RCW 91.08.550 may be presented by the
20 holders thereof to the county treasurer, who shall pay them or endorse
21 thereon the date of presentation for payment and if the same are not

23 interest until it is so presented and endorsed by the county treasurer.
24 It shall be the duty of the treasurer from time to time, when he or she

3 judgment, at or before the time fixed by the treasurer for the payment
4 of assessments without interest, by satisfying his or her judgment upon

26 Should any sum of money paid into court as compensation or damages
