- 5 **Sec. 1.** RCW 47.64.280 and 2011 1st sp.s. c 16 s 20 are each 6 amended to read as follows:
 - (1) The marine employees' commission, created in RCW 41.58.065, shall adjust all complaints, grievances, and disputes between labor and management arising out of the operation of the ferry system as provided in RCW 47.64.150.

The governor shall appoint the marine employees' commission with the consent of the senate. 5 The marine employees' commission shall consist of three members: 6 One member to be appointed from labor; one member from industry; and one 7 8 member from the public who has significant knowledge of maritime 9 The public member is chair of the marine employees' affairs. Any member of the marine employees' commission may be 10 commission. removed by the governor, upon notice and hearing, for neglect of duty 11 12 or malfeasance in office, but for no other cause. Marine employees' commission members are not eligible for state retirement under chapter 13 41.40 RCW by virtue of their service on the marine employees' 14 commission. Members of the marine employees' commission must be 15 compensated in accordance with RCW 43.03.250 and 16 must reimbursement for official travel and other expenses at the same rate 17 18 and on the same terms as provided for the transportation commission under RCW 47.01.061. 19
