(3) Unless provided otherwise in the timetable established under 22 subsection (1) of this section, each agency, using a format acceptable 23 24 to the department, must certify its full participation to the department by the November 1st of each year, beginning November 1, 25 26 2013. If an agency has not submitted all the licensing information necessary for full participation, the agency must instead submit a
