HB 1078 by Representative Appleton

Requiring the ballot proposition to reduce the terms of office of port commissioners to be submitted at the next general election.

Removes special elections as an option for submission of a ballot proposition to reduce the terms of office of port commissioners.

HB 1079 by Representatives Appleton and Freeman

Regarding economic revitalization in urban growth areas.
Includes, as a general objective of the community economic revitalization board, encouraging the

economic revitalization board, encouraging the revitalization of abandoned and vacant properties to maximize the number and type of businesses, services, and employment opportunities available in a community.

HB 1080 by Representative Appleton

Concerning the crime of rendering criminal assistance. Revises rendering criminal assistance provisions.

HB 1081 by Representative Appleton

Addressing certain annual reviews of commitment.

Addresses petitions for conditional release and examinations of mental conditions with regard to sexually violent predators.

Requires the department of social and health services, on request of a committed person, to allow a record of the annual review interview to be preserved either by audio recording or the presence of the person's attorney.

Jan 16 First reading, referred to Public Safety.

HB 1082 by Representative Appleton

Providing for a reduction of ferry fares.

Reduces the fares on state ferries.

Requires the transportation commission, when adopting fares, to consider the amount of subsidy made available solely for the reduction of the charges for transportation of passengers, vehicles, and commodities.

Jan 16 First reading, referred to Transportation.

HB 1083 by Representatives Appleton, Roberts, Jinkins, Freeman, and Hunt

Authorizing judges of tribal courts to solemnize marriages. Authorizes tribal court judges to solemnize marriages.

Jan 16 First reading, referred to Community Development, Housing & Tribal Affairs.

HB 1084 by Representative Appleton

Concerning the medical use of cannabis.

Establishes the Ric Smith memorial act.
Revises medical marijuana provisions.
Changes the term "marijuana" to "cannabis."

-- 2013 REGULAR SESSION --

Jan 16 First reading, referred to Government Accountability & Oversight.

HB 1085 by Representative Appleton

Concerning the Washington health security trust.

Creates the Washington health security trust to provide coverage for a set of health services for all residents.

Abolishes the state health care authority and transfers its powers, duties, and functions to the Washington health security trust.

Requires state employers to pay a health security assessment to the department of revenue to fund the Washington health security trust.

Requires certain residents to pay a standard monthly flat rate health security premium.

Creates the reserve account, the benefits account, and the displaced worker training account.

Deposits certain contributions, and reserves, dividends, and refunds currently in the public employees' and retirees' insurance account in the reserve account and benefits account.

Transfers the state health care authority administrative account to the reserve account and the benefits account.

Requires revenue from certain taxes to be deposited in the reserve account and the benefits account instead of the general fund.

Requires money in the tobacco settlement account to be transferred to the reserve account and the benefits account instead of the general fund.

Requires the state health care authority to: (1) Apply for a waiver from the provisions of the federal patient protection and affordable care act, as amended by the federal health care and education reconciliation act; and

(2) Upon receipt of the waiver, promptly notify in writing the office of the code reviser and the appropriate committees of the legislature.

Repeals RCW 82.04.260 (tax on manufacturers and processors of various foods and by-products).

HB 1086 by Representative Appleton

Allowing for the vacation of certain driving-related convictions under limited circumstances.

Allows a person, under certain conditions, to apply to the sentencing court for a vacation of his or her record of conviction for a violation of driving while under the influence, actual physical control while under the influence, or operating a railroad, etc. while intoxicated, or a conviction for a prior offense.

HB 1087 by Representatives Appleton, Roberts, and Freeman

Allowing for more than one vacation of a misdemeanor and gross misdemeanor conviction.

Allows for more than one vacation of a prostitution conviction, a misdemeanor conviction, or a gross misdemeanor conviction.

HB 1088 by Representatives Dunshee and Warnick; by request of Governor Gregoire

Concerning state general obligation bonds and related

Authorizes the state finance committee to issue general obligation bonds of the state to finance the projects described and authorized by the legislature in the capital and operating appropriations acts for the 2013-2015 fiscal biennium.

HB 1089 by Representatives Dunshee and Warnick; by request of Governor Gregoire

Adopting the 2013-2015 capital budget. Adopts the 2013-2015 capital budget.

HB 1090 by Representatives Shea, Reykdal, Crouse, Holy, Springer, and Dahlquist

Increasing the dollar amount for construction of a dock that does not qualify as a substantial development under the shoreline management act.

Increases to twenty thousand dollars, the dollar amount for construction of a dock that does not qualify as a substantial development under the shoreline management act

Jan 16 First reading, referred to Local Government.

HB 1091 by Representatives Shea, Overstreet, Taylor, Condotta, and MacEwen

Changing provisions relating to presidential electors. Modifies presidential elector provisions.

Jan 16 First reading, referred to Government Operations & Elections.

HB 1092 by Representatives Shea, Overstreet, and Hargrove

Providing a right of first repurchase for surplus transportation property.

Allows a former owner of certain real property to repurchase the property if the department of transportation determines the property is no longer necessary for a transportation purpose.

Jan 16 First reading, referred to Transportation.

HB 1093 by Representatives Shea, Overstreet, and Taylor

Regarding state agency lobbying activities.

Establishes the taxpayer funded lobbying reform act.

Reaffirms and strengthens the lobbying prohibition in current law.

Directs lobbying and informational activities to be done by the officials in charge of the agency instead of hiring lobbyists to engage in the activities.

Jan 16 First reading, referred to Government Operations & Elections.

HB 1094 by Representatives Shea, Overstreet, Taylor, Condotta, MacEwen, and Pollet

Requiring agreements between state agencies and the federal government to be reported to the legislature.

Requires state agencies to submit a written report to the speaker and minority leader of the house, the majority and minority leaders of the senate, and the governor, providing a comprehensive, detailed description of every agreement between the agency and the federal government.

HB 1095 by Representatives Green, Cody, Morrell, Reykdal, Appleton, Ryu, McCoy, Bergquist, and Pollet

Concerning nursing staffing practices at hospitals.

Establishes the Washington state patient safety act.

Requires the department of health to: (1) With stakeholder input, adopt patient assignment limits and recommend quality indicators;

(2) Upon receipt of a complaint, conduct an audit of a hospital's compliance with the act and investigate complaints of violations of the act; and

(3) Maintain, for public inspection, records of any civil penalties, administrative actions, or license suspensions or revocations imposed on hospitals.

HB 1097 by Representatives Hurst, Condotta, Takko, Hope, Clibborn, Dahlquist, Haigh, Parker, Morris, and Fagan

Amending provisions governing structured settlements by removing age barriers and clarifying legislative intent.

Removes age barriers and clarifies legislative intent with regard to structured settlements.

HB 1098 by Representatives Hope and Hurst

Addressing bail practices.

Adopts certain unanimous recommendations of the bail practices work group created in chapter 256, Laws of 2010.

HB 1099 by Representatives Overstreet, Taylor, Shea, Condotta, Rodne, Buys, Zeiger, Scott, Fagan, and Hargrove

Repealing the state estate tax.

Repeals the state estate tax.

HB 1100 by Representatives Overstreet, Shea, Taylor, and Scott

Reducing the state sales and use tax rate.

Reduces the sales and use tax rate.

HB 1101 by Representatives Ryu, McCoy, Pedersen, Jinkins, Green, Morrell, Bergquist, and Farrell

Designating July 25th as patient safety day.

Designates July 25th of each year as patient safety day.

HB 1102 by Representatives Van De Wege, Hunt, Stanford, Liias, Morrell, Appleton, Fitzgibbon, Hudgins, Riccelli, and Bergquist

Modifying ballot processing provisions.

Requires ballots, on the day of the primary or general election, to be processed and counted until midnight or until all ballots received up to and on that day have been processed and counted, whichever occurs first.

HB 1103 by Representatives Van De Wege, Hunt,

Stanford, Liias, Hayes, Morrell, Appleton, Fitzgibbon, Hudgins, Reykdal, and Bergquist

Concerning uniform ballot design.

Requires the secretary of state to: (1) Approve only those vote tallying systems that allow for a vote to be cast by filling in an oval; and

(2) In conjunction with county auditors, develop a uniform ballot format to be used by each county.

Authorizes the secretary of state, in conjunction with the department of enterprise services and in consultation with county auditors, to develop a master contract for vote counting equipment for purchase by local counties.

Requires ballots for all elections to be designed so that a vote is cast by filling in an oval.

Incentivizing up-front environmental planning and review. Authorizes a local government to recover its reasonable expenses of preparation of a nonproject environmental impact statement.

HB 1105 by Representatives McCoy, Morris, Wylie, Ryu, and Pollet

Modifying the renewable energy cost recovery program.

Modifies provisions relating to the renewable energy cost recovery program.

Creates a renewable energy system cost recovery incentive program to be administered by the department of commerce.

HB 1106 by Representatives McCoy, Morris, Ryu, and Hudgins

Regarding net metering of electricity.

Excludes a third-party owner of a customer-sited renewable energy facility from the definition of "electrical company" for purposes of chapter 80.60 RCW (net metering of electricity).

Changes the cumulative generating capacity available to net metering systems.

Changes meter aggregation for customer-generators participating in certain generating facilities.

HB 1107 by Representatives McCoy, Shea, Appleton, Orwall, Jinkins, Morrell, Ryu, Green, and

Freeman

Regarding residential provisions for children of parents with military duties.

Addresses temporary or permanent parenting plans or other court orders designating residential time or visitation rights of military parents.

HB 1108 by Representatives Goodman, Jinkins, Wylie, Pedersen, Green, Roberts, Pettigrew, Maxwell, Orwall, Appleton, Ryu, Morrell, and Bergquist

Modifying the definition of rape in the third degree and indecent liberties.

Revises the definitions of indecent liberties and rape in the third degree.

-- 2013 REGULAR SESSION --

Jan 16 First reading, referred to Public Safety.

HB 1109 by Representatives Hansen, Haler, Magendanz, Shea, Klippert, Smith, Green, Ormsby, Morrell, Van De Wege, Ryu, Maxwell, Zeiger, Wilcox, Jinkins, Springer, Scott, Freeman, Bergquist, Hargrove, and Parker

Requiring institutions of higher education that offer an early course registration period to provide early registration for eligible veterans and national guard members.

Requires certain institutions of higher education to have a process in place, beginning in the 2013-2014 academic year, to offer students who are eligible veterans or national guard members early course registration.

Expires August 1, 2022.

HB 1110 by Representatives Taylor and Manweller

Addressing respirator requirements for asbestos abatement projects.

Requires employers to comply with certain federal standards for the purposes of respirator requirements for asbestos abatement projects.

Jan 16 First reading, referred to Labor & Workforce Development.

HB 1111 by Representatives Taylor, Overstreet, Short, and Shea

Concerning the management of real property assets of the state.

Requires the department of fish and wildlife and the parks and recreation commission to give consideration to economic development opportunities for certain real property under its control when deciding how to most advantageously use the property.

Requires the board of natural resources to give consideration to economic development opportunities for certain public lands under its control when deciding how to most advantageously manage property.

Requires the department of natural resources to develop and the board of natural resources to implement a plan to divest the state of certain state lands and state forest lands.

Requires the state investment board to work with the board of natural resources to implement the state land divestiture plan and ensure that revenue produced from the ensuing land sales are accounted for and managed.

Authorizes the attorney general to condemn land owned by the federal government that is forested or available for active forestry uses.

Requires the board of natural resources, in implementing the divestiture plan, to ensure that land sales are awarded to the highest private sector bidder.

Concerning standards for the use of science to support public policy.

Requires the department of fish and wildlife, before taking a significant agency action, to identify the sources of information reviewed and relied upon by the agency in the course of preparing to take significant agency action.

HB 1113 by Representatives Short, Upthegrove, Springer, Pollet, Taylor, Smith, Fagan, Dahlquist, and Fey

Concerning standards for the use of science to support public policy.

Requires the department of ecology, before taking a significant agency action, to identify the sources of information reviewed and relied upon by the agency in the course of preparing to take significant agency action with regard to the water quality and shorelands and environmental assistance programs within the department.

HB 1114 by Representatives Pedersen, Rodne, Morrell, Nealey, Green, and Jinkins

Addressing criminal incompetency and civil commitment. Revises the involuntary treatment act to protect citizens from the repeated violent acts of a small group of mentally

ill and/or developmentally disabled incompetent offenders.

HB 1115 by Representatives Pedersen and Rodne; by request of Uniform Laws Commission

Concerning the Uniform Commercial code.

Revises article 4A (funds transfers) of the uniform commercial code.

HB 1116 by Representatives Pedersen, Hansen, Rodne, and Nealey; by request of Uniform Laws Commission

Adopting the uniform collaborative law act.

Adopts the uniform collaborative law act which modifies, limits, and supersedes the federal electronic signatures in global and national commerce act.

HB 1117 by Representatives Hansen, Rodne, and Pedersen; by request of Uniform Laws Commission

Concerning the transfer of real property by deed taking effect at the grantor's death.

Establishes the Washington uniform real property transfer on death act which modifies, limits, and supersedes the federal electronic signatures in global and national commerce act.

HB 1118 by Representatives Fitzgibbon, Nealey, Goodman, Rodne, Pedersen, Hansen, and Ryu; by request of Uniform Laws Commission

Revising the uniform interstate family support act. Revises the uniform interstate family support act.

HB 1119 by Representatives Goodman, Ryu, and Santos

Allowing the sheriff to waive fees associated with the service of a writ of habeas corpus under certain circumstances.

Grants volunteer fire department and law enforcement chaplains membership in the volunteer firefighters' and reserve officers' retirement system.

HB 1121 by Representatives Dunshee, Zeiger, and Morrell

Providing for the election of members of the house of representatives from house districts within each legislative district.

Creates two house districts within each legislative district and provides for the election of members of the house of representatives from those districts.

Jan 16 First reading, referred to Government Operations & Elections.

HB 1122 by Representatives Carlyle, Jinkins, Hunt, and Pollet; by request of Governor Gregoire

Increasing revenues dedicated to basic education purposes. Extends the time for additional taxes on certain business and service activities.

Requires the revenues collected from the additional tax to be deposited into the education legacy trust account.

Imposes a new excise tax on taxable fuel to provide funding for state allocations to school districts for pupil transportation purposes.

HB 1123 by Representatives Hurst and Dahlquist

Requiring state agencies to use private collection agencies.

Requires state agencies to contract with private collection agencies for debt collection services.

Provides measures for state employees displaced by this requirement.

Jan 16 First reading, referred to Government Accountability & Oversight.

HB 1124 by Representatives Hurst and Condotta

Concerning recommendations for streamlining reporting requirements for taxes and fees on spirits.

Requires the liquor control board and the department of revenue to provide recommendations to the legislature for streamlining reporting requirements for taxes and fees on spirits.

Jan 16 First reading, referred to Government Accountability & Oversight.

HB 1125 by Representatives Hurst and Dahlquist

Concerning registered sex offenders in adult family homes.
Provides certain notification and disclosure requirements for registered sex offenders seeking residence within an adult family home upon release from total confinement.

Requires specialty training for adult family homes that serve residents who are registered sex offenders.

Requires the department of social and health services to provide enhanced payments to adult family homes that serve residents who are registered sex offenders and medicaid residents.

HB 1126 by Representatives Goodman, Klippert, Hurst, Van De Wege, Warnick, Ryu, and Smith

Concerning state fire service mobilization.

Modifies the state fire service mobilization plan to include a more expansive definition of resources to be provided for mobilization.

HB 1127 by Representatives Klippert, Goodman, Warnick, Kristiansen, Van De Wege, and Ryu

Developing prefire mitigation plans.

Requires the director of fire protection to develop a

statewide plan for prefire mitigation.

Requires the office of the state fire marshal to work with the state building code council to identify potential barriers to, and encourage adoption of, the international wildland urban interface code.

Creates the wildfire prevention account.

HB 1128 by Representatives Takko, Rodne, Appleton, Johnson, Klippert, Fitzgibbon, Sullivan, Green, Clibborn, Nealey, Ryu, Walsh, Jinkins, Wylie, Moscoso, Sells, Angel, Seaquist, Hunt, Springer, Maxwell, Riccelli, Morrell, Hudgins, Bergquist, and Fey

Regarding local agencies' responses to public records requests.

Allows a local agency to: (1) Request a court to enjoin a public records request; and

(2) Adopt a policy limiting the number of hours it devotes to responding to public records requests.

HB 1129 by Representative Morris

Concerning ferry vessel replacement.

Requires a county auditor or other agent appointed by the director of the department of licensing to collect a service fee of five dollars for each initial vehicle registration and registration renewal processed by that county auditor's or other agent's office.

Directs the service fee to be deposited into the capital vessel replacement account.

HB 1130 by Representatives Hurst and Dahlquist

Modifying who is authorized to redeem an impounded vehicle.

Allows certain insurers and vendors to redeem impounded vehicles.

HB 1131 by Representatives Takko, Klippert, Moscoso, Pettigrew, Goodman, and Ryu

Adding persons who serve legal process to assault in the third degree provisions.

Modifies assault in the third degree provisions to include the assault of a person in the act of serving legal process.

HB 1132 by Representatives Hayes, Seaquist, Smith, Van De Wege, Kristiansen, Takko, Haler, Rodne, Sells, McCoy, Dunshee, Moscoso, Tharinger, Ryu, Zeiger, Green, Wilcox, Jinkins, Riccelli, Hurst, Morrell, Scott, Freeman, Dahlquist, Bergquist, Hargrove, and Parker

Authorizing spouses of United States armed forces members who died while in service or as a result of service to apply for gold star license plates.

Authorizes certain spouses of armed forces members to apply for gold star license plates.

HB 1133 by Representatives Hunt, Hurst, Appleton, and Rvu

Allowing beer and/or wine specialty shop licensees to have an endorsement to sell craft distillery products.

Allows beer and wine specialty shop licensees to receive an endorsement to sell craft distillery products under certain requirements and conditions.
