House Bills

HB 1305 by Representatives Hope, Moscoso, Klippert, Hayes, Takko, Pettigrew, Sells, Smith, Hurst, and Bergquist

Modifying vehicle prowling provisions.

Makes vehicle prowling in the second degree a class C felony upon a third or subsequent conviction of vehicle prowling in the second degree.

HB 1306 by Representatives Wylie, Moeller, Harris, Pike, Johnson, Chandler, Sells, Pollet, Upthegrove, and Moscoso

Extending the expiration dates of the local infrastructure financing tool program.

Delays the expiration of the local infrastructure financing tool program.

Jan 23 First reading, referred to Technology & Economic Development.

HB 1307 by Representatives Goodman, Lytton, Wylie, Jinkins, Cody, Roberts, Santos, and Moscoso

Concerning sexual assault protection orders.

Modifies procedures governing sexual assault protection orders including permissible methods of service, the issuance and renewal of ex parte orders, and the modification or termination of orders.

HB 1308 by Representatives Kirby, Harris, Blake, Klippert, Goodman, Rodne, and Takko

Addressing the disclosure of vehicle owner information.

Modifies provisions relating to disclosure of the name or address of an individual vehicle owner.

Requires the department of licensing to: (1) Charge a fee of two dollars for each record returned pursuant to a request made by a business entity; and

(2) Deposit the fee into the highway safety account.

HB 1309 by Representatives Upthegrove, Short, Magendanz, Nealey, Morris, Walsh, Takko, McCoy, Liias, Springer, Pollet, and Kagi

Directing state investments of existing litter tax revenues under chapter 82.19 RCW in material waste management efforts without increasing the tax rate.

Requires the department of ecology to coordinate and expend funds collected from the litter tax with priority given to products identified under RCW 82.19.020 and solely for the purposes of recycling, composting, and litter collection, reduction, and control programs.

Changes the distribution of money from the waste reduction, recycling, and litter control account.

Reducing the littering of retail carryout bags.

Authorizes a local government, through its local legislative authority, to choose to regulate consumer access to retail carryout bags.

Making coverage of certain maritime service elective for purposes of unemployment compensation.

Makes coverage of certain maritime service elective for purposes of unemployment compensation.

HB 1312 by Representatives Wylie, Hunt, Takko, Roberts, Fitzgibbon, and Moscoso

Provides transparency, accountability, and uniformity for county treasurers.

HB 1313 by Representatives Jinkins, Farrell, Morrell, Green, Dunshee, Lytton, Sawyer, Sells, Fitzgibbon, Riccelli, Moeller, Appleton, Reykdal, Roberts, Ryu, Pollet, and Moscoso

Establishing minimum standards for sick and safe leave from employment.

Provides minimum requirements for sick and safe leave from employment.

HB 1314 by Representatives Green, O'Ban, Zeiger, Fey, Upthegrove, and Jinkins

Concerning municipally produced class A biosolids.

Exempts from the definition of "turf fertilizer," for purposes of chapter 15.54 RCW (fertilizers, minerals, and limes), a commercial fertilizer where the phosphorus component is derived solely from exceptional quality biosolids.

Providing funding to continue standardized or mandatory criminal justice training associated with the criminal justice training commission.

Creates the criminal justice training account.

Requires money received by the state treasurer and designated for the criminal justice training account from certain traffic infractions to be deposited in the account and must be used to provide standardized or mandatory criminal justice training.

HB 1316 by Representatives Springer, Manweller, Roberts, Condotta, and Clibborn

Granting scheduling authority for qualified retrospective rating plan employers and groups.

Authorizes retrospective rating plan employers and groups to: (1) Assist the department of labor and industries in the processing of certain claims;

(2) Schedule medical examinations and consultations; and

(3) Schedule vocational rehabilitation assessments.

Requires the joint legislative audit and review committee's audit to include the scheduling authority granted to retrospective rating plan employers and groups.

HB 1317 by Representatives Taylor, Shea, Overstreet, Condotta, and Hargrove

Concerning poll-site voting and voting identification requirements.

Allows registered voters of any county to submit an initiative to the county auditor to establish poll-site voting in that county.

Sets out procedures for poll-site voting in the event an initiative to allow poll-site voting has passed in a county.

HB 1318 by Representatives Taylor, Blake, Shea, and Overstreet

Concerning concealed pistol license renewal notices.

Requires the department of licensing to mail a renewal notice for a concealed pistol license approximately ninety days before the expiration date of the license.

Recognizing a welcome home Vietnam veterans day.

Declares that the thirtieth day of March be recognized as welcome home Vietnam veterans day.

HB 1320 by Representatives Zeiger, Seaquist, Haler, Pollet, Magendanz, Bergquist, Moscoso, Morrell, and Tarleton

Requiring an online higher education transfer and student advising system.

Requires the student achievement council to establish and maintain a statewide online transfer and student advising system that integrates information related to programs, advising, registration, admissions, and transfer.

HB 1321 by Representatives Jinkins, Cody, Green, McCoy, Moeller, Ryu, Fitzgibbon, and Kagi

Establishing food and beverage provision and service policies.

Requires all agencies and other interested organizations to adopt and begin implementation of a food and beverage service policy.

HB 1322 by Representatives Seaquist, Kretz, Sells, Springer, Walsh, Roberts, Kagi, Moscoso, and Tarleton

Allowing nonprofit institutions recognized by the state of Washington to be eligible to participate in the state need grant program.

Allows certain nonprofit institutions to be eligible to participate in the state need grant program.

Regarding the sea cucumber dive fishery.

Modifies sea cucumber dive fishery provisions relating to the collection and deposit of license surcharges and deductions and deposits of excise taxes.

Changes the functions of the sea cucumber dive fishery account.

HB 1324 by Representatives Fitzgibbon, Springer, Upthegrove, Ryu, Dahlquist, Maxwell, Kochmar, and Hargrove

Transferring ferry and flood control zone district functions and taxing authorities to county legislative authorities in counties with a population of one million five hundred thousand or more.

Transfers county ferry district and flood control zone district functions and taxing authorities to certain county legislative authorities.

HB 1325 by Representatives Ryu and Kirby; by request of Department of Financial Institutions

Addressing fees and semiannual assessments, powers, lending limits, and technical amendments related to state-chartered banks, savings banks, savings associations, and trust companies.

Modifies provisions relating to state-chartered banks', savings banks', savings associations', and trust companies' fees and semiannual assessments, powers, and lending limits.

Makes technical changes to laws that govern the department of financial institutions.

HB 1326 by Representatives Ryu and Kirby; by request of Department of Financial Institutions

Addressing the consumer loan act.

Makes technical corrections and updates licensing and enforcement provisions of the consumer loan act.

HB 1327 by Representatives Kirby, Ryu, and Santos; by request of Department of Financial Institutions

Addressing licensing and enforcement provisions applicable to money transmitters.

Modifies provisions relating to licensing and enforcement of money transmitters.

HB 1328 by Representatives Kirby, Ryu, and Maxwell; by request of Department of Financial Institutions

Regulating mortgage brokers.

Addresses the regulation of mortgage brokers by the department of financial institutions.

Clarifies the department of financial institutions' existing regulatory authority regarding residential mortgage loan modification services.

Creating a sales tax holiday for back-to-school clothing and supplies.

Creates a back-to-school sales tax holiday.

Requires the joint legislative audit and review committee to: (1) Conduct an economic impact study of the sales and use tax exemption; and

(2) Evaluate the direct, indirect, and induced economic impacts of the exemptions and their impact on state general fund tax revenues.

Expires July 1, 2016.

Allowing dental hygienists and dental assistants to provide certain services under the supervision of a dentist.

Allows certain dental hygienists and dental assistants to apply topical anesthetic agents under the general supervision of a dentist.

Allows certain dental hygienists to perform specified delegated acts on a homebound patient under the general supervision of a dentist if the patient has first been examined by the supervising dentist.

Authorizing student advisory committees at institutions of higher education.

Authorizes a student association at a four-year institution of higher education to form a student advisory committee to advise and assist the administration of that institution on issues that directly affect students' ability to access and succeed in their educational programs.

HB 1332 by Representatives Kirby, Condotta, Hunt, Alexander, Takko, Manweller, Hurst, Shea, Blake, and Reykdal

Concerning limited on-premise spirits sampling.

Authorizes certain holders of a spirits retail license to provide single-serving samples of one-half ounce or less of spirits, and no more than a total of one and one-half ounces in spirits samples per person, for the purpose of sale promotion.

HB 1333 by Representatives Pettigrew, Walsh, Pollet, Kagi, Green, Reykdal, Santos, Sawyer, Moscoso, and Morrell

Restoring payment rates for community residential providers and annually adjusting payment rates for community residential providers by the rate of inflation.

Requires benchmark rates, indirect client support/administrative rates, and other service rate components for providers of community residential services to persons with developmental disabilities to be adjusted by an inflation factor during the first month of each fiscal year.

Provides that the act is null and void if appropriations are not approved.

Revises the definition of "motorcycle" as a motor vehicle designed to travel on not more than three wheels, not including any stabilizing conversion kits.

HB 1335 by Representatives Shea, Rodne, Overstreet, and Kristiansen

Repealing unnecessary provisions concerning the Washington State Bar Association.

Repeals statutes establishing the bar association and regulation of members of the bar.

Increasing the capacity of school districts to recognize and respond to troubled youth.

Increases the capacity for school districts to recognize and respond to troubled youth through additional training, more comprehensive planning, and emphasis on partnerships between schools and communities.

HB 1337 by Representatives Kretz, Blake, and Short

Conditioning the classification of the gray wolf by the fish and wildlife commission.

Prohibits the fish and wildlife commission from classifying, or maintaining a classification for, the gray wolf as endangered or threatened in any area of the state where a similar listing is not simultaneously in effect for the same species under the federal endangered species act.

Concerning juveniles sentenced to long terms of incarceration.

Modifies juvenile incarceration provisions relating to sentencing, sanctions, earned release time, and community custody.

HB 1339 by Representatives Tharinger, Angel, Cody, Harris, Jinkins, Green, and Moscoso

Clarifying the scope of practice for East Asian medicine practitioners and removing certain referral requirements.

Revises the definition of "East Asian medicine" by including health care services using reflexology.

Removes requirements with regard to a written plan for consultation, emergency transfer, or referral to another health care practitioner.

HB 1340 by Representative Kirby; by request of Uniform Laws Commission

Addressing debt management services.

Establishes the uniform debt management services act. Repeals chapter 18.28 RCW (debt adjusting).

Creating a claim for compensation for wrongful conviction and imprisonment.

Provides an avenue for those who have been wrongly convicted to redress the lost years of their lives.

Revises the definition of "work activity" for purposes of the WorkFirst program.

HB 1343 by Representatives Cody, Johnson, Moeller, Walsh, Morrell, Schmick, Green, and Moscoso

Removing the expiration for the additional surcharge imposed on registered nurses and licensed practical nurses.

Removes the June 30, 2013, repeal of the statute that imposes an additional surcharge on registered and licensed practical nurses.

Authorizing occupational therapists to participate in online access to the University of Washington health sciences library.

Provides occupational therapists with online access to the University of Washington health sciences library.

HB 1345 by Representatives Hayes, O'Ban, Hope, Dahlquist, and Magendanz

Regarding access to K-12 campuses for occupational or educational information.

Allows official recruiting representatives of the job corps, peace corps, and AmeriCorps access to certain K-12 campuses for the purpose of informing students of educational and career opportunities.

HB 1346 by Representatives Manweller, Condotta, Shea, and Warnick

Regulating tipped employee wages and benefits.

Requires employers to: (1) Pay to each of his or her tipped employees, eighteen years of age or older, wages at a rate of not less than seven dollars and twenty-five cents per hour; and

(2) Determine the average tipped wage rate for each tipped employee for the previous calendar month.

Establishes a study group to assess the effectiveness of the act.

Provides a January 1, 2024, expiration date for the study group.

Allowing incremental electricity produced as a result of efficiency improvements to hydroelectric generation projects whose energy output is marketed by the Bonneville power administration to qualify as an eligible renewable resource under the energy independence act.

Authorizes a qualifying utility, under the energy independence act, to use certain eligible renewable resources to meet its compliance obligation with regard to annual targets.

Prohibits a qualifying utility from transferring or selling these eligible renewable resources to another utility for compliance purposes.

Requiring that all mandatory, regulatory, licensing, and disciplinary functions regarding the practice of law and administration of justice reside exclusively in the supreme court.

Proposes an amendment to the state Constitution to require that all mandatory, regulatory, licensing, and disciplinary functions regarding the practice of law and administration of justice reside exclusively in the supreme court.

Changing retail theft with extenuating circumstances to retail theft with special circumstances.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)
 Changes the name of the crime "retail theft with extenuating circumstances" to "retail theft with special circumstances."

SB 5183 by Senators Padden and Kline
 Concerning financing statements to perfect security interests.

Modifies information required on certain financing statements used to perfect a security interest.

SB 5184 by Senators Benton, Darneille, Roach, Nelson, and Hasegawa

Expanding the membership of the capital projects advisory review board.

Adds a member, to be selected by regional transit authorities, to the capital projects advisory review board.

SB 5185 by Senators Roach, Benton, Conway, Chase, and Shin

Concerning the powers of water-sewer districts.
