**HB 1348** by Representatives Reykdal, Hope, Stanford, Pollet, Hunt, Ryu, Seaquist, Goodman, Haigh, Wylie, Fitzgibbon, Santos, Pettigrew, Lytton, Blake, Moscoso, Sells, Orwall, Liias, Roberts, Carlyle, Sullivan, Upthegrove, Dunshee, Maxwell, Green, Riccelli, Ormsby, Springer, Appleton, McCoy, Van De Wege, Bergquist, Tarleton, Fey, and Hudgins

Modifying collective bargaining law related to providing additional compensation for academic employees at community and technical colleges.

Authorizes community college boards of trustees to use the collective bargaining process to provide qualifying academic employees with step increases.

Requires the insurance commissioner to review carrier's surplus levels as an element in determining the

reasonableness of a proposed rate for individual and small group rate filings, submitted by a nonprofit health carrier for either the individual or small group markets.

**HB 1350** by Representatives Chandler and Tharinger

Providing options for local communities to balance growth of the community with water resource goals.

Authorizes county legislative authorities to balance growth of the community with water resource goals by: (1) Addressing future development criteria with regard to exempt well withdrawals; and

(2) Allowing allocation for the best use of the water resources available.

Authorizes the department of social and health services to establish limited exemption criteria in rule to address electronic timekeeping requirements of home care agencies when a landline phone is not available.

Establishes the Washington small rechargeable battery stewardship act.

Finds and declares that: (1) It is important to ensure that all entities supplying small rechargeable batteries to users in Washington, whether as stand alone units or as easily removable components of products, bear the same battery stewardship obligations; and

(2) Addressing certain existing and future barriers to implementation of voluntary industry programs to collect and recycle used small rechargeable batteries will facilitate these interests.

Creates the used battery stewardship account.

Provides that the act is void if a federal law, or a combination of federal laws, takes effect that establishes a national program for the collection and recycling of both used nonrechargeable batteries and used small rechargeable batteries.

Revises nonresident vessel permit provisions relating to a nonresident person's status and sales and use tax exemptions.

Expires July 1, 2016.

Authorizes cities and towns to: (1) Declare by ordinance what is deemed to be a nuisance within the city or town, including litter and potentially dangerous litter;

(2) Prevent, remove, and abate a nuisance at the expense of the parties creating the nuisance; and

(3) Levy a special assessment on the land or premises on which the nuisance is situated.

Authorizes schools administering the Washington kindergarten inventory of developing skills to use up to five school days at the beginning of the school year to meet with parents and families as required in the parent involvement component of the inventory.

Allows practitioners, pharmacists, medical facilities, drug manufacturers, and drug wholesalers to donate prescription drugs and supplies to pharmacies for redistribution without compensation or the expectation of compensation to individuals who meet certain criteria.

Requires pharmacies, pharmacists, and prescribing practitioners that elect to dispense donated prescription drugs and supplies to give priority to individuals who are uninsured and at or below two hundred percent of the federal poverty level.
