Concerning liquor self-checkout machines.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Allows retailers to sell liquor through self-checkout registers if the register is programmed to halt the transaction until an employee intervenes and verifies the age of the purchaser.

Revises the state civil rights act to align state law with federal law with regard to service animals and discrimination in real estate transactions.

Adopts the uniform collaborative law act which modifies, limits, and supersedes the federal electronic signatures in global and national commerce act.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Revises project selection requirements for the freight mobility strategic investment board.

Adjusts the functions of the freight mobility investment account and the freight mobility multimodal account.

**HB 1414-S** by House Committee on Agriculture & Natural Resources (originally sponsored by Representatives Chandler, Blake, Warnick, Tharinger, Stanford, McCoy, and Ross; by request of Governor Inslee)

Concerning Yakima river basin water resource management.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Authorizes the department of ecology to: (1) Implement the integrated water resource management plan in the Yakima river basin;

(2) Develop water supply solutions that provide concurrent benefits to both instream and out-of-stream uses; and

(3) Address a variety of water resource and ecosystem problems affecting fish passage, habitat functions, and agricultural, municipal, and domestic water supply in the Yakima river basin, consistent with the integrated plan.

Creates the Yakima integrated plan implementation account, the Yakima integrated plan implementation taxable bond account, and the Yakima integrated plan implementation revenue recovery account.

Concerning patient and staff safety at state hospitals.

Requires the department of social and health services to develop a plan to enhance the safety of state hospital patients and staff from assault.

**HB 1572** by Representatives Parker, Kirby, Hudgins, Hurst, Vick, Riccelli, Ryu, and Ormsby

Addressing nonprofit debt adjusters.

Allows nonprofit debt adjusters to retain and receive fair share contributions.

**HB 1573** by Representatives Harris, Hope, Pettigrew, Green, Walsh, Cody, Moeller, Stonier, and Morrell

Clarifying the prohibitions against discriminating against licensed chiropractors.

Prohibits school districts from discriminating against licensed chiropractors in performing and receiving compensation for services covered by their licenses.

Prohibits the state from entering into an agreement or contract, with the Washington interscholastic activities association, which discriminates against licensed chiropractors in performing and receiving compensation for services covered by their licenses.

Requires applicants to pay a certification fee before the issuance of initial certification for the residential services and supports program.

Creating greater efficiency in the offices of county assessor by eliminating the requirement to annually appraise tax-exempt government properties.

Eliminates the requirement of county assessors to annually appraise tax-exempt government properties.

Modifies provisions governing allowable credits for the leasehold excise tax.

Allows offices of county assessors to provide assessment, notice, or other information electronically.

Concerning the furnishment of vehicle owner lists to manufacturers of motor vehicles.

Allows the department of licensing to continue to furnish lists of registered and legal owners of motor vehicles to manufacturers of motor vehicles to be used in research activities, and in producing statistical reports, as long as the personal information is not published, redisclosed, or used to contact individuals.

Requires paint manufacturers to assume responsibility for development and implementation of a cost-effective paint stewardship program.

Creates the paint product stewardship account.

Provides that the act is void if a federal law takes effect that establishes a national program for the collection and recycling of architectural paint that substantially meets the intent of the act.

Requiring ninety-day supply limits on certain drugs dispensed by a pharmacist.

Prohibits a pharmacist from dispensing more than a ninety-day supply of certain drugs.

Prohibits persons under eighteen years of age from using an ultraviolet tanning device.

Prescribes penalties for tanning facilities that violate the act.

(2) Establish a process for effectively applying sunset provisions to rules when applicable.
