House Bills

HB 2018-S by House Committee on Appropriations (originally sponsored by Representative Hunter)

Regarding additional contribution rates for employers of the Washington state retirement systems.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Addresses additional contribution rates for contributions made after the date the service is rendered for individual employers of the state retirement systems.

Mar 25 Public hearing in the House Committee on Appropriations at 3:30 PM.

Mar 28 APP - Majority; 1st substitute bill be substituted, do pass.

Executive action taken in the House Committee on Appropriations at 3:30 PM.

Apr 1 Passed to Rules Committee for second reading.

HB 2021 by Representatives O'Ban, Green, and Zeiger

Regarding sediment removal by citizen volunteers.

Requires the department of fish and wildlife to create a pamphlet hydraulic project approval permit that allows citizen volunteers to remove sediment from streams, ponds, wetlands, and lakes without having to undertake a burdensome regulatory permitting process.

Mar 29 First reading, referred to Agriculture & Natural Resources (Not Officially read and referred until adoption of Introduction report).

Senate Bills

SB 5888 by Senators Litzow, Hobbs, Benton, Fraser, Schlicher, Mullet, Sheldon, Harper, and Fain

Concerning the fuel tax used to determine fuel tax distributions to certain accounts.

Addresses fuel tax distributions to certain accounts.

-- 2013 REGULAR SESSION --

Mar 29 First reading, referred to Transportation.

SB 5889 by Senators Nelson, Schlicher, Fain, Hatfield, Hewitt, Fraser, and Kohl-Welles

Modifying snowmobile parking permit and license fees.

Increases initial and renewal vehicle license fees for snowmobiles.

-- 2013 REGULAR SESSION --

Mar 29 First reading, referred to Ways & Means.

SB 5890 by Senators Ericksen, King, Rolfes, and Eide

Concerning the titling and registration of vehicles.

Allows motor vehicle dealers to process their own certificate of title and registration transactions.

-- 2013 REGULAR SESSION --

Apr 1 First reading, referred to Transportation.

Apr 2 Scheduled for public hearing in the Senate Committee on Transportation at 3:30 PM. (Subject to change)
