Clarifying the exemption in the public records act for customer information held by public utilities.

Clarifies the exemption from disclosure, of information relating to public utility customers, under the public records act.

Concerning the administration and operation of flood control districts.

# (DIGEST OF PROPOSED 1ST SUBSTITUTE)

Modifies flood control district provisions relating to: (1) Withholding a percentage of payments for installment contracts;

- (2) Contract and competitive bidding and sealed bids;
- (3) Composition and duties of the board of directors; and
- (4) Location of the office of the board of directors and the principal place of business of the district.

HB 2418 by Representatives Fitzgibbon, Orcutt, Ryu, Tarleton, Morrell, Tharinger, Magendanz, and Muri

Extending the alternative fuel vehicle retail sales and use tax exemption.

Provides a sales and use tax exemption to increase sales of alternative fuel vehicles by ten percent by 2023 and to reduce the difference of average cost between comparable models of alternative fuel vehicles and conventional fuel vehicles.

**HB 2419** by Representatives Manweller, Rodne, and Morrell

Concerning Washington's standard of care for medical malpractice.

Establishes the standard of care protection act.

Declares that: (1) As health system reform is implemented at both the federal and state levels, health care providers may face additional liability exposure related to federal guidelines in state civil actions;

- (2) Additional liability exposure could lead to more civil actions against health care providers, increased medical liability insurance premiums, and reduced access to health care for patients; and
- (3) States have the constitutional authority to amend their statutes to prevent the use of these provisions in medical liability actions brought under state law and should do so in order to prevent their liability climate from deteriorating for health care providers.

Requires the office of financial management and the consultants to consult with the department of corrections, stakeholder groups that represent the people who are served in these institutions, labor organizations that represent employees who work in these institutions, and other persons or entities with experience and expertise in the areas being studied.

Authorizes the operation, by local authorities, of an automated traffic safety camera to detect speed violations subject to the following limitations: (1) Only one camera is allowed within its respective jurisdiction;

- (2) The camera may only be operated if the local legislative authority has enacted an ordinance authorizing the use of the camera to detect speed violations; and
- (3) Use of the camera must first be authorized by the legislature as part of a pilot project with the traffic safety commission.

Requires the office of student financial assistance to design and implement a low interest educational loan program.

Authorizes the office of student financial assistance to award Washington advance higher education loans to eligible students from the funds available in the Washington advance higher education loan account.

Creates the Washington advance higher education loan

Provides an expiration date of July 1, 2020, for chapter 28B.97 RCW (Washington advance higher education loan program).
