Clarifying pretrial release programs.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Prohibits a pretrial release program from agreeing to supervise, or accepting into its custody, an offender who is currently awaiting trial for a violent offense or a sex offense, who has been convicted of one or more violent offenses or sex offenses in the ten years before the date of the current offense, unless the offender's release before trial was secured with a payment of bail.

Requires the department of health to convene a work group of representatives of the medical quality assurance commission, the board of osteopathic medicine and surgery, the nursing care quality assurance committee, the board of naturopathy, and an association representing physicians to develop practice guidelines for health care professionals to consider when authorizing the medical use of marijuana for patients.

Requires certain health benefit plans that are issued or renewed after December 31, 2015, to offer benefits or coverage for medically necessary elemental formula, regardless of delivery method, when a licensed physician or other health care provider with prescriptive authority diagnoses a patient with an eosinophilic gastrointestinal associated disorder and orders and supervises the use of the elemental formula.

public for any type of legal needs.

Creates a regulatory environment that is not more

of this state have ready and uncomplicated access to legal
services; and

(2) Safeguard the public from the risk that a legal service
contractor providing access to legal services may be unable
to fulfill its contractual obligations.

(4) Certain interested parties.

deferral for the manufacturing of rotorcraft, including the
components used in the manufacturing process.

students to selective four-year institutions of higher
education and independent, nonprofit baccalaureate degree-
granting institutions in this state.
