Improving the adoption process.

Changes requirements of the preplacement and postplacement reports to include an investigation of the existence of extended family and community connections

to serve as support and the planned approach to child discipline and punishment of the person requesting the report.

Requires the family and children's ombuds to: (1) Submit a report on information regarding the progress made by the department of social and health services in implementing recommendations made in the report on severe abuse of adopted children; and

(2) Convene a work group to compile a list of informational and resource materials that must be provided to prospective adoptive parents by the agency, the department of social and health services, an individual approved by the court, or a qualified salaried court employee requested to prepare a preplacement report.

Eliminating the disparate treatment of HIV in the criminal justice system.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Removes specific mention of the human immunodeficiency virus from the criminal statutes of the state to reflect that the human immunodeficiency virus should not be treated differently from other similar diseases.

Requires the department of labor and industries to inspect dumbwaiters no more often than every two years unless an inspection shows a dumbwaiter to be in an unsafe condition, in which case the department shall conduct an annual inspection until the dumbwaiter has passed inspection for two successive inspections.

Addresses a juvenile firearm offender's participation in an aggression replacement training program, a functional family therapy program, or other program applicable to the juvenile firearm offender population.

Requires the juvenile rehabilitation administration of the department of social and health services to compile and analyze data regarding juvenile offenders who have been found to have committed the offense of unlawful possession of a firearm and who made their initial contact with the criminal justice system between January 1, 2005, and December 31, 2013.

Clarifies that for multiple parcels of land that are contiguous and total twenty or more acres, an individual parcel does not have to directly produce gross income as long as activities on the combined parcels generate cash income by producing one or more agricultural products and the individual parcel is devoted primarily to agricultural uses.  
Requires the department of revenue to provide guidance to the state's county assessors in order to: (1) Assure fair, uniform, and consistent practices statewide in the administration of chapter 84.34 RCW (open space, agricultural, and timber lands--current use--conservation futures);  
(2) Provide access to the current use program for all eligible farms; and  
(3) Support the preservation of the state's working lands and agricultural economy.  
Revises the definition of "farm and agricultural land" in chapter 84.34 RCW to include land that is included in the implementation of a work plan under the voluntary stewardship program.

(2) Consider parking information system upgrades regarding special parking privileges for persons with disabilities.

Requires a homeowners' association to make available to each owner of record for examination and copying minutes from the previous association meeting not more than sixty days after the meeting.

Provides a definition for "floating on-water residence" for purposes of the shoreline management act.

Considers a floating on-water residence that is legally established before July 1, 2014, as a conforming use.

Authorizes counties to conduct public auctions via the internet.

Concerning the expiration of the advisory committee on the disproportionate representation of children of color in Washington's child welfare system.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Terminates the advisory committee on the disproportionate representation of children of color in Washington's child welfare system on July 1, 2017.

Requires the advisory committee to: (1) Consult with the governor's office of Indian affairs, the commission on African-American affairs, the commission on Asian Pacific American affairs, and the commission on Hispanic affairs to develop membership rules by August 1, 2014; and

(2) Conduct an analysis examining the number of children who have incarcerated parents at any time during their involvement with the child welfare system.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Establishes the Graham Hazzard act.

Requires the department of early learning to provide information on safe sleep practices as outlined by the American academy of pediatrics to applicants for child care licensure.

Expanding the products considered to be potentially nonhazardous as they apply to cottage food operations.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Revises the definition of "cottage food products" to include baked candies and candies made on a stovetop.

Requires the criminal justice training commission to develop criteria for the data collection and evaluation of the number of reserve peace officers who are specially commissioned Washington peace officers, employed, volunteering, or otherwise representing local law enforcement agencies each year.

Requires certain local governments, within twenty-eight days after receiving a project permit application, to mail or e-mail a written determination to any persons requesting the notification, the department of archaeology and historic preservation, and any affected tribes that request ongoing notice.
