- 8 (iii) A description of the process for notifying the office of the 9 governor and the legislature when problems with quality of care, 10 client safety and well-being, or staff safety arise within community 11 or institutional settings;
- 12 (iv) A compilation of findings since fiscal year 2010 by the 13 centers for medicare and medicaid services, and residential care 14 services, at the residential habilitation centers, nursing facilities, 15 supported living, assisted living, group homes, companion homes, adult 16 family homes, and all other community based providers;
- (v) An annotated and detailed list of all responses to findings by 18 the centers for medicare and medicaid services, and residential care 19 services, specific to audits of the nursing facility at lakeland 20 village since fiscal year 2010; and
- (vi) A description of the method in place to ascertain the outcome 22 of responses to findings."
