Funding for those programs is reduced by \$28,507,000 General Fund--State and \$30,146,000 General Fund--Federal in the FY 15-17 biennium.

Funding for the Office of Crime Victims Advocacy in the Department of Commerce is increased by \$5,000,000 in the 2015-17 biennium for grants to community sexual assault prevention programs.

Funding for the Family Caregiver Support program in the DSHS Aging

and Adult Services program is increased by \$5,000,000 in the 2015-17 biennium.

Funding for service dogs for veterans in the Department of Veterans Affairs is increased by \$8,000,000 in the 2015-17 biennium.

Funding for rapid re-housing, homeless prevention, transportation, counseling, training, child care, emergency assistance, and other programs that serve disabled veterans in the Department of Veterans Affairs is increased by \$5,507,000 in the 2015-17 biennium.

Funding for the Internet Crimes Against Children Account, established in Second Substitute House Bill 1281, is increased by \$5,000,000 from the state general fund in the FY 15-17 biennium.

FISCAL IMPACT: No net change to appropriated General Fund--State levels.

Reduces General Fund - Federal by \$30,146,000.
