4 For the purposes of RCW 42.17A.700, "executive state officer"  
5 includes:

6 (1) The chief administrative law judge, the director of  
7 agriculture, the director of the department of services for the  
8 blind, the chief information officer of the office of chief  
9 information officer, the director of the state system of community  
10 and technical colleges, the director of commerce, the director of  
11 the consolidated technology services agency, the secretary of  
12 corrections, the director of early learning, the director of  
13 ecology, the commissioner of employment security, the chair of the  
14 energy facility site evaluation council, the director of enterprise  
15 services, the secretary of the state finance committee, the director  
16 of financial management, the director of fish and wildlife, the  
17 executive secretary of the forest practices appeals board, the  
18 director of the gambling commission, the secretary of health, the  
19 administrator of the Washington state health care authority, the  
20 executive secretary of the health care facilities authority, the  
21 executive secretary of the higher education facilities authority,  
22 the executive secretary of the horse racing commission, the human  
23 resources director, the executive secretary of the human rights  
24 commission, the executive secretary of the indeterminate sentence  
25 review board, the executive director of the state investment board,  
26 the director of labor and industries, the director of licensing, the  
27 director of the lottery commission, the director of the office of

1 minority and women's business enterprises, the director of parks and  
2 recreation, the executive director of the public disclosure  
3 commission, the executive director of the Puget Sound partnership,  
4 the director of the recreation and conservation office, the director  
5 of retirement systems, the director of revenue, the secretary of  
6 social and health services, the chief of the Washington state  
7 patrol, the executive secretary of the board of tax appeals, the  
8 secretary of transportation, the secretary of the utilities and  
9 transportation commission, the director of veterans affairs, the  
10 president of each of the regional and state universities and the  
11 president of The Evergreen State College, and each district and each  
12 campus president of each state community college;

13 (2) Each professional staff member of the office of the  
14 governor;

15 (3) Each professional staff member of the legislature. For  
16 purposes of this section, a professional staff member of the  
17 legislature does not include a legislative assistant; and

18 (4) Central Washington University board of trustees, the boards of  
19 trustees of each community college and each technical college, each  
20 member of the state board for community and technical colleges, state  
21 convention and trade center board of directors, Eastern Washington  
22 University board of trustees, Washington economic development finance  
23 authority, Washington energy northwest executive board, The Evergreen  
24 State College board of trustees, executive ethics board, fish and  
25 wildlife commission, forest practices appeals board, forest practices  
26 board, gambling commission, Washington health care facilities  
27 authority, student achievement council, higher education facilities  
28 authority, horse racing commission, state housing finance commission,  
29 human rights commission, indeterminate sentence review board, board of  
30 industrial insurance appeals, state investment board, commission on  
31 judicial conduct, legislative ethics board, life sciences discovery  
32 fund authority board of trustees, liquor control board, lottery  
33 commission, Pacific Northwest electric power and conservation planning  
34 council, parks and recreation commission, Washington personnel

1 resources board, board of pilotage commissioners, pollution control  
2 hearings board, public disclosure commission, public employees'  
3 benefits board, recreation and conservation funding board, salmon  
4 recovery funding board, shorelines hearings board, board of tax
