- 1 Strike everything after the enacting clause and insert the 2 following:
- 3 "Sec. 1. RCW 9.94A.030 and 2012 c 143 s 1 are each amended to 4 read as follows:
- 5 Unless the context clearly requires otherwise, the definitions in 6 this section apply throughout this chapter.
- 7 (1) "Board" means the indeterminate sentence review board created 8 under chapter 9.95 RCW.
  - (2) "Collect," or any derivative thereof, "collect and remit," or "collect and deliver," when used with reference to the department, means that the department, either directly or through a collection agreement authorized by RCW 9.94A.760, is responsible for monitoring and enforcing the offender's sentence with regard to the legal financial obligation, receiving payment thereof from the offender, and, consistent with current law, delivering daily the entire payment to the superior court clerk without depositing it in a departmental account.
- 18 (3) "Commission" means the sentencing guidelines commission.
- 19 (4) "Community corrections officer" means an employee of the 20 department who is responsible for carrying out specific duties in 21 supervision of sentenced offenders and monitoring of sentence 22 conditions.
  - (5) "Community custody" means that portion of an offender's sentence of confinement in lieu of earned release time or imposed as part of a sentence under this chapter and served in the community subject to controls placed on the offender's movement and activities by the department.
- 28 (6) "Community protection zone" means the area within eight 29 hundred eighty feet of the facilities and grounds of a public or 30 private school.
- 31 (7) "Community restitution" means compulsory service, without 32 compensation, performed for the benefit of the community by the 33 offender.

(8) "Confinement" means total or partial confinement.

- 2 (9) "Conviction" means an adjudication of guilt pursuant to Title 3 10 or 13 RCW and includes a verdict of guilty, a finding of guilty, 4 and acceptance of a plea of guilty.
  - (10) "Crime-related prohibition" means an order of a court prohibiting conduct that directly relates to the circumstances of the crime for which the offender has been convicted, and shall not be construed to mean orders directing an offender affirmatively to participate in rehabilitative programs or to otherwise perform affirmative conduct. However, affirmative acts necessary to monitor compliance with the order of a court may be required by the department.
- 13 (11) "Criminal history" means the list of a defendant's prior 14 convictions and juvenile adjudications, whether in this state, in 15 federal court, or elsewhere.
  - (a) The history shall include, where known, for each conviction(i) whether the defendant has been placed on probation and the lengthand terms thereof; and (ii) whether the defendant has beenincarcerated and the length of incarceration.
  - (b) A conviction may be removed from a defendant's criminal history only if it is vacated pursuant to RCW 9.96.060, 9.94A.640, 9.95.240, or a similar out-of-state statute, or if the conviction has been vacated pursuant to a governor's pardon.
    - (c) The determination of a defendant's criminal history is distinct from the determination of an offender score. A prior conviction that was not included in an offender score calculated pursuant to a former version of the sentencing reform act remains part of the defendant's criminal history.
    - (12) "Criminal street gang" means any ongoing organization, association, or group of three or more persons, whether formal or informal, having a common name or common identifying sign or symbol, having as one of its primary activities the commission of criminal acts, and whose members or associates individually or collectively engage in or have engaged in a pattern of criminal street gang activity. This definition does not apply to employees engaged in concerted activities for their mutual aid and protection, or to the activities of labor and bona fide nonprofit organizations or their members or agents.
- 39 (13) "Criminal street gang associate or member" means any person 40 who actively participates in any criminal street gang and who

intentionally promotes, furthers, or assists in any criminal act by the criminal street gang.

- (14) "Criminal street gang-related offense" means any felony or misdemeanor offense, whether in this state or elsewhere, that is committed for the benefit of, at the direction of, or in association with any criminal street gang, or is committed with the intent to promote, further, or assist in any criminal conduct by the gang, or is committed for one or more of the following reasons:
  - (a) To gain admission, prestige, or promotion within the gang;
- 10 (b) To increase or maintain the gang's size, membership, 11 prestige, dominance, or control in any geographical area;
- 12 (c) To exact revenge or retribution for the gang or any member of the gang;
- 14 (d) To obstruct justice, or intimidate or eliminate any witness 15 against the gang or any member of the gang;
  - (e) To directly or indirectly cause any benefit, aggrandizement, gain, profit, or other advantage for the gang, its reputation, influence, or membership; or
  - (f) To provide the gang with any advantage in, or any control or dominance over any criminal market sector, including, but not limited to, manufacturing, delivering, or selling any controlled substance (chapter 69.50 RCW); arson (chapter 9A.48 RCW); trafficking in stolen property (chapter 9A.82 RCW); promoting prostitution (chapter 9A.88 RCW); human trafficking (RCW 9A.40.100); promoting commercial sexual abuse of a minor (RCW 9.68A.101); or promoting pornography (chapter 9.68 RCW).
  - (15) "Day fine" means a fine imposed by the sentencing court that equals the difference between the offender's net daily income and the reasonable obligations that the offender has for the support of the offender and any dependents.
  - (16) "Day reporting" means a program of enhanced supervision designed to monitor the offender's daily activities and compliance with sentence conditions, and in which the offender is required to report daily to a specific location designated by the department or the sentencing court.
    - (17) "Department" means the department of corrections.
- 37 (18) "Determinate sentence" means a sentence that states with 38 exactitude the number of actual years, months, or days of total 39 confinement, of partial confinement, of community custody, the number 40 of actual hours or days of community restitution work, or dollars or

- terms of a legal financial obligation. The fact that an offender through earned release can reduce the actual period of confinement shall not affect the classification of the sentence as a determinate sentence.
- (19) "Disposable earnings" means that part of the earnings of an 5 6 offender remaining after the deduction from those earnings of any 7 amount required by law to be withheld. For the purposes of this "earnings" means compensation paid or payable for 8 9 personal services, whether denominated as wages, salary, commission, bonuses, or otherwise, and, notwithstanding any other provision of 10 11 law making the payments exempt from garnishment, attachment, or other 12 process to satisfy a court-ordered legal financial obligation, specifically includes periodic payments pursuant to pension or 13 retirement programs, or insurance policies of any type, but does not 14 include payments made under Title 50 RCW, except as provided in RCW 15 50.40.020 and 50.40.050, or Title 74 RCW. 16
- 17 (20) "Domestic violence" has the same meaning as defined in RCW 18 10.99.020 and 26.50.010.
  - (21) "Drug offender sentencing alternative" is a sentencing option available to persons convicted of a felony offense other than a violent offense or a sex offense and who are eligible for the option under RCW 9.94A.660.
    - (22) "Drug offense" means:

- (a) Any felony violation of chapter 69.50 RCW except possession of a controlled substance (RCW 69.50.4013) or forged prescription for a controlled substance (RCW 69.50.403);
- (b) Any offense defined as a felony under federal law that relates to the possession, manufacture, distribution, or transportation of a controlled substance; or
- 30 (c) Any out-of-state conviction for an offense that under the 31 laws of this state would be a felony classified as a drug offense 32 under (a) of this subsection.
- 33 (23) "Earned release" means earned release from confinement as 34 provided in RCW 9.94A.728.
- 35 (24) "Escape" means:
- (a) Sexually violent predator escape (RCW 9A.76.115), escape in the first degree (RCW 9A.76.110), escape in the second degree (RCW 9A.76.120), willful failure to return from furlough (RCW 72.66.060), willful failure to return from work release (RCW 72.65.070), or

- willful failure to be available for supervision by the department while in community custody (RCW 72.09.310); or
  - (b) Any federal or out-of-state conviction for an offense that under the laws of this state would be a felony classified as an escape under (a) of this subsection.
- (25) "Electronic monitoring" means tracking the location of an individual, whether pretrial or posttrial, through the use of technology that is capable of determining or identifying the monitored individual's presence or absence at a particular location including, but not limited to:
- 11 (a) Radio frequency signaling technology, which detects if the
  12 monitored individual is or is not at an approved location and
  13 notifies the monitoring agency of the time that the monitored
  14 individual either leaves the approved location or tampers with or
  15 removes the monitoring device; or
  - (b) Active or passive global positioning system technology, which continuously or intermittently detects the location of the monitored individual and continuously notifies the monitoring agency of the monitored individual's location.
    - (26) "Felony traffic offense" means:

- (a) Vehicular homicide (RCW 46.61.520), vehicular assault (RCW 46.61.522), eluding a police officer (RCW 46.61.024), felony hit-and-run injury-accident (RCW 46.52.020(4)), felony driving while under the influence of intoxicating liquor or any drug (RCW 46.61.502(6)), or felony physical control of a vehicle while under the influence of intoxicating liquor or any drug (RCW 46.61.504(6)); or
  - (b) Any federal or out-of-state conviction for an offense that under the laws of this state would be a felony classified as a felony traffic offense under (a) of this subsection.
  - $((\frac{26}{1}))$  <u>(27)</u> "Fine" means a specific sum of money ordered by the sentencing court to be paid by the offender to the court over a specific period of time.
- $((\frac{27}{1}))$  (28) "First-time offender" means any person who has no prior convictions for a felony and is eligible for the first-time offender waiver under RCW 9.94A.650.
- ((\(\frac{(28)}{28}\))) (29) "Home detention" means a program of partial confinement available to offenders wherein the offender is confined in a private residence twenty-four hours a day, unless an absence from the residence is approved, authorized, or otherwise permitted in the order by the court or other supervising agency that ordered home

- detention, and the offender is subject to electronic ((surveillance))
  monitoring.
  - $((\frac{(29)}{)})$  <u>(30)</u> "Homelessness" or "homeless" means a condition where an individual lacks a fixed, regular, and adequate nighttime residence and who has a primary nighttime residence that is:
- 6 (a) A supervised, publicly or privately operated shelter designed 7 to provide temporary living accommodations;
- 8 (b) A public or private place not designed for, or ordinarily 9 used as, a regular sleeping accommodation for human beings; or
- 10 (c) A private residence where the individual stays as a transient 11 invitee.
- 12 (((30))) (31) "Legal financial obligation" means a sum of money that is ordered by a superior court of the state of Washington for 13 legal financial obligations which may include restitution to the 14 victim, statutorily imposed crime victims' compensation fees as 15 16 assessed pursuant to RCW 7.68.035, court costs, county or interlocal 17 drug funds, court-appointed attorneys' fees, and costs of defense, fines, and any other financial obligation that is assessed to the 18 offender as a result of a felony conviction. Upon conviction for 19 vehicular assault while under the influence of intoxicating liquor or 20 21 any drug, RCW 46.61.522(1)(b), or vehicular homicide while under the influence of intoxicating liquor or any drug, RCW 46.61.520(1)(a), 22 legal financial obligations may also include payment to a public 23 24 agency of the expense of an emergency response to the incident 25 resulting in the conviction, subject to RCW 38.52.430.
- $((\frac{31}{1}))$  (32) "Minor child" means a biological or adopted child of the offender who is under age eighteen at the time of the offender's current offense.
- 29  $((\frac{32}{32}))$  Most serious offense" means any of the following 30 felonies or a felony attempt to commit any of the following felonies:
- 31 (a) Any felony defined under any law as a class A felony or 32 criminal solicitation of or criminal conspiracy to commit a class A felony;

  - (c) Assault of a child in the second degree;

- (v)(i) A prior conviction for indecent liberties under RCW 9A.44.100(1) (a), (b), and (c), chapter 260, Laws of 1975 1st ex. sess. as it existed until July 1, 1979, RCW 9A.44.100(1) (a), (b), and (c) as it existed from July 1, 1979, until June 11, 1986, and RCW 9A.44.100(1) (a), (b), and (d) as it existed from June 11, 1986, until July 1, 1988;
- (ii) A prior conviction for indecent liberties under RCW 9A.44.100(1)(c) as it existed from June 11, 1986, until July 1, 1988, if: (A) The crime was committed against a child under the age of fourteen; or (B) the relationship between the victim and perpetrator is included in the definition of indecent liberties under RCW 9A.44.100(1)(c) as it existed from July 1, 1988, through July 27, 1997, or RCW 9A.44.100(1) (d) or (e) as it existed from July 25,

1993, through July 27, 1997;

(w) Any out-of-state conviction for a felony offense with a finding of sexual motivation if the minimum sentence imposed was ten years or more; provided that the out-of-state felony offense must be comparable to a felony offense under this title and Title 9A RCW and the out-of-state definition of sexual motivation must be comparable to the definition of sexual motivation contained in this section.

- (((33))) (34) "Nonviolent offense" means an offense which is not 8 a violent offense.
  - ((\(\frac{(34)}{)}\)) (35) "Offender" means a person who has committed a felony established by state law and is eighteen years of age or older or is less than eighteen years of age but whose case is under superior court jurisdiction under RCW 13.04.030 or has been transferred by the appropriate juvenile court to a criminal court pursuant to RCW 13.40.110. In addition, for the purpose of community custody requirements under this chapter, "offender" also means a misdemeanant or gross misdemeanant probationer ordered by a superior court to probation pursuant to RCW 9.92.060, 9.95.204, or 9.95.210 and supervised by the department pursuant to RCW 9.94A.501 and 9.94A.5011. Throughout this chapter, the terms "offender" and "defendant" are used interchangeably.

- (7) All courts shall develop policies and procedures by January 1, 2011, to grant victims a process to modify or rescind a no-contact order issued under this chapter. The administrative office of the courts shall develop a model policy to assist the courts in implementing the requirements of this subsection.

  - <u>EFFECT:</u> (1) Redefines the term "home detention" to include electronic monitoring rather than electronic surveillance.
  - (2) Defines "electronic monitoring" as tracking the location of a person, whether pretrial or posttrial, through technology capable of determining the person's presence or absence at a particular location and applies this definition when electronic monitoring is imposed in the following contexts:
  - (a) When imposed by the department of corrections pursuant to its discretion to monitor those convicted of sex offenses;
  - (b) When imposed by the court as part of a domestic violence protection order or after conviction for violation of such orders; and
    - (c) When imposed as a condition of release in a criminal case.
  - (3) Includes electronic monitoring in the definition of partial confinement.
  - (4) Applies the following requirements to private monitoring agencies, rather than all monitoring agencies:
  - (a) Have contingency plans for operations during power outages or other emergencies;
  - (b) Prohibit certain relationships between monitored persons and the monitoring agency;
  - (c) Not employ or be owned by persons convicted of a felony within the previous four years; and
  - (d) Obtain background checks from Washington state patrol for all employees and owners.
  - (5) Subjects a private monitoring agency, rather than all monitoring agencies, to a civil penalty of up to \$1000 per violation of some of the requirements for monitoring agencies.
  - (6) Adds to the definition of "monitoring agency" an agency monitoring an individual pursuant to an electronic monitoring program.
  - (7) Defines "supervising agency" as a public entity that authorizes, approves, administers, or manages a home detention or electronic monitoring program.
  - (8) Provides that all government contracts with private monitoring agencies for provision of electronic monitoring or home detention services be in writing.
  - (9) Removes the prohibition on pretrial home detention for defendants who have been previously convicted for violent, sex, or escape offense.
  - (10) Removes the requirement that a defendant post bail prior to pretrial release to home detention.
  - (11) Prohibits a monitoring agency from monitoring pursuant to home detention or electronic monitoring an offender who is currently awaiting trial for a violent or sex offense and has previously been convicted of one or more violent or sex offenses.
    - (12) Removes the emergency clause.
