7 (1) The appropriation in this section is provided solely for
8 loans or grants to low-income housing developers to design and
9 construct ultra-high energy efficient housing projects including
10 single and multifamily units;

11 (2) By December 1, 2015, in consultation with professional
12 building, energy efficiency and housing finance organizations, the
13 office of financial management, and appropriate legislative staff,
14 the department shall develop a process that is designed to solicit,
15 evaluate, and fund ultra-high energy efficient housing projects as
16 part of the housing trust fund competitive program.

17 (3) To receive funding, a project must demonstrate energy-saving

27 construction process that can be replicated by the Washington
28 building industry;

29 (d) The extent to which the project leverages nonstate funds;

30 (e) The extent to which the project is ready to proceed to
31 construction;

32 (f) Whether the project promotes sustainable use of resources and
33 environmental quality;

34 (g) Whether the project is being well-managed to fund maintenance
35 and capital depreciation;

36 (h) Reduction of housing and utilities carbon footprint; and

37 (i) Other criteria that the department considers necessary to
38 achieve the purpose of this program.

1 (5) The department must monitor and track the results of the
2 housing projects that receive ultra-high energy efficiency funding
3 under this section. By December 1, 2018, the department must submit a
4 report to appropriate legislative committees documenting:

5 (a) Project costs compared to the costs of traditional design and
6 construction;

7 (b) Life-cycle costs;

8 (c) Use of sustainable resources;

9 (d) Energy savings and reduction of carbon footprint;

10 (e) Any lessons learned; and

11 (f) A data collection plan to monitor actual performance in order
12 to validate projected savings.

23 Community Behavioral Health Beds - Acute & Residential (92000344)

24 The appropriation in this section is subject to the following
25 conditions and limitations:

26 (1) The appropriation in this section is provided solely for the
27 department of commerce, in collaboration with the department of
28 social and health services, to issue grants to hospitals or other
29 entities to establish new community hospital inpatient psychiatric
30 beds, free-standing evaluation and treatment facilities, enhanced
31 services facilities, triage facilities, or crisis stabilization
32 facilities with sixteen or fewer beds for the purpose of providing
33 short-term detention services through the publicly funded mental
34 health system. Funds may be used for construction and equipment costs
35 associated with establishment of the community hospital inpatient
36 psychiatric beds, free-standing evaluation and treatment facilities,
37 enhanced services facilities, triage facilities, or crisis
38 stabilization facilities. These funds may not be used for operating

1 costs associated with the treatment of patients using these services.
2 The department shall establish criteria for the issuance of grants
3 and priority must be given to those proposals to establish new
4 community hospital inpatient psychiatric beds or free-standing
5 evaluation and treatment facilities. The criteria must include:

6 (a) Evidence that the application was developed in collaboration
7 with one or more regional support networks, as defined in RCW
8 71.24.025;

9 (b) Evidence that the applicant has assessed and would meet gaps
10 in geographical access to short-term detention services under chapter
11 71.05 RCW in their region;

12 (c) A commitment by applicants to serve persons who are publicly
13 funded and persons detained under the involuntary treatment act under
14 chapter 71.05 RCW;

15 (d) A commitment by the applicant to maintain the beds or
16 facility for at least a ten-year period;

17 (e) The date upon which structural modifications or construction
18 would begin and the anticipated date of completion of the project;

19 (f) A detailed estimate of the costs associated with opening the
20 beds;

21 (g) The applicant's commitment to work with local courts and
22 prosecutors to ensure that prosecutors and courts in the area served
23 by the hospital or facility will be available to conduct involuntary
24 commitment hearings and proceedings under chapter 71.05 RCW; and

25 (h) A lack of local resources, including nonmedicaid operating
26 reserves, and regional fund balances that are not contractually
27 encumbered.

28 (2) To accommodate the emergent need for inpatient psychiatric
29 services, the department of health and the department of commerce, in
30 collaboration with the department of social and health services shall
31 establish a concurrent and expedited process for the purpose of grant
32 applicants meeting any applicable regulatory requirements necessary
33 to operate inpatient psychiatric beds, free-standing evaluation and
34 treatment facilities, enhanced services facilities, triage
35 facilities, or crisis stabilization facilities.

14 the department of commerce, in collaboration with the department of
15 social and health services and the health care authority, to issue
16 grants to entities for the development of facilities that provide for
17 the diversion or transition of patients from the state hospitals.

18 (b) Funds may be used for construction and equipment costs
19 directly associated with the establishment of community hospital
20 inpatient psychiatric beds, free-standing evaluation and treatment
21 facilities, enhanced services facilities, crisis triage centers, and

30 limited to: (i) A clear demonstration of need; (ii) a commitment to
31 servicing persons who are publicly funded; (iii) a commitment to
32 maintain the beds or facility for at least a ten-year period; and
33 (iv) specific performance and outcome measures to ensure greatest
34 benefit to the region. The department may only fund proposals that
35 provide evidence that the application was developed in collaboration
36 with one or more behavioral health organizations as defined in RCW
37 71.24.025 or the health care authority in the case of an application
38 submitted from a region that has become an early adopter of
39 integrated medical and behavioral health services pursuant to RCW
40 71.24.380(5). In awarding these funds, the department must prioritize

1 an equitable distribution for facilities in both rural and urban
2 areas with the greatest demonstrated need.

16 The appropriation in this section is subject to the following
17 conditions and limitations:

18 (1) Except as directed otherwise prior to the effective date of
19 this section, the department may not expend the appropriation in this
20 section unless and until the nonstate share of project costs have
21 been either expended, or firmly committed, or both, in an amount
22 sufficient to complete the project or a distinct phase of the project
23 that is useable to the public for the purpose intended by the
24 legislature. This requirement does not apply to projects where a
25 share of the appropriation is released for design costs only.

26 (2) Prior to receiving funds, project recipients must demonstrate
27 that the project site is under control for a minimum of ten years,
28 either through ownership or a long-term lease. This requirement does
29 not apply to appropriations for preconstruction activities or
30 appropriations whose sole purpose is to purchase real property that
31 does not include a construction or renovation component.

32 (3) Projects funded in this section may be required to comply

4 (6) Projects funded in this section, including those that are
5 owned and operated by nonprofit organizations, are generally required
6 to pay state prevailing wages.

7 (7) As the most trade dependent state in the nation, the
8 legislature recognizes the significant statewide benefits to be
9 gained from the proposed Asia Pacific cultural center. The
10 multipurpose facility will serve as a needed cultural resource for
11 Washington's Asian and Pacific Islander community; provide affordable
12 housing and educational opportunities; strengthen relations with our
13 Asia-Pacific trading partners; and deliver economic growth as a
14 commercial and tourist destination. The legislature intends to
15 support the development of the project through a grant to be used for
16 project coordination and development of a sustainable financial plan,

11 three hundred fifty-four million eight hundred fifty thousand dollars

10 Consistent with RCW 39.35B.050, the office of financial
11 management shall require a life cycle cost analysis to be prepared as
12 part of any proposal to acquire, construct, or lease all new state
13 office buildings and warehouses to establish the economic viability

EFFECT: For capital projects in the 2015-2017 biennium, the striking amendment:

Makes a total of \$95.4 million in new appropriations, including all increases and decreases: \$89.7 million from general obligation bonds and \$5.7 million from other funds.

Adjusts reappropriations by a total of (-\$39.8) million, including all increases and decreases: (-\$423,000) from general obligation bonds and (-\$39.4) million from other funds.

Authorizes community and technical colleges to enter into up to \$74.4 million in alternative financing contracts for specified capital projects.
