4 ARTICLE 1
5 GENERAL PROVISIONS

6 NEW SECTION. **Sec. 1101.** SHORT TITLE. This chapter may be known
7 and cited as the uniform business organizations code—general
8 provisions.

9 NEW SECTION. **Sec. 1102.** DEFINITIONS. The definitions in this
10 section apply throughout this chapter unless the context clearly
11 requires otherwise or as set forth in section 1401 or 1601 of this
12 act.

13 (1) "Annual report" means the report required by section 1212 of
14 this act.

15 (2) "Business corporation" means a domestic business corporation
16 incorporated under or subject to Title 23B RCW or a foreign business
17 corporation.

18 (3) "Commercial registered agent" means a person listed under
19 section 1405 of this act.

20 (4) "Domestic," with respect to an entity, means governed as to
21 its internal affairs by the law of this state.

22 (5) "Electronic transmission" means an electronic communication:

23 (a) Not directly involving the physical transfer of a record in a
24 tangible medium; and

25 (b) That may be retained, retrieved, and reviewed by the sender
26 and the recipient thereof, and that may be directly reproduced in a
27 tangible medium by such a sender and recipient.

28 (6) "Entity" means:

29 (a) A business corporation;

30 (b) A nonprofit corporation;

31 (c) A limited liability partnership;

- 1 (d) A limited partnership;
- 2 (e) A limited liability company; or
- 3 (f) A general cooperative association.
- 4 (7) "Entity filing" means a record delivered to the secretary of
- 5 state for filing pursuant to this chapter.
- 6 (8) "Execute," "executes," or "executed" means:
- 7 (a) Signed with respect to a written record;
- 8 (b) Electronically transmitted along with sufficient information
- 9 to determine the sender's identity with respect to an electronic
- 10 transmission; or
- 11 (c) With respect to a record to be filed with the secretary of
- 12 state, in compliance with the standards for filing with the office of
- 13 the secretary of state as prescribed by the secretary of state.
- 14 (9) "Filed record" means a record filed by the secretary of state
- 15 pursuant to this chapter.
- 16 (10) "Foreign," with respect to an entity, means governed as to
- 17 its internal affairs by the law of a jurisdiction other than this
- 18 state.
- 19 (11) "General cooperative association" means a domestic general
- 20 cooperative association formed under or subject to chapter 23.86 RCW.
- 21 (12) "Governor" means:
- 22 (a) A director of a business corporation;
- 23 (b) A director of a nonprofit corporation;
- 24 (c) A partner of a limited liability partnership;
- 25 (d) A general partner of a limited partnership;
- 26 (e) A manager of a manager-managed limited liability company;
- 27 (f) A member of a member-managed limited liability company;
- 28 (g) A director of a general cooperative association; or
- 29 (h) Any other person under whose authority the powers of an
- 30 entity are exercised and under whose direction the activities and
- 31 affairs of the entity are managed pursuant to the organic law and
- 32 organic rules of the entity.
- 33 (13) "Interest" means:
- 34 (a) A share in a business corporation;
- 35 (b) A membership in a nonprofit corporation;
- 36 (c) A share in a nonprofit corporation formed under chapter 24.06
- 37 RCW;
- 38 (d) A partnership interest in a limited liability partnership;
- 39 (e) A partnership interest in a limited partnership;
- 40 (f) A limited liability company interest; or

1 (g) A share or membership in a general cooperative association.
2 (14) "Interest holder" means:
3 (a) A shareholder of a business corporation;
4 (b) A member of a nonprofit corporation;
5 (c) A shareholder of a nonprofit corporation formed under chapter
6 24.06 RCW;
7 (d) A partner of a limited liability partnership;
8 (e) A general partner of a limited partnership;
9 (f) A limited partner of a limited partnership;
10 (g) A member of a limited liability company; or
11 (h) A shareholder or member of a general cooperative association.
12 (15) "Jurisdiction" when used to refer to a political entity,
13 means the United States, a state, a foreign country, or a political
14 subdivision of a foreign country.
15 (16) "Jurisdiction of formation" means the jurisdiction whose law
16 includes the organic law of an entity.
17 (17) "Limited liability company" means a domestic limited
18 liability company formed under or subject to chapter 25.15 RCW or a
19 foreign limited liability company.
20 (18) "Limited liability limited partnership" means a domestic
21 limited liability limited partnership formed under or subject to
22 chapter 25.10 RCW or a foreign limited liability limited partnership.
23 (19) "Limited liability partnership" means a domestic limited
24 liability partnership registered under or subject to chapter 25.05
25 RCW or a foreign limited liability partnership.
26 (20) "Limited partnership" means a domestic limited partnership
27 formed under or subject to chapter 25.10 RCW or a foreign limited
28 partnership. "Limited partnership" includes a limited liability
29 limited partnership.
30 (21) "Noncommercial registered agent" means a person that is not
31 a commercial registered agent and is:
32 (a) An individual or domestic or foreign entity that serves in
33 this state as the registered agent of an entity;
34 (b) An individual who holds the office or other position in an
35 entity which is designated as the registered agent pursuant to
36 section 1404(1)(b)(ii) of this act; or
37 (c) A government, governmental subdivision, agency, or
38 instrumentality, or a separate legal entity comprised of two or more
39 of these entities, that serves as the registered agent of an entity.

1 (22) "Nonprofit corporation" means a domestic nonprofit
2 corporation incorporated under or subject to chapter 24.03 or 24.06
3 RCW or a foreign nonprofit corporation.

4 (23) "Nonregistered foreign entity" means a foreign entity that
5 is not registered to do business in this state pursuant to a
6 statement of registration filed by the secretary of state.

7 (24) "Organic law" means the law of an entity's jurisdiction of
8 formation governing the internal affairs of the entity.

9 (25) "Organic rules" means the public organic record and private
10 organic rules of an entity.

11 (26) "Person" means an individual, business corporation,
12 nonprofit corporation, partnership, limited partnership, limited
13 liability company, general cooperative association, limited
14 cooperative association, unincorporated nonprofit association,
15 statutory trust, business trust, common-law business trust, estate,
16 trust, association, joint venture, public corporation, government or
17 governmental subdivision, agency, or instrumentality, or any other
18 legal or commercial entity.

19 (27) "Principal office" means the principal executive office of
20 an entity, whether or not the office is located in this state.

21 (28) "Private organic rules" means the rules, whether or not in a
22 record, that govern the internal affairs of an entity, are binding on
23 all its interest holders, and are not part of its public organic
24 record, if any. "Private organic rules" includes:

25 (a) The bylaws of a business corporation and any agreement among
26 shareholders pursuant to RCW 23B.07.320;

27 (b) The bylaws of a nonprofit corporation;

28 (c) The partnership agreement of a limited liability partnership;

29 (d) The partnership agreement of a limited partnership;

30 (e) The limited liability company agreement; and

31 (f) The bylaws of a general cooperative association.

32 (29) "Proceeding" means civil suit and criminal, administrative,
33 and investigatory action.

34 (30) "Property" means all property, whether real, personal, or
35 mixed or tangible or intangible, or any right or interest therein.

36 (31) "Public organic record" means the record the filing of which
37 by the secretary of state is required to form an entity and any
38 amendment to or restatement of that record. The term includes:

39 (a) The articles of incorporation of a business corporation;

40 (b) The articles of incorporation of a nonprofit corporation;

1 (c) The certificate of limited partnership of a limited
2 partnership;

3 (d) The certificate of formation of a limited liability company;

4 (e) The articles of incorporation of a general cooperative
5 association; and

6 (f) The document under the laws of another jurisdiction that is
7 equivalent to a document listed in this subsection.

8 (32) "Receipt," as used in this chapter, means actual receipt.
9 "Receive" has a corresponding meaning.

10 (33) "Record" means information inscribed on a tangible medium or
11 contained in an electronic transmission.

12 (34) "Registered agent" means an agent of an entity which is
13 authorized to receive service of any process, notice, or demand
14 required or permitted by law to be served on the entity. The term
15 includes a commercial registered agent and a noncommercial registered
16 agent.

17 (35) "Registered foreign entity" means a foreign entity that is
18 registered to do business in this state pursuant to a certificate of
19 registration filed by the secretary of state.

20 (36) "State" means a state of the United States, the District of
21 Columbia, Puerto Rico, the United States Virgin Islands, or any
22 territory or insular possession subject to the jurisdiction of the
23 United States.

24 (37) "Transfer" includes:

25 (a) An assignment;

26 (b) A conveyance;

27 (c) A sale;

28 (d) A lease;

29 (e) An encumbrance, including a mortgage or security interest;

30 (f) A change of record owner of interest;

31 (g) A gift; and

32 (h) A transfer by operation of law.

33 (38) "Type of entity" means a generic form of entity:

34 (a) Recognized at common law; or

35 (b) Formed under an organic law, whether or not some entities
36 formed under that law are subject to provisions of that law that
37 create different categories of the form of entity.

38 (39) "Writing" does not include an electronic transmission.

39 (40) "Written" means embodied in a tangible medium.

1 NEW SECTION. **Sec. 1103.** DELIVERY OF RECORD. (1) Except as
2 otherwise provided in this chapter, permissible means of delivery of
3 a record include delivery by hand, United States mail, private
4 courier service, and electronic transmission.

5 (2) Records may be delivered to the secretary of state by
6 electronic transmission as authorized by the secretary of state
7 pursuant to section 1104(2) of this act. The secretary of state may
8 deliver a record to an entity by electronic transmission if the
9 entity has designated an address, location, or system to which the
10 record may be electronically transmitted.

11 NEW SECTION. **Sec. 1104.** RULES AND PROCEDURES. (1) The secretary
12 of state has the power reasonably necessary to perform the duties
13 required by this chapter, including adoption, amendment, or repeal of
14 rules under chapter 34.05 RCW for the efficient administration of
15 this chapter.

16 (2) The secretary of state may adopt rules to facilitate
17 electronic filing. The rules will detail the circumstances under
18 which the electronic filing of documents will be permitted, how the
19 documents will be filed, and how the secretary of state will return
20 filed documents. The rules may also impose additional requirements
21 related to implementation of electronic filing processes, including
22 but not limited to file formats, signature technologies, delivery,
23 and the types of entities, records, or documents permitted.

24 **ARTICLE 2**

25 **FILING**

26 NEW SECTION. **Sec. 1201.** ENTITY FILING REQUIREMENTS. (1) To be
27 filed by the secretary of state pursuant to this chapter, an entity
28 filing must be received by the secretary of state, comply with this
29 chapter, and satisfy the following:

30 (a) The entity filing must be required or permitted by Title 23,
31 23B, 24, or 25 RCW.

32 (b) The entity filing must be delivered in written form unless
33 and to the extent the secretary of state permits electronic delivery
34 of entity filings pursuant to section 1104(2) of this act.

35 (c) The words in the entity filing must be in English, and
36 numbers must be in Arabic or Roman numerals, but the name of the

1 entity need not be in English if written in English letters or Arabic
2 or Roman numerals.

3 (d) The entity filing must be executed by or on behalf of a
4 person authorized or required under this chapter or the entity's
5 organic law to execute the filing.

6 (e) The entity filing must state the name and capacity, if any,
7 of each individual who executed it, on behalf of either the
8 individual or the person authorized or required to execute the
9 filing, but need not contain a seal, attestation, acknowledgment, or
10 verification.

11 (2) When an entity filing is delivered to the secretary of state
12 for filing, any fee required under this chapter and any fee,
13 interest, or penalty required to be paid under this chapter or law
14 other than this chapter must be paid in a manner permitted by the
15 secretary of state or by that law.

16 (3) The secretary of state may require that an entity filing
17 delivered in written form be accompanied by an identical or conformed
18 copy.

19 (4) A record filed under this chapter may be executed by an
20 individual acting in a valid representative capacity.

21 NEW SECTION. **Sec. 1202.** FORMS. (1) The secretary of state may
22 provide forms for entity filings required or permitted to be made by
23 Title 23, 23B, 24, or 25 RCW, but, except as otherwise provided in
24 subsection (2) of this section, their use is not required.

25 (2) The secretary of state may require that a cover sheet for an
26 entity filing and an annual report be on forms prescribed by the
27 secretary of state.

28 NEW SECTION. **Sec. 1203.** EFFECTIVE DATE AND TIME. Except as
29 otherwise provided in this chapter and subject to section 1205(4) of
30 this act, an entity filing is effective:

31 (1) On the date of filing and at the time specified in the entity
32 filing as its effective time;

33 (2) Unless prohibited by the entity's organic law, at a specified
34 delayed effective date and time, which may not be more than ninety
35 days after the date of filing;

36 (3) If a delayed effective date is specified, but no time is
37 specified, at 12:01 a.m. on the date specified; or

1 (4) If subsection (1), (2), or (3) of this section does not
2 apply, on the date and at the time of its filing by the secretary of
3 state as provided in section 1206 of this act.

4 NEW SECTION. **Sec. 1204.** WITHDRAWAL OF FILED RECORD BEFORE
5 EFFECTIVENESS. (1) Except as otherwise provided in this chapter, a
6 filed record may be withdrawn before it takes effect by delivering to
7 the secretary of state for filing a statement of withdrawal.

8 (2) A statement of withdrawal must:

9 (a) Be executed by an individual acting in a valid representative
10 capacity; and

11 (b) Identify the filed record to be withdrawn.

12 (3) On filing by the secretary of state of a statement of
13 withdrawal, the action or transaction evidenced by the original filed
14 record shall not take effect.

15 NEW SECTION. **Sec. 1205.** CORRECTING FILED RECORD. (1) An entity
16 may correct a filed record if:

17 (a) The filed record at the time of filing contained an
18 inaccurate statement;

19 (b) The filed record was defectively executed; or

20 (c) The electronic transmission of the filed record to the
21 secretary of state was defective.

22 (2) To correct a filed record, the entity must deliver to the
23 secretary of state for filing a statement of correction.

24 (3) A statement of correction:

25 (a) May not state a delayed effective date;

26 (b) Must be executed by the individual correcting the filed
27 record;

28 (c) Must identify the filed record to be corrected;

29 (d) Must specify the inaccuracy or defect to be corrected; and

30 (e) Must correct the inaccuracy or defect.

31 (4) A statement of correction is effective as of the effective
32 date of the filed record that it corrects except as to persons
33 relying on the uncorrected filed record and adversely affected by the
34 correction. As to those persons, the statement of correction is
35 effective when filed.

36 NEW SECTION. **Sec. 1206.** DUTY OF SECRETARY OF STATE TO FILE;
37 REVIEW OF REFUSAL TO FILE. (1) The secretary of state shall file an

1 entity filing that satisfies this chapter. The duty of the secretary
2 of state under this section is ministerial.

3 (2) The secretary of state shall record an entity filing on the
4 date and at the time of its receipt. After filing an entity filing,
5 the secretary of state shall deliver to the person that submitted the
6 filing a copy of the filed record with an acknowledgment of the date
7 and time of filing.

8 (3) If the secretary of state refuses to file an entity filing,
9 the secretary of state not later than fifteen business days after the
10 filing is received, shall:

11 (a) Return the entity filing or notify the person that submitted
12 the filing of the refusal; and

13 (b) Provide a brief explanation in a record of the reason for the
14 refusal.

15 (4) If the secretary of state refuses to file an entity filing,
16 the person that submitted the entity filing may petition the superior
17 court to compel its filing. The entity filing and the explanation of
18 the secretary of state of the refusal to file must be attached to the
19 petition. The court may decide the matter in a summary proceeding.

20 (5) The filing of or refusal to file an entity filing does not:

21 (a) Affect the validity or invalidity of the entity filing in
22 whole or in part;

23 (b) Relate to the correctness or incorrectness of information
24 contained in the entity filing; or

25 (c) Create a presumption that the information contained in the
26 filing is correct or incorrect.

27 NEW SECTION. **Sec. 1207.** EVIDENTIARY EFFECT OF COPY OF FILED
28 RECORD. A certification from the secretary of state accompanying a
29 copy of a filed record is conclusive evidence that the copy is an
30 accurate representation of the original record on file with the
31 secretary of state.

32 NEW SECTION. **Sec. 1208.** CERTIFICATE OF EXISTENCE OR
33 REGISTRATION. (1) On request of any person, the secretary of state
34 shall issue a certificate of existence for a domestic entity or a
35 certificate of registration for a registered foreign entity.

36 (2) A certificate under subsection (1) of this section must
37 state:

1 (a) The domestic entity's name or the registered foreign entity's
2 name used in this state;

3 (b) In the case of a domestic entity:

4 (i) That its public organic record has been filed and has taken
5 effect;

6 (ii) The date the public organic record became effective;

7 (iii) The period of the entity's duration if the records of the
8 secretary of state reflect that the entity's period of duration is
9 less than perpetual; and

10 (iv) That the records of the secretary of state do not reflect
11 that the entity has been dissolved;

12 (c) In the case of a registered foreign entity, that it is
13 registered to do business in this state;

14 (d) That all fees, interest, and penalties owed to this state by
15 the domestic or foreign entity and collected through the secretary of
16 state have been paid, if:

17 (i) Payment is reflected in the records of the secretary of
18 state; and

19 (ii) Nonpayment affects the existence or registration of the
20 domestic or foreign entity;

21 (e) That the most recent annual report required by section 1212
22 of this act has been delivered to the secretary of state for filing;

23 (f) That a proceeding is not pending under section 1603 of this
24 act; and

25 (g) Other facts reflected in the records of the secretary of
26 state pertaining to the domestic or foreign entity which the person
27 requesting the certificate reasonably requests.

28 (3) Subject to any qualification stated in the certificate, a
29 certificate issued by the secretary of state under subsection (1) of
30 this section may be relied upon as conclusive evidence of the facts
31 stated in the certificate.

32 NEW SECTION. **Sec. 1209.** EXECUTION OF ENTITY FILING. (1) Any
33 person who executes a record the person knows is false in any
34 material respect with the intent the record be an entity filing is
35 guilty of a gross misdemeanor punishable under chapter 9A.20 RCW.

36 (2) A person that executes an entity filing as an agent or legal
37 representative thereby affirms as a fact that the person is
38 authorized to execute the entity filing.

1 NEW SECTION. **Sec. 1210.** EXECUTION AND FILING PURSUANT TO
2 JUDICIAL ORDER. (1) If a person required by the entity's organic law
3 to execute a record that is to be an entity filing or to make an
4 entity filing does not do so, any other person that is aggrieved may
5 petition the superior court to order:

6 (a) The person to execute the record;

7 (b) The person to make the entity filing; or

8 (c) The secretary of state to file the entity filing unexecuted.

9 (2) If the petitioner under subsection (1) of this section is not
10 the entity to which the entity filing pertains, the petitioner shall
11 make the entity a party to the action.

12 (3) A filed record created under subsection (1)(c) of this
13 section is effective without being executed.

14 NEW SECTION. **Sec. 1211.** DELIVERY BY SECRETARY OF STATE. Except
15 as otherwise provided by section 1411 of this act or by law of this
16 state other than this chapter, the secretary of state may deliver a
17 record to a person by delivering it:

18 (1) In person to the person that submitted it for filing;

19 (2) To the address of the person's registered agent;

20 (3) To the principal office address of the person; or

21 (4) To another address the person provides to the secretary of
22 state for delivery.

23 NEW SECTION. **Sec. 1212.** ANNUAL REPORT FOR SECRETARY OF STATE.
24 (1) A domestic entity other than a limited liability partnership or
25 nonprofit corporation shall, within one hundred twenty days of the
26 date on which its public organic record became effective, deliver to
27 the secretary of state for filing an initial report that states the
28 information required under subsection (2) of this section.

29 (2) A domestic entity or registered foreign entity shall deliver
30 to the secretary of state for filing an annual report that states:

31 (a) The name of the entity and its jurisdiction of formation;

32 (b) The name and street and mailing addresses of the entity's
33 registered agent in this state;

34 (c) The street and mailing addresses of the entity's principal
35 office;

36 (d) In the case of a registered foreign entity, the street and
37 mailing address of the entity's principal office in the state or
38 country under the laws of which it is incorporated;

1 (e) The names of the entity's governors;

2 (f) A brief description of the nature of the entity's business;

3 (g) In the case of a business corporation, the names and
4 addresses of the chairperson of its board of directors, if any,
5 president, secretary, and treasurer, or individuals, however
6 designated, performing the functions of such officers; and

7 (h) The entity's unified business identifier number.

8 (3) Information in an initial or annual report must be current as
9 of the date the report is executed by the entity.

10 (4) Annual reports must be delivered to the secretary of state on
11 a date determined by the secretary of state and at such additional
12 times as the entity elects.

13 (5) If an initial or annual report does not contain the
14 information required by this section, the secretary of state promptly
15 shall notify the reporting entity in a record and return the report
16 for correction.

17 (6) If an initial or annual report contains the name or address
18 of a registered agent that differs from the information shown in the
19 records of the secretary of state immediately before the annual
20 report becomes effective, the differing information in the initial or
21 annual report is considered a statement of change under section 1407
22 of this act.

23 (7) The secretary of state shall send to each domestic entity and
24 registered foreign entity, not less than thirty or more than ninety
25 days prior to the expiration date of the entity's annual renewal, a
26 notice that the entity's annual report must be filed as required by
27 this chapter and that any applicable annual renewal fee must be paid,
28 and stating that if the entity fails to file its annual report or pay
29 the annual renewal fee it will be administratively dissolved. The
30 notice may be sent by postal or electronic mail as elected by the
31 entity, addressed to its registered agent within the state, or to an
32 electronic address designated by the entity in a record retained by
33 the secretary of state. Failure of the secretary of state to provide
34 any such notice does not relieve a domestic entity or registered
35 foreign entity from its obligations to file the annual report
36 required by this chapter or to pay any applicable annual renewal fee.
37 The option to receive the notice provided under this section by
38 electronic mail may be selected only when the secretary of state
39 makes the option available.

1 NEW SECTION. **Sec. 1213.** FEES. (1) Except as provided in
2 subsection (2) of this section, the secretary of state shall adopt
3 rules in accordance with chapter 34.05 RCW setting:

4 (a) Fees for:

5 (i) Filing entity filings;

6 (ii) Furnishing copies or certified copies of any filed record
7 under this chapter; and

8 (iii) Furnishing a certificate of existence or registration of an
9 entity, or any other certificate;

10 (b) License or renewal fees authorized under Title 23, 23B, 24,
11 or 25 RCW;

12 (c) Penalty fees; and

13 (d) Other miscellaneous charges.

14 (2) There is no fee for:

15 (a) A registered agent's consent to act as agent or statement of
16 resignation;

17 (b) Filing articles of dissolution;

18 (c) Filing certificates of judicial dissolution;

19 (d) Filing statements of withdrawal; and

20 (e) Filing annual reports when submitted concurrently with the
21 payment of annual license fees.

22 (3) The withdrawal under section 1204 of this act of a filed
23 record before it is effective or the correction of a filed record
24 under section 1205 of this act does not entitle the person on whose
25 behalf the record was filed to a refund of the filing fee.

26 (4) The secretary of state shall establish the fee schedule
27 authorized under this section in a manner that is consistent with the
28 fee schedule applicable to the various entities that is in effect on
29 the effective date of this section. The amounts of fees, charges, and
30 penalties established under this section may be no greater than the
31 amounts applicable to entity filings, penalties, and other charges in
32 effect on the effective date of this section. Fees may be adjusted by
33 rule only in an amount that does not exceed the average biennial
34 increase in the cost of providing service. This must be determined in
35 a biennial cost study performed by the secretary of state.

36 (5) All fees collected by the secretary of state shall be
37 deposited with the state treasurer pursuant to law or deposited in
38 the secretary of state's revolving fund as provided in RCW 43.07.130.

1 NEW SECTION. **Sec. 1214.** WAIVER OF PENALTY FEES. The secretary
2 of state may, where exigent or mitigating circumstances are
3 presented, waive penalty fees due from any entity previously in good
4 standing which would otherwise be penalized or lose its active
5 status. An entity desiring to seek relief under this section must,
6 within fifteen days of discovery of the missed filing or lapse,
7 notify the secretary of state in writing. The notification must
8 include the name and mailing address of the entity, the governor or
9 other entity official to whom correspondence should be sent, and a
10 statement under oath by a governor or other entity official, setting
11 forth the nature of the missed filing or lapse, the circumstances
12 giving rise to the missed filing or lapse, and the relief sought. If
13 the secretary of state is satisfied that sufficient exigent or
14 mitigating circumstances exist, that the entity has demonstrated good
15 faith and a reasonable attempt to comply with the applicable statutes
16 of this state, the secretary of state may issue an order allowing
17 relief from the penalty. If the secretary of state determines the
18 request does not comply with the requirements for relief, the
19 secretary of state shall deny the relief and state the reasons for
20 the denial. Any denial of relief by the secretary of state is not
21 reviewable notwithstanding the provisions of chapter 34.05 RCW.

22 **ARTICLE 3**
23 **NAME OF ENTITY**

24 NEW SECTION. **Sec. 1301.** PERMITTED NAMES. (1) The name of a
25 domestic entity and the name under which a foreign entity may
26 register to do business in this state, must be distinguishable on the
27 records of the secretary of state from any:

28 (a) Name of an existing domestic entity which at the time is not
29 administratively dissolved;

30 (b) Name of a foreign entity registered to do business in this
31 state under part I, Article 5 of this act;

32 (c) Name reserved under section 1303 of this act; or

33 (d) Name registered under section 1304 of this act.

34 (2) If an entity consents in a record to the use of its name and
35 submits an undertaking in a form satisfactory to the secretary of
36 state to change its name to a name that is distinguishable on the
37 records of the secretary of state from any name in any category of

1 names in subsection (1) of this section, the name of the consenting
2 entity may be used by the person to which the consent was given.

3 (3) A name may not be considered distinguishable on the records
4 of the secretary of state from the name of another entity by virtue
5 of:

6 (a) A variation in the words, phrases, or abbreviations
7 indicating the type of entity, such as "corporation," "corp.,"
8 "incorporated," "Inc.," "company," "co.," "social purpose
9 corporation," "SPC," "S.P.C.," "professional corporation," "PC,"
10 "P.C.," "professional service," "PS," "P.S.," "Limited," "Ltd.,"
11 "limited partnership," "LP," "L.P.," "limited liability partnership,"
12 "LLP," "L.L.P.," "registered limited liability partnership," "RLLP,"
13 "R.L.L.P.," "limited liability limited partnership," "LLLLP,"
14 "L.L.L.P.," "registered limited liability limited partnership,"
15 "RLLLLP," "R.L.L.L.P.," "limited liability company," "LLC," "L.L.C.,"
16 "professional limited liability company," "PLLC," or "P.L.L.C.";

17 (b) The addition or deletion of an article or conjunction such as
18 "the" or "and" from the same name;

19 (c) Punctuation, capitalization, or special characters or symbols
20 in the same name; or

21 (d) Use of abbreviation or the plural form of a word in the same
22 name.

23 (4) An entity name may not contain language stating or implying
24 that the entity is organized for a purpose other than those permitted
25 by the entity's public organic record.

26 (5) This chapter does not control the use of assumed business
27 names or "trade names."

28 (6) An entity may use a name that is not distinguishable from a
29 name described in subsection (1) of this section if the entity
30 delivers to the secretary of state a certified copy of a final
31 judgment of a court of competent jurisdiction establishing the right
32 of the entity to use the name in this state.

33 (7) An entity may use the name, including the fictitious name, of
34 another entity that is used in this state if the other entity is
35 formed or authorized to transact business in this state and the
36 proposed user entity:

37 (a) Has merged with the other entity; or

38 (b) Has been formed by reorganization of the other entity.

1 NEW SECTION. **Sec. 1302.** NAME REQUIREMENTS FOR CERTAIN TYPES OF
2 ENTITIES. (1)(a) The name of a business corporation:

3 (i)(A) Except in the case of a social purpose corporation, must
4 contain the word "corporation," "incorporated," "company," or
5 "limited," or the abbreviation "Corp.," "Inc.," "Co.," or "Ltd.," or
6 words or abbreviations of similar import in another language; or

7 (B) In the case of a social purpose corporation, must contain the
8 words "social purpose corporation" or the abbreviation "SPC" or
9 "S.P.C."; and

10 (ii) Must not contain any of the following words or phrases:
11 "Bank," "banking," "banker," "trust," "cooperative," or any
12 combination of the words "industrial" and "loan," or any combination
13 of any two or more of the words "building," "savings," "loan,"
14 "home," "association," and "society," or any other words or phrases
15 prohibited by any statute of this state.

16 (b) The name of a professional service corporation must contain
17 either the words "professional service" or "professional corporation"
18 or the abbreviation "P.S." or "P.C." The name may also contain either
19 the words "corporation," "incorporated," "company," or "limited," or
20 the abbreviation "Corp.," "Inc.," "Co.," or "Ltd." The name of a
21 professional service corporation organized to render dental services
22 must contain the full names or surnames of all shareholders and no
23 other word than "chartered" or the words "professional services" or
24 the abbreviation "P.S." or "P.C."

25 (2) The name of a nonprofit corporation:

26 (a) May include "club," "league," "association," "services,"
27 "committee," "fund," "society," "foundation," "guild," ". ,
28 a nonprofit corporation," ". , a nonprofit mutual
29 corporation," or any name of like import;

30 (b) Except for nonprofit corporations formed prior to January 1,
31 1969, must not include or end with "incorporated," "company,"
32 "corporation," "partnership," "limited partnership," or "Ltd.," or
33 any abbreviation thereof; and

34 (c) May only include the term "public benefit" or names of like
35 import if the nonprofit corporation has been designated as a public
36 benefit nonprofit corporation by the secretary of state in accordance
37 with chapter 24.03 RCW.

38 (3) The name of a limited partnership may contain the name of any
39 partner. The name of a partnership that is not a limited liability
40 limited partnership must contain the words "limited partnership" or

1 the abbreviation "LP" or "L.P." and may not contain the words
2 "limited liability limited partnership" or the abbreviation "LLLP" or
3 "L.L.L.P." If the limited partnership is a limited liability limited
4 partnership, the name must contain the words "limited liability
5 limited partnership" or the abbreviation "LLLP" or "L.L.L.P." and may
6 not contain the abbreviation "LP" or "L.P."

7 (4) The name of a limited liability partnership must contain the
8 words "limited liability partnership" or the abbreviation "LLP" or
9 "L.L.P." If the name of a foreign limited liability partnership
10 contains the words "registered limited liability partnership" or the
11 abbreviation "R.L.L.P." or "RLLP," it may include those words or
12 abbreviations in its foreign registration statement.

13 (5)(a) The name of a limited liability company:

14 (i) Must contain the words "limited liability company," the words
15 "limited liability" and abbreviation "Co.," or the abbreviation
16 "L.L.C." or "LLC"; and

17 (ii) May not contain any of the following words or phrases:
18 "Cooperative," "partnership," "corporation," "incorporated," or the
19 abbreviations "Corp.," "Ltd.," or "Inc.," or "LP," "L.P.," "LLP,"
20 "L.L.P.," "LLLP," "L.L.L.P.," or any words or phrases prohibited by
21 any statute of this state.

22 (b) The name of a professional limited liability company must
23 contain either the words "professional limited liability company," or
24 the words "professional limited liability" and the abbreviation
25 "Co.," or the abbreviation "P.L.L.C." or "PLLC," provided that the
26 name of a professional limited liability company organized to render
27 dental services must contain the full names or surnames of all
28 members and no other word than "chartered" or the words "professional
29 services" or the abbreviation "P.L.L.C." or "PLLC".

30 (6) The name of a cooperative association organized under chapter
31 23.86 RCW may contain the words "corporation," "incorporated," or
32 "limited," or the abbreviation "Corp.," "Inc.," or "Ltd."

33 NEW SECTION. **Sec. 1303.** RESERVATION OF NAME. (1) A person may
34 reserve the exclusive use of an entity name including the alternate
35 name adopted pursuant to section 1506 of this act by delivering an
36 application to the secretary of state for filing. The application
37 must state the name and address of the applicant and the name to be
38 reserved. If the secretary of state finds that the entity name is

1 available, the secretary of state shall reserve the name for the
2 applicant's exclusive use for one hundred eighty days.

3 (2) The owner of a reserved entity name may transfer the
4 reservation to another person that is not an individual by delivering
5 to the secretary of state an executed notice in a record of the
6 transfer which states the name and address of the transferee.

7 NEW SECTION. **Sec. 1304.** REGISTRATION OF NAME. (1) A foreign
8 entity not registered to do business in this state under part I,
9 Article 5 of this act may register its name, or an alternate name
10 adopted pursuant to section 1506 of this act, if the name is
11 distinguishable on the records of the secretary of state from the
12 names that are not available under section 1301 of this act.

13 (2) To register its name or an alternate name adopted pursuant to
14 section 1506 of this act, a foreign entity must deliver to the
15 secretary of state for filing an application stating the entity's
16 name, the jurisdiction and date of its formation, and any alternate
17 name adopted pursuant to section 1506 of this act. The application
18 must be accompanied by a certificate of existence, or a document of
19 similar import, from the entity's jurisdiction of formation. If the
20 secretary of state finds that the name applied for is available, the
21 secretary of state shall register the name for the applicant's
22 exclusive use.

23 (3) The registration of a name under this section is effective
24 upon the effective date of the application and until the close of the
25 calendar year in which the application for registration is filed.

26 (4) A foreign entity whose name registration is effective may
27 renew the registration for successive one-year periods by delivering,
28 not earlier than three months before the expiration of the
29 registration, to the secretary of state for filing a renewal
30 application that complies with this section. When filed, the renewal
31 application renews the registration for the following calendar year.

32 (5) A foreign entity whose name registration is effective may
33 register as a foreign entity under the registered name or consent in
34 an executed record to the use of that name by another entity.

35 **ARTICLE 4**

36 **REGISTERED AGENT OF ENTITY**

1 NEW SECTION. **Sec. 1401.** DEFINITIONS. The definitions in this
2 section apply throughout this section and sections 1402 through 1413
3 of this act unless the context clearly requires otherwise.

4 (1) "Registered agent filing" means:

5 (a) The public organic record of a domestic entity;

6 (b) An application of a domestic limited liability partnership;
7 or

8 (c) A registration statement filed pursuant to section 1503 of
9 this act.

10 (3) "Represented entity" means:

11 (a) A domestic entity; or

12 (b) A registered foreign entity.

13 NEW SECTION. **Sec. 1402.** ENTITIES REQUIRED TO DESIGNATE AND
14 MAINTAIN REGISTERED AGENT. The following shall designate and maintain
15 a registered agent in this state:

16 (1) A domestic entity; and

17 (2) A registered foreign entity.

18 NEW SECTION. **Sec. 1403.** ADDRESSES IN FILING. If a provision of
19 this chapter other than section 1410(1)(d) of this act requires that
20 a record state an address, the record must state:

21 (1) A street address in this state; and

22 (2) A mailing address in this state, if different from the
23 address described in subsection (1) of this section.

24 NEW SECTION. **Sec. 1404.** DESIGNATION OF REGISTERED AGENT. (1) A
25 registered agent filing must be executed by the represented entity
26 and state:

27 (a) The name of the entity's commercial registered agent; or

28 (b) If the entity does not have a commercial registered agent:

29 (i) The name and address of the entity's noncommercial registered
30 agent; or

31 (ii) The title of an office or other position with the entity, if
32 service of process, notices, and demands are to be sent to whichever
33 individual is holding that office or position, and the address to
34 which process, notices, or demands are to be sent.

35 (2) A registered agent shall not be appointed without having
36 given prior consent in a record to the appointment. The consent shall
37 be delivered to the secretary of state in such form as the secretary

1 of state may prescribe. The consent shall be filed with or as a part
2 of the record first appointing a registered agent. In the event any
3 individual or entity has been appointed registered agent without
4 consent, that individual or entity may deliver to the secretary of
5 state a notarized statement attesting to that fact, and the name
6 shall immediately be removed from the records of the secretary of
7 state.

8 NEW SECTION. **Sec. 1405.** LISTING OF COMMERCIAL REGISTERED AGENT.

9 (1) A person may become listed as a commercial registered agent by
10 delivering to the secretary of state for filing a commercial-
11 registered-agent listing statement executed by the person which
12 states:

13 (a) The name of the individual or the name of the entity, type of
14 entity, and jurisdiction of formation of the entity;

15 (b) That the person is in the business of serving as a commercial
16 registered agent in this state; and

17 (c) The address of a place of business of the person in this
18 state to which service of process, notices, and demands being served
19 on or sent to entities represented by the person may be delivered.

20 (2) A commercial-registered-agent listing statement may include
21 the information regarding acceptance by the agent of service of
22 process, notices, and demands in a form other than a written record
23 as provided in section 1411(5) of this act.

24 (3) If the name of a person delivering to the secretary of state
25 for filing a commercial-registered-agent listing statement is not
26 distinguishable on the records of the secretary of state from the
27 name of another commercial registered agent listed under this
28 section, the person shall adopt a fictitious name that is
29 distinguishable and use that name in its statement and when it does
30 business in this state as a commercial registered agent.

31 (4) The secretary of state shall note the filing of a commercial-
32 registered-agent listing statement in the records maintained by the
33 secretary of state for each entity represented by the agent at the
34 time of the filing. The statement has the effect of amending the
35 registered agent filing for each of those entities to:

36 (a) Designate the person becoming listed as a commercial
37 registered agent as the commercial registered agent of each of those
38 entities; and

1 (b) Delete the name and address of the former agent from the
2 registered agent filing of each of those entities.

3 NEW SECTION. **Sec. 1406.** TERMINATION OF LISTING OF COMMERCIAL
4 REGISTERED AGENT. (1) A commercial registered agent may terminate its
5 listing as a commercial registered agent by delivering to the
6 secretary of state for filing a commercial-registered-agent
7 termination statement executed by the agent which states:

8 (a) The name of the agent as listed under section 1405 of this
9 act; and

10 (b) That the agent is no longer in the business of serving as a
11 commercial registered agent in this state.

12 (2) A commercial-registered-agent termination statement takes
13 effect at 12:01 a.m. on the 31st day after the day on which it is
14 delivered to the secretary of state for filing.

15 (3) The commercial registered agent promptly shall furnish each
16 entity represented by the agent notice in a record of the filing of
17 the commercial-registered-agent termination statement.

18 (4) When a commercial-registered-agent termination statement
19 takes effect, the commercial registered agent ceases to be the
20 registered agent for each entity formerly represented by it. Until an
21 entity formerly represented by a terminated commercial registered
22 agent designates a new registered agent, service of process may be
23 made on the entity pursuant to section 1411 of this act. Termination
24 of the listing of a commercial registered agent under this section
25 does not affect any contractual rights a represented entity has
26 against the agent or that the agent has against the entity.

27 NEW SECTION. **Sec. 1407.** CHANGE OF REGISTERED AGENT BY ENTITY.
28 (1) A represented entity may change its registered agent or other
29 information on file under section 1404(1) of this act by delivering
30 to the secretary of state for filing a statement of change executed
31 by the entity which states:

32 (a) The name of the entity; and

33 (b) The information required under section 1404(1) of this act.

34 (2) The interest holders or governors of a domestic entity need
35 not approve the filing of:

36 (a) A statement of change under this section; or

37 (b) A similar filing changing the registered agent or registered
38 office, if any, of the entity in any other jurisdiction.

1 (3) A statement of change under this section designating a new
2 registered agent must be accompanied by the new registered agent's
3 consent in a record, either on the statement or attached to it in a
4 manner and form as the secretary of state may prescribe, to the
5 appointment.

6 NEW SECTION. **Sec. 1408.** CHANGE OF NAME, ADDRESS, TYPE OF
7 ENTITY, OR JURISDICTION OF FORMATION BY NONCOMMERCIAL REGISTERED
8 AGENT. (1) If a noncommercial registered agent changes its name or
9 its address in effect with respect to a represented entity under
10 section 1404(1) of this act, the agent shall deliver to the secretary
11 of state for filing, with respect to each entity represented by the
12 agent, a statement of change executed by the agent which states:

- 13 (a) The name of the entity;
14 (b) The name and address of the agent in effect with respect to
15 the entity;
16 (c) If the name of the agent has changed, the new name; and
17 (d) If the address of the agent has changed, the new address.

18 (2) A noncommercial registered agent promptly shall furnish the
19 represented entity with notice in a record of the delivery to the
20 secretary of state for filing of a statement of change and the
21 changes made in the statement.

22 NEW SECTION. **Sec. 1409.** CHANGE OF NAME, ADDRESS, TYPE OF
23 ENTITY, OR JURISDICTION OF FORMATION BY COMMERCIAL REGISTERED AGENT.
24 (1) If a commercial registered agent changes its name, its address as
25 listed under section 1405(1) of this act, its type of entity, or its
26 jurisdiction of formation, the agent shall deliver to the secretary
27 of state for filing a statement of change executed by the agent which
28 states:

- 29 (a) The name of the agent as listed under section 1405(1) of this
30 act;
31 (b) If the name of the agent has changed, the new name;
32 (c) If the address of the agent has changed, the new address; and
33 (d) If the agent is an entity:
34 (i) If the type of entity of the agent has changed, the new type
35 of entity; and
36 (ii) If the jurisdiction of formation of the agent has changed,
37 the new jurisdiction of formation.

1 (2) The filing by the secretary of state of a statement of change
2 under subsection (1) of this section is effective to change the
3 information regarding the agent with respect to each entity
4 represented by the agent.

5 (3) A commercial registered agent promptly shall furnish to each
6 entity represented by it a notice in a record of the filing by the
7 secretary of state of a statement of change relating to the name or
8 address of the agent and the changes made in the statement.

9 (4) If a commercial registered agent changes its address without
10 delivering for filing a statement of change as required by this
11 section, the secretary of state may cancel the listing of the agent
12 under section 1405 of this act. A cancellation under this subsection
13 has the same effect as a termination under section 1406 of this act.
14 Promptly after canceling the listing of an agent, the secretary of
15 state shall serve notice in a record in the manner provided in
16 section 1411 (2) or (3) of this act on:

17 (a) Each entity represented by the agent, stating that the agent
18 has ceased to be the registered agent for the entity and that, until
19 the entity designates a new registered agent, service of process may
20 be made on the entity as provided in section 1411 of this act; and

21 (b) The agent, stating that the listing of the agent has been
22 canceled under this section.

23 NEW SECTION. **Sec. 1410.** RESIGNATION OF REGISTERED AGENT. (1) A
24 registered agent may resign as agent for a represented entity by
25 delivering to the secretary of state for filing a statement of
26 resignation executed by the agent which states:

27 (a) The name of the entity;

28 (b) The name of the agent;

29 (c) That the agent resigns from serving as registered agent for
30 the entity; and

31 (d) The address of the entity to which the agent will send the
32 notice required by subsection (3) of this section.

33 (2) A statement of resignation takes effect on the earlier of:

34 (a) The 31st day after the day on which it is filed by the
35 secretary of state; or

36 (b) The designation of a new registered agent for the represented
37 entity.

1 (3) A registered agent promptly shall furnish to the represented
2 entity notice in a record of the date on which a statement of
3 resignation was filed.

4 NEW SECTION. **Sec. 1411.** SERVICE OF PROCESS, NOTICE, OR DEMAND
5 ON ENTITY. (1) A represented entity may be served with any process,
6 notice, or demand required or permitted by law by serving its
7 registered agent.

8 (2) If a represented entity ceases to have a registered agent, or
9 if its registered agent cannot with reasonable diligence be served,
10 the entity may be served by registered or certified mail, return
11 receipt requested, or by similar commercial delivery service,
12 addressed to the entity at the entity's principal office. The address
13 of the principal office must be as shown in the entity's most recent
14 annual report filed by the secretary of state. Service is effected
15 under this subsection on the earliest of:

16 (a) The date the entity receives the mail or delivery by the
17 commercial delivery service;

18 (b) The date shown on the return receipt, if executed by the
19 entity; or

20 (c) Five days after its deposit with the United States Postal
21 Service or commercial delivery service, if correctly addressed and
22 with sufficient postage or payment.

23 (3) If process, notice, or demand cannot be served on an entity
24 pursuant to subsection (1) or (2) of this section, service may be
25 made by handing a copy to the individual in charge of any regular
26 place of business or activity of the entity if the individual served
27 is not a plaintiff in the action.

28 (4) The secretary of state shall be an agent of the entity for
29 service of process if process, notice, or demand cannot be served on
30 an entity pursuant to subsection (1), (2), or (3) of this section.

31 (5) Service of process, notice, or demand on a registered agent
32 must be in a written record, but service may be made on a commercial
33 registered agent in other forms, and subject to such requirements, as
34 the agent has stated in its listing under section 1405 of this act
35 that it will accept.

36 (6) Service of process, notice, or demand may be made by other
37 means under law other than this chapter.

1 NEW SECTION. Sec. 1412. DUTIES OF REGISTERED AGENT. The only
2 duties under this chapter of a registered agent that has complied
3 with this chapter are:

4 (1) To forward to the represented entity at the address most
5 recently supplied to the agent by the entity any process, notice, or
6 demand pertaining to the entity which is served on or received by the
7 agent;

8 (2) To provide the notices required by this chapter to the entity
9 at the address most recently supplied to the agent by the entity;

10 (3) If the agent is a noncommercial registered agent, to keep
11 current the information required by section 1404(1) of this act in
12 the most recent registered agent filing for the entity; and

13 (4) If the agent is a commercial registered agent, to keep
14 current the information listed for it under section 1405(1) of this
15 act.

16 NEW SECTION. Sec. 1413. JURISDICTION AND VENUE. The designation
17 or maintenance in this state of a registered agent does not by itself
18 create the basis for personal jurisdiction over the represented
19 entity in this state. The address of the agent does not determine
20 venue in an action or a proceeding involving the entity.

21 **ARTICLE 5**

22 **FOREIGN ENTITIES**

23 NEW SECTION. Sec. 1501. GOVERNING LAW. (1) Part I of this act
24 does not authorize this state to regulate the organization or
25 internal affairs of a foreign entity registered to do business in
26 this state, or govern the liability that a person has as an interest
27 holder or governor for a debt, obligation, or other liability of the
28 foreign entity.

29 (2) A foreign entity is not precluded from registering to do
30 business in this state because of any difference between the law of
31 the entity's jurisdiction of formation and the law of this state.

32 (3) Registration of a foreign entity to do business in this state
33 does not authorize the foreign entity to engage in any activity or
34 exercise any power that a domestic entity of the same type may not
35 engage in or exercise in this state. Except as otherwise provided in
36 this chapter or other applicable law of this state, a foreign entity
37 is subject to the same duties, restrictions, penalties, and

1 liabilities now or later imposed on a domestic entity of the same
2 type.

3 NEW SECTION. **Sec. 1502.** REGISTRATION TO DO BUSINESS IN THIS
4 STATE. (1) A foreign entity may not do business in this state until
5 it registers with the secretary of state under this chapter.

6 (2) A foreign entity doing business in this state may not
7 maintain an action or proceeding in this state unless it is
8 registered to do business in this state and has paid to this state
9 all fees and penalties for the years, or parts thereof, during which
10 it did business in this state without having registered.

11 (3) The successor to a foreign entity that transacted business in
12 this state without a certificate of registration and the assignee of
13 a cause of action arising out of that business may not maintain a
14 proceeding based on that cause of action in any court in this state
15 until the foreign entity, or its successor, obtains a certificate of
16 registration.

17 (4) A court may stay a proceeding commenced by a foreign entity,
18 its successor, or assignee until it determines whether the foreign
19 entity, or its successor, requires a certificate of registration. If
20 it so determines, the court may further stay the proceeding until the
21 foreign entity, or its successor, obtains the certificate of
22 registration.

23 (5) A foreign entity that transacts business in this state
24 without a certificate of registration is liable to this state, for
25 the years or parts thereof during which it transacted business in
26 this state without a certificate of registration, in an amount equal
27 to all fees which would have been imposed by this chapter upon the
28 entity had it applied for and received a certificate of registration
29 to transact business in this state and thereafter filed all reports
30 required by this chapter, plus all penalties imposed by this chapter
31 for failure to pay such fees.

32 (6) The failure of a foreign entity to register to do business in
33 this state does not: (a) Impair the validity of a contract or act of
34 the foreign entity; (b) impair the right of any other party to the
35 contract to maintain any action, suit, or proceeding on the contract;
36 or (c) preclude the foreign entity from defending an action or
37 proceeding in this state.

1 (7) A limitation on the liability of an interest holder or
2 governor of a foreign entity is not waived solely because the foreign
3 entity does business in this state without registering.

4 (8) Section 1501 (1) and (2) of this act applies even if a
5 foreign entity fails to register under this Article 5.

6 NEW SECTION. **Sec. 1503.** FOREIGN REGISTRATION STATEMENT. (1) To
7 register to do business in this state, a foreign entity must deliver
8 a foreign registration statement to the secretary of state for
9 filing. The statement must be executed by the entity and state:

10 (a) The name of the foreign entity and, if the name does not
11 comply with section 1301 of this act, an alternate name adopted
12 pursuant to section 1506 of this act;

13 (b) The type of entity and, if it is a foreign limited
14 partnership, whether it is a foreign limited liability limited
15 partnership;

16 (c) The entity's jurisdiction of formation;

17 (d) The street and mailing addresses of the entity's principal
18 office and, if the law of the entity's jurisdiction of formation
19 requires the entity to maintain an office in that jurisdiction, the
20 street and mailing addresses of the office;

21 (e) The information required by section 1404(1) of this act;

22 (f) The names and addresses of the entity's governors, and if the
23 entity is a business corporation or nonprofit corporation, the names
24 and addresses of its officers;

25 (g) The date of the entity's formation and period of duration;

26 (h) The nature of the entity's business or purposes to be
27 conducted or promoted in this state; and

28 (i) The date on which the entity first did, or intends to do,
29 business in this state.

30 (2) The foreign entity shall deliver with the registration
31 statement a certificate of existence, or a document of similar
32 import, issued no more than sixty days before the date of submission
33 of the registration statement and duly authenticated by the secretary
34 of state or other official having custody of the entity's records in
35 the entity's jurisdiction of formation.

36 NEW SECTION. **Sec. 1504.** AMENDMENT OF FOREIGN REGISTRATION
37 STATEMENT. A registered foreign entity shall promptly deliver to the

1 secretary of state for filing an amendment to its foreign
2 registration statement if there is a change in:

- 3 (1) The name of the entity;
- 4 (2) The type of entity, including, if it is a foreign limited
5 partnership, whether the entity became or ceased to be a foreign
6 limited liability limited partnership;
- 7 (3) The entity's jurisdiction of formation;
- 8 (4) An address required by section 1503(1)(d) of this act; or
- 9 (5) The information required by section 1404(1) of this act.

10 NEW SECTION. **Sec. 1505.** ACTIVITIES NOT CONSTITUTING DOING
11 BUSINESS. (1) Activities of a foreign entity that do not constitute
12 doing business in this state under this chapter include, but are not
13 limited to:

- 14 (a) Maintaining, defending, mediating, arbitrating, or settling
15 an action or proceeding, or settling claims or disputes;
- 16 (b) Carrying on any activity concerning its internal affairs,
17 including holding meetings of its interest holders or governors;
- 18 (c) Maintaining accounts in financial institutions;
- 19 (d) Maintaining offices or agencies for the transfer, exchange,
20 and registration of securities of the entity or maintaining trustees
21 or depositories with respect to those securities;
- 22 (e) Selling through independent contractors;
- 23 (f) Soliciting or obtaining orders by any means if the orders
24 require acceptance outside this state before they become binding
25 contracts and where the contracts do not involve any local
26 performance other than delivery and installation;
- 27 (g) Creating or acquiring indebtedness, mortgages, or security
28 interests in property;
- 29 (h) Securing or collecting debts or enforcing mortgages or
30 security interests in property securing the debts;
- 31 (i) Conducting an isolated transaction that is completed within
32 thirty days and that is not in the course of repeated transactions of
33 a like nature;
- 34 (j) Owning, without more, property;
- 35 (k) Doing business in interstate commerce; and
- 36 (l) Operating an approved branch campus of a foreign degree-
37 granting institution in compliance with chapter 28B.90 RCW and in
38 accordance with subsection (2) of this section.

1 (2) In addition to those acts that are specified in subsection
2 (1) of this section, a foreign degree-granting institution that
3 establishes an approved branch campus in the state under chapter
4 28B.90 RCW shall not be deemed to transact business in the state
5 solely because it:

6 (a) Owns and controls an incorporated branch campus in this
7 state;

8 (b) Pays the expenses of tuition or room and board charged by the
9 incorporated branch campus for its students enrolled at the branch
10 campus or contributes to the capital thereof; or

11 (c) Provides personnel who furnish assistance and counsel to its
12 students while in the state but who have no authority to enter into
13 any transactions for or on behalf of the foreign degree-granting
14 institution.

15 (3) A person does not do business in this state solely by being
16 an interest holder or governor of a domestic entity or foreign entity
17 that does business in this state.

18 (4) This section does not apply in determining the contacts or
19 activities that may subject a foreign entity to service of process,
20 taxation, or regulation under law of this state other than this
21 chapter.

22 NEW SECTION. **Sec. 1506.** NONCOMPLYING NAME OF FOREIGN ENTITY.

23 (1) A foreign entity whose name does not comply with section 1301 of
24 this act for an entity of its type may not register to do business in
25 this state until it adopts, for the purpose of doing business in this
26 state, an alternate name that complies with section 1301 of this act.
27 A registered foreign entity that registers under an alternate name
28 under this subsection need not comply with chapter 19.80 RCW. After
29 registering to do business in this state with an alternate name, a
30 registered foreign entity shall do business in this state under:

31 (a) The alternate name;

32 (b) Its entity name, with the addition of its jurisdiction of
33 formation clearly identified; or

34 (c) An assumed or fictitious name the entity is authorized to use
35 under chapter 19.80 RCW.

36 (2) If a registered foreign entity changes its name to one that
37 does not comply with section 1301 of this act, it may not do business
38 in this state until it complies with subsection (1) of this section

1 by amending its foreign registration statement to adopt an alternate
2 name that complies with section 1301 of this act.

3 NEW SECTION. **Sec. 1507.** WITHDRAWAL OF REGISTRATION OF
4 REGISTERED FOREIGN ENTITY. (1) A registered foreign entity may
5 withdraw its registration by delivering a statement of withdrawal to
6 the secretary of state for filing. The statement of withdrawal must
7 be executed by the entity and state:

- 8 (a) The name of the entity and its jurisdiction of formation;
- 9 (b) That the entity is not doing business in this state and that
10 it withdraws its registration to do business in this state;
- 11 (c) That the entity revokes the authority of its registered agent
12 to accept service on its behalf in this state; and
- 13 (d) An address to which service of process may be made under
14 subsection (3) of this section.

15 (2) The statement of withdrawal must be accompanied by a copy of
16 a revenue clearance certificate issued pursuant to RCW 82.32.260.

17 (3) After the withdrawal of the registration of an entity,
18 service of process in any action or proceeding based on a cause of
19 action arising during the time the entity was registered to do
20 business in this state may be made pursuant to section 1411 of this
21 act.

22 NEW SECTION. **Sec. 1508.** WITHDRAWAL DEEMED ON CONVERSION TO
23 DOMESTIC ENTITY. A registered foreign entity that converts to any
24 type of domestic entity is deemed to have withdrawn its registration
25 on the effective date of the conversion.

26 NEW SECTION. **Sec. 1509.** WITHDRAWAL ON DISSOLUTION OR
27 CONVERSION. (1) A registered foreign entity that has dissolved and
28 completed winding up or has converted to a domestic or foreign person
29 not subject to this chapter shall deliver a statement of withdrawal
30 to the secretary of state for filing. The statement must be executed
31 by the dissolved or converted entity and state:

- 32 (a) In the case of a foreign entity that has completed winding
33 up:
 - 34 (i) Its name and jurisdiction of formation; and
 - 35 (ii) That the foreign entity surrenders its registration to do
36 business in this state; and

1 (b) In the case of a foreign entity that has converted to a
2 domestic or foreign person not subject to this act:

3 (i) The name of the converting foreign entity and its
4 jurisdiction of formation;

5 (ii) The type of person to which it has converted and its
6 jurisdiction of formation;

7 (iii) That it surrenders its registration to do business in this
8 state and revokes the authority of its registered agent to accept
9 service on its behalf; and

10 (iv) A mailing address to which service of process may be made
11 under subsection (2) of this section.

12 (2) After a withdrawal is effective under this section, service
13 of process in any action or proceeding based on a cause of action
14 arising during the time the foreign entity was registered to do
15 business in this state may be made pursuant to section 1411 of this
16 act.

17 NEW SECTION. **Sec. 1510.** TRANSFER OF REGISTRATION. (1) If a
18 registered foreign entity merges into a nonregistered foreign entity
19 or converts to a foreign entity required to register with the
20 secretary of state to do business in this state, the foreign entity
21 shall deliver to the secretary of state for filing an application for
22 transfer of registration. The application must be executed by the
23 surviving or converted entity and state:

24 (a) The name of the registered foreign entity before the merger
25 or conversion;

26 (b) The type of entity it was before the merger or conversion;

27 (c) The name of the applicant entity and, if the name does not
28 comply with section 1301 of this act, an alternate name adopted

38 and mailing addresses of that office; and

1 (ii) The information required pursuant to section 1404(1) of this
2 act.

3 (2) When an application for transfer of registration takes
4 effect, the registration of the registered foreign entity to do
5 business in this state is transferred without interruption to the
6 entity into which it has merged or to which it has been converted.

7 NEW SECTION. **Sec. 1511.** TERMINATION OF REGISTRATION. (1) The
8 secretary of state may terminate the registration of a registered
9 foreign entity in the manner provided in subsections (2) and (3) of
10 this section if:

11 (a) The entity does not pay any fee, interest, or penalty
12 required to be paid to the secretary of state under this chapter or
13 law of this state other than this chapter;

14 (b) The entity does not deliver to the secretary of state for
15 filing an annual report when it is due;

16 (c) The entity does not have a registered agent as required by
17 section 1402 of this act;

18 (d) The entity does not deliver to the secretary of state for
19 filing a statement of change under section 1407 of this act if change
20 occurs in the name or address of the entity's registered agent;

21 (e) A governor, officer, or agent of the entity executed a
22 document knowing it was false in any material respect with intent
23 that the document be delivered to the secretary of state for filing;
24 or

25 (f) The secretary of state receives a duly authenticated
26 certificate from the secretary of state or other official having
27 custody of the entity's records in the entity's jurisdiction of
28 formation stating that it has been dissolved or disappeared as the
29 result of a merger.

30 (2) If the secretary of state determines that one or more grounds
31 for termination exist under subsection (1) of this section, the
32 secretary of state shall deliver a notice of the determination to the
33 registered foreign entity's registered agent or, if the entity does
34 not have a registered agent, to the entity's principal office. The
35 notice must state the grounds for termination under subsection (1) of
36 this section.

37 (3) If the entity does not cure each ground for termination
38 stated in the notice within sixty days after the notice is effective,
39 the secretary of state shall terminate the registration of the

1 foreign entity by filing a statement of termination that recites the
2 ground or grounds for termination and the effective date of
3 termination and delivering a copy of the statement of termination to
4 the foreign entity.

5 (4) The authority of a registered foreign entity to do business
6 in this state ceases on the effective date of termination shown on
7 the statement of termination.

8 (5) The termination of a foreign entity's registration does not
9 terminate the authority of the registered agent of the foreign
10 entity.

11 NEW SECTION. **Sec. 1512.** ACTION BY ATTORNEY GENERAL. The
12 attorney general may maintain an action to enjoin a foreign entity
13 from doing business in this state in violation of this chapter.

14 **ARTICLE 6**

15 **ADMINISTRATIVE DISSOLUTION**

16 NEW SECTION. **Sec. 1601.** For the purposes of this Article 6, the
17 term "domestic entity" does not include a domestic limited liability
18 partnership.

19 NEW SECTION. **Sec. 1602.** GROUNDS. The secretary of state may
20 commence a proceeding under section 1603 of this act to dissolve a
21 domestic entity administratively if:

22 (1) The entity does not pay any fee, interest, or penalty
23 required to be paid to the secretary of state when due;

24 (2) The entity does not deliver an annual report to the secretary
25 of state not later than one hundred twenty days after it is due;

26 (3) The entity does not have a registered agent in this state for
27 thirty consecutive days; or

28 (4) The entity's period of duration stated in its public organic
29 record expired.

30 NEW SECTION. **Sec. 1603.** PROCEDURE AND EFFECT. (1) If the
31 secretary of state determines that one or more grounds exist under
32 section 1602 of this act for administratively dissolving a domestic
33 entity, the secretary of state shall serve the entity pursuant to
34 section 1211 of this act with notice in a record of the secretary of
35 state's determination.

1 (2) If a domestic entity, not later than sixty days after service
2 of the notice required by subsection (1) of this section, does not
3 cure or demonstrate to the satisfaction of the secretary of state the
4 nonexistence of each ground determined by the secretary of state, the
5 secretary of state shall administratively dissolve the entity by
6 executing a statement of administrative dissolution that recites the
7 grounds for dissolution and the effective date of dissolution. The
8 secretary of state shall file the statement and serve a copy on the
9 entity pursuant to section 1211 of this act.

10 (3) A domestic entity that is dissolved administratively
11 continues its existence as an entity but may not carry on any
12 activities except as necessary to wind up its activities and affairs
13 and liquidate its assets in the manner provided in its organic law or
14 to apply for reinstatement under section 1604 of this act.

15 (4) The administrative dissolution of a domestic entity does not
16 terminate the authority of its registered agent.

17 NEW SECTION. Sec. 1604. REINSTATEMENT. (1) A domestic entity
18 that is dissolved administratively under section 1603 of this act may
19 apply to the secretary of state for reinstatement not later than five
20 years after the effective date of dissolution. The application must
21 be executed by the entity and state:

22 (a) The name of the entity and a statement that the name
23 satisfies section 1301 of this act; if the name does not satisfy
24 section 1301 of this act, the entity must deliver with its
25 application an amendment to its public organic record changing its
26 name;

27 (b) The address of the principal office of the entity and the
28 name and address of its registered agent;

29 (c) The effective date of the entity's administrative
30 dissolution; and

31 (d) That the grounds for dissolution did not exist or have been
32 cured.

33 (2) To be reinstated, an entity must pay the full amount of all
34 annual license or renewal fees which would have been assessed during
35 the period of administrative dissolution had the entity been in
36 active status, plus a penalty fee established by the secretary of
37 state by rule, and the license or renewal fee for the year of
38 reinstatement.

1 (3) If the secretary of state determines that an application
2 under subsection (1) of this section contains the information
3 required by subsection (1) of this section, is satisfied that the
4 information is correct, and determines that all payments required to
5 be made to the secretary of state by subsection (2) of this section
6 have been made, the secretary of state shall:

7 (a) Cancel the statement of administrative dissolution and
8 prepare a statement of reinstatement that states the secretary of
9 state's determination and the effective date of reinstatement;

10 (b) File the statement; and

11 (c) Serve a copy of the statement on the entity.

12 (4) When reinstatement under this section is effective as
13 provided in section 1203 of this act:

14 (a) It relates back to and takes effect as of the effective date
15 of the administrative dissolution; and

16 (b) The domestic entity resumes carrying on its activities and
17 affairs as if the administrative dissolution had never occurred,
18 except for the rights of a person arising out of an act or omission
19 in reliance on the dissolution before the person knew or had reason
20 to know of the reinstatement.

21 NEW SECTION. **Sec. 1605.** JUDICIAL REVIEW OF DENIAL OF
22 REINSTATEMENT. (1) If the secretary of state denies a domestic
23 entity's application for reinstatement following administrative
24 dissolution, the secretary of state shall serve the entity with a
25 notice in a record that explains the reasons for denial.

26 (2) An entity may seek judicial review of denial of reinstatement
27 in the superior court not later than thirty days after service of the
28 notice of denial.

29 NEW SECTION. **Sec. 1606.** ENTITY NAME NOT DISTINGUISHABLE FROM
30 NAME OF GOVERNMENTAL ENTITY. (1) Any county, city, town, district, or
31 other political subdivision of the state, or the state of Washington
32 or any department or agency of the state, may apply to the secretary
33 of state for the administrative dissolution, or the termination of
34 registration, of any entity using a name that is not distinguishable
35 from the name of the applicant for dissolution. The application must
36 state the precise legal name of the governmental entity and its date
37 of formation and the applicant shall mail a copy to the entity's
38 registered agent. If the name of the entity is not distinguishable

1 from the name of the applicant, then, except as provided in
2 subsection (4) of this section, the secretary of state shall commence
3 proceedings for administrative dissolution under section 1603 of this
4 act or termination of registration under section 1511 of this act.

5 (2) A name may not be considered distinguishable by virtue of the
6 items specified in section 1301(3) of this act.

7 (3)(a) The following are not distinguishable for purposes of this

9 (i) "City of Anytown" and "City of Anytown, Inc."; and

10 (ii) "City of Anytown" and "Anytown City."

11 (b) The following are distinguishable for purposes of this
12 section:

13 (i) "City of Anytown" and "Anytown, Inc.";

14 (ii) "City of Anytown" and "The Anytown Company"; and

15 (iii) "City of Anytown" and "Anytown Cafe, Inc."

16 (4) If the entity that is the subject of the application was
17 formed or registered before the formation of the applicant as a
18 governmental entity, then this section applies only if the applicant
19 for dissolution provides a certified copy of a final judgment of a
20 court of competent jurisdiction determining that the applicant holds
21 a superior property right to the name than does the entity.

22 (5) The duties of the secretary of state under this section are
23 ministerial.

24 **ARTICLE 7**

25 **MISCELLANEOUS PROVISIONS**

26 NEW SECTION. **Sec. 1701.** RESERVATION OF POWER TO AMEND OR
27 REPEAL. The legislature has power to amend or repeal all or part of
28 this chapter at any time, and all domestic and foreign entities
29 subject to this chapter are governed by the amendment or repeal.

30 NEW SECTION. **Sec. 1702.** SUPPLEMENTAL PRINCIPLES OF LAW. Unless
31 displaced by particular provisions of this chapter, the principles of
32 law and equity supplement this chapter.

33 NEW SECTION. **Sec. 1703.** RELATION TO ELECTRONIC SIGNATURES IN
34 GLOBAL AND NATIONAL COMMERCE ACT. This chapter modifies, limits, and
35 supersedes the electronic signatures in global and national commerce
36 act, 15 U.S.C. Sec. 7001 et seq., but does not modify, limit, or

1 supersede Sec. 101(c) of that act, 15 U.S.C. Sec. 7001(c), or
2 authorize electronic delivery of any of the notices described in
3 section 103(b) of that act, 15 U.S.C. Sec. 7003(b).

4 NEW SECTION. **Sec. 1704.** SAVINGS CLAUSE. The repeal of a statute
5 by this act does not affect:

6 (1) The operation of the statute or any action taken under it
7 before its repeal;

8 (2) Any ratification, right, remedy, privilege, obligation, or
9 liability acquired, accrued, or incurred under the statute before its
10 repeal;

11 (3) Any violation of the statute or any penalty, forfeiture, or
12 punishment incurred because of the violation before its repeal; or

13 (4) Any proceeding, reorganization, or dissolution commenced
14 under the statute before its repeal, and the proceeding,
15 reorganization, or dissolution may be completed in accordance with
16 the statute as if it had not been repealed.

(8) "Partnership at will" means a partnership in which the partners have not agreed to remain partners until the expiration of a definite term or the completion of a particular undertaking.

(9) "Partnership interest" or "partner's interest in the partnership" means all of a partner's interests in the partnership, including the partner's transferable interest and all management and other rights.

1 (10) "Person" means an individual, corporation, business trust,
2 estate, trust, partnership, limited liability company, association,
3 joint venture, government, governmental subdivision, agency, or
4 instrumentality, or any other legal or commercial entity.

EFFECT: The striking amendment makes the following changes:

(1) Clarifies that the effective date and time of an entity filing is first determined by whether the entity filing specifies an effective time or a delayed effective date, and if not, then the effective date is the date and time of filing by the Secretary of State (SOS).

(2) Provides that a statement of withdrawal of a filed record must be executed by a person acting in a valid representative capacity, rather than a person to whom authority has been properly delegated and not revoked under the entity's organic law.

(3) Provides that a filed record may be corrected if it contained an inaccurate statement at the time of filing, rather than if it was incorrect, inaccurate, or defective.

(4) Provides that the SOS is an agent of an entity for service of process if service of process cannot be made under any of the methods for service on the registered agent or entity.

(5) Provides that a registered foreign entity that files an amendment to its foreign registration statement must do so promptly.

(6) In provisions amending laws governing business corporations and nonprofit corporations, changes the definition of "registered

office" to mean the address of the entity's registered agent, and deletes amendatory sections that are no longer necessary due to the change in the definition.

(7) Amends a section of law establishing name requirements for professional service corporations to eliminate the substantive requirements and instead reference the name requirements for professional service corporations under the HUB.

(8) Makes a variety of housekeeping amendments for clarity and consistency, and to correct inaccurate cross references.
