3 "NEW SECTION. Sec. 1. A new section is added to chapter 35.13A 4 RCW to read as follows:

- 5 (1) Except as provided otherwise by subsection (4) of 6 section, a resolution or ordinance adopted by the legislative body of a city to assume jurisdiction of all or part of a water-sewer 7 district under this chapter is subject to a referendum. 8 9 referendum petition to repeal the assumption resolution or ordinance must be filed with the county auditor within ten days of passage of 10 the resolution or ordinance. Within ten days of the filing of a 11 12 petition, the county auditor must confer with the petitioner concerning the form and style of the petition and issue a petition 13 14 identification number. The ballot title must be prepared by the 15 applicable city attorney in accordance with this section and RCW 29A.36.071, and the question posed to the voters must be written so 16 17 that an affirmative answer to the question and a majority affirmative 18 vote on the measure results in approval of the proposed assumption, and a negative answer to the question and a majority negative vote on 19 20 the measure results in the assumption being barred. The petitioner must be notified of the identification number and ballot title within 21 this ten-day period. After this notification, the petitioner has 22 forty-five days in which to secure on petition forms the signatures 23 of at least ten percent of the number of voters residing in the part 24 25 of the water-sewer district subject to the assumption resolution or ordinance who voted in the most recent general election, and file the 26 signed petitions with the county auditor. Each petition form must 27 contain the ballot title and full text of the measure to be referred. 28 29 The county auditor must verify the sufficiency of the signatures on 30 the petitions.
 - (2) If sufficient valid signatures on the petitions are properly submitted, the county auditor must submit the referendum measure to the registered voters residing in the part of the water-sewer district subject to the assumption resolution or ordinance in a

- 1 general or special election no later than one hundred twenty days
- after the signed petition has been filed with the county auditor. 2
- Elections must be conducted in accordance with general election law, 3
- and the cost of the election must be borne by the city seeking 4
- approval to assume jurisdiction of all or part of the water-sewer 5
- 6 district. The city must produce a local voters' pamphlet as provided
- 7 in RCW 29A.32.210 through 29A.32.280.
- (3) When a referendum petition is filed with the county auditor, 8

- 17 remainder of the title and insert "amending RCW 29A.36.071; and
- 18 adding new sections to chapter 35.13A RCW."

 $\underline{\text{EFFECT:}}$ Establishes that a resolution or ordinance to assume jurisdiction of all or a part of a water-sewer district may not take effect until 90 days after its adoption. Requires the applicable city attorney, rather than the county auditor, to prepare ballot titles for the referendum of a city resolution or ordinance to assume jurisdiction of all or part of a water-sewer district. Requires that a city seeking to assume jurisdiction of the district must also produce a local voters' pamphlet that conforms with statutory requirements governing the production and distribution of local voters' pamphlets. Makes a technical change to specify that the cost of a referendum must be borne by the city seeking approval to assume jurisdiction of "all or part of" the water-sewer district, rather than the city seeking approval to assume jurisdiction of the watersewer district.
