## SHB 2496 - S COMM AMD By Committee on Law & Justice

- 1 Strike everything after the enacting clause and insert the 2 following:
- "NEW SECTION. Sec. 1. (1) There is hereby created an office of military and veteran legal assistance within the office of the attorney general for the purpose of promoting and facilitating civil legal assistance programs, pro bono services, and self-help services for military service members, veterans, and their family members domiciled or stationed in Washington state.
- 9 (2) For the purposes of sections 1 through 3 of this act, the 10 following definitions apply:
- 11 (a) The term "service member" means an active or reserve member 12 in any branch of the armed forces of the United States, including the 13 national guard, coast guard, and armed forces reserves.
- 14 (b) The term "veteran" has the same meaning as defined in RCW 41.04.005 and 41.04.007.
  - (c) The term "family member" means the spouse or domestic partner, surviving spouse, surviving domestic partner, and dependent minor children of a living or deceased service member or veteran for whom the service member or veteran provided at least one-half of that person's support in the previous one hundred eighty days before seeking assistance of the programs and services authorized by this chapter.
- 23 (3) The attorney general may not directly provide legal assistance, advice, or representation in any context, unless otherwise authorized by law, and the attorney general may not provide legal assistance programs, pro bono services, or self-help services to a service member, veteran, or family member being criminally prosecuted.
- 29 <u>NEW SECTION.</u> **Sec. 2.** The office of military and veteran legal 30 assistance shall:

- 1 (1) Recruit and train volunteer attorneys and service programs 2 willing to perform pro bono services for service members, veterans, 3 and their family members, and create and maintain a registry of the 4 same;
  - (2) Assess and assign requests for pro bono services to volunteer attorneys and service programs registered with the office; and
- 7 (3) Establish an advisory committee that will include, among others, representatives from legal assistance offices on military 8 installations, the office of civil legal aid, the Washington state 9 bar association's legal assistance to military personnel section, the 10 11 Washington state veterans bar association, relevant office military service and support organizations, and organizations 12 involved in coordinating, supporting, and delivering civil legal aid 13 and pro bono legal services in Washington state. The committee shall 14 provide advice and assistance regarding program design, operation, 15 16 volunteer recruitment and support strategies, service delivery 17 objectives and priorities, and funding.
- NEW SECTION. Sec. 3. The attorney general may apply for and receive grants, gifts, donations, bequests, or other contributions to help support and to be used exclusively for the operations of the office of military and veteran legal assistance.
- NEW SECTION. Sec. 4. Sections 1 through 3 of this act are each added to chapter 43.10 RCW."
