Qualifying patients and designated providers may purchase from marijuana retailers without paying sales and use tax. Marijuana retailers may advertise that they stock products likely to be of medical use. Labels on marijuana products must include information on indicated uses. Marijuana retailers may advertise they have medical marijuana consultants on staff.
