- 19 (a) Vehicle fees imposed under RCW 36.73.040(3)(b); (b) sales and
- 20 use taxes imposed under RCW 36.73.040(3)(a); and/or (c) tolls
- 21 imposed under RCW 36.73.040(3)(d).
- 22 (5) "Supplemental transportation improvement" or "supplemental
- 23 improvement" means any project, work, or undertaking to provide
- 24 public transportation service, in addition to a district's existing
- 25 or planned voter-approved transportation improvements, proposed by a
- 26 participating city member of the district under RCW 36.73.180.

- 1 (6) "Transportation improvement" means a project contained in 2 the transportation plan of the state, a regional transportation 3 planning organization, city, county, or eligible jurisdiction as 4 identified in RCW 36.73.020(2). A project may include investment in 5 new or existing highways of statewide significance, principal 6 arterials of regional significance, high capacity transportation, 7 public transportation, and other transportation projects and 8 programs of regional or statewide significance including 9 transportation demand management. Projects may also include the 10 operation, preservation, and maintenance of these facilities or 11 programs." 12 13 Renumber the remaining sections consecutively and correct any
