SUBSTITUTE HOUSE BILL 1320

State of Washington 64th Legislature 2015 Regular Session

By House Public Safety (originally sponsored by Representatives Goodman and Moscoso; by request of Department of Corrections)

READ FIRST TIME 02/04/15.

AN ACT Relating to creating an identicard program for certain incarcerated offenders; amending RCW 46.20.117 and 46.20.117; adding a new section to chapter 72.09 RCW; creating a new section; providing effective dates; providing an expiration date; and declaring an emergency.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 NEW SECTION. The legislature intends to create an Sec. 1. identicard program to provide incarcerated offenders with a state-8 issued identicard to assist and prepare each offender for release 9 from prison and reentry into the community. The legislature finds 10 11 that each step that assists individuals being released from prison helps incarcerated offenders avoid predictable conditions that lead 12 to future recidivism and that a reduction in recidivism makes the 13 14 community safer, transforms formerly incarcerated offenders into 15 productive citizens, and strengthens the family structure that 16 surrounds each offender. The goal of the identicard program is to 17 provide proper state identification to offenders upon release to the 18 community, which is critical for accessing services, employment, 19 housing, and various other opportunities in the community.

- NEW SECTION. Sec. 2. A new section is added to chapter 72.09
 RCW to read as follows:
- 3 (1) The department, in conjunction with the department of 4 licensing, must provide offenders with a state-issued identicard 5 pursuant to RCW 46.20.117 at no cost to the offender.
- 6 (2) An offender is eligible for an original, renewal, or replacement identicard under this section if he or she:

- 23 (1) **Issuance**. The department shall issue an identicard, 24 containing a picture, if the applicant:
 - (a)(i) Does not hold a valid Washington driver's license;

 - (((c)))(<u>iii)</u> Pays the required fee. - 7 (b) Except as provided in subsection <u>(1)(b) or</u> (5) of this section, expire on the sixth anniversary of the applicant's birthdate 9 after issuance.

The fee for 27 an identicard issued or renewed for a period other than five years 28 29 from October 1, 2012, to June 30, 2013, or six years after June 30, 2013, or that has been extended by mail or electronic commerce, is 30 31 nine dollars for each year that the identicard is issued, renewed, or extended. The department may adopt any rules as are necessary to 32 carry out this subsection. 33
