## SUBSTITUTE HOUSE BILL 1511

- 1 AN ACT Relating to teaching Washington's tribal history, culture,
- 2 and government in the common schools; amending RCW 28A.320.170; and
- 3 creating a new section.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

The legislature recognizes the need to 5 NEW SECTION. Sec. 1. 6 reaffirm the state's commitment to educating the citizens of our 7 state, particularly the youth who are our future leaders, about tribal history, culture, treaty rights, contemporary tribal and state 8 government institutions and relations and the contribution of Indian 9 10 nations to the state of Washington. The legislature recognizes that 11 this goal has yet to be achieved in most of our state's schools and districts. As a result, Indian students may not find the school 12 13 curriculum, especially Washington state history curriculum, relevant 14 to their lives or experiences. In addition, many students may remain uninformed about the experiences, contributions, and perspectives of 15 16 tribal neighbors, fellow citizens, and classmates. The 17 legislature finds that a more widespread use of the Since Time Immemorial curriculum developed by the office of the superintendent 18 of public instruction, available free of charge to schools, would 19 greatly contribute to helping schools improve history curriculum and 20 21 the experiences Indian students have in our schools. - 4 mandatory in Washington's common schools.

- **Sec. 2.** RCW 28A.320.170 and 2005 c 205 s 4 are each amended to 6 read as follows:
  - (1) ((Each)) (a) Beginning the effective date of this section, when a school district board of directors ((is encouraged to)) reviews or adopts its social studies curriculum, it shall incorporate curricula about the history, culture, and government of the nearest federally recognized Indian tribe or tribes, so that students learn about the unique heritage and experience of their closest neighbors. ((School districts near Washington's borders are encouraged to include federally recognized Indian tribes whose traditional lands and territories included parts of Washington, but who now reside in Oregon, Idaho, and British Columbia. School districts and tribes are encouraged to work together to develop such curricula.))
    - (b) School districts must meet the requirements of this section by using curriculum developed and made available free of charge by the office of the superintendent of public instruction. School districts may modify the curriculum in order to incorporate elements that have a regionally specific focus or to incorporate the curriculum into existing curricular materials.
    - (2) As they conduct regularly scheduled reviews and revisions of their social studies and history curricula, school districts ((are encouraged to)) shall collaborate with any federally recognized Indian tribe within their district, and with neighboring Indian tribes, to incorporate expanded and improved curricular materials about Indian tribes, and to create programs of classroom and community cultural exchanges.
  - (3) School districts ((are encouraged to)) shall collaborate with the office of the superintendent of public instruction on curricular areas regarding tribal government and history that are statewide in nature, such as the concept of tribal sovereignty and the history of federal policy towards federally recognized Indian tribes. The program of Indian education within the office of the superintendent of public instruction ((is encouraged to)) shall help local school districts identify federally recognized Indian tribes whose
