- 1 AN ACT Relating to regulating music licensing agencies; amending
- 2 RCW 18.235.020; adding a new chapter to Title 19 RCW; prescribing
- 3 penalties; and providing an effective date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The definitions in this section apply
- 6 throughout this chapter unless the context clearly requires
- 7 otherwise.
- 8 (1) "Department" means the department of licensing.
- 9 (2) "Music licensing agency" means any individual, partnership,
- 10 association, limited liability company, limited liability
- 11 partnership, trust, corporation, and any other legal entity of two or
- 12 more copyright owners or proprietors, which has or claims the
- 13 exclusive or nonexclusive authority to issue, grant, or to contract
- 14 for performing rights licenses for two or more copyright owners.
- 15 (3) "User" means any person who, directly or indirectly, performs
- 16 or causes to be performed, musical composition for profit.
- 17 <u>NEW SECTION.</u> **Sec. 2.** A music licensing agency that licenses the
- 18 performing rights to music may not license or attempt to license the
- 19 use of or collect or attempt to collect any compensation on account

of any sale, license, or other disposition regarding the performance rights of music unless the music licensing agency:

- (1) Files annually with the secretary of state in duplicate a certified copy of each performing rights contract or license agreement made available from the music licensing agency or copyright owner to any user within the state;
- 7 (2) Completes an initial or renewal application for a music 8 licensing agency license on a form for this purpose, furnished by the 9 department;
- 10 (3) Pays the initial or renewal licensing fees as established by 11 the department; and
- 12 (4) Has a valid Washington unified business identifier number.
- NEW SECTION. Sec. 3. A music licensing agency must make available electronically to business proprietors the most current available list of members and affiliates represented by the music licensing agency and the most current available list of the performed works that the agency licenses.
- 18 NEW SECTION. Sec. 4. Separate from any fines imposed under 19 chapter 18.235 RCW, a music licensing agency is subject to a civil 20 penalty of not more than one thousand dollars for each separate violation of this chapter. Multiple violations on a single day may be 21 considered separate violations. The penalty may be imposed by the 22 23 department or in any court of competent jurisdiction and may be 24 imposed separately and in addition to any private party claims for violations under this chapter. 25
- 26 Sec. 5. (1) A person employed by or working as a NEW SECTION. contractor or agent for a music licensing agency may not enter onto 27 28 the premises of a proprietor's business for the purpose of seeking or 29 establishing a basis for seeking payment or a contract for payment of 30 royalties for the use of copyrighted works by that proprietor without first identifying himself or herself to the proprietor or the 31 proprietor's employees and disclosing that the person is acting on 32 33 behalf of a music licensing agency and disclosing the purposes for 34 being on the premises.
- 35 (2) A person employed by or working as a contractor or agent for 36 a music licensing agency must provide at least twenty-four hours' 37 notice before entering the premises of a proprietor's business.

NEW SECTION. Sec. 6. The legislature finds that the practices covered by section 5 of this act are matters vitally affecting the public interest for the purpose of applying the consumer protection act, chapter 19.86 RCW. A violation of this chapter is not reasonable in relation to the development and preservation of business and is an unfair or deceptive act in trade or commerce and an unfair method of competition for the purpose of applying the consumer protection act, chapter 19.86 RCW.

- 9 <u>NEW SECTION.</u> **Sec. 7.** In collaboration with the office of the attorney general, the department shall conduct a consumer alert campaign to inform business proprietors of their rights and responsibilities regarding the public performance of copyrighted music. The consumer alert campaign must be paid for with fees collected pursuant to section 2 of this act and penalties imposed pursuant to sections 4 and 8 of this act.
- NEW SECTION. Sec. 8. The uniform regulation of business and professions act, chapter 18.235 RCW, governs unlicensed practice, the issuance and denial of licenses, and the discipline of licensees under this chapter.
- NEW SECTION. Sec. 9. (1) The director of licensing is hereby authorized to adopt reasonable rules not in conflict with provisions hereof for the proper operation and enforcement of this chapter.
- 23 (2) The director shall set all license and renewal fees in accordance with RCW 43.24.086.
- 25 **Sec. 10.** RCW 18.235.020 and 2013 c 322 s 29 are each amended to 26 read as follows:
- 27 (1) This chapter applies only to the director and the boards and 28 commissions having jurisdiction in relation to the businesses and 29 professions licensed under the chapters specified in this section. 30 This chapter does not apply to any business or profession not
- 31 licensed under the chapters specified in this section.
- 32 (2)(a) The director has authority under this chapter in relation 33 to the following businesses and professions:
 - (i) Auctioneers under chapter 18.11 RCW;

- (3) In addition to the authority to discipline license holders, 10 11 the disciplinary authority may grant or deny licenses based on the 12 conditions and criteria established in this chapter and the chapters specified in subsection (2) of this section. This chapter also 13 14 governs any investigation, hearing, or proceeding relating to denial of licensure or issuance of a license conditioned on the applicant's 15 16 compliance with an order entered under RCW 18.235.110 by the 17 disciplinary authority.
- NEW SECTION. Sec. 11. Sections 1 through 9 and 12 of this act constitute a new chapter in Title 19 RCW.
- NEW SECTION. Sec. 12. This act takes effect January 1, 2016.
