1 AN ACT Relating to modifying the definition of resident student
2 to comply with federal requirements established by the veterans
3 access, choice, and accountability act of 2014; and amending RCW
4 28B.15.012.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** RCW 28B.15.012 and 2014 c 183 s 1 are each amended to
7 read as follows:

8 Whenever used in this chapter:

9 (1) The term "institution" shall mean a public university,
10 college, or community college within the state of Washington.

11 (2) The term "resident student" shall mean:

12 (a) A financially independent student who has had a domicile in
13 the state of Washington for the period of one year immediately prior
14 to the time of commencement of the first day of the semester or
15 quarter for which the student has registered at any institution and
16 has in fact established a bona fide domicile in this state primarily
17 for purposes other than educational;

18 (b) A dependent student, if one or both of the student's parents
19 or legal guardians have maintained a bona fide domicile in the state
20 of Washington for at least one year immediately prior to commencement

1 of the semester or quarter for which the student has registered at
2 any institution;

3 (c) A student classified as a resident based upon domicile by an
4 institution on or before May 31, 1982, who was enrolled at a state
5 institution during any term of the 1982-1983 academic year, so long
6 as such student's enrollment (excepting summer sessions) at an
7 institution in this state is continuous;

8 (d) Any student who has spent at least seventy-five percent of
9 both his or her junior and senior years in high schools in this
10 state, whose parents or legal guardians have been domiciled in the
11 state for a period of at least one year within the five-year period
12 before the student graduates from high school, and who enrolls in a
13 public institution of higher education within six months of leaving
14 high school, for as long as the student remains continuously enrolled
15 for three quarters or two semesters in any calendar year;

16 (e) Any person who has completed the full senior year of high
17 school and obtained a high school diploma, both at a Washington
18 public high school or private high school approved under chapter
19 28A.195 RCW, or a person who has received the equivalent of a
20 diploma; who has lived in Washington for at least three years
21 immediately prior to receiving the diploma or its equivalent; who has
22 continuously lived in the state of Washington after receiving the
23 diploma or its equivalent and until such time as the individual is
24 admitted to an institution of higher education under subsection (1)
25 of this section; and who provides to the institution an affidavit
26 indicating that the individual will file an application to become a
27 permanent resident at the earliest opportunity the individual is
28 eligible to do so and a willingness to engage in any other activities
29 necessary to acquire citizenship, including but not limited to
30 citizenship or civics review courses;

31 (f) Any person who has lived in Washington, primarily for
32 purposes other than educational, for at least one year immediately
33 before the date on which the person has enrolled in an institution,
34 and who holds lawful nonimmigrant status pursuant to 8 U.S.C. Sec.
35 (a)(15) (E)(iii), (H)(i), or (L), or who holds lawful nonimmigrant
36 status as the spouse or child of a person having nonimmigrant status
37 under one of those subsections, or who, holding or having previously
38 held such lawful nonimmigrant status as a principal or derivative,
39 has filed an application for adjustment of status pursuant to 8
40 U.S.C. Sec. 1255(a);

1 (g) A student who is on active military duty stationed in the
2 state or who is a member of the Washington national guard;

3 (h) A student who is on active military duty or a member of the
4 national guard who entered service as a Washington resident and who
5 has maintained Washington as his or her domicile but is not stationed
6 in the state;

7 (i) A student who is the spouse or a dependent of a person who is
8 on active military duty or a member of the national guard who entered
9 service as a Washington resident and who has maintained Washington as
10 his or her domicile but is not stationed in the state. If the person
11 on active military duty is reassigned out-of-state, the student
12 maintains the status as a resident student so long as the student is
13 continuously enrolled in a degree program;

14 (j) A student who resides in the state of Washington and is the
15 spouse or a dependent of a person who is a member of the Washington
16 national guard;

17 (k)(i) A student who has separated from the military (~~under~~
18 ~~honorable conditions~~) with any period of honorable service after at
19 least (~~two years of~~) ninety days of active duty service, and who
20 enters an institution of higher education in Washington within
21 (~~one~~) three years of the date of separation (~~who~~;

22 ~~(i) At the time of separation designated Washington as his or her~~
23 ~~intended domicile; or~~

24 ~~(ii) Has Washington as his or her official home of record; or~~

25 ~~(iii) Moves to Washington and establishes a domicile as~~
26 ~~determined in RCW 28B.15.013;~~

27 ~~(l) A student who is the spouse or a dependent of an individual~~
28 ~~who has separated from the military under honorable conditions after~~
29 ~~at least two years of service who~~;

30 ~~(i) At the time of discharge designates Washington as his or her~~
31 ~~intended domicile; and~~

32 ~~(ii) Has Washington as his or her primary domicile as determined~~
33 ~~in RCW 28B.15.013; and~~

34 ~~(iii) Enters an institution of higher education in Washington~~
35 ~~within one year of the date of discharge)); or~~

36 (ii) A student who is the spouse or child of an individual who
37 has separated from the military with any period of honorable service
38 after at least ninety days of active duty service, and who enters an
39 institution of higher education in Washington within three years of
40 the date of separation; or

1 (iii) A student who is the spouse or a child of a deceased
2 individual who completed at least ninety days of active duty service
3 and died in the line of duty, and the student enters an institution
4 of higher education in Washington within three years of the
5 individual's death;

6 ~~((m))~~ (l) A student of an out-of-state institution of higher
7 education who is attending a Washington state institution of higher
8 education pursuant to a home tuition agreement as described in RCW
9 28B.15.725;

10 ~~((n))~~ (m) A student who meets the requirements of RCW
11 28B.15.0131: PROVIDED, That a nonresident student enrolled for more
12 than six hours per semester or quarter shall be considered as
13 attending for primarily educational purposes, and for tuition and fee
14 paying purposes only such period of enrollment shall not be counted
15 toward the establishment of a bona fide domicile of one year in this
16 state unless such student proves that the student has in fact
17 established a bona fide domicile in this state primarily for purposes
18 other than educational;

19 ~~((o))~~ (n) A student who resides in Washington and is on active
20 military duty stationed in the Oregon counties of Columbia, Gilliam,
21 Hood River, Multnomah, Clatsop, Clackamas, Morrow, Sherman, Umatilla,
22 Union, Wallowa, Wasco, or Washington; or

23 ~~((p))~~ (o) A student who resides in Washington and is the spouse
24 or a dependent of a person who resides in Washington and is on active
25 military duty stationed in the Oregon counties of Columbia, Gilliam,
26 Hood River, Multnomah, Clatsop, Clackamas, Morrow, Sherman, Umatilla,
27 Union, Wallowa, Wasco, or Washington. If the person on active
28 military duty moves from Washington or is reassigned out of the
29 Oregon counties of Columbia, Gilliam, Hood River, Multnomah, Clatsop,
30 Clackamas, Morrow, Sherman, Umatilla, Union, Wallowa, Wasco, or
31 Washington, the student maintains the status as a resident student so
32 long as the student resides in Washington and is continuously
33 enrolled in a degree program.

34 (3) The term "nonresident student" shall mean any student who
35 does not qualify as a "resident student" under the provisions of this
36 section and RCW 28B.15.013. Except for students qualifying under
37 subsection (2)(e) or ~~((m))~~ (l) of this section, a nonresident
38 student shall include:

39 (a) A student attending an institution with the aid of financial
40 assistance provided by another state or governmental unit or agency

1 thereof, such nonresidency continuing for one year after the
2 completion of such semester or quarter.

3 (b) A person who is not a citizen of the United States of America
4 who does not have permanent or temporary resident status or does not
5 hold "Refugee-Parolee" or "Conditional Entrant" status with the
6 United States citizenship immigration services or is not otherwise
7 permanently residing in the United States under color of law and who
8 does not also meet and comply with all the applicable requirements in
9 this section and RCW 28B.15.013.

10 (4) The term "domicile" shall denote a person's true, fixed and
11 permanent home and place of habitation. It is the place where the
12 student intends to remain, and to which the student expects to return
13 when the student leaves without intending to establish a new domicile
14 elsewhere. The burden of proof that a student, parent or guardian has
15 established a domicile in the state of Washington primarily for
16 purposes other than educational lies with the student.

17 (5) The term "dependent" shall mean a person who is not
18 financially independent. Factors to be considered in determining
19 whether a person is financially independent shall be set forth in
20 rules adopted by the student achievement council and shall include,
21 but not be limited to, the state and federal income tax returns of
22 the person and/or the student's parents or legal guardian filed for
23 the calendar year prior to the year in which application is made and
24 such other evidence as the council may require.

25 (6) The term "active military duty" means the person is serving
26 on active duty in:

27 (a) The armed forces of the United States government; or

28 (b) The Washington national guard; or

29 (c) The coast guard, merchant mariners, or other nonmilitary
30 organization when such service is recognized by the United States
31 government as equivalent to service in the armed forces.

32 (7) The term "active duty service" means full-time duty, other
33 than active duty for training, as a member of the uniformed service
34 of the United States. Active duty service as a national guard member
35 under Title 32 U.S.C. for the purpose of organizing, administering,
36 recruiting, instructing, or training and active service under 32
37 U.S.C. Sec. 502(f) for the purpose of responding to a national
38 emergency is recognized as active duty service.
