- 1 AN ACT Relating to timing free access days at state parks with
- 2 local community events; amending RCW 79A.80.050 and 79A.05.040; and
- 3 adding a new section to chapter 79A.80 RCW.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 79A.80 6 RCW to read as follows:
- 7 (1) The director of the parks and recreation commission may, in 8 consultation with the department of natural resources and the 9 department of fish and wildlife, designate specific days when certain 10 recreation sites or lands, or all recreation sites or lands, may be 11 lawfully accessed without having to display a discover pass or day-
- 12 use permit.
- 13 (2) The free access days should be designated to best showcase 14 state parks or other recreation sites or lands, provide equitable 15 access statewide for persons with limited incomes, and 16 significantly impact state finances. In identifying appropriate free access days, the commission should consider, when practicable and 17 appropriate, the following factors: 18
- 19 (a) Any similar free access days planned by the national park 20 service for national parks;

- 1 (b) The commemoration of a grand opening of a state parks 2 facility or a facility on another state recreation site or land;
 - (c) Local community celebrations;

- 4 (d) Other local, regional, statewide, or national events, bolidays, or commemorative days.
- 6 **Sec. 2.** RCW 79A.80.050 and 2012 c 261 s 6 are each amended to 7 read as follows:
- 8 (((1))) A discover pass or a day-use permit are not required 9 within a state park for persons who have a valid camper registration, 10 or annual natural investment permit, issued by the state parks and 11 recreation commission.
- 12 (((2) The state parks and recreation commission must provide up
 13 to twelve days a year where entry to state parks is free. At least
 14 three of those days must be on weekends. When practicable, the free
 15 access days should be timed to correspond with any similar free
 16 access days planned by the national park service for national parks
 17 located in the general region of high volume state parks.))
- 18 **Sec. 3.** RCW 79A.05.040 and 1999 c 249 s 401 are each amended to 19 read as follows:
- 20 <u>(1)</u> In addition to other duties the commission may from time to 21 time impose, it is the duty of the director to:
- 22 $((\frac{1}{1}))$ (a) Ensure the control of weeds in parks to the extent 23 required by RCW 17.04.160 and 17.10.205; ((and
- 24 (2))) (b) Participate in the operations of the environmental enhancement and job creation task force under chapter 43.21J RCW; and
- 26 (c) Designate free access days pursuant to section 1 of this act.
- 27 (2) The director has the power reasonably necessary to carry out 28 these duties.
