1 AN ACT Relating to defining professional legislative staff member  
2 for purposes of personal financial affairs reporting; and amending  
3 RCW 42.17A.705.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 42.17A.705 and 2012 c 229 s 582 are each amended to  
6 read as follows:

7 For the purposes of RCW 42.17A.700, "executive state officer"  
8 includes:

9 (1) The chief administrative law judge, the director of  
10 agriculture, the director of the department of services for the  
11 blind, the chief information officer of the office of chief  
12 information officer, the director of the state system of community  
13 and technical colleges, the director of commerce, the director of the  
14 consolidated technology services agency, the secretary of  
15 corrections, the director of early learning, the director of ecology,  
16 the commissioner of employment security, the chair of the energy  
17 facility site evaluation council, the director of enterprise  
18 services, the secretary of the state finance committee, the director  
19 of financial management, the director of fish and wildlife, the  
20 executive secretary of the forest practices appeals board, the  
21 director of the gambling commission, the secretary of health, the

1 administrator of the Washington state health care authority, the  
2 executive secretary of the health care facilities authority, the  
3 executive secretary of the higher education facilities authority, the  
4 executive secretary of the horse racing commission, the human  
5 resources director, the executive secretary of the human rights  
6 commission, the executive secretary of the indeterminate sentence  
7 review board, the executive director of the state investment board,  
8 the director of labor and industries, the director of licensing, the  
9 director of the lottery commission, the director of the office of  
10 minority and women's business enterprises, the director of parks and  
11 recreation, the executive director of the public disclosure  
12 commission, the executive director of the Puget Sound partnership,  
13 the director of the recreation and conservation office, the director  
14 of retirement systems, the director of revenue, the secretary of  
15 social and health services, the chief of the Washington state patrol,  
16 the executive secretary of the board of tax appeals, the secretary of  
17 transportation, the secretary of the utilities and transportation  
18 commission, the director of veterans affairs, the president of each  
19 of the regional and state universities and the president of The  
20 Evergreen State College, and each district and each campus president  
21 of each state community college;

22 (2) Each professional staff member of the office of the governor;

23 (3) Each professional staff member of the legislature. For  
24 purposes of this section, a professional staff member of the  
25 legislature does not include a legislative assistant; and

26 (4) Central Washington University board of trustees, the boards  
27 of trustees of each community college and each technical college,  
28 each member of the state board for community and technical colleges,  
29 state convention and trade center board of directors, Eastern  
30 Washington University board of trustees, Washington economic  
31 development finance authority, Washington energy northwest executive  
32 board, The Evergreen State College board of trustees, executive  
33 ethics board, fish and wildlife commission, forest practices appeals  
34 board, forest practices board, gambling commission, Washington health  
35 care facilities authority, student achievement council, higher  
36 education facilities authority, horse racing commission, state  
37 housing finance commission, human rights commission, indeterminate  
38 sentence review board, board of industrial insurance appeals, state  
39 investment board, commission on judicial conduct, legislative ethics  
40 board, life sciences discovery fund authority board of trustees,

1 liquor control board, lottery commission, Pacific Northwest electric  
2 power and conservation planning council, parks and recreation  
3 commission, Washington personnel resources board, board of pilotage  
4 commissioners, pollution control hearings board, public disclosure  
5 commission, public employees' benefits board, recreation and  
6 conservation funding board, salmon recovery funding board, shorelines  
7 hearings board, board of tax appeals, transportation commission,  
8 University of Washington board of regents, utilities and  
9 transportation commission, Washington State University board of  
10 regents, and Western Washington University board of trustees.
