1            AN ACT Relating to increasing opportunities for accessible and  
2 effective family planning; adding new sections to 2015 2nd sp.s.  
3 c ... (ESHB 1106); making appropriations; providing an effective  
4 date; and declaring an emergency.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6            NEW SECTION.    **Sec. 1.** A new section is added to 2015 2nd sp.s.  
7 c ... (ESHB 1106) to read as follows:

8            (1) The sum of \$1,410,000, or as much thereof as may be  
9 necessary, is appropriated for the fiscal year ending June 30, 2016,  
10 from the state general fund to the state health care authority.

11            (2) The sum of \$1,388,000, or as much thereof as may be  
12 necessary, is appropriated for the fiscal year ending June 30, 2017,  
13 from the state general fund to the state health care authority.

14            (3) The sum of \$10,104,000, or as much thereof as may be  
15 necessary, is appropriated for the biennium ending June 30, 2017,  
16 from the general fund—federal to the state health care authority.

17            (4) The appropriations in this section are provided solely to  
18 increase the reimbursement rate for providing long-acting reversible  
19 contraceptives such as intrauterine devices.

1        NEW SECTION.    **Sec. 2.**    A new section is added to 2015 2nd sp.s.  
2 c ... (ESHB 1106) to read as follows:

3        (1) The sum of \$966,000, or as much thereof as may be necessary,  
4 is appropriated for the fiscal year ending June 30, 2016, from the  
5 state general fund to the state health care authority.

6        (2) The office of financial management shall reduce allotments  
7 for the health care authority by \$4,263,000 from the general fund—  
8 state appropriation for the fiscal year ending June 30, 2017, and by  
9 \$10,644,000 from the general fund—federal appropriation for the  
10 fiscal biennium ending June 30, 2017. The amounts reduced from  
11 allotments must be placed in reserve status and must remain  
12 unexpended.

13        (3) The allotment reductions in this section reflect savings  
14 attributable to providing stand-alone family planning coverage to  
15 clients regardless of citizenship status, and the savings will be  
16 achieved by preventing unwanted pregnancies that generate state costs  
17 for prenatal, birth, and postpartum services, and for medical  
18 coverage for newborns.

19        NEW SECTION.    **Sec. 3.**    This act is necessary for the immediate  
20 preservation of the public peace, health, or safety, or support of  
21 the state government and its existing public institutions, and takes  
22 effect July 1, 2015.
