- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 48.43 6 RCW to read as follows:
- 7 (1) A health carrier shall use the database selected pursuant to 8 RCW 48.165.035 to accept and manage credentialing applications from 9 health care providers.
- 10 (a) A health carrier shall make a determination approving or 11 denying a credentialing application submitted to the carrier no later 12 than fifteen days after receiving a complete application from a 13 health care provider.
 - (b) If a health care provider submits an incomplete credentialing application to a health carrier, the carrier shall notify the health care provider in writing no later than five days after receipt of the application that the application is incomplete. The notice must explain what additions or corrections to the application are necessary for the application to be considered complete. This section does not require health carriers to approve a credentialing application or to place providers into a network.

- 1 (2) This section does not apply to credentialing delegation 2 arrangements between facilities and health carriers.
- 3 (3) For purposes of this section, "credentialing" means the 4 collection, verification, and assessment of whether a health care 5 provider meets relevant licensing, education, and training 6 requirements.
- NEW SECTION. Sec. 2. A new section is added to chapter 18.130 RCW to read as follows:
- 9 (1) When submitting a credentialing application to a health 10 carrier, a health care provider shall submit the application to 11 health carriers using the database selected pursuant to RCW 12 48.165.035.
- 13 (2) This section does not apply to providers practicing at a 14 facility that has a credentialing delegation arrangement between the 15 facility and a health carrier.
- 16 (3) The definitions in this subsection apply throughout this 17 section unless the context clearly requires otherwise.
- 18 (a) "Credentialing" has the same meaning as in section 1 of this 19 act.
- 20 (b) "Facility" has the same meaning as in RCW 48.43.005.
- 21 (c) "Health care provider" has the same meaning as in RCW 22 48.43.005(23)(a).
- 23 (d) "Health carrier" has the same meaning as in RCW 48.43.005.
