1 AN ACT Relating to the Washington open education pilot grant
2 program at the state universities, regional universities, and The
3 Evergreen State College; creating new sections; providing an
4 expiration date; and declaring an emergency.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** The legislature finds that the cost of
7 textbooks is a barrier to higher education for many students. The
8 state board for community and technical colleges through the open
9 course library, and universities around the country through various
10 open education material programs, have achieved significant cost
11 savings for students. It is the intent of the legislature to create a
12 pilot grant program to reduce costs for college students by
13 encouraging faculty to accelerate the adoption of lower cost, high-
14 quality open educational resources.

15 NEW SECTION. **Sec. 2.** (1) Beginning in the 2016-17 academic
16 year, the Washington open education pilot grant program is
17 established within the student achievement council to create a
18 competitive grant program to provide an incentive for faculty to
19 adopt open educational resources and reduce students' costs of
20 attendance.

1 (2) Subject to funds appropriated specifically for this purpose,
2 the student achievement council shall award up to one hundred grants
3 per year to faculty members to develop or obtain open educational
4 materials and resources. The student achievement council shall
5 develop a process for review and selection of grant applications.

6 (3) In developing the pilot program, the student achievement
7 council is encouraged to use the Massachusetts Amherst open education
8 initiative and the California textbook affordability act as models.

9 (4) Beginning September 1, 2017, and by September 1, 2018, the
10 student achievement council shall submit to the appropriate
11 committees of the legislature a report of the pilot program,
12 including:

13 (a) How the program is being implemented, including a comparison
14 between the pilot program at the student achievement council and
15 programs at the University of Massachusetts Amherst, the California
16 State University system, and other institutions with similar models;

17 (b) The number of faculty that applied for the grant and the
18 number of faculty that received the grant;

19 (c) The courses and departments of the faculty members that
20 received the grants; and

21 (d) The total cost savings to students and the cost savings per
22 student enrolled in a course taught by a grant recipient.

23 (5) This section expires June 30, 2019.

24 NEW SECTION. **Sec. 3.** This act is necessary for the immediate
25 preservation of the public peace, health, or safety, or support of
26 the state government and its existing public institutions, and takes
27 effect immediately.

28 NEW SECTION. **Sec. 4.** If specific funding for the purposes of
29 this act, referencing this act by bill or chapter number, is not
30 provided by June 30, 2016, in the omnibus appropriations act, this
31 act is null and void.
