- 1 AN ACT Relating to creating the Washington free to finish college
- 2 program; amending RCW 28B.76.540; adding a new chapter to Title 28B
- 3 RCW; creating a new section; and providing an expiration date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that the cost of
- 6 higher education is often a barrier for students and recognizes that
- 7 in order to meet the legislature's educational attainment goal of
- 8 having at least seventy percent of Washington adults obtain a
- 9 postsecondary credential by 2023, more needs to be done to encourage
- 10 Washingtonians to go back to college. Therefore, it is the intent of

(1) "Gift aid" means financial aid received from the federal Pell grant, the state need grant program under chapter 28B.92 RCW, the college bound scholarship program under chapter 28B.118 RCW, the opportunity grant program under chapter 28B.50 RCW, the opportunity scholarship program under chapter 28B.145 RCW, or any other federal or state grant, benefit, or scholarship program that provides funds for educational purposes with no obligation of repayment. Student loans and work study programs are not "gift aid."

- 9 (2) "Office" means the office of student financial assistance, as 10 established under chapter 28B.76 RCW.
- 11 (3) "Program" means the Washington free to finish college program
 12 created in this chapter.
 - NEW SECTION. Sec. 3. (1) The Washington free to finish college program is established to encourage Washington residents who attended a postsecondary education degree or certificate program, but were unable to graduate and are no longer enrolled in a postsecondary education degree or certificate program, to return to an institution of higher education to complete their program of study. To be eligible for the program, a student needs to:
- 20 (a) Be a resident of the state, as defined in RCW 28B.15.012(2) 21 (a) through (e);
 - (b) Not previously earned a postsecondary degree or certificate;
 - (c) Be enrolled in an institution of higher education, but not enrolled for the past three years prior to the first quarter or semester of reenrollment under the program;
 - (d) Have no more than fifteen quarter credits or fifteen semester credits remaining in his or her degree or certificate program; and
- (e) Submit the free application for federal student aid (FAFSA) or the Washington application for state financial aid.
- 30 (2) The program shall be administered by the office, which may 31 adopt rules necessary to administer the program.
 - (3) Subject to the availability of funding, the office shall award grants to students who meet the criteria in subsection (1) of this section for an amount equal to the cost of tuition and fees as defined in RCW 28B.15.020 and services and activities fees as defined in RCW 28B.15.041, less any gift aid received.
- 37 (4) The program shall not result in a reduction of any federal or 38 state gift aid.

- NEW SECTION. Sec. 4. By December 1, 2017, and every December 1 st thereafter, the office shall report to the appropriate policy and fiscal committees of the legislature regarding the impact of the program, including:
- 5 (1) The number of applicants;
- 6 (2) The number of students served;
- 7 (3) Program costs;
- 8 (4) Participant demographics;
- 9 (5) Enrollment status, meaning part time versus full time;
- 10 (6) Field of study; and
- 11 (7) Any other information deemed relevant.
- NEW SECTION. Sec. 5. (1) The office shall contract with a third 12 13 party to complete an evaluation of the program. The evaluation must address the impacts and cost of the program, and it must include an 14 15 assessment of student support services provided to students who 16 qualify for the program, including whether the student 17 services are considered effective at helping students succeed at 18 college. A report on the evaluation is due to the appropriate policy and fiscal committees of the legislature by November 1, 2020. 19
- 20 (2) This section expires August 1, 2021.
- 21 **Sec. 6.** RCW 28B.76.540 and 2011 1st sp.s. c 11 s 111 are each 22 amended to read as follows:
