- 1 (iii) The state board of registration for professional engineers 2 and land surveyors established in chapter 18.43 RCW governing 3 licenses issued under chapters 18.43 and 18.210 RCW;
 - (iv) The funeral and cemetery board established in chapter 18.39 RCW governing licenses issued under chapters 18.39 and 68.05 RCW;
- 6 (v) The state board of licensure for landscape architects 7 established in chapter 18.96 RCW; and
- 8 (vi) The state geologist licensing board established in chapter 9 18.220 RCW.
- (3) In addition to the authority to discipline license holders, 10 11 the disciplinary authority may grant or deny licenses based on the 12 conditions and criteria established in this chapter and the chapters specified in subsection (2) of this section. This chapter also 13 governs any investigation, hearing, or proceeding relating to denial 14 of licensure or issuance of a license conditioned on the applicant's 15 16 compliance with an order entered under RCW 18.235.110 by the 17 disciplinary authority.
- 18 **Sec. 2.** RCW 43.24.150 and 2013 2nd sp.s. c 4 s 978 are each 19 amended to read as follows:
 - (1) The business and professions account is created in the state treasury. All receipts from business or professional licenses, registrations, certifications, renewals, examinations, or civil penalties assessed and collected by the department from the following chapters must be deposited into the account:
 - (a) Chapter 18.11 RCW, auctioneers;

- 7 Moneys in the account may be spent only after appropriation.
- 8 Expenditures from the account may be used only for expenses incurred
- 9 in carrying out these business and professions licensing activities
- 10 of the department. Any residue in the account must be accumulated and
- 11 may not revert to the general fund at the end of the biennium.
- 12 However, during the 2013-2015 fiscal biennium the legislature may
- 13 transfer to the state general fund such amounts as reflect the excess
- 14 fund balance in the account.
- 15 (2) The director must biennially prepare a budget request based
- 16 on the anticipated costs of administering the business and
- 17 professions licensing activities listed in subsection (1) of this
- 18 section, which must include the estimated income from these business
- 19 and professions fees.
